Doctors at AIIMS, RML end strike

New Delhi: In a huge relief to patients, doctors at major hospitals, including AIIMS, RML, LNJP and Maulana Azad Medical College in the national capital, ended their 11-day strike on Thursday soon after the Supreme Court made an impassioned appeal to the protesting medics to resume work and directed the Centre to provide safety measures to them.

A tough-talking apex court termed "extremely disturbing" the Kolkata Police's delay in registering the unnatural death of the woman doctor raped and killed at the RG Kar Hospital.

The court, however, said judges and doctors cannot go on a strike since they deal with matters involving life and liberty.

Following the court's appeal and directions about safety of doctors, resident doctors' association (RDA) of several hospitals ended the strike that commenced on August 12.

The Federation of All India Medical Association (FAIMA), an umbrella body of doctors, RDAs of centrerun facilities such as AIIMS, RML and Lady Hardinge Medical College, and Delhi government-run LNJP, Maulana Azad Medical Col-



lege, GTB Hospital and Indira Gandhi Hospital also announced their decision to call off the protest.

In a post on X, the Federation of Resident Doctors Association (FORDA), a major body of RDAs across the country, announced its decision to call off the strike, saying the doctors will resume their duty.

"We are thankful to all RDAs, media personnel, various medical and nonmedical associations and above all, our patients, for their support and understanding," it said.

The decision to call off the strike comes as a major relief to patients who were struggling to get regular medical care due to the closure of outpatient department (OPD) in government hospitals even as emergency services were functioning as



Kolkata: The psychoanalytic profile of the arrested accused in the rape and murder of the woman doctor at the state-run RG Kar Medical College and Hospital, Sanjay Roy, indicated that he was a pervert and severely addicted to pornography, a CBI officer said on Thursday.

Quoting the doctors from New Delhi's Central Forensic Science Laboratory (CFSL), the officer also said

that the civic volunteer of the Kolkata Police has an "animal-like instinct".

The body of the postgraduate trainee was found in the seminar room of the hospital on August 9. The civic volunteer was arrested the next day in this connection.

"The man showed no repentance and narrated the entire episode giving every minute detail without hiccups. It appeared that he had the central probe agency told PTI on Thursday.

Several pornographic contents were found in the mobile phone that Roy was using and later seized by the Kolkata Police before the investigation was handed over to the CBI on an order of the Calcutta High Court.

The CBI officer said that pieces of evidence, both technical and scientific, "very much support" that

the accused was present at the crime scene.

Referring to the CCTV footage collected from the hospital, he said, Roy could be seen near the chest department ward at around 11 am on August 8.

"Footage showed him entering the same building again at around 4 am on August 9. Certain technical and scientific evidence corroborated that," he said.

Bahrain's track team sanctioned

Monaco: Bahrain's track team will have to pause its successful strategy of naturalizing athletes from Africa after accepting a package of

sanctions related to doping

World Athletics said Thursday that Bahrain had been restricted to a maximum of 10 athletes in the track and field events at the Paris Olympics — which wasn't announced at the time — and at next year's world championships in Tokvo

Bahrain's team in Paris included Kenya-born Winfred Yavi, who won gold in Paris in the women's 3,000-meter steeplechase, and Nigeria-born sprinter Salwa Eid Naser, the silver medalist in the 400. Neither athlete was accused of any wrongdoing in the case announced Thursday.

The Bahrain Athletics Association admitted a charge of "conducting itself in relation to doping, negligently and/or recklessly and/or so as to prejudice the interests of World Athletics or bring the sport of athletics into disrepute," and another related to its employment of

staff to work with athletes, governing body World Athletics said

That followed an investigation into allegations two athletes used blood transiusions at the Tokyo Olympics in 2021 and into the BAA having "engaged" a coach who was under a doping-related ban, World Athletics

Bahrain has agreed not to recruit any more foreign athletes until 2027, World Athletics said. The next Summer Olympics are in Los Angeles in 2028. Bahrain has also committed to fund a "talent academy" to develop local athletes and has set up a new national antidoping body.

It's not the first time Bahrain has faced scrutiny over doping, particularly among its roster of athletes who were naturalized.

Naser missed the Tokyo Olympics while serving a ban for not being available for drug testing. Kemi Adekoya, a former world indoor champion in the 400, got a four-year ban in 2019 in a

Police officers virtually threatened us

The parents of the Badlapur victim narrate their ordeal to a Marathi news channel. Excerpts...



On August 13, we went for a test at a private nospitai. In this test, the doctor said that such (sexual abuse) incident happened with our daughter. Also, her report was positive. Meanwhile, a similar incident happened with the friend of the victim. So we waited for a day for her report. After that, we were shocked when the friend's report also came to light. Because a similar incident happened with both the

We went to school. We also had a medical report. The incident was reported to the school principal and school teachers. The school administration denied the incident saying that it cannot happen in our school. The incident was said to have happened outside the school and not in the school. The principal claimed that it might have happened while riding a bicycle. But we have a medical report and we told them that this cannot happen while riding.

So even after informing the school immediately, they did nothing. Therefore, we the victim's family mem bers demand that action should be taken against the principal and teachers of the school.

After this we directly reached the police station and tried to lodge a complaint. Also told the police that we have the medical report. However, the police did not even look at our medical report, instead they kept us sitting there. Also, the victim's family accused the police that they did pay heed to us. As the police did not listen to us, we called the local MNS leaders and sought their help. The MNS leaders came to the police station, but the police did not file an FIR. Later MNS people contacted senior police. Then a senior police officer came to the police station. After that our FIR was registered after almost 12 hours. But the victim's family accused the police that the police had made many changes in what we

had said in that FIR.

The next day after filing the FIR, the police called us for a medical test. The time given was 9 am but the police had entered the hospital at 11.45 am. So both the

little girls had to stay in the hospital for several hours. The innocent girls had no idea what was happening to them. Then again at 4 pm they called us to the police station and kept us there.

We had to sit in the police station with the little girl Also, some important documents were missing from the government hospital. It made us search for those documents. Later the same documents were found on the doctor's desk. The family members of the victim have alleged that they made us run from the police station to the hospital.

We had also demanded CCTV footage from the school. However, the school administration gave the reason that the CCTV was closed for 15 days. While we were in school, women police officers also entered. At that time we were made to sit outside and the lady police officer went into the room alone and discussed the school administration. After leaving the room, he told us, "No such incident happened, so don't spread false news." At this time, we also told him that we have medical evidence, but he didn't listen to anything. The vic-

tim's family alleged that the school has some conand her pregnant mother. nection with political leaders, so the lady officer tried to suppress our voice.

The doctor had asked the police to file an FIR. But the police filed an FIR only after 12 hours. The family of the victim also said that the accused was nowhere to be found after the incident, but we do not know how he was found suddenly on August

The police threatened us during the agitation at Badlapur railway station. When the agitation started at Badlapur railway station, the police told us we should wait in the vicinity of the station. Strict action will be taken if found in agitation. Also, the victim's family alleged that the police threatened to file a case against us in the name of inciting the agitation in Badlapur.

During this entire period we were abused, threatened, female officers were missing for hours. Because of what happened to us, we have lost faith in the police.

India, Poland unveil 5-year 'Action Plan'

Warsaw: India and Poland on Thursday upgraded their ties to the level of a "strategic partnership" and inked a social security pact to promote the mobility of skilled workers following wideranging talks between Prime Minister Narendra Modi and his Polish counterpart Donald Tusk.

In the meeting, both sides vowed to significantly expand the bilateral defence and security ties with Tusk expressing Warsaw's eagerness to be a key partner in New Delhi's aim to boost domestic defence production and modernise its armed forces.

Modi arrived in this Pol-

ish capital on Wednesday, in the first visit by an Indian prime minister to Poland in nearly half a century. In the second leg of his two-nation trip, Modi will be in Kyiv for around seven hours on

The prime minister also held talks with Polish President Andrzej Duda.

Following the Modi-Tusk talks, the two sides unveiled a five-year "Action Plan" (2024-2028) for the India-Poland strategic partnership identifying a range of areas including defence, trade, agri-tech, energy, green technologies, infrastructure, pharmaceuticals and mining for cooperation.

"This year we celebrate 70years of our diplomatic relations. On this occasion, we have decided to reshape our relation into a strategic partnership," Modi said in his media statement with Tusk

"Today we have identified several initiatives to give a new direction to our relations," he said.

The 'Action Plan' lists various priority areas for boosting engagement under different pillars including political and security cooperation, trade and investment, transport and connectivity, climate, energy, mining, science and technology and EU-India.

It specifically mentioned supporting the early conclusion of the ongoing India-EU trade and investment negotiations, the operationalisation of the India-EU Trade and Technology Council (TTC) and the implementation of the India-EU Connec-

tivity partnership. In his remarks, Modi said the social security agreement will promote the mobility of the workforce and ensure their welfare.

The prime minister also thanked Poland for facilitating the evacuation of Indian students from Ukraine after the conflict began in 2022.

Tusk said Poland wants to expand its defence coopera-

tion with India. "We are ready to take part in the modernisation of military equipment.'

A joint statement said both sides recognised the need to strengthen and deepen cooperation in the defence sector. To this end, they agreed to

fully utilise existing bilateral mechanisms, including the Joint Working Group for Defence Cooperation.

Modi said both sides identified several initiatives to give a new direction to the relations.

'Efforts will be made to connect the private sector to broaden economic cooperation," he said.

"Poland is among the world leaders in food processing. We want Polish companies to join the Mega Food Parks being built in India," Modi said.

The prime minister said rapid urbanisation in India is opening up new opportunities for our cooperation in areas such as water treatment, solid waste management, and urban infrastructure

"Clean coal technology, green hydrogen, renewable energy, and artificial intelligence are also our common priorities. We invite Polish companies to join Make in India and Make for the World," he said.

SC order to government

Hand over BKC land for HC by Sept 7

Court on Thursday asked the Maharashtra government to issue an order by September 7 for handing over the land at Bandra-Kurla complex to the Bombay High Court for construction of its new building.

The top court, hearing a suo motu case titled as 'Heritage Building of the Bombay High Court and allotment of additional lands for the High Court', also directed the state government to pass another order to declare the high court building's project as "vital" to ensure that it does not get affected due to enforcement of the model code of conduct for assembly polls in Maharashtra.

A special bench comprising Chief Justice D.Y. Chandrachud and Justices B.R. Gavai and J.B. Pardiwala also asked Solicitor General Tushar Mehta, appearing for the Centre, to coordinate with the chairperson of the Bank of India with regard to handing over the possession of certain portion of a building in Mumbai for shifting few facilities of the high court there.

At the outset of the proceedings, the bench asked about the progress made so far in the case.



"On July 8, 2024, an internal meeting was convened by the Chief Justice of the High Court with the Judges Committee monitoring the construction of the new premises. On July 9, 2024, another meeting was held in which all stakeholders including government officials participated.

"We have been informed that by September 10, 2024, a contiguous area of 4.39 acres in Bandra-Kurla complex will be handed over to the high court by the state government. The state has indicated a timeline to hand over the balance area in phases which measures 30.16 acres to the high court as well," the bench had said.

MPSC postpones prelim exam

MPox: BMC reserves 14-bed ward in Andheri

Mumbai: The BMC has reserved a 14-bed ward in Seven Hills Hospital in Andheri's Marol area for MPox patients as a precautionary measure, an official said on Thursday.

"Passengers suspected of having MPox infection will be sent to BMC's Seven Hills Hospital for treatment. More beds can be reserved if needed," the BMC said in a release, adding no case has been found in Mumbai. "Citizens of the financial

capital of the country are urged not to panic. This step has been taken following instructions from the Union and state governments."

The BMC said screening of the passengers arriving from Africa as well as some other countries in which MPox cases have been detected has begun at the Chhatrapati Shivaji Maha-

raj International Airport, while a health information desk has been set up there for passengers. The BMC said it had carried out a joint coordination meeting with the airport health officer (APHO) a day before to take the stock of the situation.

The Union Health and Family Welfare ministry has instructed all states to take precautionary measures in connection with MPox, while the Maharashtra government has directed that survey, prohibition and control measures be undertaken to prevent the spread.

MPox is a viral illness caused by the monkeypox virus, a species of the genus Orthopoxvirus. Common symptoms include skin rash, mucosal lesions which can last from two to four weeks accompanied by fever, headache, muscle aches, back pain, low energy and swollen lymph nodes. - PTI



Badlapur sexual abuse case

HC calls it "absolutely shocking"

Mumbai: The Bombay High Court on Thursday called the sexual assault on two minor girls at their school in Badlapur "absolutely shocking" and said that there cannot be any compromise on the safety and security of

A division bench of Justices Revati Mohite Dere and Prithviraj Chavan said that action ought to be taken against the school authorities for not reporting the incident despite being aware of it. It also blasted the police over the delay in registering the FIR.

The court had taken suo motu (on its own) cognisance of the incident where two four-year-old girls were sexually assaulted inside the school's washroom at Badlapur in Thane district by a male attendant on August 12 and 13.

The FIR in the case was lodged on August 16 and the accused was arrested on August 17, as per court documents.

The bench said the police machinery had not moved till the public hit the streets with a protest and outburst.

'Unless there is strong public outburst, machinery won't move. Won't the state move till public outbursts like this," the court asked.

The bench said it was appalled to note that the Badlapur police had not probed the case properly.

"Such serious matters where girls as young as three and four-year-olds have been sexually assaulted...how can the police take it so lightly,'

the court questioned.

"If schools are not a safe place what is a child supposed to do? What did a three and four-year-old child do? This is absolutely shocking," the court said.

The bench said it was not at all "happy" with the manner in which the Badlapur police handled the case.

"We are only interested in seeing that the victim girls get justice and this is exactly what the police should have also been interested in," HC

The bench directed the police to ensure all support is given to the victims and their families.

The victims should not be victimised further, it said. "In this case, the girls

complained, there might be so many cases which may have gone unnoticed," the bench said.

The court said the families of the girls ought to have been shown some support by the police but it was not done in this case. "First thing, the police

should have filed FIR. School authorities were silent. This discourages people from coming forward," the court said.

"People should not lose faith in the police system or the judicial system. If public had to come to the streets then think about the future," the HC said.

It also called for steps within the police machinery to sensitise cops.

The bench directed the Special Investigation Team (SIT) set up by the government to probe the case to file a report by August 27 stating what steps it has taken

"We are appalled that the Badlapur police has not taken any steps to take the statement of the second girl till date," HC said.

The court said if it comes to know that there has been an attempt to hush up the case then it won't hesitate to take action against the police officer concerned.

"Also tell us what steps is the state government taking to ensure the safety and security of girls. There can be no compromise on this," HC said.

The bench further said that the school authorities were aware of the incident but kept silent and did not inform the police.

Under the Protection of Children from Sexual Offences (POCSO) Act, nonreporting of a sexual assault is also an offence, said the

"This should have been done even before SIT was constituted. It was incumbent on the police to take action. Non-reporting of such incidents is also an offence,' the court said.

Advocate General Birendra Saraf assured the court that action would be taken against the school authority concerned on Thursday itself.

"You will be taking action against school for not reporting. School authorities had not come forward. Whosoever is responsible for the delay, action will be taken. No one will be spared," the court said.

Saraf informed the bench that the statement of one of the girls has been recorded before a magistrate and the statement of the second victim girl would be taken on Thursday.

The court sought to know why there was a delay in doing that.

The bench directed the SIT to also submit the original case diary maintained by the Badlapur police, a copy of the FIR and other papers related to the case

Saraf informed the court that the errant police officials from the Badlapur police station have been suspended.

The bench said the suspension was not enough. The alleged sexual assault

on the two kindergarten students by a male attendant had sparked a massive protest in Badlapur on

The male attendant, who was arrested on August 17, allegedly assaulted the kids in the school's toilet. A local court on Wednesday extended his police custody till Au-

Uddhav attacks CM over politically motivated remark

Mumbai: Shiv Sena (UBT) chief Uddhav Thackerav on Thursday targeted Maharashtra Chief Minister Eknath Shinde, saying those who feel there is politics behind Badlapur protest over the alleged sexual assault on two minor girls are either abnormal or protectors of the culprits.

Thackeray was referring to CM Shinde's claim that the protest was politically motivated and most of the protesters had come from outside. CM Eknath Shinde on Wednesday said that the protests at Badlapur were politically motivated and most of the protesters were outsiders.

The MVA has called for a Maharashtra bandh on August 24 to protest against the alleged sexual assault on the two girls.

Accusing the government of behaving in a very insensitive way while handling the sexual assault case, Thackeray flayed the government over the delay in registering the FIR. He said the pregnant mother of one of the girls was made to wait for hours.

He also asked where CM Shinde was when the protests took place.

He said there is no political motive behind the bandh called by the opposition bloc Maha Vikas Aghadi (MVA) on August 24. The bandh is aimed at creating awareness that the security of women should be a priority and also awakening the



He said the protest was not like the much-publicised Mukhyamantri Majhi Ladki Bahin Yojana, which he claimed has been rolled out keeping the upcoming assembly polls in mind. It is the manifestation of anger, he said.

Thackeray wondered what the use of Ladki Bahin Yojana is when sisters in the state are not safe.

"Those who feel there is politics behind the Badlapur protest are either abnormal or protectors of the culprits," the Sena (UBT) chief said at a news conference. He also slammed the government for registering cases against the protesters.

The mother said they learnt on August 13 that such an incident had happened in the school. Their son was detained on August 17, she said.

"A woman working with

the school told me about the incident and about my son being taken to the police cnowki (on August 17). rushed there and saw police thrashing him. They also beat my younger son," said the mother.

At the police station, officials told them about the crime committed by him, she claimed.

The arrested attendant's mother said she and her husband also used to go to the Badlapur school every day to clean the premises. "We used to go to the school at 5.30 pm daily for the cleaning work and come out around 8.30 pm," she said.

The mother claimed that the accused had some medical issues in his childhood and was mentally weak. But he has taken medicines for that, she said.

"Some people came to our house on Tuesday and beat up all the family members and threw out our belongings," claimed the father of the accused.

"Our house was vandalised by the people. They did not allow us to utter a single word. They just told us not to stay in the village as he (accused) is our son," the

Survey finds bakeries using wood Mumbai: An environmen-

tal non-profit has raised concerns over the alarming use of wood as fuel in Mumbai's bakeries, warning that it poses serious health risks to citizens and batting for the adoption of cleaner methods to combat air pollution.

The Bombay Environment Action Group (BEAG) surveyed 200 bakeries across the city over six months and found that about 47 per cent of these establishments rely on wood fuel, primarily scrap



sourced from furniture stores, for their operations.

This practice releases harmful volatile organic compounds (VOCs) and particulate matter (PM2.5) into the air, which leads to asthma and other diseases. BEAG has said in a report.

PM2.5 refers to fine particles with a diameter of 2.5 micrometres or less. They can enter the lungs and even the bloodstream, making them particularly harmful to human health.

As per the study, the Byculla and Mumbai Central areas (E ward) have the highest concentration of bakeries, with 84 establishments, followed by Andheri (K West ward) with 53, and Mohammed Ali Road (B ward) with 39 bread-and-

The BEAG study also estimated that 72 of the surveyed bakeries emitted 80,381 kg of PM2.5, highlighting the severity of the

Electricity is the second most common fuel source, used by 28 per cent of the bakeries, while about 21 per cent depend on a combination of liquified petroleum gas (LPG) and electricity, the report said

The environmental NGO said the study aims to raise awareness and call for prompt action to protect the health of Mumbaikars health and the city's environment.

FSSAI orders removal of A1, A2 claims

New Delhi: Food safety regulator FSSAI on Thursday directed food businesses, including e-commerce players, to remove claims of 'A1' and 'A2' types of milk and milk products from packaging, calling such labelling misleading. The Food Safety and Standards Authority of India (FSSAI) said these claims do not conform with the Food Safety and Standards Act, 2006. In its latest order, FSSAI said it had examined the issue and found that A1 and A2 differentiation is linked to the structure of beta-casein protein in milk.

However, current FSSAl regulations do not recognize this differentiation. "FBOs are instructed to re-

move such claims from their products," the regulator said, referring to food business operators.

E-commerce platforms were also told to remove these claims from products and websites immediately. Companies have been given six months to exhaust preprinted labels, with no further extensions to be granted.

A1 and A2 milk differ in their beta-casein protein composition, which varies based on cow breed

The regulator emphasized strict compliance with this directive. Welcoming the order, Parag Milk Foods Chairman Devendra Shah said the FSSAI order is a step in the right direction. "A1 and A2 is the category developed by marketing gimmick. ... It's essential that we eliminate misleading claims that can misinform consumers," he said in a separate statement.

A1 or A2 milk product category never existed and globally also this trend is fading away, he said, and added that the FSSAI's clarification supports this broader understanding.

PhonePe launches "credit line on UPI"

Mumbai: On Thursday, the leading Fintech company PhonePe launched credit line feature on the Unified Pavments Interface (UPI) platform, nearly a year after NPCI, the National Payments Corporation of India, first introduced the same feature. Additionally, this feature gives merchants on Phone-Pe's Payment Gateway the ability to present customers with an extra payment choice during the checkout process. "This not only reduces friction but also lowers cart abandonment, resulting in increased sales," the company stated.

This facility will provide small-value, high-volume retail loans.

This progress comes after the Reserve Bank of India (RBI) made a recent move to broaden the range of UPI services. This "Credit Line on UPI" feature enables users to obtain credit from banks and utilize it through UPI applications.

Doubling MMR's GDP in five years

Mumbai: A report prepared by the NITI Aayog on the development of the Mumbai Metropolitan Region (MMR) aims to double the region's Gross Domestic Product (GDP) in the next five years, and make Mumbai and its satellite towns a global economic hub.

While there are one crore employment opportunities in the MMR at present, there is a need to create 30 lakh more opportunities, the report said.

"Adding high-speed 4G/LTE network capability on the Moon will serve as a vital bridge linking astronauts to Earth, facilitating crucial data exchange, and enabling highdefinition video communication over long distances," Russell Ralston, Axiom Space executive vice president of extravehicular activity, said in a

temis III crew members to capture real-time video and communicate with mission controllers on Earth while they explore the lunar surface. it said

AI-led demand for data centres in India to go up

New Delhi : Artificial Intelligence (AI)-led demand for data centres in India is projected to drive about 500 MW of capacity addition over next four years, according to a report released by Avendus Capital on Wednesday.

India is among the fastest-growing data centre markets globally, it has seen overall capacities doubling to about 1,011 megawatt (MW) in 2023 from about 540 MW in 2019.

Poised to grow at a compound annual growth rate (CAGR) of about 26 per cent over the next three years, the sector now has the attention of investors, from growth stage PEs to longterm pension and sovereign wealth funds, as per the

According to it, India's data centre (DC) market is undergoing massive disruption led by increased demand and use cases by AI customers

The report said that AIled data centre capacity in India has the potential to add another 500 MW over the next four years.

"With AI workloads set to surge and eventually outpace traditional cloud computing, the demand for DCs is also expected to rise sharply," the report said.

Hyperscalers in India are opting to build and own data centre tailored to their specifications, marking a major deviation from trends seen globally. This preference is bolstered by India's longterm growth potential and regulatory guidance for data sovereignty.

Prateek Jhawar, Manag-

frastructure and Real Assets Investment Banking, at Avendus Capital believes that India's data centre market will pave the way for the next wave of investments in real estate and AI unlocking tremendous stakeholder

"Developers can expect to generate 25 per cent plus IRR (Internal Rate of Return) with a build-and-sell model, highlighting the sector's potential for superior returns compared to other yielding real asset classes, Jhawar said.

This will drive overall demand for DC capacity in India, which is expected to double to 2 gigawatt (GW) by 2026, Jhawar pointed out.

Close to 94 per cent of the current installed data centre capacity is concentrated in India's top seven cities. Over the next five years, around 40 per cent of the total additional capacity is projected to be added in Mumbai. Chennai is expected to contribute about 25 per cent of the new capacity, while Delhi will account for around 15 per cent.

"We anticipate heightened transaction activity from both public and private markets. Scaled investments with a vintage of over four years are expected to seek listing opportunities, while developers will look to raise larger amounts of capital to fund this growth. The industry is maturing with the entry of long-term investors with commitments of over USD 250 million per investment."

No SC order on proceedings against Byju's

New Delhi: The Supreme Court on Thursday refused to pass an interim order to ensure that the committee of creditors (CoC) does not note any meeting in pursuance of the insolvency proceedings against embattled ed-

tech firm Byiu's. A bench comprising Chief Justice D.Y. Chandrachud and Justices J.B. Pardiwala and Manoj Misra, however, said it will accord the final hearing in the matter on August 27. The bench said the developments, which may take place in the meantime, can be negated if it finds there was no merit in the appeal of the US-

based creditor Glas Trust Company LLC against the judgment of the insolvency body -- National Company Law Appellate Tribunai (NCLAT). At the outset, senior ad-

vocate Abhishek Singhvi, appearing for Byju's, and Solicitor General Tushar Mehta, representing the Board of Control for Cricket in India (BCCI). said the CoC has been constituted in the meantime and 98 per cent stakes are with the US

Singhvi said the CoC has been set up at 7 pm on August 21 and this is quite unfair and will make the case irreversible.

Not against e-commerce firms: Goyal

Mumbai: Union Commerce wiinister Piyusn Goyai on Thursday said that India is not against e-commerce companies but wants them to be fair and honest.

In remarks that came a day after he flagged concerns about e-commerce firms, Goyal said online businesses need to ensure a "fair chance" of competing. MNCs Indian arm listing recommended

Mumbai: Multinational companies with Indian subsidiaries should consider listing their subsidiaries on the stock exchanges and improve the valuation of the parent company, said a report by ICICI Securities.

'We note that Hvundai Motors and Coca-Cola ap-

pear to be exploring such an opportunity," the report said. The report points out that it is in the interest of the parent company to look at its valuation on SoTP (sum of the parts) basis.

Looking at the parent ex-India implies a far lower valuation multiple. However, for this to make a meaningful difference, the Indian subsidiary's contribution to profit should increase beyond the current mid single digit levels. Case in point being HUL-Unilever, where Unilever's 18x 2- year forward P/E reduces to 14xex-India business given HUL stock trades at 51x P/E, the report said

Higher the P/E (price-to earning multiple, expensive is the valuation and lower the P/E, attractive or cheaper is the company. The above example indicates that the parent company is under-valued compared to its Indian subsidiary.

"Several global consumer companies (Mondelez, L'Oreal, Nivea, Reckitt Benckiser, Carlsberg) have

significant Indian operations. As per the above SoTP valuation methodology of MNC parent companies, we believe that listing of such companies in India may improve the valuation of their parent stock - or even rerate it." Although revenue and profit contribution of most Indian consumer MNCs to their parent have increased over the past couple of years, they still remain in low-tomid-single digit (barring HUL and Kansai Nerolac). ICICI Securities believes that Nestle India is likely to increase its contribution to its parent company Nestle SA given India's outperformance.

Indian consumer MNCs'

stocks have largely outperformed their parents' over 2-5-10-20 years periods and their valuation multiple has expanded over the past few years driven by (1) earnings outperformance (Colgate, HUL, Nestle, USL) and (2) expectations of volume growth acceleration (Akzo Nobel India, Kansai Nerolac), the report said.

Doctor Rape and Murder

'Extremely disturbing': SC on delay in registering death

New Delhi: The Supreme Court on Thursday termed "extremely disturbing" the Kolkata Police's delay in registering the unnatural death of the woman doctor who was raped and murdered at the RG Kar Medical College and Hospital. It also asked protesting doctors to resume work and assured them that no adverse action would be taken after they

Questioning the sequence and timing of legal formalities conducted by police, a bench comprising Chief Justice DY Chandra chud said it was very surprising that the postmortem of the deceased was

conducted on August 9 between 6.10 pm to 7.10 pm before the registration of case as unnatural death.

"How was it that the post-mortem was conducted at 6.10 pm on August 9 and vet the unnatural death information is sent to Tala police station at 11.30 pm on August 9. This is extremely disturbing," the bench, also comprising Justice J B Pardiwala and Manoi Misra, said.

It directed the Kolkata Police officer, who registered the first entry about the rape-murder that has shocked the country, to appear in the next hearing and disclose the time of the

Solicitor General Tushar Mehta, appearing for the CBI, told the top court that the most shocking fact is that the FIR was registered at 11.45 pm after the postgraduate medic was

"State police told parents it was suicide, then they said it was murder. Victim's friend suspected cover up and insisted on videography," Mehta told the bench. As the hearing com-

menced, the top court asked protesting doctors to resume work, and assured them that no adverse action will be taken against them after they rejoin.

The apex court was told

by the counsel for resident doctors at AIIMS Nagpur that they are being victimised for protesting over the Kolkata rape-murder case.

"Once they get back to duty, we will prevail upon authorities to not take adverse action. How will public health infrastructure run if the doctors do not work?" the bench asked

"If there is difficulty after that, come to us... but let them first report to work," it said The top court said its

heart goes out to all pa-

tients visiting public hospitals. It assured doctors' associations that the Na

tional Task Force will hear all stakeholders.

The brutal assault and murder of the junior doctor has sparked nationwide protests. Her body was found with severe injury marks inside the seminar hall of the staterun hospital's chest department. A civic volunteer was arrested by the Kolkata Police in connection with the case the following day on August 10.

On August 13, the Calcutta High Court ordered the transfer of the probe from the Kolkata Police to the CBI, which started its investigation on August 14.

Chandrayaan-3 data

Moon's surface once an ocean of magma

New Delhi: Data from IS-RO's Chandravaan-3 mission supports the theory that the Moon was once covered in an ocean of magma, or a 'magma ocean', an analysis, published in the journal Nature, has suggested.

The analysis pertained to measurements of the lunar soil, recorded by the Pragyan rover and taken at multiple points along a 100-metre track on the surface.

The rover was deployed by the Vikram lander, which made a soft landing near the south pole of the Moon on August 23, 2023. Chandravaan-3, consisting of the lander and rover, was launched by the Indian Space Research Organisation (ISRO), Bengaluru.

The study's authors, including those from the Physical Research Laboratory, Ahmedabad, said that previous missions, such as NASA's Apollo and the Soviet Union's Luna, have mainly relied on samples of soil taken from equitorial and mid-latitude regions of the Moon, respectively.

Analysing Pragyan's data, which came from the Moon's south pole, the researchers found that the samples suggested that the lunar soil was uniformly composed of a single rock type - ferroan anorthosite. or FAN.

The authors said that their results were similar to those from analysis of samples taken from the equatorial and mid-latitude

Further, the similar composition of samples taken



from geographically distant locations supports the lunar magma ocean hypothesis, a widely accepted scenario for Moon's early evolution, they said.

The hypothesis provides one of the possible explanations of how the Moon's crust, mantle, and core formed.

According to the hypothesis, Moon was formed as a result of collision between two protoplanets (stage preceding planet formation). While the bigger planet became the Earth, the smaller became the Moon.

As a result, the Moon became very hot, thereby, melting its entire mantle into a 'magma ocean,' the theory suggests.

It further states that as the Moon cooled while it was forming, less dense FAN floated to the surface, whereas heavier minerals sank to form the mantle, which lies underneath the crust. Therefore, the theory posits that the Moon's crust is largely made of

FAN.

However, the analysis also revealed that Pragyan detected magnesium in the lunar soil, which the researchers said could not be explained by the lunar magma ocean, or LMO,

They added that the hypothesis has been questioned by some studies based on recent re-analysis of many samples procured during Apollo's mission. "Although alternative

scenarios exist, the APXSmeasured composition, its uniformity over regional scales and the geological context support the LMO hypothesis," the authors

An Alpha Particle X-ray Spectrometer, or APXS, aboard the Pragyan rover was used to collect information about elements in the soil in the vicinity of the Chandrayaan-3 landing site, which was named the 'Shiv Shakti Point' on Au-

NGT fines Kanpur DM

New Delhi: The NGT has imposed a fine of Rs 25,000 on the district magistrate of Kanpur Nagar in Uttar Pradesh for not following the tribunal's directions to apprise it personally about a report on people getting affected by exposure to toxic metals, including chromium.

The National Green Tribunal (NGT) was hearing the matter regarding the discharge of chromium or untreated industrial effluents by tanneries and improper functioning of the common effluent treatment plant at Jajmau village in Kanpur Nagar district, besides the issue of disposal or dumping of chromium at some places across Kanpur Dehat and Kanpur Nagar districts.

In an order passed on August 14, a bench of NGT Chairperson Justice Prakash Shrivastava said the tribunal had earlier directed the DMs of Kanpur Nagar and Kanpur Dehat to file a report about the status of people



affected by exposure to the toxic metals and the health facilities provided to them.

The bench, also comprising judicial member Justice AFrun Kumar Tyagi and expert member A Senthil Vel, underscored that the tribunal's directions dated May 13, 2024, had specified that if any DM wished to file a report directly before the tribunal, the officer had to personally appear before it.

Delhi to revise 2019 Climate Action Plan

New Delhi: The rapid environmental degradation over the last few years has prompted the Delhi government to revise the 2019 Climate Action Plan and a draft policy on it will be submitted to the Centre in the next two weeks, Environment Minister Gopal Rai said on Wednesday.

"The rapid environmental degradation we have witnessed over the past few years prompted

us to initiate a review of the 2019 policy. A stakeholder group was formed and meetings were held to discuss the necessary updates," Rai said.

He emphasised the severe impact of recent extreme weather events, including unprecedented heatwaves and recordbreaking rainfall.

"The reckless exploitation of nature in the name of development has led to consequences that are now being directly felt by people," Rai said, highlighting the urgent need to address climate change. "Given the seriousness

of the matter, we have drafted a new policy which will be submitted to The previous plan fothe central government,'

The revised plan will focus on seven key areas -- energy, urban planning, water, forests, transport,

agriculture, and health,

Second food forensic unit in Himachal

Shimla: Checking adulteration in food items and detecting causes of food-borne illnesses would no longer be a tedious exercise in Himachal Pradesh as the state government has given the nod to set up a food forensic unit in the

Once established, it would be the second food forensic unit in the country after the one in Gujarat

"Quality food products are the need of the hour and the forensic unit would check the sugar content, pesticides and insecticides present. Samples of ration being distributed through public distribution system will also be tested in the long run," Director, state forensic services, Meenakshi Mahajan told PTI on Thursday.

"Once established, this would be the second food forensic unit in the country after Gujarat. The lab could be set up in the state forensic science laboratory at Junga near Shimla or at regional laboratories in Mandi or Dharamshala," she said and added that the department would also give a proposal to set up a self-sufficient unit where industrial samples



could also be tested.

Presiding over the HP Forensic Sciences Development Board meeting at Shimla on Tuesday, Chief Minister Sukhvinder Singh Sukhu had said forensic behavioral analysis unit, food forensic units and other new units would be established in the department for effective functioning.

Forensic chemistry employs chemical methodologies to assist investigative organisations and law enforcement while food forensics is an academic discipline that examines explicitly and investigates any unlawful activities associated with food items or their use within a particu-

"There have been cases

where people have died due to food poisoning and two infants were killed in Mandi few months back after consuming baby feed. A family of lawyers died due to food poisoning in Dharamshala and another instance was death of two girl students of a government college after taking food in Kangra dis-

Paris Agreement on climate change at stake

New Delhi: The Paris Agreement is at risk if countries fail to deliver a meaningful new climate finance goal to help developing nations combat and adapt to climate change, the spokesperson for the Like-Minded Developing Countries (LMDC) has warned.

LMDC is a bloc of around 25 developing nations that advocates for shared positions in international climate negotiations. This group includes India, China, Pakistan, Argentina, Iran, and Egypt, and

represents more than 50 per cent of the world's population.

In a virtual interview with PTI, Diego Pacheco, the spokesperson for LMDC and the lead negotiator for Bolivia, said developed countries are attempting to dilute their responsibility to provide climate finance by creating a complex New Collective Quantified Goal (NCQG) framework with multiple

lavers. NCQG refers to the new, larger amount that developed nations must mobilize each year, starting in 2025, to support climate action in developing countries.

Countries are expected to finalize NCQG at this year's UN climate conference COP29 in Azerbaijan's Baku in

Pacheco said developing countries are implementing their national climate plans to achieve Paris Agreement goals or nationally determined contributions (NDCs) without "any support at all" from developed countries that have historically benefited from industrialization and contributed the most to greenhouse gas emissions.

"Developing countries cannot move forward with more commitments without the necessary financial support. After 10 years since the approval of the Paris Agreement, it is time to discuss the key issue for the implementation of the pact.

"If we cannot succeed in achieving a meaningful NCQG, all the agreements made in Paris are at stake," he told PTI.

The LMDC spokesperson added the Global South has been calling for greater cooperation to tackle the climate crisis

French destroyer rescues 29 mariners



Dubai: A French destroyer rescued 29 mariners from an oil tanker that came under repeated attack in the Red Sea, officials said Thursday, while also destroying a bomb-carrying drone boat in the area.

Yemen's Houthi rebels are suspected to have carried out the assault on the Sounion. The attack, the most serious in the Red Sea in weeks, comes during a monthslong campaign by Houthis targeting ships over the Israel-Hamas war in the Gaza Strip that has disrupted a trade route through which \$1 trillion in cargo typically passes each

The Sounion is now at anchor in the Red Sea and no longer drifting, the European Union's Operation Aspides said. However, it wasn't clear if the vessel was still ablaze. The vessel had been staffed by a crew of Filipinos and Russians. Military officials did not name the French destroyer involved in the rescue.

In the attack Wednesday, men on small boats first opened fire with small arms about 140 km (90 miles) west of the rebel-held Yemeni port city of Hodeida, the British military's United Kingdom Maritime Trade Operations centre said. Four projectiles also hit the ship, it added. It wasn't immediately clear if that meant drones or missiles.

The Houthis did not immediately claim responsibility for the attacks, though it can take them hours or even days before they acknowledge their assaults. However, they did acknowledge US airstrikes in Hodeida that the American military's Central Command said destroyed a Houthi surface-to-air missile and radar system.

The Houthis have targeted more than 80 vessels with missiles and drones since the war in Gaza started in October. They seized one vessel and sank two in the campaign that also killed four sailors.Other missiles and drones have either been intercepted by a US-led coalition in the Red Sea or failed to reach their targets

The rebels maintain that they target ships linked to Israel, the United States or the UK to force an end to Israel's war against Hamas in Gaza. However, many of the ships attacked have little or no connection to the conflict, including some

Imran's party postpones power show

By Sajjad Hussain Islamabad: The Pakistan Tehreek-e-Insaf party on Thursday postponed its planned rally in the capital here until next month on the direction of its founder and jailed former premier Imran Khan after the government refused to permit the demonstration.

Party leader Azam Swati said while talking to the media outside the Adiala Jail Rawalpindi where he along with party leader Gohar Khan met Khan.

"The rally has been rescheduled and now will be held on September 8 as directed by Imran Khan," Swati made the announcement, adding that the government also agreed to the new date.

He also quoted Khan as saying that the party workers, who were already out on the road to reach the venue, should go back.

The announcement comes as the capital city was tense due to the threat by the Pakistan Tehreek-e-Insaf party (PTI) leaders to go ahead with its plan to hold the rally in Islamabad despite the government's refusal to give permission.

The government closed all schools in Islamabad and also blocked all main entries to the city by placing shipping containers on roads to stop the movement of the PTI workers. There were reports of traffic jams and long queues of vehicles on the inter-city roads which were still open.

PTI had sought to hold a power show after months of political wrangling over the cases against its party chief Khan and other leaders.

UN team to arrive on fact-finding mission

Dhaka: A team of UN experts is set to arrive in Dhaka on Thursday to set a framework for the fact-finding mission that will investigate the killings of at least 650 protesters ahead of and in the aftermath of Sheikh Hasina's resignation as the prime minister earlier this month.

"This is the primary UN team of experts before the UN fact-finding mission comes and investigates (the atrocities). We are expecting to sign an agreement of framework for the probe," The Daily Star newspaper quoted a UN official based in Dhaka as saying on Wednesday.

The UN team is expected to discuss detailed terms and conditions for investigating all the human rights violations that took place between July 1 and August 15, the official said.

The delegation will stay here for at least a week and meet the civil society groups, victims of human rights violations, students and government officials and any other actors concerned, the official added.

Foreign ministry officials also confirmed the arrival of the three-member UN team.

Bangladesh descended into chaos after Hasina's government collapsed and she fled to India on August 5 amid violent protests over quota reforms for government jobs, while the Army stepped in to fill the power vacuum on August 5. Before that, the anti-government protests had killed more iournalists covering the

than 500 people since mid-July. Nobel laureate Muhammad Yunus took oath as the Chief Adviser of the interim government on August 8.

According to a primary report of the UN Office of the High Commissioner for Human Rights published on August 16, between July 16 and August 11, as many as 650 people were killed in Bangladesh during the student-led protests and after the fall of the Awami League regime. Of these, nearly 400 deaths were reported from July 16 to August 4, while around 250 people were reportedly killed following the ouster of the Awami League-led government on August 5

and 6. The reported death toll is likely an underestimation, as information collection has been hindered by restrictions on movement due to the curfew and the internet shutdown, the OHCHR said. The UN human rights body further says that the number of reported killings in revenge attacks since August 5 remains to be determined. Those killed include protesters, bystanders,

events and several members of the security forces.

Thousands of protesters and bystanders have been injured, with hospitals overwhelmed by the influx of patients. The majority of deaths and injuries have been attributed to the security forces and the student wing affiliated with the Awami League.

This will be the first time the UN is sending a factfinding mission to Bangladesh since its independence in 1971 to investigate widespread human rights abuses in the country, the Chief Adviser of the Government of Bangladesh said in a post on X last week, the handle for which is run by Yunus' office.UN human rights chief Volker Turk last week assured his support and said an inclusive, human rights-centred approach will ensure the transition in Bangladesh succeeds. Turk had underlined the need for accountability for all those responsible for human rights violations and violence, including against religious minorities, in Bangladesh.



Houston: A 90-foot-tall bronze murti of Lord Hanuman, unveiled near here, symbolising "a new milestone in the cultural and spiritual landscape of America," has become the latest landmark in Texas visible from miles away, and the third tallest sculpture in the

feet), organisers said. The 'Statue of Union' Hanuman murti, which was unveiled at the Sri Ashtalakshmi Temple in Sugar Land, about 35-odd km from here. during a grand Prana Prathishta Mahotsavam ceremony from August 15 to 18, symbolises "selflessness, devotion, and unity," the organisers said, adding, the murti is named so to "honour Hanuman's pivotal role in reuniting Lord Ram and Sita."

"This awe-inspiring structure is the result of the visionary efforts of His Holiness Sri Chinna Jeeyar Swamiji, a Padma Bhushan awardee, and a renowned Vedic scholar, who envisioned the project as a spiritual epicentre for North America." the organiser said in a

The festivities commenced on August 15, coinciding with India's Independence Day and the core of the celebrations unfolded on August 18, with the grand Pran Prathistha ceremony. "The rituals, led by Sri Chinna Jeeyar Swamiji and overseen by a multitude of Vedic priests and scholars, were a powerful display of devotion and spirituality." The ceremony featured a

helicopter showering flowers upon the murti, sprinkling of sacred water, and placing of a 72-foot-long garland around statue's neck.

The Malaise of Mollywood

he recent publication of the Justice Hema Committee report has laid bare the disturbing underbelly of the Malayalam film industry, revealing a culture rife with exploitation, discrimination, and abuse.

What emerges from the report is not just a picture of individual misconduct but a systemic failure. The Malayalam film industry, long celebrated for its artistic excellence, now stands accused of perpetuating a culture of misogyny and abuse.

The 235-page report, which languished in bureaucratic limbo for five years before its release, paints a grim picture of an industry dominated by a few powerful men—producers, directors, and actors—who operate with impunity, treating female colleagues as commodities in a system that resembles a feudal fiefdom more than a modern workplace. It exposes a litany of horrors that have long been whispered about but rarely confronted. Sexual exploitation is rampant. Women entering the industry are subjected to demands for sexual favours in exchange for roles, often from well-known figures who wield significant influence. The report notes chilling accounts of actresses being coerced, harassed, and even assaulted, with some incidents occurring just before these women were expected to perform alongside their abusers on set.

The power dynamics at play are stark and unforgiving. The industry's 'mafia', as one actor described it, exerts control through an informal but effective system of bans, and operates through a law of 'omerta' (silence).

The Women in Cinema Collective (WCC), which played a crucial role in bringing these issues to light, has itself been targeted by these shadowy forces, with members facing professional blacklisting for daring to challenge the status quo. Beyond sexual predation, the report also highlights a myriad of other abuses like unsafe working conditions and inadequate facilities on sets for women.

The junior artists, who are the most vulnerable in this ecosystem, are often treated worse than slaves, subjected to gruelling hours and denied basic rights. The absence of legal protections compounds these problems. The Malayalam film industry operates in a legal vacuum where contracts are frequently informal, leaving actors and technicians at the mercy of unscrupulous producers and directors. The Kerala government, too, must shoulder its share of the blame. That the report remained unpublished for five years is a damning indictment of its commitment to addressing these issues. The authorities must now act decisively, ensuring that the perpetrators are held accountable and that comprehensive reforms are implemented to protect those working in the industry.

As for the future of Malayalam cinema, it is at a crossroads. The industry can either continue to be defined by the toxic practices detailed in the Hema Committee report or it can seize this moment to cleanse itself. Only then can it hope to reclaim its reputation and truly be a beacon of cinematic excellence.

In the Shadow of War

he weight of a complex history accompanies Prime Minister Narendra Modi during his first visit to Ukraine – the first Indian PM to visit the war-torn country in 30 years.

With Ukraine embroiled in a protracted and brutal conflict with Vladimir Putin's Russia since February 2022, Modi's visit signals a nuanced shift in India's foreign policy, a diplomatic quadrille shaped by both ancient alliances and modern geopolitical realities.

It certainly is a performance of balance, reflecting India's intricate and, at times, contradictory stance on the Russo-Ukrainian war. (His meeting with Ukrainian President Volodymyr Zelenskyy comes barely a month after he met with Putin in Moscow.) Modi's visit comes at a time when the world is increasingly polarized between pro-Ukrainian and pro-Russian factions.

The Russo-Ukrainian war has complicated India's historical friendship with Russia. Modi's visit to Ukraine is reflective of India's broader strategy of multi-alignment, where it seeks to engage with all major powers without becoming entangled in their conflicts.



British Prime Minister Winston Churchill had famously described Russia as "a riddle wrapped in a mystery inside an enigma" during a radio broadcast on October 1, 1939, shortly after the outbreak of World War II. Churchill's now iconic and oft-quoted observation was a recognition of the complex, often opaque nature of Russian foreign policy and a cautionary note about the challenges of predicting Russia's moves on the international stage.

While this statement encapsulates the West's frustration and bewilderment in dealing with the Soviet Union and Russia during the Cold War and post-Cold War era, India has had less reason to regard Russia as a riddle or an enigma.India's historical ties with Russia are deep and enduring, dating back to the Cold War era when Moscow was one of New Delhi's most reliable allies. Yet, the ongoing conflict in Ukraine presents India with a diplomatic conundrum: how to maintain its strategic partnership with Russia without alienating the West or appearing indifferent to the sovereignty of a Ukraine under siege.

Officially, Modi's visit framed as an effort to discuss humanitarian aid and reconstruction efforts in Ukraine, but the subtext is far more complex. India has abstained from UN resolutions condemning Russia's actions, a stance that has been

criticized by Western powers as tacit support for Moscow. Yet, Modi's presence in Kyiv suggests an attempt to recalibrate this perception, to position India as a neutral powerbroker rather than a passive observer. To understand India's cautious diplomacy, one must delve into the historical context that has shaped its relationship with Russia. During the Cold War. non-aligned India found itself at odds with both the United States and China. It was the Soviet Union that provided military and economic support to India, a lifeline during moments of crisis such as the 1971 Bangladesh Liberation War, where Moscow's backing was crucial in countering American and Chinese pressure.

This legacy of support forged a bond that has persisted long after the dissolution of the Soviet Union. Even today, Russia remains a key supplier of defense equipment to India, accounting for a significant portion of India's military arsenal. And yet, the situation in Ukraine presents both risks and opportunities for India to diversify its defence partnerships.

One area ripe for collaboration is aerospace technology. Ukraine has expertise in missile technology, particularly in areas like radar systems, anti-tank guided missiles, and aircraft engines. India, with its ambitious defence modernization plans, could benefit from accessing this technology, especially as it seeks to reduce its reliance on Russian arms. There are already precedents for this: Ukraine has supplied India with gas turbine engines for its naval vessels and has been involved in the overhaul of India's fleet of An-32 transport aircraft.

Another potential area of cooperation lies in the realm of unmanned aerial vehicles (UAVs) and drones. Ukraine has made significant strides in drone technology, which has proven critical in its current conflict. India, which has been rapidly expanding its drone capabilities, could look to Ukraine for advanced UAV systems that are battle-tested and could be integrated into its military arsenal. The possible joint development and production of military equipment also offer a promising avenue. India's emphasis on 'Atmanirbhar Bharat' (self-reliant India) in defence aligns with Ukraine's need to bolster its defence production capabilities in the face of ongoing conflict. By engaging with Kyiv, India is signalling that it is not indifferent to the plight of Ukraine, even as it refrains from outrightly condemning Russia. It is a diplomatic tightrope walk, reflecting India's broader strategy of multi-alignment, where it seeks to engage with all major powers without becoming entangled in their conflicts.

How did I unmask Puja Khedkar

he Indian Administrative Service (IAS) is widely regarded as the backbone of India's administrative machinery, a bastion of neutrality, integrity, and dedication to public service. Yet, the recent controversy surrounding 32-year-old Puja Khedkar has cast a long shadow over this esteemed institution, shaking its very foundations. Khedkar, an alleged IAS officer, became the center of a storm when her extravagant lifestyle, including the ownership of a luxury Audi car, sparked an investigation that unravelled a web of deceit.

My involvement in exposing Khedkar's fraud was born out of a simple curiosity. A photo of her car, complete with a beacon—a symbol of authority—surfaced on social media. As someone deeply invested in transparency and good governance, I found myself questioning whether such a lifestyle was consistent with the modesty expected of

public servants. What began as a casual inquiry soon morphed into a full-fledged investigation.

A few keystrokes on Google revealed a treasure trove of information about Khedkar, including details of her caste certificate and disability claims. This information, readily available on UPSC websites, painted a picture that did not quite fit the narrative expected of a public servant. Further scrutiny raised uncomfortable questions about her personal integrity and the broader ethical standards that should guide public officials in India. The IAS, known for its role in implementing government policies and ensuring social justice, operates on principles of neutrality and integrity. However, political interference and corruption can erode its effectiveness, making it all the more crucial to preserve its integrity.

The revelations surrounding Khedkar, fuelled by the leak of UPSC files, have highlighted the need for greater scrutiny within the

Khedkar's opulent lifestyle, particularly her ownership of an Audi that was actually owned by a private limited company (Thermoverita) ignited outrage on social media. The ostentatious display of wealth raised immediate doubts about the source of her riches and whether her conduct aligned with the standards expected of an IAS officer.

As more sensitive information, such as her caste and disability certificates, came to light, suspicions of systemic manipulation began to mount. I began to put out these revelations on social media platforms like 'X' thereby playing a small part in ensuring the pressure was on the administration to probe Khedkar.

One of the most damning pieces of evidence was her father's recent election affidavit, revealing assets worth Rs. 40 crores. This staggering wealth starkly contradicted her eligibility for non-creamy layer benefits, a key factor in her selection for the IAS. Despite her claims of mental illness and multiple disabilities, Khedkar repeatedly evaded medical examinations—a fact that only deepened the suspicion of foul play.

The family's significant assets, including 110 acres of agricultural land, shops, flats, gold, and multiple vehicles, not only violate regulatory frameworks but also cast serious doubt on the authenticity of her non-creamy layer certificate. Khedkar herself owns property valued at Rs. 17 crores, further complicating the narrative of her purported financial and social status.

This case underscores systemic issues within the IAS and broader public services. It highlights the urgent need for stricter scrutiny of public officials' wealth and lifestyle to prevent abuses of power. It calls for greater transparency in the verification of caste and disability certificates, ensuring that benefits are reserved for those who genuinely need them.

Interestingly, Manohar now wants to 'retire' claiming he is uncomfortable with the state of politics today, pointing out his minister is preoccupied with maintaining his reputation and image and neglecting his constituency. Additionally, he points out that his boss seems unaware of his actual superiors! The 33-year-old farmer began his career with the Akhil Bharatiya Vidyarthi Parishad, the party's youth wing, and was responsible for expanding the party's footprint in the interiors of Sindhudurg district. When his requests to accommodate himself and the people he had cultivated over the years in the party's local elections were ignored, Ritesh decided it was time to move on.

In Ajit Pawar's Nationalist Congress Party, 65-year-old Ramanand Parab (name changed) regrets his decision to leave senior Pawar for junior Pawar. He is now looking to hang up his boots. The merger of the trinity—the BJP, NCP, and Shiv Sena has left a considerable trail of destruction at the grassroots level. While their leaders have smoothly defected to the other side and joined hands for power, many foot soldiers of these parties are struggling to make the transition.


Long-term grassroots workers are retiring, while younger ones prefer freelancing over committing to a single political party. Many workers have been vocal about not being reimbursed for recent Lok Sabha election work. Additionally, sharing office space with workers from the newly created factions of Shiv Sena and NCP has led to clashes. Faced

with these challenges, senior leaders and political parties are now turning to social media platforms and job sites, including LinkedIn, to find candidates or outsource campaign work. Political success in India depends on its ability to win elections, with grassroots workers playing a crucial role in this process. Running a political party requires dedication, support, and skills of people from diverse backgrounds. While not everyone is destined to be a leader, each has a role in advancing their party's leadership.

Party workers play an important role in laying the foundation for the party's growth and leadership. These men and women are instrumental in running the show, yet they remain in the background, often invisible or made to feel unimportant. Despite doing their jobs effortlessly, many are kept away from positions within the hierarchy of the party. Dedicated foot soldiers leave no stone unturned to see their masters excel and achieve great heights. Ironically, these same foot soldiers can be the downfall of their masters as well

As political alliances shift and grassroots workers grapple with uncertainty, the real question remains: Can the foundations of a party, built by the very individuals now disillusioned, withstand the upheaval, and redefine their role in the new political landscape?

Is is a unique name that resonates far beyond the cricketing world, even inspiring Bollywood blockbusters. The man behind this legendary name had a distinctive appearance, sporting curly locks, a unique batting style, exceptional footwork, and wristy strokes. Additionally, he was a classy left-hander, the epitome of grace and elegance, with a huge amount of runs to his credit—an enviable average of close to 45 runs per inning.

He distinguished himself in a team brimming with world-class legendary talent, standing shoulder-to-shoulder with formidable batsmen like Sir Vivian Richards, Sir Gordon Greenidge, Sir Clive Lloyd, Desmond Haynes, and a huge battery of world-class pace bowlers.

Alvin Kalicharan has his name etched in the annals of cricketing history. A legend in his own right, he faced the unfortunate consequence of losing several of his prime cricketing years due to his decision to play in South Africa during the height of apartheid—a time when such actions were fraught with political and moral implications.

By choosing to play in South Africa, Kalicharan went against the prevailing norms and expectations. He not only defied the directives of



his cricket board but also challenged the stance of his country on the issue. This bold decision led to severe repercussions, resulting in a lifetime ban from international cricket. This ban forced Kalicharan to forge a new path for himself.

I had the pleasure of meeting this cricketing superstar at a book inauguration organised by the Cricket Club of India. My introduction to him was made by another Indian left-handed hero, Karsan Ghavri. He is not only like an elder brother to me but also a great friend of Alvin Kallicharan. He was grace personified, as was his batting, and his simplicity and humbleness impressed

The three of us spent almost an hour chatting and exchanging notes. As a fan of his batting, it was an occasion to remember, for sure! His energy was infectious: and his arms were moving like those of a boxer in training. I wondered how, at his age, he could still be so full of life and energy, and what his fitness level and footwork must have been like when he was a young cricketer taking on the world's best bowlers. He still seemed good enough to give the new-age bowlers a hell of a time.

His behaviour reminded me of another gentleman, the Indian batting star Gundappa Vishwanath, one of the best batsmen India ever produced. Both legends were similarly built, small in stature, but with big exploits on the cricketing field. Getting their prized wickets would be a dream for any bowler at that time. Both are true gentlemen.

No wonder they called Cricket a gentlemen's game then.

At 75 years not out, Alvin Kallicharan who resides in the United States with his wife, continues to impart his cricketing knowledge to scores of youngsters, and we hope he will score yet another well-deserved century."

I wish him luck, love, and a long and healthy life!!!

What is the link between Kolhapur and Poland?



Prime Minister Narendra Modi's historic two-day visit to the Central European country of Poland marked the first visit by an Indian PM to the nation in 45 years. In the Polish capital of Warsaw, Modi paid tribute to the Jam Saheb, the 'Good Maharajah' of Gujarat, and honoured the memory of Indian soldiers who fought in the 1944 Battle of Monte Cassino. He also paid homage to the Kolhapur Memorial.

Historical background

Poland was dismembered as part of the 1939 infamous pact signed between Adolf Hitler's Nazi Germany and Joseph Stalin's Soviet Union. The result of this pact or 'the Devil's Alliance' (as stated by historian Roger Moorhouse), saw the cream of Poland's officer corps, which included several members of the country's intelligentsia, being massacred by the dreaded Soviet NKVD in the Katyn Forest in 1940.

The refugees, who were deported and lodged in Stalin's camps and fi-



nally made it to India, were the fortunate ones to flee Europe's bloodlands after Hitler invaded the Soviet Union in June 1941.

With Poland thus trapped between the two dictatorship and the Second World War in full swing, a stream of refugees made their way to Valivade village in Kolhapur district, 235 km from Pune.

Here, they tasted freedom after having endured the living hell of Soviet camps following their deportation by the dreaded NKVD or the Soviet secret police.

They made their harrowing jour-

ney through Kazakhstan and Turkmenistan from the Soviet camps in Siberia and the Urals before reaching India.

They first reached Jamnagar in Gujarat, where the ruler, Jam Saheb Digvijayasinhji Jadeja, in a noble gesture, took the refugees under his wing. From there, some of the migrants proceeded to Kolhapur, where the noble Chhatrapati Rajaram III opened his doors to the Polish migrants.

The camp established at Valivade, Kolhapur, provided shelter to Polish people during the war. This settlement housed approximately 5,000 Polish refugees, including women and children.

The Good Maharaja Square and the memorial dedicated to the royal family Kolhapur in Warsaw are testimony to these humanitarian actions.

In September 2019, a commemorative pillar in memory of these Polish families and individuals who lived in Valivade between 1942 and 1948 was unveiled at Kolhapur as well.

Zaheer likely to leave Mumbai

"Apart from the role of mentor,


heer a wider profile that will mean involvement with the scouting and player-development programmes during the off season."

LSG are also without Morne Morkel, who was LSG's bowling coach. The former South Africa pacer has joined Gambhir's support staff in the India men's team in the same role.

Zaheer, who had retired from all forms of cricket after the 2017 season, is also in the list for two other franchises, who too are keen on bringing him on board ahead of the IPL mega auction, for which the retention rules will be announced by early September.

New Delhi: Ravichandran Ashwin doesn't like "latching on to people" and that's one reason why he has never warmed up to the idea of banking on coaches in the traditional sense as he believes that such dependence makes players dogmatic.
