'How there was no blood if she fell from 14th floor?'

DISHA SALIAN'S FATHER'S ALLEGATIONS AGAINST **AADITYA THACKERAY HITS UP POLITICS**

Mumbai: Satish Salian, the father of a celebrity manager Disha Salian, has raised several questions regarding her suspicious death in his petition to the Bombay

"Overall, looking at the entire investigation, I think it is murder," Salian told Republic TV. "Because a person's body falls from the 14th floor, but still there is not a single injury visible on that person's body. There is no injury anywhere on the head, so how can this happen? We need to think about this. Even if a body falls from the 14th floor, how can that body remain

Salian produced photographs and videos of Disha's dead body for the first time since her death on June 8, 2020. Her head and face are seen clean without any injury

mark. In their investigation, the Mumbai Police had concluded that she had jumped from her 14th floor apartment in Malad

Salian said, "There was no pressure on me from anyone. However, I was convinced that way. Also, I had faith that Disha's friends who were present at the party on that night would never lie about what happened. Also, the police had told us at that time that it was a suicide. We had trusted the police then."

He said then Mumbai Mayor Kishori Pednekar had come to his house and convinced him that Disha had ended her life.

Salian's lawyer Nilesh Oiha said from the first days of the incident, Satish Salian had the same question that not a single drop of blood was seen after falling from the 14th floor. Also, not a single drop of blood was found

on the clothes. "The most important thing is that when Disha Salian's body was handed over to her family, there was no injury on her body. Then how come there was no injury after falling from the floor of the building? This is the question," said Ojha.

Ojha, told ANI, "During the murder. Uddhav Thackeray's government was there (in Maharashtra), and the accused was his son Aaditya Thackeray. The corrupt police officials tried to cover up the case. After 2.5 years, Shinde's government came, and Fadnavis was the Home Minister. This matter has not come all of a sudden."

He further added, "On 12th January 2024, a written complaint was filed accusing Aaditya

Thackeray, Sooraj Pancholi and others of gang rape. FIR was not registered for more than one year. The affidavit filed by Aaditya Thackeray stated lies that he was given a clean chit by the CBI in the case. There is also proof that Anil Deshmukh didn't want

to file the peti-

tion. "Nothing happened, but the conversations around it made Disha Salian's father realise that he had been lied to, and he came to us. After that, his petition was drafted and filed," he said.

Demanding that the police officials who failed to register an FIR be penalised, Ojha said that action must also be taken against the SIT official as per the Supreme Court's guidelines on rape and murder cases. Otherwise, the concerned police officials must be penalised as per the relevant sections of IPC. In this case, they have failed to register a case in over a year. This is a serious matter, and action must be taken against the SIT official, he

Reacting to Salian's plea, Kishori Pednekar called it a conspiracy. "Someone is behind it, and there is a conspiracy. How come this matter has come under the spotlight after more than four years? The CID conducted an enquiry, there is already an SIT (formed to probe the matter)," Pednekar told PTI.

Markets climb for fourth day

Mumbai: Rallying for the fourth straight session, stock market benchmarks Sensex and Nifty surged over 1 per cent on Thursday, powered by acrossthe-board buying amid a mixed trend in global equities after the US Federal Reserve maintained its rate cut projections for this year.

Hectic buying in market heavyweights Reliance Industries, Bharti Airtel and IT stocks bolstered investor sentiment, traders said.

The 30-share BSE benchmark Sensex jumped 899.01 points or 1.19 per cent to settle at 76,348.06, regaining the 76,000 level. During the day, it soared 1,007.2 points or 1.33 per cent to 76,456.25.

As many as 2,410 stocks advanced while 1,606 declined and 129 remained unchanged on the BSE.

The NSE Nifty surged 283.05 points or 1.24 per cent to reclaim the 23,000mark to finish at 23,190.65.

"Nifty surged by 283 points, marking gains for the fourth consecutive day as all sectors closed in the green. Optimism was driven by signals of two Fed rate cuts in 2025 and hopes of a halt in FII selling," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

Bharti Airtel was the biggest gainer in the Sensex pack, rising 4.17 per cent, followed by Titan, Tata Consultancy Services, Hindustan Unilever, Infosys, Nestle, Reliance Industries, Mahindra & Mahindra, HDFC Bank and Tata Motors.

In contrast, IndusInd Bank, Bajaj Finance and UltraTech Cement were the laggards.

Meanwhile, the Federal Reserve said the US economy still looks healthy enough to keep interest rates unchanged. The US central bank pointed out that it is expecting to cut rates twice this year even as inflation stays elevated.

"On Wednesday, the Federal Reserve announced its decision to keep the policy rate in the 4.25-4.50 per cent range. Policymakers anticipate two rate cuts in 2025, with economic growth projected at 1.7 per cent and inflation at 2.7 per cent for the year.

"Overall, this decision has mixed implications for currency movements, capital flows and market sentiment in India. Higher US interest rates could lead to foreign capital outflows from Indian markets, whereas lower rates may attract investment," Ravi Singh, SVP - Retail Research, Religare Broking Ltd, said.

The BSE smallcap gauge climbed 0.73 per cent, and the midcap index rose 0.61 per cent.

Four Dead in Pune Bus Disgruntled bus driver

started fire: Police

minibus owned by a private firm that claimed the lives of four employees near Pune was allegedly an act of sabotage by a disgruntled driver, police said

on Thursday. "Investigation revealed that the fire was not an accident but sabotage," said deputy commissioner of police Vishal Gaikwad of Pimpri Chinchwad Police at a press conference here.

Janardan Hambardekar, the accused driver, was angry after his salary was cut recently, he said.

The incident took place in Hinjawadi area near Pune city on Wednesday morning as the bus, owned by Vyoma Graphics and carrying 14 of its employees to the workplace, caught fire.

"The accused had procured benzene (an inflammable chemical). He had also kept a cloth used to wipe toners in the bus. On Thursday, as the bus neared Hinjawadi, he lit a fire," said the DCP.

In the resultant fire, he himself also suffered injuries though he got down from the bus along with a few others after the fire started.

Hambardekar was undergoing treatment at hospital and will be arrested later, the police official

Ten passengers sustained burn injuries of which two were seriously injured.

Four of the employees -- Shankar Shinde (63), Raian Chavan (42), Gurudas Lokare (45) and Subhash Bhosale (44) -- died as they were sitting in the rear and could not open the emergency exit door in time.

Further probe was on, the DCP said.

Body of Pune man found in Andamans

Port Blair: The body of a middle-aged man was found near Radhanagar beach at Swaraj Dweep

Pune: The deadly fire in a match and set the cloth on (Havelock Island) in Andaman and Nicobar Islands on Thursday, police said.

> According to police, the man was identified as Avneesh Hegde (40), a resident of Kalyani Nagar in Maharashtra's Pune.

Sources said the body was first seen by local people at 11.40 am at Neil's Cove (near Radhanagar beach), who alerted Swaraj Dweep police station.

"A police team, accompanied by an executive magistrate, soon reached the spot. Upon searching the deceased's belongings, a PAN card and an HDFC Bank ATM card were found. Using these, we identified the man and found his address," a senior officer said.

"The family of the deceased has been informed. No injury marks were found on the body," he said.

30 Naxalites, one cop killed

Bijapur/Kanker: In a fresh offensive against Naxals, security forces killed at least 30 members of the banned CPI (Maoists) in two separate encounters in Chhattisgarh's Bastar region on Thursday, officials said.

While 26 Naxalites were killed in Bijapur district, four Maoists were gunned down in Kanker by a joint team of the BSF and District Reserve Guard (DRG) personnel of the state police.

A police jawan was also killed in the encounter in Bijapur, the officials said. Union Home Minister

Amit Shah said the secu-

rity forces have achieved another big success in their march to make the country Naxal-free with the two encounters.

'The Modi government is moving forward with a ruthless approach against Naxalites and is adopting a zero tolerance policy against those Naxalites who are not surrendering despite all the facilities being offered to them, ranging from surrender to inclusion. The country is going to be Naxal-free by March 31 next year," Shah wrote on X in Hindi.

An official said a gunfight broke out around 7 am in a forest along the border of Bijapur and Dantewada districts when a joint team of security personnel was out an anti-Naxalite operation in Gangaloor police station area

in Bijapur. The bodies of 26 Naxalites besides firearms and explosives were recovered from the spot, Inspector General of Police, Bastar Range Sundarraj P told PTI.

A jawan of the DRG unit was also killed in the gunfight, he said.

Another encounter took place in the morning in a forest along the border of Kanker and Narayanpur districts when a joint team

of the DRG and Border Security Force (BSF) was out on an anti-Naxal operation, Kanker Superintendent of Police Indira Kalyan Elesela said.

The bodies of four Naxalites and automatic weapons were recovered following the action.

Search operations were underway at both the encounter sites, police said.

With the latest action, 113 Naxalites have been killed in encounters in the state so far this year. Of them, 97 were eliminated in the Bastar division comprising seven districts including Bijapur and mad al-Sharaa and others during a visit to Damascus, her second since the fall of former President Bashar Assad in December. Among the European Union's 27 members, Italy

reopened its embassy last year before the fall of Assad, and Spain reopened its embassy after his ouster.

"With this embassy opening, we are saying very clearly that Germany is back in Damascus, Germany has a paramount interest in a stable Syria," Baerbock said. For time being the embassy will have a very small team, supported by colleagues based in neighbouring Lebanon, and offer no consular or visa services.

India's 118th rank below Pakistan, Ukraine, Palestine

London: India ranked 118th in the World Happiness Report 2025 published Thursday, up from the 126th position in the previous year but below countries such as Nepal, Pakistan, Ukraine and Palestine

The report, released coinciding with the International Day of Happiness that falls on March 20 each year, focuses on the impact of caring and sharing on people's happiness, including how sharing a meal increases happiness

Finland is ranked as the happiest country in the world for the eighth consecutive year and other Nordic countries - Denmark, Iceland and Sweden - continued to remain in the top four, in that order.

The annual report, published by the Wellbeing Research Centre at the University of Oxford in partnership with Gallup, the United Nations Sustainable Development Solutions Network ranks the countries according to the self-assessed life evaluations by those

DENMARK AT THE TOP PLACE, AFGHANISTAN AT LAST polled averaged over the years 2022-2024.

Country rankings for the three benevolent acts covered by the Gallup World Poll-donating, volunteering, and helping strangers vary depending on cultural and institutional differences, the authors of the report said.

While India ranked 118th overall, in terms of the 'Country rankings for six measures of benevolence', it was listed much higher at 57 for (how people) donated; at 10 for how people volunteered; 74 for helping a stranger, and in case of wallet returned by a neighbour (115), stranger (86) and police (93).

In India's neighbourhood, Afghanistan is again ranked as the unhappiest country in the world, this year 147th against last year's 143rd rank (last). While Nepal with 92nd rank (93 in 2024) and Pakistan, with 109th rank (108 in 2024) remained much ahead of India, Sri



Lanka, with 133rd rank (128 in 2024) and Bangladesh 134th position (129 in 2024) lagged

China was ranked in 68th position this year, down from the 60th last year. State of Palestine is ranked 108th (103 in 2024) while Ukraine is at 111 rank (105 in 2024).

According to the World Happiness Report website, the annual report and much of the growing interest in happiness research "exists thanks to Bhutan," which had sponsored a resolution for considering happiness for a holistic approach to development.

Bhutan's resolution was adopted by the UN General Assembly on July 19, 2011 and the first World Happiness Report was brought out in 2012. After the UN General Assembly adopted and declared March 20 as the International Day of Happiness, the World Happiness Re-

Fahim Khan, six others booked for sedition

Nagpur: The cyber police have booked local leader Fahim Khan, a key accused in the Nagpur violence, and five others on charges of sedition and spreading misinformation on social media during the unrest here, officials said on Thursday.

These six persons are among 50 accused against whom the cyber department has registered four First Information Reports (FIRs) in connection with the violence here on Monday, they said.

The cybercrime department has also asked for information from Facebook. X, Instagram and YouTube authorities about 230 profiles on their platforms and sought for them to be blocked, DCP Cyber Crime Lohit Matani said at a press briefing.

As soon as the department gets the information, the accused will be identified and arrested, he said.

The official said their probe has indicated that misinformation was spread initially after some videos were shared on social media, which fuelled violence further and then more vid-"glorified the violence"

Six persons, including Minority Democratic Party (MDP) city head Fahim Khan, have been booked for sedition in the cyber police's FIRs, Matani said.

Rumours about a 'chadar' with holy inscriptions being burnt during protests led by the Vishwa Hindu Parishad (VHP) seeking the removal of Mughal emperor Aurangzeb's tomb, located in Chhatrapati Sambhajinagar district, was the prima facie trigger for vio-

Probe harassment of woman cop:

The state's legislative council Deputy Chairperson Neelam Gorhe on Wednesday directed the DGP to conduct an immediate inquiry into the alleged harassment of a woman police constable during a violent clash in Nagpur.

A group of rioters allegedly touched the constable inappropriately and tried to disrobe her during the violence on Monday after protests against Mughal emperor Aurangzeb's tomb, officials had said. Calling the incident "extremely shameful and outrageous", Gorhe said, "The accused must be identified immediately, and an inquiry should be conducted by the DGP. It should also be examined whether other women in the area faced any harassment during violence".

Speaking in the council, Gorhe stressed the need for special planning to prevent such incidents in the future and called for enhanced security measures for women police personnel.

"There should be specific provisions to ensure the safety of women police officers, along with adequate training and necessary equipment. Attacks on women police officers are serious and unacceptable. Strict measures will be taken immediately to prevent such incidents," Gorhe said.

Cyber cell finds over 140

objectionable posts The Cyber department has identified more than 140 posts and videos containing objectionable contents across social media platforms aimed at inciting communal unrest, officials said.

These videos and posts were found uploaded on Facebook, Instagram, X and YouTube, an official said on Wednesday. Notices have been issued under section 79(3)(b) of the Information Technology (IT) Act 2000 to facilitate the immediate take-down of such content, he said. Additionally, notices have also been served under section 94 of the Bharatiya Nagarik Suraksha Sanhita (BNSS) to uncover the real identities of the individuals operating these accounts.

The Maharashtra Cyber, in coordination with the Nagpur City Cyber police station, has identified multiple social media accounts engaged in disseminating objectionable content concerning the Nagpur riots which took place on Monday. The content in question was deliberately designed to hurt the sentiments of a particular religious group, incite communal unrest, and further escalate the ongoing law and order situation in the state, the Maharashtra Cyber stated in a release. By exploiting deeply held beliefs, such material seeks to provoke the public, create discord and deepen divisions within communities, it said.

Such actions not only violate legal provisions but also pose a serious threat to peace and stability, it added. Noting that riots have caused significant damage to public property, the cyber department said strict legal action will be taken against those responsible for spreading such provocative content.

The chosen 'Bagadya' observes a strict five-day fast, consuming only Neem leaves and abstaining from water, while residing in the temple until

The Bagad, a large chariot, consists of two massive stone wheels. A 10-footlong pole is connected to an 18-foot-tall tiger-mouth post, with a 40-foot-tall bamboo structure attached at a precise angle, from which the chosen

The festivities begin on the eve of the yatra with 'Chhabina', with a palanquin procession of the deity being taken out.

On the panchami day, the Bagadya is taken to the banks of the Krishna river

for a ritual bath before being suspended from the hook, as the chariot is drawn through the rugged farm paths amid chants of " Kashinathacha Changbhal".

Knives out in legislature

Mumbai: Death of celebrity manager Disha Salian in 2020 once again rocked the Maharashtra legislature on Thursday. While cabinet ministers Nitesh Rane and Shambhuraj Desai demanded that Shiv Sena (UBT) leader Aditya Thackeray be arrested in the case, BJP MLA Amit Satam in the assembly and another BJP member Chitra Wagh in the council demanded that the report of SIT to probe Salian's death be made public.

Incidentally, amidst repeated disruptions in both the houses, some members from the treasury benches were seen speaking in favour of Aditya Thackeray, while Shiv Sena (UBT) members like Adv Anil Parab were seen supporting the BJP members' demand that the report of the SIT probe be made public. In addition, there were allegations and counter allegations and personal accusations among members from the treasury and opposition benches which led to heated debate on occasions.

The opposition termed the attempts from the treasury benches to link Shiv Sena (UBT) leader Aditya Thackeray's name in the case, as a 'conspiracy'.

"I think this matter has gone to the court. We have no idea what he (Disha's father) has said, but Aaditya Thackeray is a mature leader, a young leader. The Bharatiya Janata Party is conspiring to defame him by putting pressure on him. We don't need to answer to this conspira-

cy. The court will answer," Ambadas Danve said.

Earlier in the day, when the house gathered for the business, Minister of State for Home appraised the assembly of the status in this case. "SIT has been formed to probe in the case. Their report has not been received as yet. However, the government shall act according to directives from the court," the minister told the house.

Another BJP minister Nitesh Rane, however, said that since Satish Salian has levelled allegations against an MVA minister, that leader be treated like a common person and that everybody should be treated equally before the law. Shiv Sena minister Shambhuraj Desai too supported the demand. "Since the allegations are grave, the person in question should be immediately arrested and the case be investigated," he said.

Later, while speaking to media in the legislature premises, Rane asked Uddhav Thackeray to come clean on the issue. "If they

say that we are politicizing the issue, Uddhav Thackeray should also tell the people why he had called, not just once but twice, to the then union minister Narayan Rane urging him to save his son?" Rane said.

He also accused the opposition of shying away from coming clean on the issue. "If they feel that we are not telling the truth, they should say so in the house. But they are shying away from doing so. Bhaskar Jadhav, who is always aggressive, was nowhere to be seen when this issue came up in the house. Sunil Prabhu too escaped the house under the pretext of a phone call. I challenge them to say that whatever I said on the issue is wrong," Rane said.

He also said that Aditya Thackeray should resign on moral grounds till his name is cleared in the case.

BJP MLA Amit Satam demanded that the details of the SIT probe be made public so that the people would know if the probe is headed in right direction.

Interestingly, while the ruling parties were targeting the opposition in the case, senior BJP leader Sudhir Mungantiwar surprised all with his unexpected support to Thackerays. "I do not have any evidences in the case. But if her father has made any fresh allegations that needs to be investigated thoroughly. The assembly can discuss the issue at length tomorrow. In the meanwhile, members like Rane, who seem to have some evidences in the case should hand them over to the investigating agencies and help the probe," he told the house.

Shiv Sena's Sanjay Gaikwad and Sheetal Mhatre too toed the line and demanded that more and more evidences should come

Similarly, when members of treasury benches were pushing for revealing the details of the probe till date to the public, Shiv Sena (UBT) member Anil Parab supported the demand. "Doing that shall conclusively prove the innocence of Aditya Thackeray,'

"Have evidence to show that Disha was raped, murdered"

Mumbai: As the Disha Salian death case rocked the Maharashtra Assembly on Thursday, Nitesh Rane, Minister for Fisheries and Ports, who has been keenly following the case since June 2020, tells 'The Perfect Voice' that he has enough evidence to show that Disha was raped and murdered.

You've been speaking about this case since her death in June 2020. Who all do you think are involved?

June 8 and June 13 were related. To cover up what happened on June 8, June 13 occurred. I have been speaking about it since June 2020 because I know it wasn't a suicide or accidental death but it was a murder. We have enough evidence to show that Disha Salian was raped and murdered.

What is the incriminating evidence that you have?

There are mobile tower records which show that Disha, Aditya Thackeray, and a Zomato delivery person's phones were at the same location in Malad. The Zomato delivery person has also given his statement in this regard.

How was an alleged murder brushed off as a suicide?

The post mortem report was modified and tampered with. I have the original post mortem report which I procured from the municipal hospital where the post mortem was done. But these original reports were never made public. It shows that Disha was gang raped and mur-

dered because the report shows injury marks around her private parts. There are many loopholes in their theory- if someone falls from the 14th floor, there are bound to be injuries on the face but the photographs we saw yesterday show no marks on her

"We have to protect our sisters in this state."

face. The post mortem reports that were released say that there were injuries on her face but look at the recent photos. Where are the marks? How is that even possible?

You have made a connection between Aditya Thackeray, Dino Morea and Sooraj Pancholi. What is the connection?

They are all friends who were partying during the Covid lockdown when everyone was staying home.

Most people are questioning the timing of Disha Salian's father's petition in the court. Why now after almost five

Her father stated that he was until now brainwashed into believing it was a suicide. But now he wants justice for his deceased daughter. Why question the timing?

A father wants justice so he has approached the High Court. The police will act on court orders. It will come up for hearing on the High Court on Monday or Tuesday next week. Our assembly colleagues have come together to say that we should follow the Supreme Court's judgement—that if a person is accused of rape, he should first be arrested. In the Assembly, we have only made this demand that the Supreme Court's judgement

should be followed.

Deshmukh points towards 'conspiracy'

Mumbai: Former home minister of Anil Deshmukh on Thursday stated that in a way the issue of Disha Salian resurfaced it seems like it's a larger political conspiracy. The timing selected for targeting Shiv Sena (UBT) leaders has raised many questions. "Aditya Thackeray has nothing to do with this," he

Deshmukh said, "I am taking information on the plea filed by Disha Salina's father. All this now looks like a gloomy affair. Disha's father has gone to court Salian has named Aditya Thackeray, but we are sure Aditya Thackeray has nothing to do with this. We are with him, but let the court decide. If a person is trying to get justice. he should get justice".

"Significantly, if you look at the BJP's style of functioning, they will now start doing politics on it. Four years ago Sushant Singh Rajput committed suicide. At this juncture I am gathering information on the sensitive Disha episode. Once I get the details on this particular issue I will come before the media.'

Rattled, Thackeray says 'do not rely on lies'

Mumbai: Shaken by the sudden spotlight on the Disha S. Salian death case, Shiv Sena (UBT) President and ex-CM Uddhav Thackeray and his son Aditya Thackeray appeared at a loss for words to react to the development, but said 'lies' should not be relied upon.

In a relief of sorts, a ruling ally Shiv Sena MLA came out in open support of the beleaguered Thackerays and the ex-CM expressed his gratitude.

The five-year-old incident concerning the unexplained death of Bollywood celeb manager Disha rocked the Maharashtra Legislature afresh with the ruling MahaYuti and Opposition Maha Vikas Aghadi allies hurling accusations at each other.

"There is no substance in these allegations... The matter is in the court...let them say it there," dared Thackeray, who served as the MVA CM from November 2019-June 2022 when the case had blown up.

"I am confident that the case would boomerang on them in the court,' Thackeray declared dismissively, with Aditya beside him.

Thackeray wondered "why the issue keeps cropping up only during the Legislature sessions", and said there is nothing new in this.

"Every time the Legislature comes into session, this matter is raised...



Why did it not come in the past couple of sessions... I am surprised. It keeps coming up but there is nothing new to it. Whatever Satish Salian's lawyer claims, he should say it in the court," said Thackeray sharply.

"Many generations of our family are in front of the public. We have no connection with this case at all. But if politics is being twisted and taken in the wrong direction, everyone will suffer. When you rely on lies, it will also backfire on you," warned Thackeray.

During a brief interaction with the media earlier in the day, Aditya Thackeray said that "since the matter has gone to the court, I shall also submit whatever I have to say before the court".

"For the past five years they have been trying to defame me. But they were exposed on all counts... Now, the matter has gone in the court... I will respond there," said Aaditya.

'satisfied' with cops

A few years ago, the Salian couple had said that they were satisfied with the police and other agencies' probe plus pleaded publicly that the media and politicians should stop hounding or defaming their family. In March 2022, Satish and his wife Vasanti had written to the President of India, complaining that the (then) Union Minister Narayan Rane and his son Nitesh Rane are 'liars and virtually driving them (the Salians) to suicide". Drawing parallels with the Nirbhaya rape-cum-murder case of Delhi over a decade ago, the Salians pointed out that till now, that victim's identity has not been revealed, but "Rane is blatantly taking my daughter's name" repeatedly and saying that she was raped. Displaying signs of desperation, the Salians asked "whether the law of the land is not applicable to the Union Minister", and pointed out how even after registering a (police) complaint against them, the "liars" Rane duo did not stop maligning the family's

SIT remained on paper

Mumbai: The Special Investigation Team (SIT) formed in June 2023 to investigate the death of Disha Salian has not yet submitted its report to the state government.

A source said that the investigation was hampered as all the officers who were inducted in this SIT have been transferred The SIT was headed by then Additional Commissioner of Police Rajeev Jain. Deputy Commissioner of Police Ajay Kumar Bansal and Senior Inspector Chimaji Adhav were other members of the SIT.

The source said the SIT had issued several summonses to those who alleged foul play in Disha's death. The work remained incomplete. An officer said they had recorded statements of her friends who were present at the party. They reportedly said she was upset due to some monetary losses at work and that they had also called a friend living abroad to help cheer her up. Fisheries Minister Nitesh Rane have raised questions over the induction of Adhav in the SIT. "A few senior police officers were also under suspicion in this case. How come an officer of a Senior Inspector rank question his superiors?" Rane said.

HC upholds closure order for mall

Mumbai: The Bombay High Court has upheld the closure directions against a suburban mall for not obtaining environmental clearance, noting that operating such an establishment raises the "seriousness of the ecological

The petitioner company, Grauer and Weil (India) Limited, considers itself above the law and has shown scant regard for environmental concerns, a division bench of Justices M S Sonak and Jitendra Jain said in its order on Wednesday.

It further said the petitioner company has taken law into its

own hands and proceeded with construction of the mall without obtaining any environmental clearance, hence it is only proper that the closure directions are implemented immediately.

"The contention that the petitioner has applied for clearance under some amnesty scheme certainly does not entitle it to reap commercial profits at the cost of environmental clearances," the bench said.

It directed the Maharashtra Pollution Control Board (MPCB) to immediately enforce the closure directions. The HC dismissed the petition



filed by Grauer and Weil (India) Limited, which operates the mall in Kandivali area here, challenging the closure directions issued against it by the Maharashtra MPCB on March 5.

No case is made out to interfere with the closure order, the court said, adding that relief can be granted only to promote justice and not perpetuate gross

"Operating a mall that is constructed without obtaining any environmental clearance is extremely serious and operating such a mall without obtaining consent to establish/operate magnifies the seriousness of the ecological issue," the HC said.

The petitioner company has taken law into its own hands and proceeded with construction of the mall without obtaining any environmental clearance, hence it is only proper that the closure directions are implemented immediately, the court added.

The bench directed the MPCB to immediately enforce its closure directions.

The plea claimed the principles of natural justice were not followed before passing of the orders and that there was no grave urgency for the closure or-

der to be passed. The high court, however, refused to accept this contention and said the authority cannot wait for some environmental

Vidhie is Indrani's daughter from her first marriage to Sanjeev Khanna, also an accused in the

Sheena Bora, Indrani's daughter from an earlier relationship, was allegedly strangled to death by Indrani, her driver Shyamvar Rai, and her former husband Khanna.

Her body was then burned and disposed of in a forest in Raigad district.

The crime came to light in 2015 when Rai, who later turned approver, revealed details following his arrest in another case. Former media executive Indrani and Khanna were arrested in August 2015, and Peter Mukerjea, Indrani's exhusband and media baron, was arrested three months later. All accused are out on

REMEMBERING BISMILLAH KHAN ON HIS BIRTH ANNIVERSARY

Varanasi: The stairs are crumbling to dust, the walls ravaged by the passage of time and just beyond flows the Ganga as if in eternal serenity. It was here that a young Bismillah Khan practiced for hours - from 4 am till the sun came up and again in the afternoon till it went down.

The strains of his shehnai have long faded away from the Naubat Khana but the Ustad, who took the instrument to the world stage and became synonymous with it, lives on somewhere in its recesses. And outside it too

On his 109th birth anniversary on Friday, memories of the man counted as one of India's greatest musicians linger in the corners of the temple town where he lived, learnt and played.

He was the classical musician who famously heralded India's independence on August 15, 1947 by playing Raag Kafi from the ramparts of the Red Fort ahead of Jawaharlal Nehru's momentous 'Tryst with Destiny speech.

Anecdotes from the life of the sultan of shehnai, born Qamaruddin Khan in Bihar's Dumraon on March 21, 1916, abound around the ghats and narrow gullies of the ancient city of Varanasi, or Banaras as it was known. For the residents of the town, some who knew him and others who grew up on stories about him, he was the world renowned musician and also a beacon of the

Hindu-Muslim syncretic

culture - the "Ganga Jamuna tehzeeb".

The Naubat Khana, at the intersection of the Balaji and Mangala Gauri temples, was perhaps his first stage. Nearly 20 years since his passing in 2006, the floor of the room and the passage to it has fallen through. "This is the place where

he used to sit. His meditation was of four phases. He would light a diya in the alcove inside and sit down to play the shehnai at 4 am, then in the noon, then in the evening and later in the night," Pandit Narayan Guru, head priest of the Mangala Gauri temple, told PTI.

The routine he followed for more than three years as a young student was an odd mix of Hindu and Muslim morning rituals, starting from taking a dip in the Ganga, followed by morning namaz at Alamgir mosque nearby and then settling down to play at the Naubat Khana after lighting an earthen lamp.

"He would play the shehnai at the Naubat Khana and also at the entrance of the temple but never inside. He was a devout Muslim but never looked differently at any Hindus he met, asking for their and their family's well being," recalled Prabhat Kumar Sharma, who manages the Balaji

Remembering the shehnai maestro as the best example of the culture of harmony for which the land was known for, Sharma said Khan would also donate money for the temple's food offerings.

Khan, who was awarded the Bharat Ratna in 2001,

GOVT RULES SAY NO OVERTIME FOR SUNITA, BUTCH AFTER **GETTING STUCK IN SPACE**

New York: Will Sunita Williams and Butch Wilmore get overtime for staying longer in space than planned? Not a chance.

Williams and Wilmore, who returned to Earth on Tuesday after spending 286 days in space - 278 days longer than anticipated after their spacecraft malfunctioned - will not get any overtime for their unexpectedly long stay, according to NASA rules, the New York Times reported.

But they do get USD 5 a day for "incidentals", the paper added.

Despite their far-flung destination and the danger of space travel, when it comes to pay, astronauts are treated effectively "like any other government employee who takes a business trip...", the NYT said.

"While in space, NASA astronauts are on official travel orders as federal employees," Jimi Russell, a spokesman for the agency's Space Operations Mission Directorate, told NYT via email.

Williams and Wilmore were essentially unable to leave their workplace for more than nine months. But astronauts aboard the International Space Station receive no overtime, holiday or weekend pay, Russell

Their transportation, meals and lodging are covered, and like other federal employees on work trips, they receive a daily "incidentals" allowance, Russell said. This is a per diem payment given to employees in the place of reimbursements for travel expenses.

The incidental allowance for travel to any location is \$5 per day, Russell said.

This means that in addition to their annual salary -about \$152,258, according to NASA - Wilmore and Williams received around \$1,430 for their 286 days in space, the NYT said.

What incidental expenses might Wilmore and Williams have incurred while in orbit 250 miles above Earth? It's unclear. Usually, these are "fees and tips given to porters, baggage carriers, hotel staff, and staff on ships," according to the US General Services Administration

Williams and Wilmore did not exactly see their extended stay as a hardship. "This is my happy place," Williams told reporters in September. "I love being up here in space. It's just fun, vou know?'

Still, if a \$5 per diem seems low for a job that causes enough muscle and bone loss for you to need a gurney when you return to Earth, spare a thought for Clayton Anderson, the NASA astronaut who spent 152 days aboard the International Space Station in 2007, the NYT said.

Anderson said he received a per diem of only about \$1.20, or \$172 in total.

"Remember that for me being an astronaut - was amazing, but it IS a government job with government pay. But that's okay too, it's a job I did because I dreamed of and loved it, not because of the money I could earn," he wrote on social media in 2022. -PTI

One of the fraudsters posed as a 'CBI officer' to extort money from the woman, they said, adding three persons have been arrested in connection with the crime which took place between December 26, 2024 and March 3 this year.

The accused persons had also forced the victim to stay at home for two months and to check her location daily by calling her every

three hours, an official said. The cyber police have managed to freeze Rs 77 lakh belonging to the woman by identifying the bank accounts to which the money was transferred, he

While investigating the case, the cyber police found the money was transferred to various bank accounts, including one of Shayan Jamil Shaikh (20), resident of Malad area here, he said.

The police said Rs 4.99 lakh was transferred to Shaikh's account, which he had withdrawn and handed over to another fraudster. The cyber police recently

tracked down Shaikh and after his arrest and interrogation, they also nabbed another accused Razique Azan Butt (20), resident of Mira Road in neighbouring Thane the official said

The police on Wednesday identified one more accused. Hritik Shekhar Thakur (25), resident of Andheri area, in whose account Rs 9 lakh was transferred, and arrested him late night, he said.

Thakur has admitted to the withdrawal of Rs 9 lakh from an SBI account, which was transferred by his aides after duping the woman, the official said.

Principal's dismissal sparks protests

Dombivli: Parents and students staged a massive protest outside Greens English School in MIDC, Dombivli, after the abrupt termination of Principal Archana Mohite by the school administration Mohite who had served as the principal for over a decade and received the Best Principal Award, alleged that she was dismissed for opposing the administration's arbitrary decisions.

Speaking to 'The Perfect Voice', Mohite stated that she was given just 48 hours to respond to an official notice. Despite submitting her reply, she received a termination letter via courier on March 18, declaring that she had failed to respond within the stipulated time. The letter also warned her against entering the school premises from the next day.

Mohite further claimed that the school management had installed highquality audio-visual surveillance cameras in her cabin without her consent, violating her right to privacy. "These cameras allowed people to monitor me remotely, which is a serious legal offense. Even as a woman, my privacy was completely disregarded," she said.

She also accused the administration of failing to follow due process. "Even a criminal is given a chance to present their case, but I was terminated without any inquiry, discussion, or a hearing with the management," Mohite added. Mohite mentioned that

the school's management is currently under dispute, with legal cases pending before the Charity Commissioner. She claimed that individuals with no legal authority were exerting pressure on her and interfering in school matters. "I was caught between two conflicting committees. The rightful management should take charge instead of creating confusion and harassment.'

She alleged that in December, a newly appointed teacher-still under probation-was given undue preference over experienced teachers with 25-30 years of service. However, the school's governing body has refuted Mohite's claims. Shirish Deshpande, Vice President of Dombivli Progressives, stated that Mohite had submitted false educational credentials and misled the institution.

Chandigarh: Following the eviction of protesting farmers from the Shambhu border, Haryana security personnel on Thursday morning started removing cemented barricades, which were erected to prevent the Punjab farmers from heading to

At the Shambhu border, JCB and other machines have been deployed to remove the concrete blocks to clear the Shambhu-Ambala road, which remained closed for over a year.

The Haryana security officials had fortified the state border with Punjah with cement blocks, iron nails and barbed wire to scuttle any attempt by the farmers from Punjab to move towards the capital as part of their 'Delhi Chalo' programme.

Punjab Police also resumed its operation to dismantle the remaining temporary structures on the Punjab side of the Shambhu border on Thursday to clear the road.

Dharnas outside offices Meanwhile, the Samyukta Kisan Morcha (Non-Political) and the Kisan Mazdoor Morcha on Thursday announced to hold dharnas outside the offices of deputy commissioners in protest against the Punjab Police crackdown.

Both the bodies, which spearheaded the farmers' stir at Shambhu and Khanauri border points, slammed the Aam Aadmi Party (AAP) government in Punjab for evicting the protesters and detaining farmer leaders on

He suffered bullet injuries and was taken to Sielmat Christian Hospital. where he was declared dead. The clashes between the two tribes started after Hmar Inpui general secretary Richard Hmar was attacked by some Zomi people on Sunday, leading to violence and imposition of curfew in the district the next day. Meanwhile, several displaced people from the Kuki community in relief camps were moved to safer locations.

Churachandpur is mainly home to Zomi people, with Hmar and Kuki communities living in some areas. Hours after a fresh shutdown was imposed by a student body in the district on Wednesday, a group of MLAs and tribal organisations separately appealed for peace.

At least 12 Kuki-Zomi and Hmar organisations have called for peace among communities and agreed to form a joint peace committee to monitor the situation and prevent misunderstandings in

Police ask MLA to use bulletproof vehicle

Hyderabad: A notice has been issued to BJP legislator T Raja Singh by the city police, directing him to use the bulletproof vehicle and security personnel allotted to him by the government for security reasons.

Singh, who represents the Goshamahal constituency in the city, stated that he prefers to travel by his two-wheeler to remain accessible to the people, as a bulletproof car would cause inconvenience in the narrow lanes and bylanes of his constituency.

The notice was issued to Singh on March 19 by the Mangalhat Police Station, and he has acknowledged its receipt, a police official said on Thursday.

"He (Singh) has been asked to use the bulletproof vehicle and the (1+4) security personnel allotted to him to prevent any untoward incidents, as he has been seen moving in public without them," they said, adding that the notice is a routine alert as part of security measures.

"It is to alert you that you have been receiving frequent threatening calls, and it has been noticed that you often leave your residence and office without security personnel, moving among the public, which shows negligence towards your safety," the notice addressed to Singh stated.

Acknowledging the notice, the firebrand Hindutva leader reiterated that his priority is to remain accessible to the people.

He emphasised that his constituency consists of residential colonies, slums,

and business establishments, with narrow lanes where a bulletproof car would be inconvenient.

The MLA said travelling freely on a two-wheeler allows him to stay connected with people without causing unnecessary disruptions. However, he took exception to the police rejecting his request for a gun license.

"What exposes the hypocrisy of the system is that when I applied for a gun license citing security concerns, the same police department rejected my application, citing cases against me. Ironically, many individuals with pending cases have been granted gun licenses without any objections," Singh said in a statement.

First chartered flight after pandemic

"He then carried out a cesarean operation on the woman at a private hospital a few days ago and sold the child to the couple by preparing false documents," she said.

Comprising 13 unique panels that occupy almost 14 feet across a single canvas, Gram Yatra, which means 'village pilgrimage', is widely regarded as a cornerstone of Husain's oeuvre, celebrating the diversity and dynamism of a newly independent nation.

"We are thrilled to have been a part of setting a new benchmark value for the work of Maqbool Fida Husain and the entire catego-

ry. This is a landmark moment and continues the extraordinary upward traiectory of the Modern and Contemporary South Asian Art market," Nishad Avari, head of Christie's South Asian Modern and Contemporary Art, said in a statement.

Hong Kong's richest man angers Beijing

Hong Kong: Hong Kong tycoon Li Ka-shing's business empire is in the crosshairs after CK Hutchison Holdings chose to sell its Panama Canal port assets to a consortium that includes US investment firm BlackRock Inc, apparently angering Beijing.

Over the past week, Beijing's Hong Kong affairs offices have posted scathing commentaries from a local state-backed media outlet over the tentative deal by Hutchison, which is controlled by Li's

That raises questions about the deal and highlights the difficulties Hong Kong businesses face as they balance demands from Beijing for national lovalty and their own capitalist interests in the once free-wheeling Asian financial hub. Here's what to know about the issue.

Nicknamed "Superman," Li is among the world's 50 richest people, with Forbes calculating his net worth at USD 38 billion. Li, 96, retired from his position as chairman of CK Hutchison in 2018, succeeded by his elder son Victor. But he's still one of Hong Kong's most influential figures.

Li's ties with Beijing

Li's influence extends beyond business. He has met with top Chinese leaders and has served on the elite



committee that selected Hong Kong's leader.

Experts on ties between Beijing and Hong Kong said ruling Communist Party leaders once understood that support from the business sector was crucial for maintaining Hong Kong's capitalist system. It's has been strategically vital for mainland China's economy, given the role their global networks and resources play in the country's development. So, Li has had notable political influence.

Some unconfirmed reports have suggested Chinese leaders were angry not to have been consulted in advance about the deal.

Ports are valuable strategic assets and transactions involving them are always sensitive, said Wilson Chan, co-founder of the Pagoda Institute, a think tank focusing on public policy and the global political economy.

It is unclear whether pressure from Beijing will affect the deal, which has to be approved by Panama's government. China's Foreign Ministry deflected a question about whether authorities are investigating the deal, saying reporters should ask other authorities.

Longer term implications

If Beijing steps up pressure on Li to scrap the deal, the Trump administration could hit back with more sanctions and restrictions on Hong Kong and Chinese businesses and some individuals, he said

The situation shows that Washington's concerns about Hong Kong's business autonomy are valid.

No windfall tax on oil cos after new law

New Delhi: Oil and gas companies will not face any new taxes like the windfall profits tax after the coming into effect of a new law that promises stability of fiscal regime, Petroleum Minister Hardeep Singh Puri said.

Parliament has passed the Oilfields (Regulation and Development) Bill, 2024 that provides policy stability to investors, decriminalises provisions and promotes ease of doing

"After this bill, it will be difficult to levy (new taxes like) windfall tax because somebody will sue us (for failing to keep the promise of fiscal stability)," he said at a reception he hosted to celebrate the passage of

India imposed a windfall profit tax on July 1, 2022 joining a growing number of nations that tax super normal profits of energy companies. At that time, export duties of Rs 6 per litre (USD 12 per barrel) each were levied on petrol and ATF and Rs 13 a litre (USD 26 a barrel) on

A Rs 23,250 per tonne (USD 40 per barrel) windfall profit tax on domestic crude production was also levied. The tax rates were reviewed every fortnight based on average oil prices in the previous two weeks. The levy was scrapped in December last year after 30 months. Puri said global oil majors have been exploring investing in India.

The Bill is part of the government's reforms agenda to make it easier to find and produce crude oil (which is refined into fuels like petrol and diesel) and natural gas (which is used to generate power, make fertilizer or turn into cooking gas and CNG).

Trump believes India will lower tariffs

New York: President Donald Trump has said that he believes India will lower its tariffs on American goods, even as he reiterated his threat to impose reciprocal US tariffs on the country starting April 2.

In an interview with Breitbart News, an American news, opinion, and commentary website, Trump discussed the US' relationship with India.

Asked about his summit with Prime Minister Narendra Modi last month, Trump said he has a "very good relationship" with

"But the only problem I have with India is they're one of the highest tariffing nations in the world," the website quoted Trump as

"I believe they're...probably going to be lowering those tariffs substantially, but on April 2, we will be charging them the same tariffs they charge us," Trump added.

When asked about the India-Middle East-Europe-Economic Corridor (IMEC), a deal he signed the US on to during Modi's visit to the US, Trump did not mention China in particular but said it was a "group of wonderful nations" banding together "countering other countries that look to hurt us on trade.'

"We have a powerful group of partners in trade," Trump said.

"Again, we can't let those partners treat us badly, however. We do better in many ways frankly with our foes than we do with our friends," Trump was quoted as saying by the

"The ones that wouldn't be as friendly to us in some cases treat us better than the ones that are supposed to be friendly, like the European Union, which treats us terribly on trade," Trump explained.

"India and everybody would think of them as an ally. I can say the same for others. But this is a group of wonderful nations that is countering other countries that look to hurt us on trade," Trump further added.

Trump earlier this month said that India has agreed to cut its tariffs "way down" as he reiterated his claim that the country charges America massive tariffs that make it difficult to sell products



GCCs in India expect 9.8 pc salary growth

as the top payers, outpacing traditional IT services in pay parity and growth, and are expected to give 9.8 per cent salary growth over the next 12 months, 'India's Talent Takeoff -The GCC 4.0 Story' report by digital talent solutions provider NLB Services said.

"With India hosting over 55 per cent of the world's GCCs and projected to reach a market size of USD 110 billion by 2030, these centres have become critical nodes for organisations seeking agility, cost efficiency, and access to a vast talent pool. This growth trajectory is now translating into significant salary increases for employees, especially for specialised skills which are commanding higher premiums than ever before," NLB Services CEO Sachin Alug said.

However, he said, despite this strong momen-



tum, gender-based disparities still require attention, with women earning approximately 75-85 per cent of male salaries on average, a gap which further widens at senior positions, reflecting the limited representation in leadership

The strong salary growth spans across junior and mid-level roles, fueled by demand in fields like AI, ML, Cloud Computing, and Cybersecurity. On the contrary, senior roles are set for modest increases as organizations prioritize cost efficiency in leadership, said the report.

Looking ahead, India's GCC sector is expected to grow at a compound annual growth rate (CAGR) of 9-12 per cent through 2030, and salaries are set to grow exponentially, the report added.

a time. The sprayer has been designed by local engineer Yogesh Gawande, who formed a company in 2019 to manufacture the product in Chhatrapati

Sambhajinagar. The company has so far sold more than 5,000 sprayer units and generated 100plus direct and indirect job opportunities, as per Gawande.

Bill Gates tried his hand at operating the sprayer at the Indian Agricultural Research Institute (IARI) in New Delhi on March 17 in the presence of Gawande

"I first made the sprayer as part of a project during my engineering course," Gawande said a press meet held at the Marathwada Accelerator for Growth



and Incubation Council (MAGIC) office here on Wednesday.

With this sprayer, farmers do not need to carry heavy chemical tanks on their back for spraying pesticides. They can now spray chemicals over four rows of crops at the same time with this innovative device which is operated on wheels, he said. The height of the spray-

er's nozzles can be adjusted till 12-14 feet to cover large trees. The pressure of nozzles is adjustable and hence, the crop is not damaged due to the pressure, Gawande said.

"I had earlier tried to sell this sprayer on a highway near Chittepimpalgaon (Gawande's native village) at Paithan in Chhatrapati Sambhajinagar. Subsequently, I dropped the idea to manufacture it further because though the prod-

uct was applauded, it could not be converted into a business," he said.

Gawande said he later received help from MAG-IC, following which he started his company.

"I am connected to the Gates Foundation. As Bill Gates came to India, my product was selected to be presented before him. He gave 5-7 minutes to us and also tried his hand at the sprayer. He asked multiple questions on the sprayer's functioning like a farmer," Gawande said.

Strikes hit Sanaa, Yemen's rebel-held capital, as well as their stronghold of Saada in the country's northwest on Wednesday night, the Houthi's al-Maisrah satellite news channel reported.

It also said strikes happened overnight Tuesday, though the US military has not offered a breakdown of places targeted since the airstrikes campaign began. The first strikes this weekend killed at least 53 people, including children, and wounded others.

As the strikes hit, Trump wrote on his Truth Social website that "tremendous damage has been

Tehran routinely denies arming the rebels, despite physical evidence, numerous seizures and experts tying the weapons back to Iran. That's likely because Tehran wants to avoid sanctions for violating a United Nations arms embargo on the Houthis.

The Houthi rebels attacked over 100 merchant vessels with missiles and drones, sinking two vessels and killing four sailors, from November 2023 until January this year when a ceasefire began in Gaza.

The campaign also greatly raised the Houthis' profile in the wider Arab world and tamped down on public criticism against their human rights abuses and crackdowns on dissent and aid workers.

Indian scholar in US detained over Hamas ties

New York: An Indian national enrolled as a postdoctoral fellow in the US has been detained by immigration authorities, said a media report, less than a week after a Columbia student from India self-deported following allegations of activities supporting Hamas.

Badar Khan Suri's lawyer claimed that he is being punished "because of the Palestinian heritage of his wife — who is a US citizen - and because the government suspects that he and his wife oppose US foreign policy toward Israel."

He is a former student of Jamia Millia Islamia, New

Suri is currently a postdoctoral fellow at the Alwaleed Bin Talal Center for Muslim-Christian Understanding at the Edmund A Walsh School of Foreign Service, Georgetown University, Washington DC.

A report in Politico said that Suri, who was studying and teaching on a student visa, has been "detained by federal immigration authorities amid the Trump administration's crackdown on student activists whom the



posing American foreign policy.

According to his profile on the website of Georgetown University, Suri completed his PhD in Peace & Conflict Studies from Nelson Mandela Center for Peace and Conflict Resolution, Jamia Millia Islamia, New Delhi in 2020.

He wrote his thesis on "Transitional Democracy, Divided Societies and Prospects for Peace: A Study of State Building in Afghanistan and Iraq" in which he underlined the complexities involved in introducing democracy in ethnically diverse societies; as

well as challenges to project state building.

He has travelled extensively in the conflict zones of India, Pakistan, Balochistan in Iran, Iran, Turkey, Kurdish Areas in Turkey, Syria, Lebanon and its southern region, Egypt and Palestine.

Suri's detention comes less than a week after Ranjani Srinivasan, an Indian student at Columbia University, self-deported after her visa was revoked for allegedly "advocating for violence and terrorism' and involvement in activities supporting Hamas.

Srinivasan had entered the United States on an F-1 student visa as a doctoral student in Urban Planning at Columbia University, the Department of Homeland Security had said.

It added that Srinivasan was "involved in activities supporting" Hamas, a terrorist organisation.

The Department of State had revoked her visa on March 5. The Department of Homeland Security said it has obtained video footage of Srinivasan using the Customs and Border Protection (CBP) Home App to self-deport on March 11.

Singapore: Singapore and Japan unveiled on Wednesday the world's deepest ocean art installation comprising three metal cubes designed by the city state's leading Indian-origin artist Lakshmi Mohanbabu.

Deployed 7 km below the sea, the artwork is by Mohanbabu, local tech firm NuStar Technology and Nanyang Technological University (NTU) here.

"Singapore is now the first country to have an art installation 7,000 metres beneath the ocean," said a media release from the three partners in the project.

The historic milestone, part of Singapore's SG60 (60 years of independence) celebrations was observed on Wednesday at Gallery ART NOW.

A tribute to all those impacted by natural disasters, these artworks were installed near the Mariana Trench off the coast of Japan by NuStar Technologies in December last year,

said the release.

Sharing her sentiments about the project, Mohanbabu said, "But beyond art, this project holds a deeper significance. It illuminates global efforts to mitigate challenges posed by natu-

ral disasters. While we cannot avert nature's wrath, we can honour those impacted and highlight the collective global efforts to mitigate it."

"The ocean floor installation is a symbol of that

collective effort—a reminder of what we can achieve when we come together for a greater cause." said Mohanbabu, a leading artist, architect and leader of the project.

Each of the three hollow cubes is crafted from corrosion-resistant stainless steel, measuring 10 cm on each side. There are five sides for each cube, showcasing the iconic "Universal Language of Symbols" by Mohanbabu.

One of the cubes was made using a new hybrid

manufacturing process developed by NTU. To accommodate the art-

work, specially designed cavities and holders were incorporated into the Long-Term Borehole Monitoring System (LTBMS) equipment bay frame.

The LTBMS was originally developed to monitor seismic activity near tectonic plate boundaries and supports real-time data monitoring for earthquake and tsunami early warning systems.

Truth Awaits

or nearly four years, the death of Disha Salian, manager of late actor Sushant Singh Rajput, has remained a matter of intense speculation, whispers and conspiracy theories. Now, in a new twist, her family has approached the Bombay High Court, demanding a fresh investigation into what they allege was no suicide but a brutal murder orchestrated at the highest levels of politics and entertainment. The petition names, among others, Shiv Sena (UBT) leader Aaditya Thackeray, scion of one of Maharashtra's most famous political dynasties. The allegations are serious and it is high time for Thackeray to come forward and clear the air, and not evade the questions that refuse to go away.

Salian (28) was found dead on June 8, 2020, after falling from the 14th floor of a high-rise building in Malad. Just six days later, Sushant Singh Rajput was found dead in his own apartment. The twin tragedies, which occurred under the watch of Aaditya's father - Uddhav Thackeray's Chief Ministership - set off a storm of speculation and political mudslinging with an absence of definitive answers. The Mumbai police quickly concluded that both deaths were suicides. But questions persisted. Why was Salian's post-mortem conducted two days after her death? Why was it not disclosed earlier that her body was found without clothes? Why was the case hurriedly closed as an accidental death without exhausting all forensic avenues?

The latest petition filed by Salian's father alleges that she was sexually assaulted and murdered, with a politically motivated cover-up shielding the guilty. It demands the transfer of the case to the Central Bureau of Investigation (CBI) and the registration of an FIR against Aaditya Thackeray. The petition further claims that Salian was in possession of damaging information about a powerful coterie of politicians, film industry figures and law enforcement officials, making her a target. It alleges that forensic and eyewitness evidence has been ignored or suppressed.

The Sena (UBT) predictably has dismissed the allegations as politically motivated, accusing the ruling Bharatiya Janata Party (BJP) of using the case as a tool to discredit him. There is no doubt that politics is in play. But politics does not negate the need for accountability.

For Thackeray, this case is no longer just about a legal challenge but about his credibility. Silence, in such matters, fuels suspicion. If he truly has nothing to hide, he should welcome a thorough reinvestigation rather than dismiss it as a conspiracy. Anything less will allow doubts to fester and deepen public distrust.

The Mumbai police, too, must explain their actions. Their handling of Salian's case has been clumsy at best and evasive at worst. The rushed conclusion of suicide despite circumstantial evidence suggesting otherwise is precisely what led to accusations of a cover-up.

The courts will decide whether the allegations against Thackeray and others hold merit. But perception matters. For a leader hoping to carve out a future beyond the shadow of his father, Aaditya cannot afford to be seen as dodging tough questions. He must cooperate fully with investigators and make a clean breast of any involvement in order to prove his innocence.

Modi-Jinping Bhai Bhai? - Trade, Tariffs and the Ghosts of 1962

onald Trump did not invent trade wars, but his ongoing onslaught of tariffs and geopolitical brinkmanship has forced nations – friends as well as foes - across the world to rethink their strategic footing. Nowhere is this more apparent than in the uneasy tango between India and China - two Asian giants with shared histories, deep suspicions and economic ambitions. Let us rewind to the winter of 1949, when Mao Zedong stood atop Tiananmen Gate and declared the birth of the People's Repub-

Mao's rise was a triumph of Marxist-Leninist ideology, but it came at an enormous human cost. His Great Leap Forward (1958–1962), an attempt at rapid industrialization and collectivization, resulted in one of the deadliest famines in recorded history. His Cultural Revolution (1966–1976) upended China's intellectual and political class, sending thousands of 'bourgeois elements' to labour camps, leaving an indelible scar on the nation's psyche. Yet, despite economic deprivation, Mao's China was ideologically unified, exporting its brand of communist insurgency beyond its borders.

How India and China's tangled past informs their economic manoeuvring in the age of Trump's trade wars.

India was not immune to the ideological ripples emanating from Beijing. In the late 1960s, inspired by Mao's vision of peasant uprisings, Naxalite rebels in India's eastern states launched a violent insurgency that still simmers in remote pockets of the country today. But China's involvement with India was not merely ideological: it was also territorial. When Mao's forces annexed Tibet in 1950, it was the first tremor in a geopolitical fault line that would culminate in outright war.

By the early 1960s, India had embraced the idealism of Prime Minister Jawaharlal Nehru, whose faith in diplomacy led to the now-infamous "Hindi Chini Bhai Bhai" (Indians and Chinese are brothers) slogan. This faith, however, was shattered in 1962 when China launched a swift and brutal invasion into Indian territory, occupying 40,000 square kilometers in Aksai Chin, a region that remains under Chinese control

In Himalayan Blunder (1968), arguably the most famous memoir to come out of this humiliating defeat, Brigadier John Parashuram Dalvi, who became a prisoner-of-war in the early stages of the conflict, revealed how India's failure to utilize its superior air force - a decision made at the highest levels of government – was one of the main causes of the

When questioned in Parliament about the loss of territory, Nehru merely quipped, "Not a fig leaf grows there." The indifference of Oxford-educated Nehru to the ground realities of war left a wound on India's national psyche, one that would fester for decades.

Fast forward to the present when the world's economic order is shifting under the weight of American protectionism, and Trump's trade war with China and other countries has set off a scramble among global manufacturers. Beijing is keenly aware of the potential repercussions.

In this scenario, India is walking a



dra Modi has projected himself as a strongman capable of standing up to China, his government is also aware of the economic imperative to maintain a functional relationship. The recent thawing of rhetoric between New Delhi and Beijing is not an act of ideological convergence but of necessity. India, coping with its own Trump-imposed tariffs, has been hedging its bets - deepening defence deals with Washington while simultaneously exploring free trade agreements with the European Union. China, in turn, has responded with uncharacteristic warmth, lauding Modi's diplomatic pragmatism.

At a psychological level, this courtship evokes uncomfortable historical echoes. In the months preceding the 1962 war, Chinese Premier Zhou Enlai made a high-profile visit to India, and the 'Hindi Chini Bhai Bhai' slogan had reached fever pitch.

The betrayal that followed in form China's invasion was a moment of national humiliation that we still have not quite come to grips with. The scars of 1962 run deep, and they resurface every time India faces off against China whether in the high-altitude standoff at Doklam in 2017 or the deadly skirmishes in the Galwan Valley in 2020.

However, India in 2025 is not the India of 1962. Its military is better equipped, its leadership less naïve and its economglobal stage, too, is vastly different. Trump's America has jettisoned its post-Cold War role as a stabilizing force, leaving nations to fend for themselves in an increasingly volatile economic landscape. Washington's preoccupation with China's rise has made India a convenient counterweight, but New Delhi knows better than to be a pawn in someone else's game. Modi's strategy appears to be one of cautious engagement - leveraging the U.S.-China rivalry to extract concessions from both sides while avoiding direct entanglement.

In the long run, the question remains: Can India and China put aside their historical baggage for sheer economic pragmatism? The potential is undeniable for together, they account for nearly 40 percent of the world's population and wield enormous economic clout.

It is tantalizing to think if the Indo-China relationship transforms from that of uneasy coexistence to genuine partnership, can overtures of friendship be met with the cautious refrain of Modi-Jinping Bhai Bhai?

Until then, the world must contend with an awkward reality: Modi and Xi Jinping may exchange diplomatic pleasantries, but the specter of Mao and Nehru still looms large. And in the shadow of that history, every overture of friendship is met with the cautious refrain—Modi-Jinping Bhai Bhai?

ast year. India-Maldives relations appeared to be at their ident Mohamed Muizzu's initial pro-China stance, coupled with the lingering echoes of the "India Out" campaign, raised concerns in New Delhi about the future of its traditionally warm ties with Malé. However, the trajectory of 2025 suggests a marked improvement in bilateral relations, buoyed by mutual strategic necessities and historical interdependencies.

The Maldives' former President Mohamed Nasheed, in a recent discussion at the Raisina Dialogue, succinctly captured the island nation's predicament when he said that the safety, security and prosperity of the Maldives depended on keeping good relations with India. His remarks underscored an enduring reality that New Delhi remains Malé's most reliable partner in

times of crisis Muizzu's early days in office were marked by tensions with India. His administration distanced itself from the country's long-standing security partnership with New Delhi, seeking to reduce the Indian military's footprint in the archipelago. This shift was widely perceived as a tilt towards China, which has been increasing its influence in the Maldives through infrastructure investments albeit at the cost of significant debt distress.

Yet, the need for developmental assistance, economic stability, and crisis management brought New Delhi back into the picture. The Maldives' Foreign Minister MoosaZameer had explicitly distanced his government from the 'India Out' campaign that had been championed by former President Abdulla Yameen. This was reinforced by Defence Minister Ghassan Maumoon's visit to India, where he acknowledged New Delhi's consist-

sponder in times of crisis.

For decades, India has extended military, economic and humanitarian aid to the Maldives, irrespective of the political dispensation in Malé. When mercenaries attempted a coup in 1988, India swiftly launched 'Operation Cactus' to reinstate the legitimate government. Following the 2004 Asian tsunami, India provided substantial relief aid. In 2014, under Yameen's rule, New Delhi had dispatched potable water when Malé's only desalination plant suffered a fire accident this, despite his anti-India stance. More recently, during the COVID-19 pandemic, India delivered medical supplies and extended \$250 million in financial aid to the Maldives when tourism, its economic lifeline,

These instances illustrate why Maldivian leaders eventually gravitate back towards India. A recent Memorandum of Understanding (MoU) between the two nations will facilitate further High Impact Community Development Projects (HICDPs), reinforcing India's longterm role in Maldivian development.

Beyond economic and developmental cooperation, defence relations are also stabilizing. India has agreed to replace its military personnel operating aerial platforms in the Maldives with civilian experts. Simultaneously, India has reaffirmed its commitment to strengthening the Maldives' defence capabilities, announcing a \$4 million grant for supplying essential equipfence Force (MNDF).

The timing of these developments is crucial, given China's continued attempts to entrench itself in the Indian Ocean region. During a recent visit to Malé, Chinese Foreign Minister Wang Yi emphasized fasttracking key infrastructure projects, particularly in housing and road construction. His visit, while symbolic of Beijing's growing influence, lacked a strategic security component, indicating that Malé is maintaining some distance when it comes to deeper military engagement with China.

Unlike its assertive stance against Chinese encroachments elsewhere in South Asia, India has opted for quiet diplomacy and strategic patience in dealing with the Maldives. By ensuring a smooth transition in the defence arrangement and continuing its developmental initiatives, India has reinforced its indispensable role without appearing overbearing.

This approach seems to be yielding results. The recalibration of ties, characterized by renewed defence cooperation and economic collaboration, suggests that the worst of last year's turbulence is behind them. If recent months are any indication, the Maldives understands the perils of over-reliance on Beijing and the value of sustaining a cooperative relationship with India. For India, patience and continued engagement appear to be the most effective strategies in ensuring that its smallest maritime neighbour remains within its strategic fold.

fresh wave of violence in Mathey control most of the land in the the deep fault lines in the state's ethnic landscape. Clashes between the Hmar and Zomi communities erupted just two days after their leaders signed a peace agreement, underscoring the futility of diplomatic efforts in the face of long-standing animosities. The unrest, which left one dead and several injured, is only the latest flare-up in a state that has been in turmoil since May 2023, when fighting between the Kuki-Zo tribes and the dominant Meitei community plunged Manipur into chaos. Despite government interventions, curfews, and appeals for calm, violence continues to simmer.

The immediate spark for the recent clashes was the attempt by a Zomi group to hoist their community flag. Hmar groups opposed the move, arguing that it would deepen ethnic divisions rather than promote unity. The disagreement quickly turned into street battles, with mobs pelting stones, torching vehicles, and firing shots. The situation had already been volatile following an earlier attack on Hmar Inpui general secretary Richard Hmar by suspected Zomi assailants, which had led to the imposition of a curfew. That restrictions and a peace deal failed to prevent further bloodshed speaks to the fragility of the region's security apparatus and the deep-seated mistrust among its communities.

A state of barely three million people, the divide between the valley-dwelling Meiteis who dominate the political and economic landscape and the hill tribes (comprising the Kuki-Zo, Zomi and Hmar groups) has caused decades of conflict in Manipur. While the Meiteis constitute around 53 percent of the population,

nipur's Churachandpur dis-trict has once again exposed Imphal Valley and have historically held disproportionate political power. The hill tribes, who together make up about 40 percent of the population, have resented their exclusion and have often agitated for greater autonomy. The latest bout of violence stems from the broader battle for

ethnic and territorial assertion. The Kukis and Zomis, despite their shared ancestry, have had a strained relationship, especially over representation in local governance. The demand for a separate

administrative region for the Kuki-Zo people has deepened tensions, as different subgroups within this broad identity struggle for political dominance. The Hmar community, traditionally allied with the Kukis, has found itself increasingly at odds with the Zomis over influence in Churachandpur.

MANIPUR

This internal fragmentation among tribal groups comes against the backdrop of a larger, more destructive war between the Kuki-Zo groups and the Meiteis. Since May 2023, over 250 people have been killed and thousands displaced in a paralyzing ethnic conflict. The violence was triggered by the Meiteis' demand for Scheduled Tribe status. which would have given them greater access to land and government benefits, a move fiercely opposed by the Kuki-Zo tribes.

Manipur's governance has collapsed under the weight of these crises. The resignation of Chief Minister N Biren Singh last month and the subsequent imposition of President's Rule have left the state without an elected government.

Why Is Crimea Coveted by Both Russia and Ukraine?

Russia's seizure of the Crimean Peninsula from Ukraine exactly 11 years ago on March 18, 2014, was quick and bloodless, but it sent Moscow's relations with the West into a downward spiral unseen since the Cold War.

It also paved the way for Russia's full-scale invasion of Ukraine in 2022, during which Moscow annexed more land from the war-torn country. A look at the diamond-shaped peninsula in the Black Sea, coveted by both Russia and Ukraine for its naval bases and beaches:

Why is Crimea important?

Crimea's unique location makes it a strategically important asset, and Russia has spent centuries fighting for it. Crimea was home to Turkic-speaking Tatars when the Russian empire first annexed it in the 18th century. It briefly regained independence as a Tatar republic two centuries later before being swallowed by the Soviet Union.

In 1944, Soviet dictator Josef Stalin deported nearly 200,000 Tatars, or about a third of Crimea's population, to Central Asia, 3,200 kilometres to the east. Stalin had accused them of collaborating with Nazi Germany — a claim widely dismissed by historians. An estimated half of them died in the next 18 months of hunger and harsh conditions.

Soviet leader Nikita Khrushchev transferred the peninsula from Russia to Ukraine in 1954, when both were part of the USSR, to commemorate the 300th anniversary of the unification of Moscow and Kyiv. In 1991, when the Soviet Union collapsed, the peninsula became part of newly independent Ukraine.

Russia kept a foot in the door, however: Its Black Sea Fleet had a base in the city of Sevastopol, and Crimea—as part of Ukraine—continued to host it

tinued to host it.

Sevastopol also was a preferred holiday destination for Nicholas II, the last Russian czar. The southern town of Yalta was a prime holiday destination in Soviet times, with many sanatoriums there. It drew



worldwide renown when Stalin, US President Franklin D. Roosevelt and British Prime Minister Winston Churchill met there in 1945 to discuss the fate of Germany and Europe after World War II.

For Kyiv, Crimea had been a strategic asset, too. By the time Russia annexed it in 2014, it had been a part of Ukraine for 60 years and had become part of the country's identity.

What happened after annexation of Crimea?

Putin has called Crimea "a sacred place," and has prosecuted those who publicly argue it is part of Ukraine. Repressions against the Crimean Tatars continued under Putin, despite Moscow's denials of discrimination. They strongly opposed the annexation, and an estimated 30,000 of them fled the penin-

sula between 2014 and 2021.
Ukrainian President Volodymyr
Zelenskyy vowed to retake it and
said that Russia "won't be able to
steal" the peninsula.

Russia's relations with the West plummeted to new lows. The United States, the European Union and other countries-imposed sanctions on Moscow and its officials.

Weeks after the annexation, fighting broke out in eastern Ukraine between pro-Kremlin militias and Kyiv's forces. Moscow threw its weight behind the insurgents, even though the Kremlin denied supporting them with troops and weapons.

Russian hard-liners later criticised Putin for failing to capture all of Ukraine that year, arguing it was easily possible at a time when the government in Kyiv was in disarray and its military in shambles.

The fighting in eastern Ukraine continued, on and off, until February 2022, when Putin recognised the two war-torn Ukrainian regions of Donetsk and Luhansk as independent states and several days later launched a full-scale invasion of Ukraine.

What role does Crimea play in Russia's war in Ukraine?

In its assault on Ukraine, Moscow deployed troops and weapons to Crimea, allowing Russian forces to quickly seize large parts of southern Ukraine in the first weeks of the

Before the invasion, Zelenskyy focused on diplomatic efforts to get Crimea back, but after Russian troops rolled across the border, Kyiv started publicly contemplating re-

taking the peninsula by force.

The peninsula soon became a battleground, with Ukraine launching drone attacks and bombing it to try to dislodge Moscow's hold on the territory. The attacks targeted the Russian Black Sea Fleet there, as well as ammunition depots, air fields and Putin's prized asset — the Kerch Bridge linking Crimea to Russia, which was struck in October 2022 and again in July 2023. -AP

Why US Targeted Houthi Rebels?

The United States under President Donald Trump has launched a new campaign of intense airstrikes targeting Yemen's Houthi rebels.

The recent strikes killed at least 53 people, including children, and wounded others. The campaign is likely to continue, part of a wider pressure campaign by Trump now targeting the Houthis' main benefactor, Iran, as well.

How it all started

The Houthi rebels attacked over 100 merchant vessels with missiles and drones, sinking two vessels and killing four sailors, from November 2023 until January this year. Their leadership described the attacks as aiming to end the Israeli war against Hamas in the Gaza Strip.

The campaign also greatly raised the Houthis' profile in the wider Arab world and tamped down on public criticism against their human rights abuses and crackdowns on dissent and aid workers.

Why US targeted Houthis before?

Under former President Joe Biden, the US and the United Kingdom began a series of airstrikes against the Houthis starting in January 2024. A December report by The International Institute for Strategic Studies said the US and its partners struck the Houthis over 260 times up to that point.

US military officials during that period acknowledged having a farwider target list for possible strikes.

While the Biden administration didn't go too far into explaining its targeting, analysts believe officials largely were trying to avoid civilian casualties and not rekindle Yemen's stalemated war, which pits the Houthis and their allies against the country's exiled government and their local and international allies, such as Saudi Arabia and the United Arab Emirates.

The Trump administration, however, appears willing to go after more targets, based on the weekend's strikes and public remarks



made by officials.

"We're doing the entire world a favour by getting rid of these guys and their ability to strike global shipping," US Secretary of State Marco Rubio told CBS News' "Face The Nation" on Sunday. "That's the mission here, and it will continue

until that's carried out."
Rubio added: "Some of the key people involved in those missile launches are no longer with us, and I can tell you that some of the facilities that they used are no longer existing, and that will continue."

Impact on wider Mideast?

In two words: More attacks. The Houthis said last week they'll again target "Israeli" ships travelling through Mideast waterways like the Gulf of Aden and the Red Sea, because of Israel's blocking of aid to the Gaza Strip. No rebel attack targeting commercial shipping has been reported as of Monday

morning.

However, the new US campaign likely could inspire Houthi attacks at sea or on land beyond American warships. The rebels previously targeted oil infrastructure in Saudi Arabia and the UAE, two countries deeply involved in Yemen's war since 2015.

Gulf Arab countries "will distance themselves from ongoing hostilities but now face threats to their major oil infrastructure. The Houthis will want to hit President Donald Trump where it hurts, oil

prices."

Meanwhile, the Houthis likely

will expand their possible targets for ship attacks, meaning shippers will continue to stay out of the region, said Jakob P Larsen, the head of maritime security for BIMCO, the largest international association representing shipowners.

The stand of Iranians?

Iran long has armed the Houthis, who are members of Islam's minority Shiite Zaydi sect, which ruled Yemen for 1,000 years until 1962. Tehran routinely denies arming the rebels, despite physical evidence, numerous seizures and experts tying the weapons back to Iran.

That's likely because Tehran wants to avoid sanctions for violating a United Nations arms embargo on the Houthis.

The Houthis now form the strongest group within Iran's self-described "Axis of Resistance." Others like Lebanon's Hezbollah and the Palestinian militant group Hamas have been decimated by Israel after the October 7, 2023 attack by Hamas that sparked Israel's war of attrition in the Gaza Strip.

Allied Shiite militias in Iraq largely have kept their heads down since the US launched retaliatory attacks last year over a drone attack that killed three American troops and injured at least 34 others at a military base in Jordan.

While Iranian state television aired footage of civilian casualties from the weekend strikes in Yemen, top political leaders stayed away from suggestion Tehran itself would get involved in the fight. -AP



New Delhi: The BCCI on Thursday announced a cash reward of Rs 58 crore for the Indian cricket team that won the ICC Champions Trophy earlier this month in Dubai.

The Rohit Sharma-led India defeated New Zealand by four wickets in the final to grab their third Champions Trophy title.

The financial windfall will cover the players, coaching and support staff and members of the men's selection committee headed by Ajit Agarkar. The Board did not give a breakup of the reward in its statement.

"Winning back-to-back ICC titles is special and this reward recognises Team India's dedication and excellence on the global stage," said BCCI president Roger Binny in a release.

Binny said the Champions Trophy triumph is a testament to India's strong cricketing eco-system.

"This was also our second ICC Trophy in 2025, following the ICC U19 Women's World Cup triumph and it highlights the strong cricketing ecosystem in place in our country," he

In fact, it was India's third ICC trophy in the last eight months as they had won the last year's T20 World Cup, beating South Africa in the final.

BCCI secretary Devajit Saikia said the victory justified India's top-ranking in white ball formats.

"Their dominance in world cricket is a result of vears of hard work and strategic execution. This victory has justified India's top ranking in white-ball

cricket, and we are sure the team will continue to excel in the years to come," said

Saikia.

India dominated the Champions Trophy from the start, registering four commanding victories en route to the final.

India began their campaign with a solid six-wicket win over Bangladesh, then secured a convincing six-wicket triumph against Pakistan.

They continued their momentum with a 44-run victory over New Zealand before overcoming Australia by four wickets in the semifinal.

"The dedication and commitment shown by the players have set a new benchmark, and we are confident that Indian cricket will keep raising the bar on the global stage," Saikia

WTC 2025-27 Cycle

Bonus point system to be pondered over

New Delhi: The International Cricket Council (ICC) is likely to ponder over a new bonus points system during its board meeting in April which could give more weightage to bigger victories, especially overseas, during the next World Test Championship cycle.

The 2025-27 WTC cycle will begin with India's fivematch away Test series against England in June.

As per the prevailing rules, the team winning by the smallest margin or by an innings gets 12 points, six points for a tie and four points for a draw.

But this could see a change as the global governing body, as per a report in Telegraph, is considering awarding bonus points for innings victories or for a win above a certain big margin such as 100 runs.

"In fact, issues such as

giving bonus points for innings wins etc has been in continuous discussion from the beginning of the WTC, as many teams felt that due weight is not getting for wins against big teams," a source close to the development told PTI.

"So, such topics have been a part of discussions, and this could again come up for deliberations," he said.

But this could now change as the ICC might bring in bonus points for landslide wins, and extra points could be given to victories over frontline teams such as India, Australia and England, as per their rankings.

"Yeah, it's a good move if it really happens. The teams will be more motivated to go for results, as we could see some exciting games," a former India player told PTI on condition of anonymity.

The ICC is also mulling giving extra points for wins away from home. "Yeah, it will be a motivating factor for, you know, those 'smaller' teams, Look, when New Zealand beat India last year, it was a historic win for them as not many teams came here and beat us. "While winning away from home in itself can act as a motivating factor, now the teams will have that carrot in front of them extra points, if it really happens," he added.

Other than this, the ICC board meeting might also consider the two-tier Test system.

"It needs a lot of discussion before putting into practice as some teams might feel deprived of regular chances to play against strong teams like India or Australia.

Parag (23) will have the distinction of being one of the youngest captains in IPL. Virat Kohli holds the top position in that list having captained Royal Challengers Bengaluru as a 22-year-old.

"Rajasthan Royals have announced that Riyan Parthe first three matches of IPL 2025," RR said in a statement.

"The young all-rounder will take charge in the

opening fixture against Sunrisers Hyderabad on March 23, followed by home encounters against defending champions Kolkata Knight Riders on March 26 and five-time champions Chennai Super Kings on March 30," the franchise stated.

Samson, an integral part of the Royals set-up, will remain a key contributor with the bat till he gets cleared for wicket-keeping and fielding. He will return as captain once fully fit and could be used as an impact substitute in these three games.
