## **Promotion Of Anti-India Ideology** NIA raids 11 places in Tamil Nadu

New Delhi: The NIA conducted searches at multiple locations across Tamil Nadu on Tuesday as part of its probe into an "anti-election campaign" promoted by the Hizb-ut-Tahrir, a pan-Islamist organisation seeking to establish Islamic rule in the country, an official statement said.

It said officials of the National Investigation Agency (NIA) raided the houses of 11 suspects in Chennai, Tambaram and Kanyakumari districts, and seized incriminating materials, including digital devices, unaccounted cash and literature belonging to the Hizb-ut-Tahrir.

The NIA said the searches were conducted as part of a case related to causing and creating disaffection through various social media handles and campaigning against the exercise of the electoral franchise, which is deemed by the Hizb-ut-Tahrir as un-Islamic or 'Haram'.

The Hizb-ut-Tahrir is a fundamentalist organisation engaged in instigating its followers to overthrow the lawfully established

democratic government through divisive actions, according to the anti-terror

> Hameed Hussain, a key conspirator in the case, had collaborated with five other accused to hold secret meetings to promote the anti-India ideology of the Hizb-ut-Tahrir, it said.

> "NIA investigations in the case so far have revealed that the accused, along with several groups of people, had carried out campaigns throughout Tamil Nadu to establish Khilafah or Islamic rule in India.'

## Israel kills top Hezb commander

Beirut: The Israeli military says it has killed a top commander with Hezbollah's missile and rocket unit in a strike in Beirut.

Military officials said Ibrahim Kobeisi, who they said was responsible for launches towards Israel, was killed Tuesday. The military said "other key commanders" were with Kobeisi at the time of the strike, but officials did not say whether any of the others were killed or wounded.

# Modi calls for ceasefire in West Asia, dialogue

New York: Prime Minister Narendra Modi has called for a ceasefire in West Asia, the release of hostages and a return to the path of dialogue and diplomacy as he stressed that only a two-state solution will deliver enduring peace and stability in the volatile region.

Modi expressed deep concern at the humanitarian crisis unfolding in Gaza and the deteriorating security situation in the region during his meeting with Palestinian President Mahmoud Abbas on the margins of the Summit of the Future here on Monday.

He reaffirmed India's unwavering support to the people of Palestine, including continued humanitarian assistance, the Ministry of External Affairs said in a statement.

Prime Minister Modi "reiterated India's timetested principled position on the Israel-Palestine issue, and called for a ceasefire, the release of hostages and return to the path of dialogue and diplomacy," it said.

He stressed that only a two-state solution will de-



liver enduring peace and stability in the region.

Recalling that India was one of the first countries to recognize Palestine, he conveyed India's continued support for Palestine's membership of the UN.

"The two leaders held constructive discussion on various facets of India-Palestine hilateral relations, including India's support to Palestine at the United Nations and ongoing assistance and support to Palestine in the field of education, health, and other capacity building efforts," the statement said.

Both leaders reaffirmed their commitment to further deepen India-Palestine bilateral relations, it added.

Briefing reporters Monday evening as Modi wrapped up his three-day visit to the US, Foreign Secretary Vikram Misri said that President Abbas

thanked Prime Minister Modi for the assistance that India had provided, including on political issues, and "hoped that India would continue to play its role for bringing peace in the region."

Describing the meeting with Abbas as "very good", Misri said it allowed the Palestinian leader to "appreciate the stance that India has taken in an overall sense on the Palestine

He added that Abbas "did explicitly state that he was very appreciative of India's support, not just for humanitarian assistance,

# CID to investigate killing, family wants SIT probe

Mumbai: Maharashtra's Crime Investigation Department (CID) will conduct a probe into the death of Badlapur sexual assault case accused Akshay Shinde, officers said on

A team of forensic science experts on Tuesday examined the police vehicle, in which Shinde was allegedly shot by a cop on Monday evening, they said.

Shinde, 24, was accused of sexually assaulting two minor girls at a school in Badlapur town of Thane district.

A contractual sweeper at the school in Badlapur, Shinde was arrested on August 17, five days after he allegedly sexually abused the two girls in the school toilet.

He was killed near Mum-

According to the J.J. hospital authorities, the accused had internal bleeding in head after a bullet hit the head.

The post-mortem was done according to the guidelines of **National Human Rights** Commission. A team of five doctors conducted autopsy and the body and reports are handed over to Mumbra Police around 5 pm.

### Father moves HC, seeks SIT probe

The father of Akshav Shinde has moved the Bombay High Court seeking probe by a special investigation team into the death. Anna Shinde, in his petition filed through advocate Amit Katarnaware, alleged that his son was killed in a "fake encounter".

An SIT should be formed to probe the killing and the high court should monitor the investigation, the petition

"The accused was in custody when he was shot dead in a fake encounter. This is a cold-blooded murder by criminals in uniforms," advocate Katarnaware said. The petition will be heard by a division bench of Justices Revati Mohite Dere and Prithviraj Chavan on Wednesday.

## HC slams SRA over Bhandup project

Mumbai: The Bombay High court recently directed the Slum Redevelopment Authority (SRA) to complete the survey of eligible persons on land at Kanjur village Bhandup West within four weeks for a rehabilitation project.

The court further directed the Deputy Commission-

er of Police (Operations), Bhandup, to provide adequate police protection to the SRA. "The police authorities must understand that the orders for the survey have been given by the Additional Collector, AGRC, and finally, this Court. The officials present, virtually pleaded helplessness. The statutory authority, which

has statutory powers, can-

not plead such helplessness," the court observed.

In this matter, we find that IIVK Constructions LLP & ANR, the Petitioners, from 2017 onwards, have been pursuing the survey of a property, which is the subject matter of this Petition. Authorities like SRA have accepted the survey fees, but no survey has been undertaken.

## Vodafone Idea to pay senior citizen for service deficiency

Mumbai: A consumer commission here has directed Vodafone Idea to pay Rs 50,000 in compensation to a senior citizen for mental harassment following the abrupt disconnection of his mobile services and not letting him use international roaming pack data.

The District Consumer Disputes Redressal Commission (Central Mumbai) held the mobile service provider guilty of service deficiency for causing "inconvenience, mental, and financial harassment and agony" in an order passed on Monday.

The complainant, a resident of Mumbai, had opted for an international roaming pack (I- RoamFree) on his mobile number for 28 days from May 2, 2019. In addition to unlimited incoming and outgoing calls, the plan provided 5.2 GB of internet data

The complainant started using the plan after visiting Kenya on May 2, 2019. He consumed about 75% of the data (out of 5.2 GB).

He used the data during his visit to Victoria in Zimbabwe for two days believing that the region was covered under the pack. He claimed to have not received any message from the service provider informing him that the Victoria Falls area is not covered under the plan.



The complainant also didn't receive any cautionary message informing him about a roaming rate schedule which kicks in whenever one enters a new country.

After the consumer used a nominal 124 MB data, his mobile phone service was abruptly stopped by Vodafone Idea sans any intimation mail or message, the complaint stated. The service provider unreasonably imposed a heavy cost of Rs

The complainant re-

turned to Kenya within 2

days and requested the company to restore his services and allow him to use the remaining data from the 5 GB pack, but the service provider rejected his request and asked him to pay around Rs 60,000 to-

The complainant raised the matter with the customer relationship cell, nodal officers, and the Telecom Regulatory Authority of India (TRAI), among others, but failed to get a response. After being out of

service for nearly 40 days,

the complainant was com-

pelled to pay a bill of Rs

86,290, including GST. The complainant alleged wrongful loss due to service deficiency on the part of Vodafone Idea by illegally disconnecting the network

services. The mobile service provider argued that the customer knew only 77 countries were listed in the discounted rate plan. For the rest, standard international charges are applicable for usage under the I-RoamFree Pack. As Zimbabwe was not

among the 77 countries, the complainant was billed at the standard rate, the company said. The commission held

that the complainant was entitled to avail of the benefit of I -RoamFree Pack after returning to Kenya which he had availed for Rs 5,999 for 28 days and had not fully exhausted the data.

'We hold that the opposite party was deficient in the service to the extent of not informing the complainant in advance about the applicable roaming charges, arbitrarily letting him use the roaming services up to Rs 72,419, forcing him to clear the same and disconnecting his services abruptly and not restoring it even at Kenya,' the commission observed.

The complainant, who is a senior citizen, was deprived of the services even in the country (Kenya) to which it was applicable caused inconvenience, mental, and financial harassment and agony for which he is entitled to be compensated and directed the mobile service provider to pay Rs 50,000 and Rs 10,00 towards the cost of filing the complaint.

Mumbai: The MMRDA presented a revised draft development plan for the Backbay Reclamation Scheme considering slum rehabilitation and metro projects with the special focus on natural features such as beaches and mangroves.

The revised plan was presented during MMRDA's bearers gathered at the 158th meeting chaired by Nagpur airport to give Chief Minister Eknath Shinde on Tuesday.

The revised draft plan has proposed a dedicated marina for tourism which will include ports for small boats and yachts to boost tourism

The plan for the Backbay Reclamation Scheme (Blocks III to VI), formulated under section 26 of the Maharashtra Regional and Town Planconnectivity projects, such as the Backbay Reclamation and the access-controlled highway, are critical to shaping the future of the Mumbai Metropolitan Region. - Sanjay Mukherjee,

The MMRDA has proposed the expansion of the new legislative building and the introduction of link roads, including proposed connectivity between Netaji Subhash Chandra Marg and Jagannath Bhosle Marg.

proval has been granted for the preliminary alignment report of an access-controlled highway connecting Kalyan, Dombivli, Ulhasnagar, Ambernath, and Badlapur with Mumbai and Navi Mumbai, as per the release. The proposed highway be-

tween the Virar-Alibaug corridor and Badlapur is estimated to cost Rs 10,833 crore which will cut travel time between these cities and Mumbai to 60 minutes and Navi Mumbai to 30 minutes. It will also provide direct

connectivity to the upcoming Navi Mumbai International Airport and NAINA, while also reducing congestion in Thane and nearby highways.

"The project will feature an eight-lane divided carriageway with service lanes. ensuring a design speed of 80 km/hour. Major interchanges are proposed with key roadways, including the Mumbai-Vadodara Expressway (JNPT spur), Katai-Badlapur and the Kalyan Ring Road," the release highlighted.

The authority also approved the allotment of a commercial plot at BKC (Bandra Kurla Complex) to construct a new administrative office for the National Payments Corporation of India (NPCI).

The MMRDA also gave administrative approval for the formation of a dedicated "Project Implementation Unit" and a "Business Development Cell" to execute the Mumbai Metropolitan Region's economic master

## Police pumped three bullets in 'self-defense', netas want probe

Thane: As the chilling details of the alleged encounter of Badlapur sexual assault accused Akshay Shinde coming to the fore, doubt turning into reality that deceased was shot to kill and not to defense self.

Sanjay Shinde, the police inspector who shot dead Akshay Shinde, has reportedly worked with suspended former 'encounter specialist' Pradeep Sharma in the past. Akshay Shinde, 24, who was accused of sexually assaulting two minor girls at a school in Badlapur, was killed in 'encounter' on Monday has drawn sharp criticism from the rival political parties.

Deep-diving details have found that Sanjay Shinde had previously worked with the anti-extortion cell of the Thane Police Crime Branch, then headed by Pradeep Sharma. He was part of the team which arrested gangster Dawood Ibrahim's brother Iqbal Kaskar. Sharma earned a reputation as an 'encounter specialist' in the Mumbai Police, credited with neutralising more than 100 criminals throughout his career. Sanjay Shinde faced suspension and an inquiry after murder accused Vijay Palande escaped police custody. In 2014, Shinde was

A contractual sweeper at the school in Badlapur, Akshay Shinde was arrested on August 17, five days after he allegedly sexually abused the two girls in the school toilet.

#### Attempt to murder

A senior police officer said that Crime Investigation Department (CID) will investigate the incident as it is related to death in police custody. Officials said that a team of forensic experts examined the police vehicle in which Shinde opened fire on the police to retaliate, a policeman fired shots in self-defense on Monday evening.

"On Monday evening,

while Akshay Shinde was being taken to a police vehicle in connection with the investigation of another crime reported by his wife, he grabbed a policeman's revolver and opened fire," the officer said, adding that a case of attempt to murder has been registered against

Notably, Shinde was killed near Mumbra Bypass in Thane while he was being ferried in a police vehicle as part of a probe into a case registered against him on the complaint of his former wife.

## Sena workers celebrate in Thane

Thane: Shiv Sena workers here on Saturday burst firecrackers and distributed sweets to celebrate the death of the accused in the Badlapur sexual assault case in an alleged police encounter.

Similar celebration was also seen in Pune. They also congratulated the Maharashtra government led by party chief Eknath Shinde.

Pramod Bhangire, Pune city chief of the Shiv Sena, said they celebrated by bursting firecrackers and distributing `pedha' sweets outside the party office to boost the morale of state police.

"We congratulate the state Government and Maharashtra police. Whatever action the police have taken, it was excellent," he said. Bhangire also criticised the Opposition for questioning the alleged encounter. "Instead of criticising and casting doubt on the incident, Opposition should support the police and help boost their mo-

rale," he said. In Thane district, local Shiv Sena leaders led by Thane MP Naresh Mhaske visited `Shakti Sthal', the memorial of late Sena leader -- and chief minister Shinde's political mentor -- Anand Dighe, and offered floral tributes. Party workers also burst crackers.

At Dombivli, a number of women activists were seen celebrating, while hoardings featuring Eknath Shinde were put up in many places. Sena workers also distributed sweets to police personnel.

In Badlapur, Shiv Sena leader Mahesh Gaikwad handed over a cheque of Rs 51,000 to the police department.

## Govt protecting school management: Raut

Mumbai: The accused in the minor girls' sexual assault case was killed in an encounter as the Eknath Shinde government was trying to shield the pro-BJP Badlapur school management, Shiv Sena (UBT) MP Sanjay Raut alleged on Tuesday.

Hitting back, the ruling Shiv Sena slammed the Uddhav Thackeray-led faction for questioning the bravery of police officers.

Though the encounter was suspicious, there is no need to show sympathy for such a person (Akshay Shinde who is accused of sexually assaulting two minor girls in a school), said Shiv Sena (UBT) MP Sanjay Raut. "This murder or encounter that has taken place was done to save the main accused (the school management)," Raut told reporters.

Questioning the circumstances of Shinde's death, Raut asked, "How convincing is it that a janitor snatches a gun from a policeman and fires a locked weapon? This is a basic question". Chief Minister Eknath Shinde and Home Minister Devday said that police had fired in self-defence.

Raut suggested that Akshay Shinde was the main piece of evidence that was destroyed given that CM Shinde and Fadnavis wanted to shield the school management.

"This is a big conspiracy. Those who are being saved enjoy the patronage of the chief minister and deputy chief minister,' Raut alleged.

He claimed the CCTV footage of the school in Badlapur where the two minor girls were sexually assaulted has gone missing. "The school is related to BJP and yesterday's story (Akshay Shinde's killing) was done to save them," Raut claimed.

Shiv Sena (UBT) leader and former minister Aaditya Thackeray asked where are the trustees of the Badlapur school and why are they being protected bу government.

"It is understood that the trustees of the school are affiliated to the BJP who are being protected," Thackeray claimed.

## Parents cry foul play

Thane: The family members of Badlapur sexual assault case accused Akshay Shinde, who has been shot dead by police, have termed the incident as an "encounter" and sought a probe into his killing.

His father Anna Shinde, however, said an inquiry should be conducted into his son's killing.

Speaking to reporters outside the hospital on Monday, Akshay Shinde's mother and uncle alleged it was a conspiracy by police and management of the Badlapur school.

They claimed Akshay Shinde had told his kin that he was being beaten up police in custody and he also sent a chit seeking money.

"My son was afraid of bursting crackers and crossing the road. How can he shoot at policemen?" Akshay Shinde's mother asked.

"The police have killed our child. The school management must also be probed. The police got him to write something but we don't know what it is. This should be investigated," the kin further said.

## to police after post-mortem Mumbai: The body of Ak-

shay Shinde, the accused in the Badlapur sexual assault case, was on Tuesday handed over to police after post-mortem at the JJ Hospital in south Mumbai, an official said.

Shinde was killed near Mumbra bypass in Thane on Monday evening when he allegedly snatched the gun of a policeman while being ferried in a police vehicle as part of a probe into a case against him on the complaint of his former wife, the official said.

The body of the 24-yearold school sweeper was transferred from Kalwa Civic Hospital in Thane to the state-run JJ Hospital on Tuesday morning, for a post-mortem.

"The post-mortem was done according to the guidelines of National Human Rights Commission by a team of five doctors The body and reports were handed over to Mumbra police around 5 pm on Tuesday," a hospital official said.

Hospital dean Dr Pallavi Saple said the government guidelines to record the video of the post-mortem were followed.

## **Brilliant future ahead** for manufacturing

New Delhi: A series of measures to improve ease of doing business, zero tolerance for corruption and the focused effort on emerging sectors like electronics have helped promote 'Make In India' and boost both domestic and foreign investments in the country, Commerce and Industry Minister Piyush Goyal said on Tuesday.

"We have achieved great success and a brilliant future is ahead for manufacturing in the country as the 'Make in India' programme is celebrating its 10 years," he said.

"We are seeing very big investment plans on the anvil which will create millions of jobs and expand our manufacturing contribution to the economy," Goyal told PTI.

Recalling the journey of the initiative, the minister said that the Modi-government started with "very' tough times as the mood of investments both domestically and internationally was "very" low in 2014 and businesses were not sure about the future.

Internationally, the image of the country was down and the country was categorised as a "fragile five" economy, he said adding it took this government some time to earn the trust of investors.

"But that happened very quickly under Prime Minister Narendra Modi because he took very bold decisions whether it is one nation one tax - GST, whether it is IBC (Insolvency and Bankruptcy

Code), or putting in place a transparent process for auction of mines," he said.

The government also gave investors stable and predictable policies, with a commitment not to do retrospective amendments. the minister said.

Due to measures like digitisation and simplifying procedures, India's rank in the ease of doing business climbed 14 rungs to 63 among 190 countries.

"Zero tolerance for corruption, and the focused effort on emerging sectors for promoting Make in India ignited the investments both domestically and internationally," Goyal said.

"And 10 years later, we are both redeemed by the results and excited about the future. In many areas, we have seen significant progress like in mobiles, we are now world's second

largest manufacturers with production going on from only two factories to 200 in this field," he added.

Besides, sectors like steel, and cement where demand was generated because of a significant ramp-up in infrastructure funding, India witnessed massive investments and growth under the Make in India programme.

The government's initiatives in other segments such as textiles, ceramics, toys, plastics, chemicals, and pharma, have resulted in an increase in domestic capacities which have met the needs of India as well as helped boost the country's exports which reached an all-time high of USD 778 billion in 2023-24.

The minister expressed confidence that with the increasing momentum

seen under the Make in India programme, "We believe that the share of manufacturing will also start increasing in the coming years".

The steps taken to boost manufacturing and attract investments include easing foreign direct norms in a number of sectors such as space, coal mining, e-commerce, pharma, civil aviation, contract manufacturing, and digital media.

In 2020, the government rolled out the Production Linked Incentive (PLI) Schemes for a number of sectors to provide financial incentives to enhance domestic manufacturing. The scheme has attracted substantial investments in key sectors such as electronics, pharmaceuticals.

The other measures include national logistics policy, national single window system, Jan Vishwas (Amendment of Provisions) and law to decriminalize 183 provisions in 42 legislations.

## Rahul asks SEBI name big profiteering players

New Delhi: Congress leader Rahul Gandhi on Tuesday said 90 per cent of small investors have lost Rs 1.8 lakh crore in Futures and Option (F&O) trading in three years and asked the SEBI to reveal the names of the "so called big players" profiteering at their expense.

More than 91 per cent, or 73 lakh, individual traders lost money in the F&O segment in FY24 with an average net loss of Rs 1.2 lakh per person, a study conducted by markets regulator SEBI revealed. Further, 93 per cent of over 1 crore individual F&O traders incurred average losses of about Rs 2 lakh per trader during the three years from **-PTI** ⋮ FY22 to FY24.

In a letter addressed to Prime Minister Narendra Modi, the state government and the Deendaval Port Authority (DPA), the ITF has called for action to help the estimated 2,500 workers who have been left destitute.

"This shocking act, justified by what our affiliate believes to be spurious claims of security concerns, has left thousands of people homeless," said ITF General Secretary Stephen Cotton. "We are deeply concerned about the wellbeing of the displaced residents, many of whom have been integral to the operation of what is India's largest public sector port. We believe that is a basic duty of the Deendayal Port Authority and the Indian government fundamental human rights," he said.

ITF said its affiliate, Shri Kutch General Mazdoor Sangh (SKGMS), is closely monitoring the situation on the ground near Kandla Port as it supports them to ensure restitution for the workers who have lost their homes.

Among its demands, the ITF is calling on the government of India to provide compensation and resettlement for displaced workers, in accordance with Indian law; DPA and local government to stop all plans for further demolitions of worker settlements and instead develop a plan for the rehabilitation of workers.

## **BYJU's default confirmed** by Delaware SC

New Delhi: The Delaware Supreme Court ruling has affirmed that edtech firm BYJU's has defaulted on Term Loan B.

BYJU's US-based lenders on Tuesday said the Delaware Supreme Court affirmed the previous ruling by Delaware Court of Chancery's and said an event of default had occurred under the credit agreement and entitled BYJU's lenders and their administrative agent, GLAS Trust for action

against the company. BYJU's, from US-based lenders, had raised USD 1.2 billion Term Loan B (TLB) -- a loan which is issued by institutional investors through its holding company Byju's Alpha. The lenders through their administrative agent GLAS Trust approached Delaware Court of Chancery alleged default in the payments under the loan agreement and sought early payment of the USD 1.2 billion TLB. Think and Learn, which owns BYJU's brand, had contested the claim but the Delaware Court of Chancery ruled in favour of the lenders

According to a statement of The steering committee of the ad hoc group of term loan lenders, BYJU'S founder and CEO Byju Raveendran

and his brother Riju Ravindran have voluntarily conceded that BYJU's was in default of credit agreement by October 2022.

"We are gratified that the Delaware Supreme Court decisively affirmed what we have known all along: BYJU's breached and defaulted on the credit agreement it knowingly and willingly entered into.

"Most notably, this ruling confirms that BYJU's was in default, which both Byju and Riju personally acknowledged when they signed multiple amendments to the credit agreement on BYJU's behalf from October 2022 to January 2023," the commit-

tee said. A query sent to BYJU's did not elicit any immediate reply.The US-based lenders through GLAS Trust had filed claims of USD 1.35 billion dues in Indian courts during ongoing insolvency proceedings against the edtech firm. In the latest statement, the lenders have raised their total claim to USD 1.5 billion. The committee said that the Delaware Supreme Court ruling has validated that the Lenders were well within their contractual rights to accelerate the Term Loan and take control of BYJU's Alpha Inc.

## Design for GST e-invoicing for retailers ready

New Delhi: The design architecture for implementing GST e-invoicing for retailers is mostly ready and being vetted by industry experts, **GST Network CEO Manish** Kumar Sinha said on Tuesday.

E-invoicing is already present in the B2B sector. The GST Council, in its meeting earlier this month, decided to extend e-invoice to the B2C sector on a pilot basis. Sinha said the GST department is currently in discussion with the industry for the issuance of electronic invoices for every B2C transaction.

"Initially, we will do a pi-

lot project. The design of the architecture is mostly done, and we are getting it vetted by some of the best people we have in the industry," Sinha said.

The threshold for businesses that would be required to issue e-invoices is in the process of being decided. "We have to give time to the industry, particularly, small mom-and-pop stores. What we want to get right is the technology. Large organised retail, e-commerce operator, big companies... have a good IT set up with them, ... at least encourage them to start adoptingit,"

The association said that housing sales in any particular quarter could fall due to lesser number of launches, but consumer demand that has surged post COVID pandemic remains intact

CREDAI is holding its flagship conference 'CRE-DAI NATCON' here during September 23-26 being attended by more than 1,100 delegates.

He was replying to a query about PropEquity latest data which estimates 18 per cent fall in sales across nine major cities to 1,04,393 units during July-

September period. Irfan Razack, CMD of Prestige Group and past president of CREDAI, said, "Demand is there. There is no inventory.

## Karnataka HC dismisses Siddaramaiah's petition

Bengaluru: In a setback to Chief Minister Siddaramaiah, the Karnataka High Court on Tuesday dismissed his petition challenging Governor's approval for investigation against him in a site allotment

The Chief Minister had challenged the approval given by the Governor Thaawarchand Gehlot for an investigation against him in the alleged irregularities in the allotment of 14 sites to his wife by the Mysuru Urban Development Authority (MUDA) in a prime locality.

After completing the hearings on the petition in six sittings from August 19, the single judge bench of Justice M Nagaprasanna on September 12 reserved its verdict. It had also extended its August 19 interim order directing the special court for people's representatives that was slated to hear complaints against him in the case, to defer its proceedings till the disposal of the petition.

"The facts narrated in the petition would undoubtedly require investigation, in the teeth of the fact that the beneficiary of all these acts is not anybody outside but the family of the petitioner. The petition stands dismissed," Justice Nagaprasanna ruled.

He said: "interim order of any kind subsisting today shall stand dissolved."

Deputy Commissioner of Police (East) Apoorva Gupta said a patrol team spotted blood stains on a street near Ramji Samosa shop in Shakarpur around 7.15 pm on Monday and conducted an enquiry. She said local people informed the team that a group of boys had stabbed one boy, who was taken to the LNJP Hospital.


The victim was identified as Sachin (16), who lived nearby, the official said, adding that the incident occurred in full public view.

Gupta said Sachin succumbed to injuries in the hospital about an hour later and two stab wounds were found on his back

"The group demanded a party or a treat to celebrate the purchase but Sachin refused. An argument ensued, leading to the stabbing," Gupta added.

This system of prasad should be operational in all temples across the country until the government and the management of temples guarantee the purity of ghee used to prepare prasad, said Mahant Ravindra Puri, president of the Akhil Bharativa Akhara Parishad, an important body

"Items like rock sugar, cardamom and dry fruits are traditionally offered as Bhog to Hindu deities. Their distribution as prasad will leave no room for adulteration," he said.

Expressing his disgust at the adulteration of 'prasadam' at the Tirupati Balaji Temple, Puri said it had hurt the sentiments of Hindus all over the world.

He suggested that Hindus feeling guilty about having eaten adulterated prasad unknowingly at Tirupati Balaji can purify their system by consuming Ganga jal or Gomutra (cow urine).

The matter came to fore after the woman noticed some unusual activity on her WhatsApp, Deputy Commissioner of Police (east) Apoor-



## Interlinking river projects to bring opportunities

### India needs funding to scale up wind, solar capacities

New Delhi: India will need increased climate finance to scale up wind and solar capacities to over 600 gigawatt, a study said on

Tuesday. Enhanced international cooperation, including the provision of grants and concessional finance help to mobilise private capital, is urgently needed to ensure emerging and developing countries benefit equally from the renewables rollout, the report by Climate Analytics and New-Climate Institute said.

For India, the study said, 'The country has made impressive progress on wind and solar but would need more international climate finance to scale them fivefold to over 600 GW to meet growing demand and move away coal dependence."

## Tsunami waves splash ashore Japanese islands

Tokyo: Small tsunami waves splashed ashore on remote Japanese islands on Tuesday morning after an earthquake that may have been triggered by volcanic activity.

The offshore quake was not felt, and the tsunami advisory was lifted about three hours later. No damage or injuries were reported.

The Japan Meteorological Agency had advised that waves up to 1 metrr (yard) above tide levels could occur on the coasts of the Izu and Ogasawara island chains after the magnitude 5.8 quake occurred off the Izu Islands. The US Geological Survey measured the quake's strength at 5.6 magnitude.

About 21,500 people live on the islands in the Izu group and about 2,500 on the Ogasawara Islands.

JMA said a tsunami of

about 50 centimeters was

detected in the Yaene district on Hachijo Island about 30 minutes after the quake. Smaller waves were detected on three other islands — Kozushima, Miyakejima and Izu Oshima. The offshore quake occurred about 180 kilometers (111 miles) south of Hachijo island, which is about 300 kilometers (186

miles) south of Tokyo. Television footage showed waves splashing against a wharf on Hachijo island but no major swelling was seen.

Residents on Hachijo said they did not feel the quake and only heard the tsunami advisory, Japan's NHK public television said.

Ryuji Minemoto, a Hachijo resident, told NHK that he was on high ground overlooking the ocean but didn't notice changes in the water. "I can see some ships but they don't seem to be moving violently," he said. Minemoto said he did not feel the earlier quake.

Fumihiko Imamura, a Tohoku University seismologist, said the tsunami is believed to be related to undersea volcanic activity that might have caused a rise or sinking of parts of the seabed. Imamura told NHK that such movement, unlike ordinary quakes, may not have caused rattling. Japan sits on the Pacific "Ring of Fire", a line of seismic faults encircling

the Pacific Ocean.

## NTPC Green Energy's IPO likely in early November

New Delhi: NTPC Green Energy, a subsidiary of state-owned power giant NTPC, is likely to bring its initial public offering (IPO) to raise Rs 10,000 crore in first week of November, a source said.

Last week, NTPC Green Energy had filed preliminary papers with capital markets regulator Sebi to raise Rs 10,000 crore through IPO.

The highly placed source said the IPO is expected to be launched in first week of November this year.

The company has planned roadshows in India (Mumbai) as well as abroad, especially in Singapore, the source informed.

The initial share-sale is entirely a fresh issuance of equity shares with no offer-for-sale (OFS) component, according to the draft red herring prospectus (DRHP). The company said proceeds of the issue to the tune of Rs 7,500 crore will be used to repay or prepay part or all of its subsidiary NTPC Renewable Energy Ltd's (NREL) outstanding

New Delhi: Delhi has reported over 300 more dengue cases in past seven days, as mosquito borne diseases seemingly are on a slow but steady rise in the national capital, according to official data.

Cases of malaria are considerably higher so far when compared to last year. Delhi has already reported 363 malaria cases till this month while the figure stood at 294 in the corresponding month in 2023.

The total malaria cases last year were 426. Most number of malaria cases are reported from West Delhi zone. As for chikungunya, 43 cases have been reported so far. This is nearly double than last year when the figure stood at 23. A total of 65 cases of the virus was reported last vear. The most number of chikungunya cases are reported from South Delhi

zone this year. Last week, the city witnessed a spike of nearly 250 cases of dengue in seven days, PTI had reported.

Delhi reports 300 dengue cases in a week

So far, a total of 1,229 dengue cases have been reported in the city with the death of a 54-year old registered in Lok Nayak Hospital, senior official at the hospital had confirmed.

As per Municipal Corporation of Delhi's data till September 21, Delhi reported 651 cases of dengue this month. Last month, a total of 256 dengue cases were reported in the city. The number of cases have become three digit since August. These numbers, however, are comparatively lower than the number of cases reported last year collectively as well as on month on month basis.Last year, Delhi reported 3,013 dengue cases till the corresponding month.

Kuala Lumpur: Women have a key role to play at the forefront of climate action.

They drive policy change, inspire sustainable solutions and champion environmental protection and social justice. From government positions to corporations and grassroots movements, their leadership is crucial.

However, there is a caveat. While a privileged few women hold influential positions, the vast majority are often excluded from the conversation. Women are significantly under-represented in decision-making roles at all levels, including within the

climate change arena. Only 15 out of 133 world leaders who attended COP28 in 2023 were women. While women's leadership often flourishes in communities, their voices are less prominent at national level.

### Climate frontline

Research underscores the connection between women's leadership and stronger climate policies, highlighting the importance of empowering women to play a greater role in shaping climate solutions.

Still, a few outstanding women scientists, women academics, women indigenous leaders and women philanthropists are leading the charge for change and offer hope for the millions whose voices are yet to be heard.

Datu Dr Lulie Melling, for example, is the first Asian woman elected to the International Peatland Society's executive board. Her continued leadership underscores the invaluable contributions of women to tropical peatland research and the broader scientific community.

Women are also leading the transition to a low-carbon future. Professor Phoebe Koundouri, a global authority on sustainable development, is spearheading efforts to integrate climate and energy models worldwide through the UN Sustainable Development Solutions Network's Global Climate Hub.

## **World leaders meet** to discuss three wars

United Nations: World leaders will open their annual meeting at the UN General Assembly on Tuesday under the shadow of increasing global divisions, major wars in Gaza, Ukraine and, Sudan and the threat of an even larger conflict in the wider Middle

Secretary-General Antonio Guterres previewed his opening "State of the World" speech to presidents, prime ministers, monarchs and ministers at Sunday's "Summit of the Future", saying "our world is heading off the rails and we need tough decisions to get back on track".

He pointed to conflicts "raging and multiplying, from the Middle East to Ukraine and Sudan, with no end in sight" and to the global security system, which he said is "threatened by geopolitical divides, nuclear posturing, and the development of new weapons and theatres of war".

He also cited huge inequalities, the lack of an effective global system to respond to emerging and even existential threats,

and the devastating impact of climate change.

One notable moment at Tuesday's opening assembly meeting: US President Joe Biden's likely final major appearance on the world stage, a platform he has tried upon for decades.

US Ambassador Linda Thomas-Greenfield told reporters last week that the US focus in the assembly will be on ending "the scourge of war", lamenting that roughly two billion people live in conflict-affected areas.

But she also said: "The most vulnerable around the world are counting on us to make progress, to make change, to bring about a sense of hope for them.'

Among other speakers on opening day are Brazil's President Luiz Inacio Lula da Silva, Turkiye's President Recep Tayyip Erdogan, King Abdullah II of Jordan, and Iran's new President Masoud Pezeshkian.

## In a first, China operates all three aircraft carriers By K J M Varma

Beijing: The Chinese navy for the first time carried out exercises and tests of all three of its aircraft carriers recently to highlight that its carrier warship programme has entered a fast lane, official media reported on Tuesday.

Currently, China has two aircraft carriers in operation - the Liaoning, a refit of the Soviet-era ship commissioned on Sept 25, 2012 - and Shandong, an indigenously built 2nd aircraft carrier

commissioned in 2019.

China's third aircraft carrier Fujian, which is larger than the two carriers with a displacement of 80,000, is currently undergoing trials.

Ahead of the 12th anniversary of the commissioning of China's first aircraft carrier, which falls on Wednesday, all three Chinese aircraft carriers reportedly carried out exercises or tests over the past week, state-run Global Times reported on

With this, China's aircraft carrier programme has entered a fast lane, it quoted observers as

saying

According to the official media, the Chinese navy plans to have four to five aircraft carriers making them the frontline force of its navy as China seeks to expand its global influence with deployments in the South China Sea, the Taiwan Strait and the Indian Ocean in future.

Fujian is the "first fully domestically developed and constructed" aircraft carrier with an electromagnetic aircraft launch system (EMALS) similar to that of the American aircraft carrier USS Gerald R. Ford, according to official

media reports. China's other two aircraft carriers are equipped with ski-jump take-off ramps while the Fujian features a flat-top flight deck.

Liaoning last week provoked protests from Japan by spotted sailing in waters near Diaoyu Dao islands in the western Pacific which

are under the control of Japan, which calls the islands the Senkakus.

China periodically sends its coast guard ships to assert its claim over the islands. Liaoning, which the Chi-

nese navy uses for mostly training purposes, reportedly carried the new fighter jet J-35, an advanced version of the J-15 currently being used by the navy. The J-35 jet was designed to be used on Fujian, which has an EMALS landing

China's second aircraft carrier, the Shandong, recently hosted a certification test for night-time operation for a group of new fighter jet pilots during a combat exercise in the South China Sea, the staterun CCTV reported.

The move further enhanced the PLA Navy aviation force's round-theclock, all-domain combat capabilities, as more fighter jet pilots are qualified to operate on aircraft carriers. according to the CCTV re-

## A Murky Death

The killing of Akshay Shinde, the prime accused in the Badlapur molestation case, has unleashed a torrent of controversy, with allegations of a 'big conspiracy' surrounding the official account of events. According to Maharashtra police, Shinde, while being escorted from Taloja Central Jail, allegedly snatched a police officer's gun and fired three rounds, prompting an officer to fatally shoot him. But the account provided by Shinde's family paints a different picture, one of premeditated execution. Their accusations, along with calls from the Opposition Maharashtra Vikas Aghadi (MVA) for a judicial probe, raise important questions about systemic lapses of police and administrative procedure.

Arrested for allegedly sexually abusing two young girls in a school toilet in Badlapur, Shinde was at the center of a scandal involving the school's management and local police. Amid public pressure, a Special Investigation Team (SIT) had taken over the case, filing chargesheets that included grave allegations not only against Shinde but also against the school authorities. The police's failure to act promptly and their mishandling of the initial investigation had already led to mass protests. The question now is: was Shinde's killing a hasty attempt to close the case, or was it part of a broader cover-up to protect powerful individuals involved?

From the police's initial delay in registering the molestation case to the murky circumstances surrounding Shinde's death, the situation underscores a state apparatus increasingly incapable of managing political pressures. Further concerns arise from the circumstances of Shinde's transport, including how he was taken out after jail hours and whether the revolver which he allegedly snatched and fired at the police had been secured. Could this have been an extraordinary failure in protocol, or was the narrative later fabricated to justify an extrajudicial killing?

The Opposition MVA, while questioning how a handcuffed man could have possibly snatched a gun from a trained police officer, have categorically accusing the ruling Mahayuti government of foul play. Shinde's death, they argue, conveniently shuts down an investigation that might have implicated powerful individuals linked to the BJP. Despite widespread calls for their arrest, members of the school board, many of whom are associated with the ruling party, remain at large, they claim. As Maharashtra heads towards election, the MVA will doubtless rake up the Shinde killing as an illustration of the fragility of the rule of law in the state under the ruling Mahayuti.

Whether a genuine act of self-defence or an orchestrated encounter, Shinde's has revealed serious flaws in both law enforcement and political accountability. Calls for a judicial probe must be heeded if public faith in the state's justice system is to be restored.

Extra-judicial killings in India are often cloaked in the rhetoric of swift justice, but they signify a breakdown of due process and a dangerous slide toward lawlessness. When the state allows such acts, it sends a wrong message that the law can be bent to serve political or institutional

## Sacred Sweets and Sacred Rage: The Politics of Religious Offence

The controversy surrounding the Tirupati Laddu, one of Hinduism's most cherished offerings, underscores a stark truth about the nature of religious tolerance in India. Despite the discovery of sub-standard ghee and traces of animal fat in the famed prasadam, there has been no violence and no rioting from the devout millions who revere the Tirumala Venkateswara Temple – arguably India's most visited religious site. No doubt the political fallout has been fierce. and the hurt to religious sentiment palpable, but the response from Hindu devotees has been largely peaceful.

Contrast this with the reaction to perceived blasphemy in Islam. Across the world, even minor offences against the Prophet Muhammad or the religion's tenets have triggered violent reprisals. In 2015, when the French satirical magazine Charlie Hebdo published cartoons of the Prophet, the result was a brutal terrorist attack on its offices that left 12 people dead. The violence was not confined to France. Demonstrations and riots erupt-

ed in Muslim-majority countries from Pakistan to Yemen, with protesters demanding retribution. Similarly, the 2005 publication of caricatures in the Danish newspaper Jyllands-Posten led to a global wave of riots, embassy burnings and multiple deaths.

In June 2022, Umesh Kolhe, a chemist in Amravati district, was gruesomely murdered for forwarding a WhatsApp message supporting then-BJP spokesperson Nupur Sharma, who had made controversial remarks about the Prophet Muhammad. Around the same time, in Udaipur, Rajasthan, tailor Kanhaiyya Lal Teli was similarly killed for the same reason, with one assailant recording the act on a mobile phone.

The point here is that Hinduism, in contrast, offers a model of remarkable tolerance and resilience in the face of insult or perceived sacrilege - notwithstanding the disparaging from the so-called 'liberal' champions of secularism.

This is not to suggest that Hindus are immune to provocation. India has seen its fair share of communal violence, often political in nature. But when it comes to religious offence, especially in cases involving sacred rituals or deities, the general pattern is one of legal redress rather than an immediate turn to violence seen in other parts of the world.

In the Tirupati laddu controversy, while Chief Minister N. Chandrababu Naidu's Telugu Desam Party (TDP) is rattling sabres with Y.S. Jagan Mohan Reddy's Yuvajana Sramika Rythu Congress Party (YSRCP), the broader Hindu population has remained calm. Rather than calls for violence, there were demands for accountability, investigation and ultimately justice.

The response to religious affront in Islam, by comparison, tends to escalate more quickly into violence. The theological underpinnings of this difference are complex. In Islam, any depiction or criticism of the Prophet is viewed as an act of blasphemy, punishable by death in several countries. This is rooted in sharia



law, which prescribes severe penalties for apostasy and blasphemy. Even in countries where such laws do not exist, Muslim communities often react with intensity to perceived slights against their religion.

Hinduism, by contrast, is more decentralised and diverse in its interpretation of the sacred. With thousands of deities, multiple schools of thought, and no single religious authority, there is a degree of pluralism inherent in the faith which often extends to matters of religious offence.

The Laddu controversy, while deeply wounding to Hindu sensibilities, has been addressed within the boundaries of state authority. Investigations are underway, and while political rivalries continue to play out, the broader Hindu response has been one of tolerance, or at least restraint. This restraint is not a modern phenomenon. It is deeply rooted in India's historical tradition of religious tolerance, exemplified by emperors such as Harsha and Samudragupta, whose rule, based on the tenets of 'Dharmashastras,' stood in stark contrast to the bloodlust and rapacity of marauding Islamic conquerors from Afghanistan and Central Asia who swept through India in the 11th century.

Though Harsha himself was a devout Buddhist, his kingdom embraced a pluralistic approach, with support extended to Buddhist, Hindu and Jain institutions alike. His administration was marked by tolerance and accommodation of multiple faiths. His diplomatic outreach to China and sponsorship of religious councils reflects a ruler more interested in intellec-

tual exchange than religious dominance. Similarly, Samudragupta, called the 'Napoleon of India' by Vincent Arthur Smith for his military conquests in the 4th century CE, also presided over a period of religious pluralism. Whatever Smith thought, I regard Samudragupta as being far greater to Napoleon, whose conquests brought misery to Europe for two decades and overshadowed his reforms.

This tolerance contrasts sharply with the rule of Islamic conquerors like Mahmud of Ghazni, whose infamous sacking of the Somnath Temple in 1026 CE was not merely a political act of conquest but one deeply imbued with religious motives. The looting and destruction of Hindu temples became a pattern among many subsequent Islamic rulers, from Muhammad of Ghor to the Mughal Emperor Aurangzeb. This contrast is certainly not a commentary nor meant to disrespect Indian Muslims, many of whose remarkable contributions have greatly enriched Indian social life at every stage post-Independence.

The point is that the legacy of pluralism inherited from rulers like Harsha and Samudragupta has left a deep imprint on the Hindu psyche. Hinduism, with its multitude of deities, philosophies, and practices is inherently more accommodating of diversity and dissent.

The Tirupati Laddu affair highlights Hinduism's capacity for measured responses to even the most delicate of religious insults - a lesson in tolerance that many other faiths, grappling with their own theological rigidity, would do well

## What If Eisenhower Had Raced for Berlin?

magine a Cold War without the Berlin Wall – that iconic symbol **L**of a stark ideological divide adorned in the covers of books by every major spy thriller writer from John le Carré to Joseph Kanon. A divided Berlin has been emblematic of the Cold War (1945-91). In this context, one cannot help asking a counterfactual often asked in the past what if the Supreme Commander of the Allied Expeditionary Force in Europe, Gen. Dwight D. Eisenhower, had opted to push east and race the Soviets to Berlin?


In the spring of 1945, as Hitler's Third Reich lay in ruins, Eisenhower made a fateful decision: to halt American and Allied forces at the Elbe River and allow the Soviet Red Army to take Berlin.

Had Eisenhower pushed for Berlin, the Cold War might still have occurred, but it would have been a different conflict. A united Germany, neutral or aligned with the West, would have weakened Soviet power in Europe. Berlin, without its iconic wall, would not serve as the stark symbol of ideological rivalry.

The nature of Postwar Europe would have been profoundly altered. The Cold War would have swung in a way favourable to the West, or perhaps its inception may have been prevented altogether.

The absence of Berlin as a flashpoint could have led to fewer tensions in Europe, and NATO's forma-

tion might have shifted in focus. What prevented Eisenhower from



a campaign of misdirection, Stalin minimized the military significance of Berlin, presenting it merely as another urban battleground while emphasizing other military priorities. Eisenhower, pragmatic by nature,

thought it prudent to avoid a bloodbath in Berlin and focus on defeating the remaining German armies across central and southern Europe. Another factor in Eisenhower's decision to forego Berlin was the intelligence, later revealed to be exaggerated, suggesting that Hitler, along with remaining SS units and German divisions would make a last stand in his 'Alpine Redoubt' bastion. As it turned out, the Allies found no well-organized Nazi stronghold and Hitler, far from fleeing to the Austrian Alps, remained holed in his Berlin bunker, awaiting the

In a noted book-length essay, Eisenhower and Berlin, 1945: The Decision to Halt at the Elbe (1967), historian Stephen Ambrose, Eisenhower's official biographer, critiqued Ryan's



However, if Eisenhower had ordered the armies of Field Marshal Montgomery and Gen.Omar Bradley to take Berlin, the post-war landscape would have looked very different. This does not mean the Cold War would vanish. But the intensity of the Cold War, that characterized postwar Europe, would have been channelized in other regions, such as the Middle East, Southeast Asia and Africa (where it eventually did

with great intensity and loss of life). That said, Stalin's paranoia about Western intentions, evidenced by his brutal consolidation of power in Eastern Europe, would still persist. Moscow would still desire a buffer zone, likely seeking control over Poland, Hungary, and Czechoslovakia. However, with Berlin in Western hands, Stalin's expansion might have been less aggressive, and the tension between East and West more political than militarized.

Eisenhower's pragmatic decision to halt at the Elbe had profound implications for the postwar order. The question of whether a bolder approach might have significantly altered the geopolitical landscape of the 20th century is now an academic one.

## The Rising Scourge of Crimes Against Women

he recent, gruesome discovery of a 29-year-old woman's body, dismembered into 50 pieces and stored in a refrigerator in Bengaluru, has cast an unflattering light on the law-and-order situation of the current Congress-led regime in Karnataka - a state traditionally known for its cosmopolitan cities and vibrant IT hubs.

The recent horror immediately echoes the macabre murder of 27-year-old Shraddha Walkar in Delhi in 2022, who was killed by her boyfriend and dismembered before being discarded in a forested area. Karnataka's experience highlights a worrying pattern of increasing violence against women.

In the case of the fridge murder, the deceased had been living apart from her husband. As per the police, the prime suspect, originally from Odisha, had been living in Bengaluru and

was now presently in West Bengal. Between April and May, Karnataka witnessed the brutal murders of four women - all at the hands of men known to them - friends, lovers, and fiancés - men unable to cope with rejection. The murder of 22-year-old Neha Hiremath on April 18 sent shockwaves around the state. Stabbed to death by her former classmate Fayaz Khondunaik at her college campus in Hubballi, Neha's murder ignited pro-

tests across the country, highlighting the urgent need for change.

Before that, Bengaluru had been rocked by a double murder when a married man, Suresh, fatally stabbed his 25-year-old colleague before being bludgeoned to death by the victim's mother. On May 9, 33-year-old Prakash Omkarappa beheaded his 16-year-old fiancée after the District Child Protection Unit intervened in their engagement. The most recent incident saw 21-year-old Girish Sawant stabbing 20-year-old Anjali Ambiger to death at her home in Hubballi on May 15.

The ruling Congress and the Opposition BJP engaged in sabre-rattling, with the latter accusing the Siddaramaiah-led government of a breakdown of law and order.

Data from the National Crime Records Bureau (NCRB) revealed that crimes against women in Karnataka surged by over 10% between 2022 and 2023. Cases of domestic violence, dowry deaths, and sexual assaults are worryingly commonplace, with Bengaluru accounting for a disproportionate share of these incidents.

In the first half of 2024 alone, Karnataka has recorded an alarming 6,551 cases of crimes against women, as reported by the State Police. This statistic underscores a deteriorating landscape for women's safety.

The rise in reported cases of sexual violence is particularly disconcerting with more than 2,000 molestation cases filed under Section 354 as per police records. The disturbing trend does not stop there; kidnappings, dowry-related violence, and domestic abuse reflect a pervasive culture of misogyny and violence that threatens the safety and autonomy of women across Karnataka - a state perceived


Karnataka's Home Minister, G Parameshwara, acknowledged the need for urgent measures, assuring the public that programs like Nirbhava are ongoing and that initiatives, including CCTV installations, are being pursued.

The rising incidence of crime against women bears comparison to West Bengal, recently rocked by the rape and murder of a junior doctor at the RG Kar medical college with the opposition BJP demanding the resignation of West Bengal's Chief Minister, Mamata Banerjee. The BJP have cited a staggering 50,000 cases of rape and murder during the tenure of Banerjee's Chief Ministership and the TMC rule.

The recent case of the dismembered woman raises critical questions about the effectiveness of law enforcement and the social stigma surrounding gender-based violence. As Karnataka grapples with this unsettling reality, the question remains: what will it take to ensure the safety and dignity of



# What is the conflict between Israel, Hezbollah?

The past week has seen a rapid escalation in the nearly yearlong conflict between Israel and Lebanon's Hezbollah. First came two days of exploding pagers and walkie-talkies used by Hezbollah deadly attacks pinned on Israel that also maimed civilians across

Hezbollah's leader vowed to retaliate, and on Friday the militant group launched a wave of rockets into northern Israel. Later in the day, the commander of Hezbollah's most elite unit was killed in a strike in Beirut that killed dozens more people.

The cross-border attacks ramped up early Sunday, with Hezbollah, an Iranian-backed Shiite group that is Lebanon's most powerful armed force, launching more than 100 rockets deeper into northern Israel, with some landing near the city of Haifa. Israel launched hundreds of strikes on Lebanon.

Then, on Monday, Israel launched a series of strikes that killed more than 490 Lebanese, the deadliest attack since the 2006 Israel-Hezbollah war. Israel warned residents in southern and eastern Lebanon to leave their homes ahead of a spreading air campaign against Hezbollah.

Many fear the escalating violence could lead to an all-out war between Israel and Hezbollah, which would further destabilise a region already shaken by the fighting in Gaza. Both sides have said they don't want that to happen, even as they have defiantly warned of heavier attacks.

Israel and Hezbollah have launched repeated strikes against each other since the Gaza war began, but both sides have pulled back when the spiral of reprisals appeared on the verge of getting out of control, under heavy pressure from the US and its allies.

But in recent weeks, Israeli leaders have warned of a possible bigger military operation to stop attacks from Lebanon to allow hundreds of thousands of Israelis displaced by

### What were the latest strikes?

More than 1,600 Lebanese were injured in Monday's deadly strikes and thousands more fled southern Lebanon. Israel said it was targeting Hezbollah weapons sites, and had hit some 1,600 targets. Lebanon's health minister said hospitals, medical centres and ambulances had been

The Israeli military warned residents to immediately leave areas where Hezbollah is storing weapons. The Lebanese media said the evacuation warning was repeated in text

messages. Hezbollah said it had fired dozens of rockets toward Israel, including at military bases, and officials said a series of air-raid sirens were ringing out in northern Israel warning of rocket attacks. On Friday, an Israeli airstrike brought down a high-rise building in Beirut's southern suburbs, killing Ibrahim Akil, the commander of Hezbollah's elite Radwan unit, and other top unit leaders. Israel said Akil led the group's campaign of rocket, drone and other fire into northern Israel.

At least 45 people were killed in that attack and more than 60 wounded. That strike came after the shock of the electronic device bombings, in which thousands of pagers and walkie-talkies used by Hezbollah detonated on Tuesday and Wednesday. At least 37 people were killed, including two children, and around 3,000 were wounded.

Israel has neither confirmed nor denied its involvement. Analysts say that attack had little effect on Hezbollah's manpower, but could disrupt its communications and force it to take tighter security measures.

#### What is the situation on the border?

The Israel-Lebanon border has seen almost daily exchanges since the Is-



rael-Hamas war began on October 7. Before Monday, the exchanges had killed around 600 people in Lebanon - mostly fighters but also about 100 civilians — and about 50 soldiers and civilians in Israel. It has also forced hundreds of thousands of people to evacuate homes near the border in both Israel and

Hezbollah leader Hassan Nasrallah promised to retaliate for the electronic device bombings. But Hezbollah also has proved wary of further stoking the crisis. The group faces a difficult balance of stretching the rules of engagement by hitting deeper into Israel in response to its brazen attacks, while at the same time trying to avoid the kind of large-scale attacks on civilian areas that can trigger a full-scale war

that it could be blamed for.

Hezbollah says its attacks against Israel are in support of Hamas. Last week, Nasrallah said the barrages won't end — and Israelis won't be able to return to homes in the north — until Israel's campaign in Gaza

### What is Israel planning?

Israeli officials say they haven't yet made an official decision to expand military operations against Hezbollah – and haven't said publicly what those operations might be. Last week, though, the head of Israel's Northern Command was quoted in local media as advocating for a ground invasion of Lebanon.

Meanwhile, as fighting in Gaza has slowed, Israel has increased its forces along the Lebanese border,

including the arrival of a powerful army division believed to include thousands of troops.

Israeli Defense Minister Yoav Gallant last week declared the start of a "new phase" of the war as Israel turns its focus toward Hezbollah.

"The centre of gravity is shifting to the north," he said.

A UN-brokered truce to the 2006 war called on Hezbollah to pull back 29 kilometers (18 miles) from the border, but it has refused, accusing Israel of also failing to carry out some provisions. Israel is now demanding Hezbollah withdraw eight to 10 kilometers (five to six miles) from the border - the range of Hezbollah's anti-tank guided missiles.

The monthlong 2006 war, triggered when Hezbollah fighters kidnapped two Israeli soldiers, included heavy Israeli bombardment of southern Lebanon and Beirut and a ground invasion into the south. The strategy, Israeli commanders later said, was to inflict maximum damage in areas where Hezbollah operated to deter them from launching attacks.

But Israel could have a more ambitious goal this time: to seize a buffer zone in south Lebanon to push back Hezbollah fighters from the border. A fight to hold territory threatens a longer, even more destructive and destabilising war - recalling Israel's 1982-2000 occupation of southern Lebanon.

#### What would be the impact of a full-blown war?

The fear is that a new war could be even worse than the one in 2006, which was traumatic enough for both sides to serve as a deterrent ever since.

The fighting then killed hundreds of Hezbollah fighters and an estimated 1,100 Lebanese civilians and left large swaths of the south and even parts of Beirut in ruins. More than 120 Israeli soldiers were killed and hundreds wounded. Hezbollah missile fire on Israeli cities killed dozens of civilians.

Israel estimates that Hezbollah now possesses about 150,000 rockets and missiles, some of which are precision-guided, putting the entire country within range. Israel has beefed up air defences, but it's unclear whether it can defend against the intense barrages of a new war.

Israel has vowed it could turn all of southern Lebanon into a battle zone, saying Hezbollah has embedded rockets, weapons and forces along the border. And in the heightened rhetoric of the past months, Israeli politicians have spoken of inflicting the same damage in Lebanon that the military has wreaked in Gaza.

"He started doing too much, and I was very happy that he became the third youngest Grandmaster in the world. I felt so happy when he won the Candidates in Toronto and earned the right to challenge world champion Ding later this year in Singapore.'

Bhaskar is also happy that Gukesh's contribution played a key role in India winning the gold medal at the Olympiad. The 18-yearold won nine of the 10 matches he played with one ending in a draw.

"It is the first time the Indian (men's and women's) teams have won, and his (Gukesh's) wins against the opponents assured the gold in the 'Open' category. I am extremely happy for the whole team, particularly for Gukesh, and my best wishes for him to see him as the youngest world champion."

#### **Double joy for Babu**

There was double joy for Ramesh Babu, the father of R Praggnanandhaa and R



Vaishali, as both his children won gold in the most prestigious biennial team chess event in the world.

While GM Praggnanandhaa was an integral part of the men's team, his elder sister Vaishali also played a key role in the women's title triumph. "We are very proud (of Praggnanandhaa). My daughter Vaishali's team also won the gold medal, so we're happy about that as well," said Ramesh Babu.

"All the team players have done very well and won gold medals." He added that the success of Indian chess players had given a huge boost to the game in the country.

"Nowadays, chess has become very popular after cricket. More and more people are getting interested. Apart from academics, playing chess is becoming a part of their career. Youngsters are taking it up as a career." He added that both Praggnanandhaa and Vaishali were aiming for more success in their ca-

"When I played him in GCL last season, he was a different player, may be not a different player but in different form. I didn't play a particularly interesting game against him in the Olympiad. I played a very straight game. I like to be challenged by the strongest players on the planet even though it's going to get more difficult with this young Indian generation coming up. But I am not entirely depressed."

## **Gukesh is super** impressive: Rapport

New Delhi: Hungarian Grandmaster Richard Rapport, who was one among the two players to manage a draw against an unstoppable D Gukesh in the Chess Olympiad, is in awe of India's phenomenal rise in the sport but still wouldn't declare the teenager an outright favourite for the world crown.

The reason being that the eagerlyawaited showdown in November-December is a "different" level in the difficulty meter and Gukesh will have an experienced rival in Ding Liren to counter at the showpiece.

For now, the 18-year-old is celebrating India's maiden Olympiad gold in Budapest where he was the star of the campaign, remaining unbeaten through the event with eight wins and two draws.



Rapport was the first to hold Gukesh during a seemingly invincible run and speaking to PTI, the 28-year-old lauded the youngest ever challenger to the world title. The two are likely to face off once against next month during the Tech Mahindra Global Chess League (GCL) in

Rapport had beaten Gukesh when the two got a game against each other in the inaugural season of the event last year.

Gukesh and Rapport clashed in the sixth round of the Olympiad and signed peace after 44 moves. Uzbekistan's Abdusattorov Nodirbek was the only other player to clinch half a point against Gukesh. Like the rest of the chess world. Rapport too is looking forward to the world championship. He was Liren's second when the Chinese GM won the crown last Nepomniachtchi.

The Hungarian believes it won't be easy for Gukesh to claim the title in November 20 to December 15 clash due to the wealth of experience that Liren has.

"If you look at the last event (the Olympiad), Gukesh is supposed to be favourite but that match is very different and Ding has experience and I think may be there would a new champion. But I would not put the numbers in favour of anybody. It's way too difficult than any tournament ever. "Experience is a huge advantage for anyone. I expect a very close (match) and I expect a big fight. I hope to see some good ideas, worthy of a world championship, which I think the last match definitely delivered." he said.

Coming back to the Olympiad and Rapport said he was also impressed with the performance of the Indian women's team. which too won gold to make it a clean sweep. "The ladies team was actually surprising. We are all focussing on the Open team but in that team you had two players (Gukesh and Arjun Erigaisi) who were playing just unbelievably. If you have (even) one player, you have a very good chance of winning a tournament but you had two," he pointed out.

"But in the ladies team, it was very tight competition. They stood their ground and played really well, that's really impressive. I mean, look at Kazakhstan, they had a very strong ladies team but, I don't want to insult anyone, an unremarkable team in the men's section. I mean decent players but not top players," he said.

"...(but) your country is up there when it comes to chess." Rapport, who switched allegiance to Romania for a couple of years as he felt ignored by his country of birth, returned to Hungary's fold before the Olympiad after being made to feel "looked after" by the national chess body.

At the GCL, he will have Norwegian maverick Magnus Carlsen and Indian wizard R Praggnanandhaa among others as his teammates in Alpine SG Pipers.

"For me, if I was not playing, this league would be something that I would be watching. In a way it kind of succeeded in that regard," he said of the league that starts on October 3.

## Will get Sindhu back on podium: Sridhar

New Delhi: P.V. Sindhu still has the hunger to succeed, and the primary aim is to help her regain consistency, says her new coach Anup Sridhar, who has been roped in by the twotime Olympic medallist on a trial basis following the Paris Games

Sindhu, who returned from the French capital without a medal for the first time in three Olympics, has been training under Sridhar, a Beijing Olympian, for the past three weeks at the Gachibowli Stadium in Hyderabad.

"I spoke with Sindhu's team a few weeks ago, and she has been training under me in Hyderabad since the start of this month. We've made significant progress,



and in two weeks, we'll head to tournaments in Europe." the 41-year-old Sridhar, who also briefly coached Lakshya Sen, told PTI.

Sindhu lost in the prequarters to China's He Bingiiao at the Paris Games and will restart her BWF world tour season with the European leg, which includes the USD 420,000 Arctic Open in Vantaa, Finland

(October 8-13), and the USD 850,000 Denmark Open (October 15-20) in Odense.

"I'm taking it week by week," said Sridhar, who has been brought on board for the remainder of the season after Indonesian Agus Dwi Santoso's contract ended post-Paris Olympics. "Since we haven't committed to anything long-term, it's hard to plan for 2025. However, there are a couple of tournaments in 2025 that Sindhu should aim to peak at," he said.

'You can plan for physical peaks, but not for form. I have my eye on a few tournaments next year, but the immediate focus is to enhance her consistency and get her back on the podium -- that's the big goal." -PTI

New Delhi: The Badminton Association of India announced on Tuesday a total reward of Rs 50 lakh for the para shuttlers who secured medals at the Paris Paralympics last month.

Indian para shuttlers won five medals, including one gold, two silver and as many bronze, at the Paris Games. Nitesh Kumar, who clinched the coveted gold in the men's Singles SL3 category, will receive a prize of Rs 15 lakh, while silver medallists Suhas Yathiraj (men's singles SL4) and Thulasimathi Murugesan (women's singles SU5) will each be awarded Rs 10 lakh. Bronze-medal winners Manisha Ramadass and Nithya Sre Sivan will each receive Rs 7.5 lakh.

## Soccer pitch collapses due to floods in UK

**London:** A soccer pitch in London collapsed and other parts of the United Kingdom were submerged by flash floods Monday after some areas saw a month's worth of rainfall in 24

Roads were closed, some train lines in London were suspended and dozens of people reported their houses being submerged as parts of central and southern England saw about 60 to 80 millimeters (2 to 3 inches of rainfall. A few locations were expected to be hit by more than 120 mm (4.7 inches) of rain, weather forecasters said.

In the capital, the London Fire Brigade said emergency responders received some 350 flood-related calls. The service said these included rescuing people trapped in cars, assisting


people from their homes.

Somdev's plea New Delhi: The Delhi High Court on Tuesday sought the stand of the All India Tennis Association (AITA) on a petition against holding of its election later this month allegedly in viola-

tion of the Sports Code. Justice Purushaindra Kumar Kaurav issued notice to the sports body as well as the Centre on the petition by former India tennis player Somdev Devvarman and doubles player Purav Raja, and said the election will be subject to the outcome to the plea.

While refusing to stay the election at this stage, the judge also directed that the result of the polls, which are scheduled to be held on September 28, shall not be published.

The senior counsel appearing for the petitioners argued that AITA was holding the election in a "clan-

destine manner" as there was "nothing on the website".

Seeking a stay on the election, the senior lawyer submitted that the conduct of the AITA was in flagrant violation of the Sports Code as well as the decisions passed by the high court.

The court asked the petitioner to make the Returning Officer of the election a party to the proceedings and asked the respondent parties to file their replies.

It further said that if the

election is subsequently found to be in violation of the Code, the elected office bearers will not be allowed to function and an independent entity may be appointed in their place.

"I am not staying. Election requires a lot of preparation. If the election process is conducted in defiance of the subsisting directions, the office bearers will be restrained from functioning. Then we will consider appointing someone as the ad hoc (body)... That election will be set aside," the court said

"In the meantime, the election of respondent no 2 will be subject to the outcome of the instant writ petition.. The result of the election shall not be published," the court ordered.

The matter will be heard next on October 14.
