# Biden, Harris real threat, will never surrender: Trump

### Donald Trump Dodges second assassination attempt in Florida; Suspect arrested

Washington: Former US president Donald Trump is safe after he escaped an apparent assassination attempt while he was golfing on his course in Florida, a second bid on his life in two months

The incident took place on Sunday at the Trump International Golf Club in West Palm Beach, Florida.

Secret Service agents "opened fire on a gunman located near the property line" of Trump International Golf Club in West Palm Beach, Rafael Barros, the special agent in charge in Miami, said during a news conference. adding that the agency was "unsure whether the individual,' who is in custody, "was able to take a shot at our agents.'

Trump, who was golfing at the club, was unharmed.

According to Palm Beach County Sheriff Ric Bradshaw, a Secret Service agent spotted the suspect with a rifle sticking through the fence of the golf course and immediately fired at the man before he fled the scene.

The 78-year-old Republican presidential nominee was 300 to 500 yards away from the suspect, Bradshaw said.

"He (the attacker) believed the rhetoric of Biden and Harris, and he acted on it," Trump told Fox News. "Their rhetoric is causing me to be shot at, when I am the one who is going to save the country, and they are the ones that are destroying the country — both from the inside and out."

In a message to his supporters, Trump said he is safe.

Ryan Wesley Routh, a 58-year-old owner of a small construction company in Hawaii, was detained in connection with the incident.

On Monday, he appeared briefly in federal court in West Palm Beach. He was wearing dark prison scrubs, and his feet and hands were shackled, CNN reported.

Routh has been charged with two firearm counts. The counts include possession of a firearm while a convicted felon and possession of a firearm with an obliterated serial number, the channel said.

A detention hearing has been set for September 23 and the arraignment is set for September

This was the second attempt on Trump's life in two months. In July, a life-threatening attack on Trump during his rally in Pennsylvania shocked the entire nation. He injured his right ear after the young shooter fired multiple shots at him at the campaign rally.

Florida Governor Ron DeSantis Monday said that he has not yet spoken with Trump after the incident, but reiterated that his state was doing its own investigation as "there is a need to make sure that the truth about all of this comes out in a way that is credible.

The Democratic president said he had been briefed on the incident and the federal investigation into the matter.

Soon after the gunshots were heard at the golf club in Florida. where Trump was golfing, the FBI said that it was "investigating what appears to be an attempted assassination of former

The incident took place at roughly around 1:30 pm local time when Secret Service agents spotted a person with an AK-47 near the golf course. Agents opened fire at him.

"Officials believe the shots fired at Trump International Golf Club were intended for former President Donald Trump, according to sources familiar on the matter," CNN reported.

"Sources said the Secret Service spotted a suspicious individual on the Trump International Golf Course West Palm Beach and opened fire when agents saw what appeared to be the barrel of a gun," the New York Post reported.

"Just spoke with President Trump. He is one of the strongest people I've ever known. He's in good spirits and he is more resolved than ever to save our country," said Senator Lindsey Graham after speaking with Trump.

JD Vance, Trump's running mate, said on X that he spoke with Trump before the news was public and that the former president "was, amazingly, in good spirits" and there is "still much we don't know."

## **All tribes** in India are Hindu: VKA

New Delhi: All tribes in India are "originally" Hindu but some people are trying to create divisions in the tribal society by linking its members with other religions like 'Sarna', a senior functionary of RSSaffiliate Akhil Bharatiya Vanvasi Kalyan Ashram said on Monday.

Various groups in Jharkhand and its neighbouring states have been demanding that 'Sarna' be declared as the religion of the tribals as their practices and method of worship are different from Hindus and all other religions in the country.

Supporting the view, the Jharkhand Mukti Morcha (JMM), which rules Jharkhand, has been pitching for the inclusion of a separate "Sarna Code' for tribals in the census.

"All tribes are originally Hindus. They were Hindus in the past, they are Hindus at present and they will remain Hindus in future," Vanvasi Kalyan Ashram's all India publicity and media communications head Pramod Pethkar said.

"Some people are engaged in creating division in the tribal society by carrying out such ideological attacks," he said.

## Congress slams PM as 'weak', says running 'U-turn' govt

New Delhi: With Modi 3.0 completing 100 days, the Congress on Monday claimed that Narendra Modi in his third term had proven to be a "weak" prime minister who was dependent on crutches and setting new records for **U-turns** 

Congress spokesperson Supriya Shrinate said the past 100 days had weighed heavily on the nation's farmers, youth, women, infrastructure, Railways, and overall peace.

These hundred days have proven that Modi has neither a solution nor a vision for the country's problems, she said at a press conference at the AICC headquarters. Modi's "habit" of turning a blind eye to issues and running away from challenges continues to persist, she claimed.

"Each moment of the government in these 100 days has been marked by instability, indecision and immaturity. There have been multiple attempts to inflate a punctured balloon



but the thorn pricked by the public in the Lok Sabha elections has not given Narendra Modi any chance to rise again," she said.

"Do you remember the tall claims made during the election campaign that Narendra Modi was planning for the first 100 days? Where is that plan now? plaint was lodged with the police claiming a man and his associates waved the Palestine flag during the Eid-e-Milad procession at Mahavir Chowk, a press release stated.

The complainant stated the act has hurt the sentiments of Indians.

# State gets three new Vande Bharat trains

Mumbai: The number of Vande Bharat trains plying in Maharashtra increased to eleven as Prime Minister Narendra Modi flagged off three new services via video link from Ahmedabad on

The new trains will be operated on Nagpur-Secunderabad, Kolhapur-Pune, and Pune-Hubballi routes, officials said.

Until now eight Vande Bharat Express trains were operated on various routes in Maharashtra by the Western Railway and Central Railway

Mumbai-Ahmedabad and Mumbai-Gandhinagar Vande Bharat trains are operated by Western Railway, and Mumbai-Madgaon, Mumbai-Solapur, Mumbai-Sainagar Shirdi, Mumbai-Jalna, Nagpur-Raipur, and Nagpur-Bilaspur by the CR.

Swapnil Nila, Chief Public Relations Officer of Central Railway, said Vande Bharat trains on all three new routes are the upgraded 2.0 version of the semi-highspeed trains.

"Central Railway has presented three more Vande Bharat trains with 21 updates to increase the comfort and safety of passengers," Nila said.

The eight-coach Pune-Kolhapur and Pune-Hubballi Vande Bharat Express trains will run three days per week, while the 20-coach Nagpur-Securndarabad Vande Bharat train will ply six days a week.

Pune-Hubballi Vande Bharat Express will leave Pune at 16.15 hrs on Monday and reach Hubballi at 23.40 hrs the same day. The Nagpur-Secunderabad Vande



Bharat Express will depart Nagpur at 4.15 PM and reach Secunderabad at 11.25 PM the same day, the CR stated

The Kolhapur-Pune-Kolhapur Vande Bharat Express will run three days per

Kolhapur-Pune Vande Bharat Express will run every Thursday, Saturday and Monday effective September 19. It will start from Kolhapur at 8.15 AM and reach its destination Pune at 1.30 PM the same day.

Pune-Kolhapur Vande Bharat Express will be operated every Wednesday, Friday and Sunday effective September 18. It will depart from Pune at 2.15 PM and reach Kolhapur at 7.40 PM the same day, the CR

The Kolhapur-Pune-Kolhapur Vande Bharat Express will halt at Miraj, Sangli, Kirloskarwadi, Karad and Satara stations.

The Pune-Hubballi-Pune Vande Bharat Express will also run three days a week on Thursday, Saturday and Monday.

With effect from September 19, the Pune-Hubballi Vande Bharat Express will leave Pune station at 14.15 hrs and reach Hubballi at 22.45 hrs the same day.

Hubballi-Pune Vande Bharat Express will be operated every Wednesday, Friday and Sunday from September 18. The train will leave Hubballi at 5 AM and reach Pune at 1.30 PM the same day with scheduled halts at Satara, Sangli, Miraj, Belagavi and Dharwad stations, the Central Railway said.

Nagpur-Secunderabad-Nagpur Vande Bharat Express will run six days a week, except Tuesday, departing from Nagpur at 5 AM on September 19 and reaching Secunderabad at 12.15 PM the same day.

The Secunderabad-Nagpur Vande Bharat Express will also run six days a week. except Tuesday, which will leave Secunderabad at 1 PM and reach Nagpur at 8.20 PM the same day. This train will halt at Sevagram, Chandrapur, Ballarshah, Ramagundam and Kazipet stations.

## Sena MLA announces reward for chopping

Mumbai: A Shiv Sena MLA Sanjay Gaikwad on Monday sparked yet another controversy after he announced a reward of Rs 11 lakh to anyone who will "chop off the tongue" of Congress leader Rahul Gandhi over his statements on reservation in

Gaikwad said andhi wants to end reservation for backward tribals and others and hence he is using language of ending it.

"When the demands of reservation are rising in Maharashtra and the country, senior Congress leader Rahul Gandhi made a statement to end reservation in the country. In the Lok Sabha elections, he spread a false narrative to get votes. Today he is speaking the language of ending reservation from the country and has shown the real face of the Congress. This is my challenge whoever chops off Rahul Gandhi's tongue will be given a reward of Rs 11 lakh on my behalf," said

Gaikwad. On his trip to the US, Rahul Gandhi said the Congress party will "think of ending reservation when India is a fair place" and that he was not interested in living in a country "where 90 per cent of the people do not have access to opportunity".

Gaikwad is an MLA from Buldhana. He is not new to controversies. In a video posted on social media in February this year, Gaikwad claimed he had hunted a tiger in 1987 and has been wearing a tooth of the animal around his

## Mahayuti likely to face ST ire over Dhangar move



Mumbai: The Mahayuti government's decision to recognise Dhangar and Dhangad as one community is likely to face a stiff opposition from the Sched-Tribe community.

The state government on Sunday announced to form a panel to establish the validity of the Dhangar community. Once these two communities are recognised as one the Dhangars will be able to get benefits of the ST quota.

Narhari Zirwal, an NCP leader, said he was not against the reservation to the Dhangar community. "Our only contention is that they should not be inducted in the ST and they should be kept out of the ST quota.

At present, the Dhangars are included in the Vimukta Jati (VJ) and Nomadic Tribe (NT). They VJ and NT have 2.5 per cent quota whereas the ST have 7 per cent quota.

The Dhangar (shepherd) community has been long demanding their inclusion in the ST.

"The government should have consulted us before taking this step. I will appeal all the ST MLAs and leaders to come forward against the government decision and protest the rights of the ST."

They point that all states excluding Maharashtra provide ST benefits to the community. In other states the community is known as Dhangad. "There is only a difference of pronunciation. A misplaced r instead of d cannot deprive us from the benefits of ST quota," a Dhangar leader said. The fallout

The Dhangars live mostly in Western Maharashtra and Marathwada They have a 9 per cent share in Maharashtra's population. The community is in good numbers in four Lok Sabha constituencies, Baramati, Madha, Solapur, and Satara. In 2015, the state government had roped in Tata Institute of Social Sciences (TISS) to establish whether Dhangars meet the criteria to be identified as ST. The study is yet unfinished.

If the Dhangars are included in their quota its repercussions are likely to be felt in the ST community.

Politically, the ST are divided between Congress and BJP. Over the period of years, the BJP has succeeded in making inroads in the ST bastions of north Maharashtra and Vidarbha. Any move going against the interests of the ST community is likely to dent the BJP vote bank in these areas ahead of the Assembly election.

The election is likely to be held in the second week of November.

#### Meat worth Rs 4 lakh seized

#### Labourer hammers contractor to death

Thane: A 23-year-old labourer was arrested in Ambernath in Thane district for allegedly bludgeoning his employer to death, a police official said on Monday. Saleem Yakub Sheikh hammered labour contractor Abdul Rehman (52) to death on Sunday following an argument after the former's daily wages were reduced from the promised Rs 1,000 to Rs 700, Ambernath police station senior inspector Ashok Bhagat said.

#### Man booked for abetment of suicide

Thane: A man was booked in Bhiwandi in Thane for abetment of suicide after a 16-year-old boy hanged himself, a police official said on Monday. The accused has been identified as vada pay seller Kunal Chowdhary, the Narpoli police station official said. "On September 11, deceased Gaurav Jha went to Chowdhary's shop to buy vada pav. He asked the teen to drop some items at his house, which the boy refused. Chowdhary slapped him. Insulted, the boy hanged himself in his house some time later," Senior Inspector Bharat Kamath said.

#### Man held for wife's murder

Thane: A 50-year-old man was arrested in Thane district within hours after he allegedly killed his wife by slashing her neck over domestic issues, police said on Monday. The accused, identified as Pritesh Shirke, was nabbed on Sunday evening, a few hours after he fatally attacked his wife, Draupati Shirke, 47, with a sharp weapon.

## **CR services** Court denies bail to suspected woman drug peddler



Mumbai: A special court here denied bail to a woman arrested in a drugs case, noting the offence was "heinous in nature" and releasing her may be prejudicial to the society's interest.

Priyanka Karkaur, a singer by profession, was held along with several other persons in December 2023 for alleged possession of a commercial quantity of drugs.

In an order passed earlier this month, special NDPS court judge Mahesh Jadhav stated the available material suggests the accused (Karkaur) had played an "active role" in the

"The offence alleged to be committed by the accused is of heinous nature." the court stated while rejecting the bail plea of Karkaur who claimed absence of "positive material" to establish a nexus between herself and the co-accused.

The amount of cash allegedly recovered by the probe agency was not related to her, the plea stated.

The prosecution contended that 14 grams of charas was found from Karkaur who was sitting in a car, along with the co-accused.

Additionally, two Aadhaar cards with photos of the accused with different names and Rs 17,06,250 cash were recovered from her house.

The quantum of drugs recovered is of commercial quantity which warrants a case under section 37 (offences involving commercial quantity) of the Narcotic Drugs and Psychotropic Substances Act (NDPS), the prosecution said.

The court noted that the investigation suggested the involvement of the accused in peddling drugs and colluding with the co-accused

At this stage, the accused prima facie failed to demonstrate that she was not involved in the crime.

"Considering the above facts and discussion and prima facie appreciation of the material on record, the release of the accused at this stage is likely to be prejudicial to the interest of the society at large," the court observed.

The liberal approach in granting bail in such kind of offences under the NDPS Act is also uncalled for.

On the prima facie appreciation of the material on record and considering the gravity of the offence, there are no justifiable grounds for releasing the accused on bail at this stage, the judge said.

## Dengue, Malaria make citizen ill

**Mumbai:** The city has been reeling under vector-borne diseases, which are increasing every month, leading to people falling sick. In just two weeks of September (1-14), the Brihanmumbai Municipal Corporation (BMC) recorded a 25.44 per cent and 17.47 per cent rise in Dengue and Malaria cases compared to August (1-14) during the same period. Meanwhile, the cases of other illnesses have witnessed a steep drop.

According to the BMC monsoon report, the city recorded 705 dengue cases from September 1-14, an increase from the 562 cases recorded in the fortnight of August. Similarly, Malaria cases increased to 605 in the first 14 days of September, compared to 555 recorded between August 1-14.

As per the doctors, these

illnesses may persist for a week or two even after the rain stops completely. They are expecting to see a reduction in cases by mid- or end-September. If rain continues, there is also a possibility of a further spike in cases by September or October.

A state official said the rise in dengue was a global problem and that overall weather conditions and heat have contributed to an untick in its transmission. Additionally, reporting has been strengthened for all vector-borne diseases, said the official.

J.J. Hospital's medicine unit head Dr. Madhukar Gaikwad said they see 10-12 dengue cases daily, of which 50-60 per cent of patients need hospitalisation as their platelet count decreases. "Most of them come with fever, body pain and headaches. It takes them around 8-14 days to recover

Prior to his appointment at the institute, Ranade was group executive president and chief economist with Aditya Birla Group. He has taught in universities in India and the US and has served as member of several RBI committees.

He was also a member of the Maharashtra Government's task force on postpandemic economic recovery.

# **SEBI** withdraws statement on unprofessional work

New Delhi: Seeking to defuse tensions with employees protesting against alleged "unprofessional work culture," SEBI on Monday retracted its earlier statement blaming "external elements" for the unrest and committed to address the concerns 'amicably internal through channels'.

The withdrawal comes nearly two weeks after a protest on September 5. where hundreds of SEBI employees gathered outside the regulator's headquarters demanding the withdrawal of the contentious September 4 press release and the resignation of SEBI chairperson Madhabi Puri Buch.

The initial statement had suggested that the protesting employees were being influenced by external forces to target Sebi's credibility and leadership.

This was not the first instance of a protest at the SEBL which witnessed a similar protest over a month-ago by some employees. At that time, officials had said that the protests were by a few elements and did not have the backing of the recognised unions or associations.

In its fresh statement on Monday, the Securities and Exchange Board of India (SEBI) emphasized that it handles employee-related matters through proper internal mechanisms and that it had constructive discussions with officers from various grades.

"SEBI addresses employee-related matters through appropriate internal

## **Doctor Rape And Murder Case**

# Ghosh was in touch with policeman 12 hrs before case registered: CBI

New Delhi: R.G. Kar Medical College's former principal Sandip Ghosh was found to be "deceptive" while answering important questions on the rape and murder of a trainee woman postgraduate doctor during his polygraph test and layered voice analysis, officers

The CBI, probing the case, arrested Ghosh on September 2 in connection with financial irregularities at the hospital. The federal probe agency later added charges of evidence tampering against him.

During the investigation, Ghosh was subjected to layered voice analysis and polygraph test.

According to a report from Central Forensic Science Laboratory (CFSL), New Delhi, his version has been found to be "deceptive on certain important issues" relating to this case, officials in the know of the developments said.

Information revealed during the polygraph test may not be used as evidence during the trial but the agency may gather corroborative evidence which could be used in court, they said.

A polygraph test can help in assessing inaccuracies in the statements of suspects and witnesses. By monitoring their psychological responses, heart rate, breathing pattern, sweating and blood pressure, investigators can determine if there are discrepancies in their

"We have the majority and we will be invited and then the process for oath taking will happen. This should take a week," he added.



The Garhi Sampla-Kiloi assembly segment, a Jat-dominated rural constituency in Rohtak from where the former chief minister is seeking a reelection, came into being in 2007, following the delimitation of constituencies. ## Audit report flags 'lack of coordination'

the Accountant General of Madhya Pradesh has flagged concerns over the management of Project Cheetah in Kuno National Park, highlighting a "lack of coordination" between central and state government departments.

The report also revealed that despite the arrival of cheetahs from Africa, the park's management plan for 2020-2030 has no mention of cheetah reintroduction.

When asked about these concerns, the chief conservator of forests and director of the Lion Project, Uttam Sharma, said they had provided responses to the auditors but declined to share specific details. "It's

conducted in several phases. Any action, if required, will be taken after the completion of the entire process," he said.

The audit, covering the period from August 2019 to November 2023, found that ground staff and the Kuno Wildlife Division were not involved in either "site selection" or "cheetah reintroduction study".

The report, obtained under the Right to Information Act, said the Kuno Sanctuary was originally identified as a second habitat for Asiatic lions. "However, no effort has been made for the reintroduction of Asiatic lions till November 2023," it said.

S.P. Yadav, the Director



al Big Cat Alliance, told PTI last week that natural geographic isolation is occurring among Asiatic lion populations in Gujarat and there is currently no need to translocate them.

The audit report said, "There was no mention of cheetahs in this management plan... Therefore, the expenditure of Rs 44.14 crore incurred on Project Cheetah from 2021-22 to 2023-24 (till January 2024) was not in accordance with the approved management plan."According to the report, the auditors could not find any records clarifying "under whose instructions the cheetah reintroduction work began".

## Typhoon Bebinca makes landfall in Shanghai

Beijing: Bebinca, the strongest typhoon to have hit China's Shanghai city in 75 years packing wind speed of 42 meters, made landfall on Monday bringing the megacity of 25 million to a grinding halt.

The typhoon, with the maximum wind force near its center reaching 42 meters per second, churned ashore at the Lingang area of Shanghai's Pudong District, the Shanghai central meteorological observatory said. The city has already mobilised thousands of relief and rescue workers to

attend to emergencies Bebinca is believed to be the strongest typhoon to land in Shanghai in 75 years. It is the 13th typhoon

to hit China this year. The State Flood Control and Drought Relief Headquarters on Sunday activated a Level IV emergency response for east China's Anhui Province and raised the response in Shanghai and Zhejiang to Level III, state-run Xinhua news agency reported. Bebinca has already led to flight cancellations.

## Two earthquakes jolt British Columbia

Vancouver (British Columbia): Two earthquakes struck off the northern coast of the Canadian province of British Columbia Sunday but there were no immediate reports of damage.

The United States Geological Survey said the first earthquake, measuring magnitude 6.5, happened around 3:20 pm local time.

It was located off the tip of Haida Gwaii, an archipelago located about 1,720 kilometres (1,069 miles) north of Vancouver and occurred at a depth of 33 kilometres (20 miles).

Natural Resources Can-

ada said a second earthquake, measuring 4.5, occurred about an hour

later in the same area. The US Tsunami Warning Center reported that there was no threat of a tsunami from the quakes. No damage was

reported.

## Replacing rice with other crops could recover groundwater

New Delhi: Replacing about 40 per cent of the area sown with rice with other crops could help recover 60-100 cubic kilometres of groundwater lost since 2000 in north India, a study has found.

Current cropping patterns -- dominated by rice, which relies heavily on groundwater for irrigation -- could result in a loss of about 13-43 cubic kilometres of groundwater if warming of the planet continues, a team of researchers, including those from the Indian Institute of Technology Gandhinagar, Gujarat, said.

The researchers proposed shifting from existing cropping habits by cutting down on cultivating rice as a potential solution for sustaining the fast-depleting resource in a warmer world that threatens food and water security.

"Replacing 37 per cent area of rice with other crops can recover 61 to 108 cubic kilometres groundwater compared to 13 to 43 cubic kilometres with current cropping pattern under the 1.5-3 degrees Celsius global warming levels," the authors wrote in the study accepted for publication in the journal Proceedings of the National Academy of Sciences (PNAS) Nexus.

Compared to current cropping trends, the benefits of switching crops in saving



groundwater are more during the prolonged dry periods predicted under global warming, the researchers said

Changing crop patterns can

be substantially beneficial -particularly for the states of Punjab, Haryana, and Uttar Pradesh -- for ensuring groundwater sustainability

According to the 2018 Intergovernmental Panel on Climate Change's (IPCC's) Special Report: Global Warming of 1.5 degrees Celsius, if current trends continue, global warming is likely to reach 1.5 degrees Celsius between 2030 and 2050 and could reach 3 degrees Celsius by 2100.

and farmers' profitability, the authors said.

They also found that switching of crops did not substantially impact groundwater levels where recovery rates were low such as in the states of Himachal Pradesh, Uttarakhand, and Jharkhand.

The findings have policy implications for identifying optimal cropping patterns for sustaining groundwater in the irrigated regions of north India, along with ensuring farmers' profitability and income, they said.

Previous estimates have suggested that about 300 cubic kilometres of groundwater have been lost between 2002 and 2022 as a result of the cropping trends in north India, where 80 per cent of the cultivated area is sown with rice.

Parts of Punjab and the Ganga basin experienced the

fastest rates of groundwater depletion in the world, the researchers said, and added that northern and northwestern regions of India are among the global groundwater hotspots. Studies have shown crop

switching to be beneficial for environmental sustainability and farmers' income in China, the US and India.

In this study, the researchers looked at current cropping patterns in regions that have seen considerable groundwater depletion. The team then used groundwater, well and satellite observations and models to estimate groundwater lost between 2002 and 2022.

# Trump's attacker supports Harris, Ukraine

New York: In an apparent second assassination attempt on Republican presidential nominee Donald Trump, the former President was moved to safety after authorities a man armed with an AK-style rifle was found hiding at a golf course in Florida.

The man, hiding in bushes roughly 400-500 yards from Trump, was confronted by Secret Service agents. Agents opened fire when they spotted the gunman and fired four to five rounds of ammunition, reports said. Sheriff Bradshaw stated that the suspect dropped the rifle and fled in a vehicle, abandoning the weapon along with two knapsacks, a scope used for aiming a weapon and a Go-Pro camera. The FBI is currently leading the investigation.

The man has been identified as Ryan Wesley Routh by news agency AP. The FBI, so far, has declined to comment

#### Who is Ryan Wesley Routh?

The 58-year-old is originally from North Carolina and later a resident of Hawaii. Routh operated a shedbuilding business with his son and had a notable presence on social media, where he frequently commented on US politics and international affairs.

According to AP, voter records show Routh as an unaffiliated voter in North Carolina. He most recently voted during the state's Democratic Party primary in March 2024. He has also made donations to Act-

Blue, a political action committee that supports Democratic candidates.

On his social media, Routh has supported former Democratic candidate Tulsi Gabbard, who later switched over to the Republican party. Over the years, his political views have shifted towards supporting President Joe Biden and Vice President Kamala

#### What we know from Routh's social media?

Following the first assassination attempt on Trump in Pennsylvania, Routh urged Biden and Harris to visit those wounded in the shooting at the hospital and to attend the funeral of a former fire chief killed at the rally.

He has also expressed support for Ukraine's fight against Russia's invasion. He frequently commented on the war on his social media, and ran a website to raise money and recruit volunteers to go to Kyiv.

#### Routh's past

Routh has had multiple run-ins with law enforcement, including a conviction in 2002 for possession of a weapon of mass destruction following a standoff with North Carolina police.

After the incident, Trump, in an email to his supporters, confirmed he was unharmed and expressed gratitude to his security team for their swift action. He was on the fifth hole of his golf course when the event occurred and was quickly evacuated. Though safe, Trump joked that he regretted not finishing his round, as he "was even and had a birdie putt." Fox News host Sean Hannity, a close associate, reported that Trump remained in good spirits.

This marks the second

recent attempt on Trump's life. Two months ago, during a campaign event in Butler, Pennsylvania, Trump was shot at, with one bullet grazing his right ear. The Secret Service later confirmed that the shooter was killed during the incident, which also left one rally attendee dead and two others injured. The shooter was identified as Thomas Matthew Crooks of Bethel Park, Pennsylvania. Security officials have told CBS News that the suspect fired from between 200 ft and 300 ft away on an elevated shed with an ARstyle rifle. -AP

## **Germany begins** random checks at borders

day began random checks at its borders with five Western European nations as it seeks to crack down on irregular migration, expanding a system of controls that are already in place at four other

The police controls began at the borders with France, the Netherlands, Belgium, Luxembourg and Denmark on Monday morning and are due to continue for six months. Germany has already been carrying out the checks at its borders with Poland, the Czech Republic, Austria and Switzerland since last vear.

Germany, a European Union member, announced last week that it was expanding border checks to all nine of its land borders this week as part of an effort to crack down on irregular migration and crime following recent extremist attacks. Last month, a knife attack blamed on a Syrian asylum-seeker in Solingen killed three people. The suspect claimed to be inspired by the Islamic State group. In June, a knife attack attributed to an Afghan immigrant left a police officer dead and four

other people wounded. The border controls are testing European unity because it is seen by some as a step away from the spirit of the EU's free travel arrangement known as Schengen. The freedom of citizens in Europe to travel freely across borders for work and pleasure is one of the most beloved benefits of the EU.

The other is Pakistan. News of the suspension was relayed to UN agencies right before the September immunisation campaign was due to start. No reason was given for the suspension, and no one from the Taliban-controlled government was immediately available for comment.

A top official from the World Health Organisation said it was aware of discussions to move away from house-to-house vaccinations and instead have immunisations in places like mosques

The WHO has confirmed 18 polio cases in Afghanistan this year, all but two in the south of the country.

That's up from six cases in "The Global Polio Eradi-

cation Initiative is aware of the recent policy discussions on shifting from house-to-house polio vaccination campaigns to siteto-site vaccination in parts of Afghanistan," said Dr. Hamid Jafari from the WHO. "Partners are in the process of discussing and understanding the scope and impact of any change

in current policy. Anti-polio campaigns in neighbouring Pakistan are regularly marred by violence. Militants target vaccination teams and police assigned to protect them, falsely claiming that the campaigns are a Western conspiracy to sterilise children.

The suspension of the September campaign is a blow for the eradication of

ment an "intensive and synchronized campaign" focusing on improved vaccination coverage in endemic zones and an effective and timely response to

detections elsewhere. During a June 2024 nationwide campaign, Afghanistan used a house-tohouse vaccination strategy for the first time in five years a tactic that helped to reach the majority of children targeted, the WHO

But southern Kandahar province, the base of Taliban supreme leader Hibatullah Akhundzada, used site-to-site or mosque-tomosque vaccination campaigns, which are less effective than going to people's homes.

Kandahar continues to have a large pool of susceptible children because it is not carrying out house-tohouse vaccinations, the WHO said.

## Former BBC news anchor gets suspended sentence

# Papua New Guinea violence: 20-50 killed

Melbourne: Between 20 and 50 people have been killed in violence among illegal miners in Papua New Guinea, a United Nations official said Monday.

The fighting started days ago and is continuing in the Porgera Valley, near the site of a landslide in May estimated to have killed more than 2,000 people, according to the South Pacific island nation's government.

The U.N.'s humanitarian adviser for Papua New Guinea, Mate Bagossy, said

the death toll of at least 20 as of Sunday was based on information from community members and local authorities in Enga province in the nation's mountainous inland.

"We have confirmed that at least 20 people have been killed, but as per the last news that I have, it's likely up to 50 people," Bagossy told The Associated Press. "The fighting is continuing.

Bagossy did not have information on the numbers wounded

## TikTok heads to court over US law

Washington: The US government and TikTok will go head-to-head in federal court on Monday as oral arguments begin in a consequential legal case that will determine if - or how - a popular social media platform used by nearly half of all Americans will continue.

Attorneys for the two sides will appear before a panel of judges at the federal appeals court in Washington. TikTok and its China-based parent company, ByteDance, are challenging a U.S. law that requires them to break ties or face a ban in the U.S.

## Columnists resign over fabricated artciles

London: Three prominent columnists have resigned from the newspaper Jewish Chronicle over allegations it published fabricated articles about the Israel-Hamas

The resignations on Sunday came after the Londonbased newspaper removed multiple articles by a freelance journalist and apologized to readers, saying it conducted an investigation into the writer and was "not satisfied with some of his claims".

The newspaper did not specify which articles by the journalist, Elon Perry, were problematic. Among other claims, Perry — who described himself as a commando in the Israel Defense Forces — alleged that Hamas leader Yahya Sinwar planned to smuggle himself and Israeli hostages out of Gaza through the border area with Egypt known as the Philadelphi corridor. The claims were questioned by Israeli media outlets. Long-time Jewish Chron-

icle columnist Jonathan Freedland resigned in protest on Sunday, saying "the latest scandal brings great disgrace on the paper" and that it has "departed from the traditions that built its reputation as the world's oldest Jewish newspaper".

"Too often, the JC (Jewish Chronicle) reads like a partisan, ideological instrument, its judgements political rather than journalistic," Freedland wrote on the social media platform X.

Singapore: Senior Minister Teo Chee Hean, in his Diwali message, has urged Singaporeans to take part in festivals across all communities to foster unity and a shared sense of humanity.

## IS responsible for killing two Pak police officers

Quetta (Pakistan): The Islamic State group claimed responsibility for the weekend bombing that killed two police officials in restive southwestern Pakistan, officials said on Monday.

Analysts say the latest violence is a sign of increasing coordination between Islamic militants and separatists who for years have been targeting security forces and civilians in the oil- and gas-rich dering Iran and Afghanistan.

The Islamic State group said in a statement on Sunday that it detonated an explosive device a day earlier targeting a Pakistani police vehicle in Kuchlak town near Quetta, the capital of Balochistan. Pakistani officials say the attack killed two officers and wounded two others on a highway.

## Constitutional Overreach?

ndia's Vice-President Jagdeep Dhankhar recently launched a scathing attack on Congress leader Rahul ■Gandhi over remarks the latter made in the United States, accusing Gandhi of undermining the Indian Constitution. Gandhi, no stranger to controversy, has often aimed his verbal salvos at the ruling Bharativa Janata Party (BJP) with his overseas speeches being thinly-veiled criticisms of India's democratic fabric under the Modi administration. But the Vice-President's public remarks has raised an important constitutional question: Should a figure occupying one of the highest apolitical offices in the land act as a de facto spokesperson for the ruling party?

Vice-presidents are meant to embody neutrality. According to the Constitution, India's Vice-President, like its President, is expected to rise above partisan squabbles, representing the entire polity rather than a single faction. The office of the Vice-President holds a unique position—it is second only to the President, and also serves as the chair of the Rajya Sabha, or the upper house of Parliament. In this role, impartiality is critical to maintain the balance of power between the government and the opposition.

Yet Dhankhar's outburst against Gandhi hints at a troubling erosion of this impartiality. While the Congress leader's comments about India's democracy and Constitution may warrant scrutiny, the Vice-President's role is not to censure political figures but to uphold the dignity of his office and the constitutional values he is tasked with safeguarding. When a vice-president adopts the language of a party loyalist, it undermines not only the office he holds but the very essence of India's democratic institutions.

This is not an isolated case. Indian politics has a long history of its vice-presidents showing leanings towards the ruling establishment. In the late 1970s, Vice-President B.D. Jatti, who briefly acted as President, was criticized for his perceived proximity to the ruling Congress party under Indira Gandhi, especially during the Emergency. Similarly, Gopal Swarup Pathak, Vice-President from 1969 to 1974, was accused of leaning towards Congress when he controversially withheld assent for a crucial bill, allegedly under pressure from the ruling party.

More recently, Hamid Ansari, who served as Vice-President from 2007 to 2017, was frequently targeted by the BJP for allegedly displaying a 'pro-Muslim' bias, though Ansari himself consistently maintained his commitment to the Constitution. To be sure, the criticisms Gandhi made abroad may well have crossed the line of diplomatic propriety, but such remarks should ideally be rebuffed by government ministers or party leaders—not the Vice-President. By involving himself in the day-to-day political fray, Dhankhar risks reducing his office to just another tool in the hands of the ruling establishment. Ultimately, the Vice-President is not a partisan warrior but a custodian of constitutional values. Regardless of whether Rahul Gandhi's criticisms of the government deserve rebuke, it is not the Vice-President's role to deliver it. When they act as political enforcers, they not only diminish their own role but also erode the public's trust in India's constitutional institutions.

## Towards a Healthy India

yushman Bharat Pradhan Mantri Jan Arogya Yojana (PM-JAY) **L**is a national health insurance scheme by the Government of India, offering free healthcare coverage to lowincome earners and a range of benefits. It covers a wide range of medical expenses, including medical examinations. treatment, and consultation; pre-hospitalisation up to three days; medicine and medical supplies; non-intensive and intensive care services; diagnostic and laboratory tests; medical implantation services; accommodation benefits; and food services. Unlike previous schemes, this one offers medical and allied services completely free.

More so, it comes with cashless access to healthcare services at empanelled public and private hospitals across India. Additionally, these benefits are port-

able across India, so beneficiaries can visit any empanelled hospital for cashless treatment, and there are no restrictions on family size, age, or gender, However, it was observed that over a quarter of those admitted under the scheme were senior citizens, many of whom still faced barriers due to income restrictions. Therefore, the union cabinet's decision to remove income level conditions for Ayushman Bharat beneficiaries was a logical step to ensure broader access to healthcare, especially for the elderly.

While PM-JAY is a significant step toward addressing healthcare accessibility for low-income groups, the broader healthcare landscape in India remains a complex mix of progress and challenges. On one side, one would find glitzy steel and glass structures delivering hightech medicare to the well-heeled, mostly urban Indian, while at the other end rests the ramshackle outposts in the remote reaches of the "other India," trying desperately to live up to their identity as health sub-centres, waiting to be transformed into shrines of health and wellness. With the rapid population growth,

diversity is likely to bring in even more complexity in the future. However, awareness, accessibility, affordability, and accountability have consistently been common challenges, while the availability of adequately trained manpower remains the primary hurdle in providing healthcare for all.

The glorious tradition of our public health dates back to the Indus Valley civilisation (5500-1300 BCE), where one finds mention of "Arogya" as reflecting "holistic well-being." However, the five A's mentioned earlier prevented us from attaining the goal of Aarogya for all. The enormity of the goal catering to almost a fifth of the global population—was also an obvious cause.

Awareness is the foremost challenge. Adequate knowledge regarding breastfeeding practice was found in only onethird of the antenatal mothers in two studies. Moving ahead in the lifecycle, a study in urban Haryana found that only 11.3% of the adolescent girls studied knew correctly about key reproductive

A review article on geriatric morbid-

ity found that 20.3% of participants were aware of common causes of prevalent illness and their prevention. All these studies indicate a low level of health awareness in the Indian population. The remedy to this problem can be found in the recent success of Swach Bharat Abhivan and the way the issue of open defecation was made an issue of the past. A similar time-bound approach and timely interventions at the school level would help resolve this problem.

There is hardly any diversity of opinions that other issues of accessible, affordable, and accountable health facilities would be resolved with the advancement of schemes like PMJAY. What remains is the issue of the availability of an adequately trained workforce. With the present government's thrust on skills training and the rapid increase in the training facilities for medical and paramedical students across the country, the issue of the availability of workforce is expected to be resolved very soon.

While initiatives like PM-JAY are tackling domestic healthcare challenges, they also have broader implications. As India enhances its healthcare infrastructure and access for its citizens, it simultaneously establishes itself as a leading destination for medical tourism. Factors such as cost-effective treatments, advanced technology, a diverse range of specialities, alternative medicine options, English language proficiency, and ease of travel have all contributed to the growth of India's medical tourism industry.

While India's healthcare sector is evolving with initiatives like PM-JAY and the rise of medical tourism, the journey toward providing comprehensive, accessible, and affordable healthcare for all is far from over. Addressing the systemic challenges of manpower shortages, infrastructure gaps, and health awareness will be key to building a more equitable healthcare system. With continued investment and innovative solutions, India has the potential to transform not just as a leader in medical tourism but also as a country that ensures quality healthcare for all its citizens.

# What If Aurangzeb Had Lost the War of Succession?

ounterfactual history, though generally disdained by scholars, can be valuable in exploring alternate historical outcomes by respecting historical evidence as stressed by historian Niall Ferguson.

While the question of what might have happened had Aurangzeb lost the 'War of Succession' (1658-59) may seem asinine, contemplating an alternate outcome is fascinating as it doubtless would have altered the trajectory of Indian history. Aurangzeb's triumph over his elder brother Dara Shikoh in the decisive battles of Dharmat, Samugarh, and Deorai paved the way for his 49-year reign, marked by territorial expansion and religious orthodoxy.

Aurangzeb's military prowess was undeniable. His victories were not the result of mere luck, but of superior generalship, tactical expertise, and an ability to remain calm under pressure. His defeat of not only Dara but also his other brothers, Shah Shuja and Murad Baksh, set the stage for his reign, which historian Sir Jadunath Sarkar describes as bringing the Mughal Empire to its greatest extent. In his monumental five-volume 'History of Aurangzib' (1912-24), Sarkar notes how Aurangzeb's empire stretched from Ghazni to Chittagong and Kashmir to the Karnatak—an expanse unmatched by any Indian state prior to British rule.

Yet, the cost of this expansion was immense and the socio-religious tensions it fostered left lasting scars on the subcontinent. Had Dara Shikoh won, the ethos of the empire would



have been fundamentally different. Known for his deep intellectual curiosity and his commitment to fostering religious inclusivity, his translation of the Upanishads, the ancient Hindu philosophical texts, from Sanskrit into Persian in Sirr-e-Akbar ('The Greatest Mystery'), aimed to reconcile the mystical elements of Hinduism with Islam. He boldly asserted that the Upanishads held the key to understanding the esoteric aspects of the Quran, a view that placed him at odds with the more orthodox Islamic factions of the Mughal

Dara's deep respect for Hindu culture and close relationships with Raiput rulers set him apart from Aurangzeb, who later alienated the Rajputs with his aggressive policies. It is conceivable that the Rajput revolt of 1679, which saw Durgadas Rathore rise against Aurangzeb after the Mughal emperor attempted to annex Marwar, would never have occurred

Beyond the Rajput rebellion, the protracted Mughal-Maratha war in the Deccan (1681-1707), which bled the empire of its wealth and resources, could also have been avoided. Aurangzeb's execution of Chhatrapati Sambhaji in 1689 incited widespread resistance among the Marathas, turning the Deccan into a quagmire that drained Mughal coffers and military

might. Sarkar, in his comparison of this conflict to Napoleon's Peninsular War, remarked that "the Deccani ulcer killed Aurangzeb." A more diplomatically inclined Dara might have sought a peaceful resolution to the Deccan problem, sparing the empire from this debilitating war.

The execution of Guru Tegh Bahadur in 1675 solidified Sikh resistance, with Guru Gobind Singh transforming the Sikhs into a militant community through the founding of the Khalsa in 1699. Dara's more inclusive policies might have prevented this radicalization, preserving the Sikhs as a spiritual movement rather than a military force

The Jat rebellion in Agra, led by Churaman and later his nephew Badan Singh, was another consequence of Aurangzeb's oppressive rule. The Jats, emboldened by the emperor's preoccupation with other fronts, rose in defiance, destabilizing Mughal authority in northern India.

While François Bernier, the 17thcentury French physician and traveller, dismissed Dara as politically naïve, Sarkar was critical of Dara's limitations as a ruler of men. Nonetheless, had he triumphed, he would have left behind his vision for a pluralistic India. Aurangzeb's orthodox reign, by contrast, left the empire weakened by internal strife, setting the stage for its eventual decline.

# Intense Wrestling Among Parties For Future

he upcoming Haryana Assembly election, already a significant battleground for the ruling Bharatiya Janata Party (BJP) and the opposition, has gained a new dose of star power. The state, known for its history of agricultural protests and castebased politics, now finds its electoral stage glamorized by the entry of two iconic women: Vinesh Phogat and Kavita Dalal. Both hailing from Haryana's wrestling heartland, they have garnered national fame and international accolades, with Phogat as a Commonwealth Games gold medallist and Dalal, (known by her moniker Kavita 'WWE' Dalal) as a professional wrestling sensation.

## What's at stake in Sri Lanka's first presidential vote since its economic meltdown?

🦳 ri Lanka will hold its presidential election on Sept. 21 in a crucial vote that will decide the future of the South Asian nation still struggling to recover from its economic collapse in 2022, which provoked mass protests and forced the former President Gotabaya Rajapaksa to flee the country and later resign.

The election is seen as a referendum on President Ranil Wickremesinghe's two-yearlong rule that has overseen a fragile recovery of the country's economy.

He faces a tough challenge from the leader of the opposition in parliament, as well as from a left-leaning politician with a powerful alliance, who is gaining popularity among young voters.

#### Who are the main candidates?

Wickremesinghe, whose United National Party has been weakened by a split, is running as an independent candidate. Even though Wickremesinghe remains unpopular for carrying out austerity measures including sharp tax hikes — in exchange for an International Monetary Fund bailout, he is hoping to gain votes from his success in largely abating the shortage of essentials such as fuel, cooking gas, medicines and food. But Wickremesinghe — a six-time Prime Minister — is at a disadvantage because he belongs to the old guard, whom Sri Lankans blame for

the economic collapse. Anura Kumara Dissanayake, the leader of a Marxist-led coalition named National People's Power, is fast emerging as a key challenger to Wickremesinghe due to his popularity among the young people fed up

with corruption that they be-

lieve caused the economic crisis. He is also drawing support from some voters who participated in the 2022 protests demanding the resignation of the then-President Rajapaksa.

Although he has been a leftist in the past, Dissanayake now professes economic freedom and promises welfare measures to help the working class. Political analysts say he is a strong contender because, unlike his rivals, he is not linked with the business and political elites who ran the country in the past.

Wickremesinghe's other challenger is Sajith Premadasa, the incumbent president's former deputy and leader of his breakaway party, United People's Power. Premadasa promises to continue with the IMF program but with changNo of Sri Lanka's eligible people for voting

people. He has also promised a degree of power devolution to the minority Tamil community, who make up about 11 per cent of the country's population. In return, Premadasa has secured the support of a strong Tamil political bloc.

#### How does the election work?

Votes will be cast throughout the day on September 21, with results expected to be out by evening the following day.

Voters can select three candidates from the ballot paper in the order of their preference. The first preferences will be counted first and the candidate who secures more than 50 per cent of the valid votes will be declared winner.

If there is no clear winner, the first two candidates will be retained in the race and ballot papers that chose other candi-

dates for No. 1 will be checked to see if either of the top two contenders are their second or third preference. Those votes will be added to the tally of the remaining two candidates. The candidate who gets the highest number will be declared the winner.

Sri Lanka has a powerful executive presidential system with the President being the head of state, government, cabinet and the armed forces. The prime minister has some powers like recommending Cabinet ministers.

There are no reliable opinion polls to suggest which candidate is in the lead, but many observers say Dissanayake has been gaining popularity.



New Delhi: Olympic medallists Sakshi Malik and Aman Sehrawat, along with former world championship bronze-winner Geeta Phogat, on Monday announced that they would soon launch a Wrestling Champions Super League (WCSL) for the country's budding grapplers but are yet to get the national federation's backing for it.

Sakshi, along with Bajrang Punia and Vinesh Phogat, had spearheaded the wrestlers' protest against ousted Wrestling Federation of India President Brij Bhushan Sharan Singh, who was accused of sexual harassment.

She has, however, distanced herself from the latter two after they took the political plunge by joining Congress ahead of next month's Haryana assembly elections.

She won the 58kg bronze in 2016 Rio Olympics, and announced the project with Phogat, a 55kg bronze winner in 2012 World Championships through their social media handles. The two, while announcing that they had Paris Games bronze-winner Aman on board, did not provide any details.

Phogat told PTI that she is hopeful of support from the federation and the government.

"We are doing it for the players, for their benefit. -PTI : That is the idea and vision, Sakshi and I have been planning this League for long. Soon it will take a final shape. We have not yet spoken to the WFI but it would be great if **WFI** and government support us. It will be the first league that will be

two in-form stars in World Championship challenger D Gukesh and Arjun Erigaise, the Indian men scored a 3-1 victory over Azerbaijan in the fifth round of the 45th Chess Olympiad here.

It seems like Gukesh and Arjun can do nothing wrong in this Olympiad as they overpowered Aydin Sulemanli and Rauf Mamedov respectively with their white pieces in quick time.

Praggnanandhaa played another draw on board two to only ensure an Indian victory while Vidit Gujrathi played out a draw with Shakhriyar Mamedyarov in a marathon game to complete the triumph.

After scoring the fifth victory on the trot, the Indian men maintained a



clean slate on ten points and they were joined by Vietnam who continued with their impressive show and downed Poland 2.5-1.5.

The other two teams that joined the leaders' pack were China and Hungary who scored identical 2.5-1.5 victories over Spain and Ukraine respectively.

With six rounds still to come in the biggest chess event, Magnus Carlsen's

Norway and Iran are the only two teams sharing the

fifth spot on 9 points apiece. Norway defeated a talented Turkey team by a 3-1 margin while Iran made most of the opportunities to down Canada 3.5-0.5.

In the women's section, Grandmaster D Harika suffered a shock defeat to give Kazakhstan an early lead. Better for most of the game. Harika misplayed after many pundits believed her now followed by Georgia position to be winning against Bibisara Assaubayeva.

"We have been working on mental strength for a long time. The last 3-4 overs are the most crucial. T20 cricket is not a small format; at the end of the day, you are playing 40 overs," Kaur told Star Sports.

"In the last 4-5 overs, the team that is mentally strong wins the

match. We have been focusing on this for a while. If we can remain mentally stable in those final five overs, we can execute what's best

India's performances in summit clashes have featured in discussions given the team lost in the 2020 final by 85 runs to Australia, while England had pipped them by a mere nine runs in the 2017ODI World Cup final.

Even in the Commonwealth Games 2022. Australia eked out a nine-run win to clinch the gold medal despite a spirited show with the bat from India in the final, with Kaur's team settling for the silver.

"We are working on those aspects, and hopefully, we will overcome this hurdle in the tournament," she added.
