# Haryana polls deferred to honour Bishnois

New Delhi: The Election Commission on Saturday deferred the Haryana assembly poll date to October 5 from October 1, saying the decision was taken keeping in mind a centuries-old festival of the Bishnoi community.

The counting of votes for Jammu and Kashmir and Haryana assembly polls will now be held on October 8 instead of October 4.

It has been a practice of the EC to hold the counting of votes on the same day for assemblies which go to polls together as the results of one state could affect trends in others.

Before the revision of the date, the Haryana polls were to be held along with

Interestingly, the **Chief Election Commissioner** Rajiv Kumar had cited the reason of festival season for not holding the **Assembly elections** in Maharashtra along with Haryana.

the third and last phase of the Jammu and Kashmir elections.

The decision to postpone the Haryana elections has been taken to honour both the voting rights and traditions of the Bishnoi community which has upheld a 300-400-year-old practice in remembrance of their Guru Jambheshwar, the EC said.

It said it had received a representation from the national president of the All India Bishnoi Mahasabha, Bikaner, Rajasthan for rescheduling the Haryana assembly elections.

### NC to prioritise lifting of AFSPA

Srinagar: The National Conference will prioritise the lifting of AFSPA from Jammu and Kashmir and put an end to the "unjust harassment faced by Kashmiri youth" if it is voted to power, party vice-president Omar Abdullah said on

Abdullah had pitched for the revocation of the controversial Armed Forces (Special Powers) Act (AFSPA) in 2012 when he was chief minister of the erstwhile Jammu and Kashmir state.

He had even announced that AFSPA would be revoked during his tenure but the proposal faced strong opposition from the Army.

Once in power, the National Conference-led government will prioritise the lifting of AF-SPA, putting an end to the unjust harassment faced by our youth," Abdullah said as he welcomed prominent political activists into the

#### Third front taking shape in Maharashtra Manoj Jarange-Patil is likely to join hands with Bachchu Kadu, Sambhaji Raje and Rajratna Ambedkar By Suyash Padate

Mumbai: Despite Past Hiccups, a third front consisting of smaller parties is in the offing in the state. Prahar Janshakti Party (PJP) leader Bachchu Kadu has taken the initiative to form this alliance ahead of Assembly elections in Maharashtra. This development is seen as an attempt to queer the

pitch for Maharashtra Vikas

Aghadi (MVA). Even as the ruling as well as the opposition gears up for the crucial assembly elections, at least a half a dozen smaller parties with pockets of influence in the state have announced their plans to either go solo or ioin the third front. Calling the exercise as a gamechanging development, Bachchu Kadu seems to be confident of smooth sailing

of the third front. Speaking to The Perfect Voice, Kadu, a Shiv Senabacked Independent MLA said, "We are considering joining hands with former Rajya Sabha MP Sambhaji Raje Chhatrapati and Bhartiya Jawan Kisan Party



leader Narayan Ankush to form a third front in the state. If this government does not make any decision regarding farmers and the disabled, I am prepared to take action. What's the use of leaders who say 'Jai Shivray' and 'Jai Shriram' only for convenience? The third front will be established in the next two weeks. After the formation of this front we will leave the Mahavuti soon"

Kadu's PJP was the first partner of the MVA government to offer its support to the Shiv Sena rebel group led by Eknath Shinde. However, he was unhappy because he wasn't given a ministerial berth in the government. While expressing his dissatisfaction with the government, Kadu said, "My party will contest 20 seats in the forthcoming election. It will be too early to say anything but once we reach a decision we will make the announcement".

Sources have claimed that efforts are being made to include Prakash Ambedkar and his Vanchit Bahujan Aghadi (VBA) in the front. The discussion among the leaders focused on how many seats each party will contest and the key issues the third front will prioritise. However, even after the two meetings consensus has not yet been reached on some key points.

Significantly, Rajratna Ambedkar, great grandson of Dr. Babasaheb Ambedkar has made up his mind to join the third front. When contacted Ambedkar said, "We have formed a third front. Along with Bachchu Kadu, Sambhaji Raje and Maratha reservation activist Manoj Jarange-Patil are all set to join the hands. Our fullfledged plan is ready. Next government of Maharashtra will be formed only on our support".

When asked about Praksh Ambedkar joining the third front, he refused to say anything.

Sambhaji Raje who is in touch with all the leaders said, "Some issues about the formation are expected to be clarified in upcoming meetings. Maharashtra has a tradition of fighting against injustice. To continue this fight, we have decided to form the third front and we will go ahead with our decision".

Smaller parties who are neither aligned with the BJP nor the MVA, have begun to unite their forces in a bid to explore the formation of a Third Front. As many as six smaller parties have announced to either go into the elections on their own or float a third front. With the Maharashtra Assembly elections expected to be a close fight, the third front could play a spoilsport for the MVA as it goes all out to dislodge the BJP-Sena-NCP alliance from power. Elections in Maharashtra are expected to be held later this year and leaders expect clarity on the formation of a third front less than a month

According to trade experts and exhibitors, this is a good way to fill up the halls and recover money as those who loved watching these movies or missed them at the time of their release seem keen for the big screen experience.

"It's beneficial for exhibitors, and whoever holds the right to the film also earns money. For instance, when 'Laila Majnu' and 'Rockstar' were released, they didn't do well but this generation loved these films

"The average occupancy for 'Laila Majnu' was 40 per cent all over India. In some properties in Mumbai, it registered over 80 per cent occupancy," trade analyst Atul Mohan told PTI, adding that he is confident that "Gangs of Wasseypur" will be immensely



I hope this trend continues because it's helping the exhibition industry to engage with the audience differently. Exhibitors are reeling under losses as the newly-released films are not appealing to people."

Ashish Kanakia, CEO of MovieMax Cinemas, emphasised that re-released films do not always generate huge profits but for them, it's all about bring-

ing audiences to theatres. 'Re-released films represent a different kind of investment. They help us maintain a balance between showing new and old films, which helps keep our audience numbers steady," Kanakia told PTI.

"Usually, the occupancy for re-released films hovers around 30 per cent, but it's about more than just the numbers. It's about giving people the opportunity to relive the nostalgia and magic of the big screen experience. Besides, the success of re-releases shows that people still have a strong desire to experience their favourite films in theatres," he said.

## Funds transferred to 1.7 crore beneficiaries

Chief Minister Eknath Shinde on Saturday said the ambit of the Majhi Ladki Bahin Scheme will be expanded to cover 2.5 crore women even as the state government has transferred money into the bank accounts of 1.7 crore beneficiaries so far.

The Chief Minister launched the second phase of the scheme at Reshimbagh ground here in the presence of Deputy Chief Ministers Devendra Fadnavis and Ajit Pawar, Union Minister Nitin Gadkari, and Women and Child Welfare Minister Aditi Tatkare.

## Skeletal remains of elderly couple, daughter found

Palghar: Police have recovered the skeletal remains of three persons suspected to be an elderly couple and their daughter - from a house in a village in Palghar district, a senior official said on Saturday.

They were recovered from Nehroli village in Wada tehsil of the district on Friday, he said.

"Local residents complained of foul smell emanating from the house, which was locked from inside, and alerted the police about it," senior inspector Datta Kindre of Wada police station said.

"The police personnel rushed to the house and broke open the door. They were shocked to find the skeletal remains of two women in the drawing room, while those of the man were inside in the bathroom. The bodies were completely decomposed with only skeletal



remains in place," he

These remains are sus-

pected to be those of a 70 year-old man, his 65-yearold wife and their daughter aged 35.

They were immediately sent to a government hospital for a post-mortem procedure, he added.

On Saturday, when asked about the political developments around him and provocations from leaders in alliance parties, he said his policy is to keep on working hard and ignore everything else. "I'm a man of work. I brought in a budget that would benefit the people," Pawar added.

However, that doesn't mean he is docile and meekly accepting whatever is coming his way. When the state government appeared confused as to what needs to be done after the Chhatrapati Shivaji Statue at Malvan collapsed on Monday, it was Ajit Pawar

who gave a definite direction to the government by tendering a public apology for the incident. He also ordered party workers to hold silent demonstrations, visited the site of the statue himself and asserted the CM's announcements that no one found guilty should be spared and a new grand memorial would be built very soon. In doing so he managed a clever balance between drawing a distinctly separate line of the pasty, making the government follow him and also being seen with the government.

The task is not easy. Especially when one looks at him as a leader of a party with the poorest performance in the alliance during Lok Sabha election. Also, his party is the juniormost partner in the alliance as BJP and Shiv Sena (Shinde) faction had been in government for more than a year before he joined in and they have more numbers in the assembly. Yet, he is trying to have an almost equal share within the alliance, at least as much as what Shiv Sena under CM Shinde gets. Hence, the sudden assertion from Ajit Pawar over the past week can be seen as a pre-seat-sharing-talks maneuver.

However, some of the political analysts feel this is something different. NCP (SP) leader Rohit Pawar, while giving a reason for the sudden assertion of Ajit Pawar earlier this week, said that the BJP's grand plan for the Maharashtra assembly elections is to have a third front to cut the opposition votes. He also said that Ajit Pawar and Raj Thackeray have been given the responsibility to build this 'third front' and both have started acting on the

plan. Another set of analysts too feel that Pawar's assertion is aimed at clinching more seats during seat sharing talks. But, they don't think that he would leave the alliance. They say that the state BJP has already fixed a target of winning 125 seats by contesting around 145 seats, leaving the rest to Shinde and

Ajit Pawar will have to show that he is truly out of the shadow of his uncle Sharad Pawar and he certainly is working hard towards the goal.

## MVA's proposed protest politically motivated: BJP

Addressing a press conference here on Saturday, state BJP chief

leged the agitation planned by MVA partners on Sunday is politically motivated with an eye on upcoming Assembly elections.

He said the opposition's love for the founder of the Maratha empire was superficial.

The Shiv Sena (UBT), NCP (SP), and Congress have called for "jode maro" (hit with footwear) protests against the Mayahuti Upadhye asked MVA whether

they will stage similar protests for the past "apologies" by Jawaharlal Nehru over his remarks on Chhatrapati Shivaji Maharaj and by Sonia Gandhi over the 1984 anti-Sikh riots.

"Rahul Gandhi had also apologised for his comments on the Rafale episode. Will they (MVA) apologies?" Upadhye questioned.

PM Modi apologised to Chhatrapati Shivaji Maharaj and those hurt by the collapse of the warrior king's statue in Sindhudurg district amid backlash by the opposition. "Is the PM's apology not enough?" the BJP chief spokesperson asked.

Upadhye said the BJP's Youth Wing would stage agitations across Maharashtra on Sunday near the statues of Chhatrapati Shivaji Maharaj to "expose" the opposition.

Alleging that the MVA's planned protest is politically motivated in view of the upcoming assembly elections, Upadhye alleged the previous governments (led by Congress) did nothing to preserve the forts of Chhatrapati Shivaji Maharaj.

"We regret to inform you that there is disruption in services due to a broken Overhead Equipment (OHE) between Mankhurd and Vashi on the Harbour Line," Rajnish Goyal, divisional railway manager of Central Railway's Mumbai division said on social media platform X.

According to the spokesperson, tower wagons used for repairing overhead wire and equipment were sent to the spot and the issue was fixed by 9.30 am.

During the affected time, passengers were allowed to travel via the Trans-Harbour line using the same tickets and passes, Goyal said. Harbour line provides suburban railway connectivity to Navi Mumbai along with the Western and Eastern suburbs of Mumbai from south Mumbai. Lakhs of passengers use the suburban services on this route on a daily basis.

The non-profit organisation released three reports on maternal and child health, adolescent

health as well as children's safety.

SNEHA released its program endline reports concerning their findings related to key social issues. This includes issues such as maternal and child health, adolescent health and wellbeing as well as ensuring safety and protection among children. These reports, titled EHSAS (Empowerment, Health & Sexuality of Adolescents) Endline Report, PVC (Prevention of Violence against Children) Endline Survey Report and Maternal & Child Health intervention evaluation

The PVC Ensline Survey Report (2022-2024) revealed that the negative forms of disciplinary practices by parents in terms of physical punishment such as hitting on hands, legs and arms have reduced from 77 per cent to 58 per cent. Communication between parents and child in terms of understanding worries



and concerns of children improved from 62 per cent to 77 per cent, while psychological aggression in

terms of yelling or shouting remained the same at 88 per cent during the project cycle.

## Slowing of GDP growth due to lower govt spending: RBI Guv

of India's economic growth to a 15-month low of 6.7 per cent in the April-June quarter was due to "lower" government spending in the wake of the enforcement of the model code of conduct for the recent Lok Sabha polls, RBI Governor Shaktikanta Das said here on Saturday.

"The Reserve Bank projected a growth rate of 7.1 per cent for the first quarter. However, the first advance estimation data released by the National Statistical Office showed the growth rate at 6.7 per cent," Das told re-

The components and main drivers responsible for the GDP growth like consumption, investment, manufacturing, services and



construction have registered a growth of more than

Only two aspects have pulled the growth rate slightly down. Those aregovernment (both central and state) expenditure and agriculture, the RBI governor pointed out.

He said the government expenditure was low during the first quarter perhaps due to elections (April to

June) and operation of model code of conduct by the Election Commission.

"We would expect the government expenditure to pick up in coming quarters and provide the required support to growth," Das

Similarly, the agriculture sector has recorded a minimal growth rate of around 2 per cent in the April to June quarter. However, the monsoon was very good and spread all over India except a few areas. So, everyone is optimistic and positive about the agriculture sector, he noted

"Under these circumstances, we have reasonably confident expectations that the annual growth rate of 7.2 per cent projected by the RBI will be materialized in coming quarters," the governor asserted.

## Expect above normal rainfall in Sept

New Delhi: After a wetterthan-normal August, India is likely to experience above normal rainfall in September, with heavy to very heavy precipitation expected in northwest India and the surrounding

Above normal rainfall is likely over most parts of India, except for some areas in extreme northwest India, many parts of the southern peninsula, northern Bihar, and northeastern Uttar Pradesh, as well as most of northeast India. where below normal rainfall is expected, the IMD

Addressing a virtual press conference, IMD Director General Mrutyunjay Mohapatra said that the country is expected to receive above normal rainfall in September, at 109 per cent of the long-period average of 167.9 mm.

## Property registration set to rise in Mumbai

Mumbai: Registration of properties in Mumbai municipal region is likely to rise 7 per cent annually in August to around 11,650 units on strong demand, according to Knight Frank India Citing Maharashtra gov-

ernment data, real estate consultant Knight Frank India said that Mumbai city (area under BMC jurisdiction) has recorded 11,631 property registrations so far in the month of August. The data is till 8.15 pm on Saturday, August 31 and the number is likely to increase slightly to around 11,650 units

In August 2023, the Mumbai city saw registration of 10,902 properties. The data pertains to registration of properties transacted in both primary (first sale) and secondary (resale) markets.

The state government is expected to earn more than Rs 1,050 crore from the registration of these properties.

## Govt plans FMD-free zones in eight states

New Delhi: The government plans to establish Foot and Mouth Disease (FMD)free zones in eight states to boost exports of animal products, according to a senior government official.

Alka Upadhyaya, Secretary in the Department of Animal Husbandry and Dairying, announced the initiative at the workshop that concluded on August 30 on the issue of animal infectious disease prioritisation, organised by the Food and Agriculture Organisation (FAO) in collaboration with the department.

"We've made significant progress in tackling four critical diseases: FMD, Peste des Petits Ruminants, Brucellosis, and Classical Swine Fever under the National Control Programme," Upadhyaya said.

The government "plans to establish FMD-free zones in eight states, where advanced vaccination efforts are underway", she said.

This strategic move is expected to pave the way for expanded export opportunities for Indian animal products, enhancing the country's global market presence, she added.

The three-day workshop resulted in a prioritized list of the top 20 animal infectious diseases, based on factors including severity, transmissibility, and national importance.

An action plan was developed focusing on coordination, communication, monitoring and surveillance, prevention and control, therapeutics, and socio-economic and contingency

planning.

Speaking on the sidelines of a programme, the actor said the executive panel of the Association headed by him resigned recently in the wake of "unnecessary allegations" being raised against it

after the release of the report. Justifying his alleged delayed response over the findings in the report, Mohanlal said he never ran away from his responsibilities but could not appear before the media in the past few days as he was away



from the state due to his personal and professional commitments.

He said he had been part of the film industry for the past 47 years and it was "painful" to answer the questions with regard to the unfortunate issues in the film industry.

He said as a movie professional, he had deposed before the Hema Committee twice and he had no knowledge about its content other than what has appeared on the media. However, he said he was unaware about the report's revelations on the alleged presence of a power group in the film industry.

"I am not part of any power group in Malayalam cinema and not aware of the existence of any such group. I have heard about it for the first time," the actor said.

## searches in

New Delhi: As part of a crackdown on the banned outfit CPI (Maoist), the NIA conducted searches at seven locations in two districts of Bihar and seized incriminating digital devices, documents and ammunition, an official statement said on Saturday.

Searches were conducted on Friday at five locations in Kaimur district and two in Rohtas district in the case connected with the arrest of two key CPI (Maoist) leaders, Vijay Kumar Arya and Umesh Chaudhary, the National Investigation Agency (NIA) said. The duo were picked up from Rohtas in April 2022. Levy receipts, pamphlets and digital devices were seized from Arya at that time, according to the statement.

Three accused -- Anil Yadav alias Anil Vyas, Rajesh Kumar Gupta and Rupesh Kumar Singh -- are cur-

rently in judicial custody. Digital devices including mobile phones, SIM cards, memory cards along with some incriminating documents and diaries and live ammunition were seized.

## NIA conducts Indian Ocean co-founder Susmit Sen files complaint

New Delhi: Susmit Sen, cofounder of Indian Ocean, has filed a police complaint against former bandmates Rahul Ram and Amit Kilam over unpaid royalties, which the duo has dismissed as an arm-twisting tactic for "illegal and unwarranted demands"

Sen has filed the complaint along with Sunita Chakravarty, wife of Ashim Chakravarty, with whom he had formed the band in 1990. Ashim Chakravarty died in 2009 following complications from a cardiac arrest, while Sen left Indian Ocean in 2013 and started his own band called Susmit Sen Chronicles

Kandisa Music Productions Pvt Ltd, the company that runs the Indian Ocean band, is also listed as an accused in the police complaint, which Sen lodged at Mukheriee Nagar police station in New Delhi on August 16. An FIR is yet to be registered in the case.

The charges, made under multiple sections of the Bharatiya Nyay Sanhita (BNS), include criminal conspiracy, criminal breach of trust, cheating, misappropriation, falsification of accounts, fraud against the Registrar of Companies



(RoC) and authorities, among others.

"After forming the band, I was there with them for 23 and a half years... There was so much trust. And when it breaks, it's a very painful procedure. It is quite heartbreaking when your close friends, partners and colleagues behave like this," Sen told PTI. Sen claimed that he has not received royalties or payments from the Indian Ocean since 2020, and Sunita Chakravarty has not been paid since 2021. The complainants have alleged that they have been denied royalty payments amounting to over Rs 50 lakh each, based on calculations made

two years ago. After Sen's complaint became public, Ram and Kilam released a statement on Saturday and said they are surprised at the police case as the matter is already a pending matter in the National Company Law Tribunal

"We are saddened to learn from the media that a police complaint has been filed against us by Mr Susmit Sen (Former member of Indian Ocean) and Ms Sunita Chakravorty (Spouse of former Indian Ocean member Asheem Chakravorty). We have not seen a copy of the complaint as yet and thus cannot address it on it's merits," they said. Sen said Ram and Kilam have not yet reached out to him to resolve the matter. "There is another case that we filed in NCLT (National Company Law Tribunal) in March 2023. At that point of time, the court had also asked them to resolve this matter amicably within themselves. But they did not reach out," Sen said.

He claimed the band members told them during the COVID-19 pandemic that they were not able to pay the royalties due to lack of work. Ram and Kilam have questioned the timing of the criminal complaint and called it an attempt to pressure them into settling the pending civil dispute.

## Web series on Project Cheetah approved

New Delhi: The National Tiger Conservation Authority (NTCA) has approved a proposal for the filming of a four-part web series on Project Cheetah to "showcase the efforts of the country to the world", official records

It is learned that the filming is likely to start in September, around the second anniversary of Project Cheetah on September 17.

In a letter to the chief wildlife warden of Madhya Pradesh on July 21, Vaibhav Chandra Mathur, Deputy Inspector General of the NTCA, wrote that the eighth technical committee of the authority accorded approval to the proposal for a web series on the world's first intercontinental translocation of a large carnivore -- Project Cheetah.

"In this regard, it is requested to kindly facilitate M/s Shen Films and Planting Productions to undertake and complete filming at the Kuno National Park and the Gandhi Sagar Wildlife Sanctuary as per standard terms and conditions, so that efforts of the country can be showcased to the world," the letter read.

The state's chief wildlife warden approved the proposal on August 6.

"It is requested to grant permission to M/s Shen Films and Planting Produc-



tions for filming as per the terms and conditions and also ensure necessary support to the crew members during the documentation of Project Cheetah. Please also ensure that during the filming of cheetahs, the minimum number of crew members carry out their work under the supervision of officials/veterinarians in the bomas," Subharanjan Sen, the then CWLW of the state, said in a letter to the additional principal chief conservator of forests, Shivpuri, and the divisional forest officer, Mandsaur.

According to the proposal, seen by PTI, the web series will be aired on Discovery Network in 170 countries in different languages

The film aims to highlight

the conceptualisation of Project Cheetah, the struggles faced in bringing the animal back to India, the status of the cheetahs and the expectations for the future.

The goal is to make people "understand the nuances of this mammoth project", the proposal said.

The creators, who have previously collaborated with the NTCA and the Wildlife Institute of India, have also approached 'Madhya Pradesh Tourism' and the MP Tiger Foundation for assistance in securing funding for the project's execution.

"Although financial assistance isn't possible, we will give full support for the filming of the web series as directed," an official said, requesting anonymity.

Bhopal-based wildlife activist Ajay Dubey questioned the rush to film the "documentary", saying that the project faces "several challenges that should be addressed first".

He also questioned the process for granting permission to film the web series, noting that records indicate the Cheetah Project Steering Committee -- formed in May last year to monitor and review the progress of the project and advise the MP forest department and the NTCA on its execution -- "never discussed the issue".

Twenty cheetahs have been brought to India from Africa so far -- eight from Namibia in September 2022 and 12 from South Africa in February 2023.

By reducing the water content, the volume and weight of the



CNF material are significantly decreased, making transportation and handling more economical and environmentally friendly. This process also facilitates easier incorporation of CNF into various industrial applications, as less water needs to be removed during the final stages of production.

This pioneering research introduces a game-changing solution. The invention of "Electrostatic Contact Dewatering technique". This innovative technique utilizes the electrostatic attraction between negatively charged CNF and positively charged precipitated calcium carbonate particles. By making this composite, the dewatering process accelerates fivefold, significantly reducing drying time and enhancing the cost-efficiency of CNF

The implications of this breakthrough are far-reaching. With high solids slurries of CNF now producible more efficiently, various industries can incorporate CNF-composites into their products. Potential applications span coatings, cosmetics, pharmaceuticals, biomedical fields, electronics, and, notably, packaging.

The research, detailed in the paper "Influence of Electrostatic Interactions on the Dewatering and Mechanical Properties of Cellulose Nanofiber/ Precipitated Calcium Carbonate Composite Films," published in the Cellulose Journal, reveals that these sustainable composite materials also exhibit exceptional strength. The strength of these films surpasses that of polypropylene, a commonly used plastic, making this composite a revolutionary development for packaging and other industries. This exceptional and extraordinary research was also presented as an invited talk at the International Conference on Nanotechnology for Renewable Materials in Helsinki, Finland. The research represents a significant leap forward in our quest for a greener, more sustainable

As industries strive to reduce their environmental footprint, the advancements provide a beacon of hope. By harnessing the power of natural materials and innovative processes, the path toward sustainable and cost-effective biobased packaging is clearer than ever. The future of packaging, and indeed many other sectors, looks bright with nanocellulose leading the charge.

### Poba Reserve Forest to become wildlife sanctuary

Guwahati: The Poba Reserve Forest, a rainforest located in the northeastern part of Assam, will soon be notified as a wildlife sanctuary, state Environment and Forest Minister Chandra Mohan Patowary said.

The proposed Poba Wildlife Sanctuary will encompass an area of 257.29 sq km, including the Poha Reserve Forest, Kabu Chapri Proposed Reserve Forest and the surrounding riverine areas, he said. Making the announce-

ment on Friday, the minister said it is a testament of the government's commitment for conservation and sustainable development of the state's natural resources and biodiversity.

Known for its rich wildlife, Poba Reserve Forest serves as an important migratory route for various animals, particularly elephants, as it connects the D' Ering Memorial Wildlife Sanctuary, Kabu Chapri Proposed Reserve Forest and Dibru-Saikhowa National Park, an official state-



ment said.

This corridor is the second significant elephant migration route from the north to the south bank of the Brahmaputra river, the other being the Panpur-Kaziranga route.

Herds of approximately 70-80 elephants migrate across the river at various times, while male elephants utilise these routes almost throughout the year.

Poba Reserve Forest is home to various arboreal species, including the slow

loris and capped langur. Among the most common mammal species is the wild

The forest is also a habitat for about 45 species of birds and reptiles, and the confluence of Siang and Lohit rivers supports a diverse range of fish species.

Moreover, the forest is renowned for its variety of orchids, making it an attractive destination for nature enthusiasts and researchers alike, the statement added.

By looking at the codacorrelation wavefield, we detected tiny signals stemming from multiple

reverberating waves we wouldn't otherwise see. By understanding the paths these reverberating waves had taken and matching them with signals in the coda-correlation wavefield, we worked out how long they had taken to travel through the planet.



## Top Brazilian judge orders suspension of X

## Judge says Elon Musk showed total disrespect for Brazilian sovereignty

Sao Paulo: A Brazilian Supreme Court justice has ordered the suspension of Elon Musk's social media giant X in Brazil after the tech billionaire refused to name a legal representative in the country, according to a copy of his

The move on Friday further escalates the monthslong feud between the two men over free speech, farright accounts and misinformation.

Justice Alexandre de Moraes had warned Musk on Wednesday night that X could be blocked in Brazil if he failed to comply with his order to name a representative, and established a 24-hour deadline. The company hasn't had a representative in the country since earlier this month.

"Elon Musk showed his total disrespect for Brazilian sovereignty and, in particular, for the judiciary, setting himself up as a true supranational entity and immune to the laws of each country," de Moraes wrote in his decision.

The justice said the platform will stay suspended until it complies with his



orders, and also set a daily fine of 50,000 reais (\$8,900) for people or companies

using VPNs to access it. In a later ruling, he backtracked on his initial decision to establish a 5-day deadline for internet service providers themselves - and not just the telecommunications regulator - to block access to X, as well as his directive for app stores to remove virtual private networks, or

Brazil's telecommunications regulator Anatel has 24 hours to comply. The regulator's chairman Carlos Baigorri told GloboNews channel that the country's biggest service providers will respond quickly, but added smaller ones might need more time to suspend X from their services.

The full bench of Brazil's Supreme Court is expected to rule on the case, but no date for deliberations was set.

Brazil is an important market for X, which has struggled with the loss of advertisers since Musk purchased the former Twitter in 2022. Market research group Emarketer savs some 40 million Brazilians, roughly one-fifth of the population, access X at least once per month.

### **Another** knife attack in Germany, six hurt

Berlin: Police arrested a 32-year-old woman after six people were hurt in a knife attack on a bus headed to a festival in western Germany. Authorities said on Saturday that there was no evidence of a political or religious motive.

Three of those attacked are in life-threatening condition, police said on Friday evening.

The knife attack took place in Siegen, east of Cologne. The bus was on its way to a local festival in the town and at least another 40 people were on board when the attack took place at about 7:40 p.m.

Police and prosecutors said the six people wounded were aged between 16 and 30 and all were from the region. By Saturday morning, three of them had left the hospital after outpatient treatment.

Local authorities planned to go ahead with the festival.

The stabbing in Siegen happened a week after a knife attack in Solingen, a city in the same state of North Rhine-Westphalia, in which a suspected Islamic extremist from Syria who had avoided being deported is accused of killing three people and wounding another eight.

The Solingen attack prompted the governing coalition to draw up plans to tighten knife laws and make deportations easier.

Police said the woman arrested in Siegen was a German citizen with no immigrant roots.

### Pakistan's ISI complicit with terrorists, says former US NSA

Washington: There is an "undeniable complicity" of Pakistan's Inter-Services Intelligence (ISI) with terrorist groups, former US National Security Advisor Lt Gen (retd) H R McMaster has said, revealing that during his tenure under then President Donald Trump, the White House faced resistance from the state department and Pentagon over providing security aid to Islamabad.

Despite directions from Trump to stop all aid to Pakistan till it stops giving safe havens to terrorists, McMaster in his latest book 'At War with Ourselves: My Tour of Duty in the Trump White House' says that the then Defence Secretary Jim Mattis was planning to deliver a military aid package to Islamabad that included over USD 150 million worth of armoured vehicles.

However, the aid was stopped after his intervention. McMaster writes in the book that hit the bookstores this week.

"It was difficult to get State and Defence even to comply with Trump's directives to stop certain activities. I discovered that contrary to the South Asia strategy, which called for the suspension of all aid to Pakistan with a few exceptions, when Mattis visited Islamabad in the coming weeks, the Pentagon was going to deliver a military aid package that included more than USD 150 million worth of armoured vehi-

cles," he writes. McMaster says soon after he came to know about

it, he called for a meeting with Mattis, the deputy director of the Central Intelligence Agency, Gina writes. Haspel, and other senior

officials. "I started by noting that the president (Trump) had been very clear on multiple occasions to suspend aid to the Pakistanis until they halted support for terrorist organisations that were killing Afghans, Americans, and coalition members in Afghanistan...We had all heard Trump say, 'I do not want any money going to Pakistan'," he says.

Mattis, the former NSA writes, noted the possibility that Pakistan might retaliate in certain ways, but others, including Ambassador David Hale, who had joined by video from Islamabad, did not share those concerns.

"Mattis reluctantly halted that shipment of assistance, but other aid would continue, prompting Trump to tweet on New Year's Day, 'The United States has foolishly given Pakistan more than 33 billion dollars in aid over the last 15 years and they have given us nothing but lies & deceit thinking of our leaders as fools. They give safe haven to the terrorists we hunt in Afghanistan with little help. No more!'," he

"Pakistan was not changing its behaviour, and almost as an insult, the government released Hafiz Saeed, the mastermind behind the 2008 Mumbai terrorist attacks, on the eve of Mattis's visit. Moreover, a recent event in Pakistan involving hostages had exposed the undeniable complicity of Pakistan's Inter-Services Intelligence with the terrorists," McMaster

He notes that news reports that time criticised the president's tweet as capricious and devoid of a coherent policy. But halting assistance was a critical part of the South Asia strategy that Trump had approved at Camp David in August, he says.

"A lunch that the president hosted with the vice president, Tillerson, Mattis, Kelly, and me on December 14 helped me understand why it was difficult to implement Trump's guidance on Pakistan or to foster cooperation on contingency plans for North Korea, says McMaster.

## **Doctor who fought** 'Agent Orange' in the list

Manila: A Vietnamese doctor who has helped seek justice for victims of the powerful defoliant dioxin "Agent Orange" used by US forces during the Vietnam War is among this year's winners of the Ramon Magsaysay Awards — regarded as Asia's version of the Nobel Prizes

The other winners announced on Saturday were a group of doctors who struggled to secure adequate healthcare for Thailand's rural poor, an Indonesian environmental defender, a Japanese animator who tackles complex issues for children and a Bhutanese academician promoting his country's cultural heritage to help current predicaments.

First given in 1958, the annual awards are named after a Philippine president who died in a 1957 plane crash, and honour "greatness of spirit" in selfless service to people across Asia.

Vietnamese doctor Nguyen Thi Ngoc Phuong carried out extensive research into the devastating and long-term effects of Agent Orange which she said she first encountered in the late 1960s as a medical intern when she helped deliver babies with severe birth defects as a result of the lingering effect of highly toxic chemical, according to the

awards body. "Her work serves as a dire warning for the world to avoid war at all costs as its tragic repercussions can reach far into the future," the Magsaysay foundation said. "She offers proof that it can never be too late to right the wrongs of war and gain justice and relief for its hapless victims."

American forces used Agent Orange during the Vietnam War to defoliate Vietnamese jungles and to destroy crops for the Vietnamese Communists, or Viet Cong, who fought against South Vietnam

and the United States.

Between 1962 and 1971, the US military sprayed roughly 11 million gallons of the chemical agent dioxin used in Agent Orange across large swaths of southern Vietnam. Dioxin stays in the soil and in the sediment of lakes and rivers for generations. It can enter the food supply through the fat of fish and other animals.

Vietnam says as many as 4 million citizens were exposed to the herbicide and as many as 3 million have suffered illnesses from it, including the children of people exposed during the war.

Indonesian Farwiza Farhan won the award for helping lead a group protect the Leuser Ecosystem, a 2.6-million-hectare forest on Sumatra Island in his country's Aceh province where some of the world's most highly endangered species have managed to survive, the foundation said. -AP

Chinese survey ship entering water

## Japan lodges formal protest

Tokyo: Japan lodged a formal protest via China's embassy against what it called an incursion by a Chinese survey ship into its territorial waters Saturday, the Japanese foreign ministry

The ministry expressed "strong concern" after the ship was spotted near Kagoshima Prefecture, southwestern Japan, early in the morning.

The Chinese ship, confirmed in territorial waters at 6 am local time, left shortly before 8 am, according to Japan's Defence Ministry, adding it was monitored by a Japanese military vessel and plane.

Recently, China's increasingly assertive activity around Japanese waters and airspace has caused unease among Japanese defence officials, also concerned about the growing military cooperation between the Chinese and

airspace on Monday. It was the first time the Japanese Self Defence Force detected a Chinese military aircraft in Japan's airspace. Chinese foreign ministry spokesperson Lin Jian said on Tuesday his country had "no intention" to violate any country's airspace.

## Escalating Conflict in Balochistan Threatens Global Stability

In the province of Balochistan on the southwestern edge of Pakistan, violence has become disturbingly routine. It's a region rich in natural resources and geopolitical significance, yet its story is largely untold outside the corridors of power in Islamabad, Washington, and Beijing. And that's a problem—because what's happening in Balochistan could have repercussions far beyond Pakistan's borders.

Imagine, if you will, a bus journey where the passengers—ordinary men, women, and children—are suddenly thrust into a nightmare as armed men storm the vehicle. These men, hardened by years of conflict, pull off the male passengers, leaving behind women and children to run for their lives. Moments later, the night air is filled with the staccato of gunfire and the gut-wrenching cries of men being executed on the spot.

This isn't the plot of a Hollywood thriller, but the grim reality that unfolded in Balochistan left nearly two dozen people dead. It is part of a broader wave of violence that claimed at least 74 lives within a 24-hour span.

So, why should the U.S. and the international community care about Balochistan? The answer lies in the interconnected nature of global politics, where even remote conflicts can have far-reaching and unpredictable consequences.

Balochistan is the linchpin in the China-Pakistan Economic Corridor (CPEC), a multi-billion-dollar infrastructure project critical to China's global ambitions, including its Belt and Road initiative. The province's Gwadar Port offers China access to the Arabian Sea and the Middle East.

Balochistan remains one of the most underdeveloped and unstable regions in Pakistan, with the ethnic Baloch locals feeling marginalised by the central government. Their grievances the exploitation of their land's resources without any tangible benefits to the local population—have fuelled a decades-long insurgency by the Baloch Liberation Army (BLA) and the Balochistan Liberation Front (BLF), who have demanded greater autonomy or outright independence.

This insurgency might have stayed local, but outside involvement changed the game. Islamabad has accused India of backing Baloch separatists, especially after the capture of Kulbhushan Yadav, who Pakistan claims was running a spy network in Balochistan. Yadav's arrest and confessions have intensified suspicions that India is fanning the rebellion in Pakistan's most restive province.

Additionally, Islamist militant groups, including Tehrik-i-Taliban Pakistan (TTP) and Lashkar-e-Jhangvi (LeJ), have also entrenched themselves in the province, turning it into a battleground for their sectarian and anti-state agendas. These groups have targeted Shia Muslims, security forces, and even Chinese nationals working on CPEC projects, creating a volatile mix that threatens to destabilise the entire region.

For Pakistan, the situation is a security nightmare. Despite launching multiple military operations and killing dozens of militants, the state has struggled to contain the violence. The porous border with Afghanistan provides

militants with a safe haven, complicating Islamabad's efforts to restore order.

The United States, too, has a stake in what happens next in Balochistan. As tensions rise between Washington and Beijing, the stability of regions like Balochistan becomes increasingly important. If CPEC falters due to instability, it could slow China's economic rise, impacting global markets in ways that would be felt in New York as much as in Islamabad or Beijing. Furthermore, the spread of extremist ideologies in Balochistan could eventually find its way back to the West, as has happened with other conflict zones.

If insurgents are for better governance, fair distribution of resources, and respect for their cultural identity, then they are reasonable, and the authorities in Islamabad need to take care of it. On the other hand, if the insurgents only intend to blackmail, Islamabad needs to come hard on them. Beijing, the US, and the entire world should help Pakistan to quell militancy in Balochistan.

Washington must recognise the province's strategic importance and support efforts to address the root causes of the conflict—poverty, underdevelopment, and political disenfranchisement. This means

encouraging Islamabad to pursue a more inclusive approach, one that prioritises dialogue over brute force. Second, the international community must press all the forces to end their proxy battles in Balochistan. Islamabad needs support on a large scale to quell militancy in Balochistan.

Finally, the U.S. should work with Pakistan to counter the growing influence of Islamist militant groups in the province. This requires more than just military cooperation; it involves supporting educational and economic initiatives that can offer young Baloch a viable alternative to joining extremist organisations.

The situation in Balochistan is complex, and there are no easy solutions. But as the violence continues to spiral out of control, the cost of doing nothing becomes increasingly untenable. For the sake of regional and global security, it's time the world starts helping Pakistan in its fight against militancy and terrorism.

Because in a world as interconnected as ours, the conflicts that seem far away are often closer than we think!

## To Lam: Steely Pragmatist

In a meticulously choreographed ascent to power, To Lam, a veteran security chief, has emerged as the new General Secretary of the Communist Party of Vietnam (CPV). His rise, following the unexpected death of his predecessor Nguyen Phu Trong, marks a decisive turn in the Communist Party's playbook—a shift from the typical technocratic leadership to a man who has long been the embodiment of Vietnam's internal security apparatus.

Lam's deep roots in the Ministry of Public Security have shaped him into a leader known for his uncompromising stance on internal security and a penchant for maintaining the party's firm grip on power. His background is steeped in the shadowy arts of state security, and he has overseen a tightening of state control over civil society, the press, and the internet. This however, has come at a cost — criticism from Western governments and international rights groups over human rights abuses have often punctuated Lam's tenure. Yet, within the Vietnamese leadership, these critiques are viewed as proof of Lam's efficacy in safeguarding the party's  $% \left( \frac{1}{2}\right) =\left( \frac{1}{2}\right) ^{2}$ 

His leadership will likely preserve the current trajectory of Vietnam's governance but is also likely introduce subtle shifts in its diplomatic engagements in the current global scenario.

To Lam's foreign policy manoeuvres began swiftly. On August 18, Lam made his first official visit abroad as CPV leader to China, prompting speculation about a potential pro-China tilt in Hanoi. However, such interpretations overstate the significance of this move. Lam had already visited Cambodia and Laos—Vietnam's traditional partners-earlier this year after becoming President in May, making China the next logical destination. The trip to Beijing, likely planned months in advance before Trong's death, aligns more with diplomatic protocol than a strategic pivot towards Beijing.

Vietnam's 'bamboo diplomacy' (a



metaphor for its flexible and resilient foreign policy approach), continues to serve as the cornerstone of its international relations. Much like bamboo that bends but does not break, Vietnam adeptly balances its ties with major powers without becoming overly aligned with any. This non-aligned strategy enables Hanoi to maintain its sovereignty and navigate the complex geopolitical landscape of Southeast Asia. Lam's subsequent anticipated visit to New York next month for the United Nations General Assembly or the U.N. Summit of the Future underscores Hanoi's balanced approach.

Despite the symbolic nature of any potential meeting with U.S. President Joe Biden or Vice-President Kamala Harris, it reinforces Vietnam's delicate balancing act—a diplomatic dance perfected by Lam's predecessors.

The prospect of To Lam's engagement with U.S. officials comes at a delicate time in U.S.-Vietnam relations. Last year, Biden upgraded the bilateral relationship to a "comprehensive strategic partnership" during a visit to Hanoi, setting the stage for deeper ties. Yet, Hanoi was recently disappointed by the U.S. Commerce Department's refusal to reclassify Vietnam as a "market economy," a decision that stings amid a growing trade surplus with the U.S., now doubling to \$104 billion singe 2010.

billion since 2019. Lam's possible encounter with

Biden or Harris at the U.N. meetings would be largely ceremonial, yet it could serve as a crucial gesture of neutrality amid growing U.S.-China tensions. Should Harris ascend to the presidency, Vietnam may find a more receptive audience for its market economy aspirations, though this remains speculative. The South China Sea remains a perennial challenge for Vietnam. Lam, with his background in security, may take a firmer approach to maritime disputes, balancing assertiveness with a readiness to engage in diplomatic dialogues. His administration could deepen security ties within ASEAN, seeking regional solidarity against external pressures while avoiding outright confrontation with China.

The South China Sea remains the linchpin of Vietnam's foreign policy challenges. Lam doubtless understands the tightrope Vietnam walks between asserting its claims and managing China's ambitions. His leadership could see a continuation of the calibrated assertiveness that has characterized Vietnam's approach: maintaining military readiness, building up its naval capabilities, and engaging in quiet diplomacy with regional and extra-regional powers. His administration could deepen security ties within ASEAN, seeking regional solidarity against external pressures while avoiding outright con-

frontation with China.

Domestically, Lam's rise signals a continued focus on stability, with an unwavering stance on suppressing dissent and fortifying state control over media and civil society. His leadership style is unlikely to disrupt the economic liberalization that has spurred Vietnam's growth but will certainly prioritize the party's ideological integrity and security apparatus.

Lam's pragmatic realism will be tested by the interplay of global powers and domestic imperatives. His tenure may not bring radical shifts, but it will undoubtedly shape the contours of Vietnam's foreign policy in an increasingly polarized provided.

her boss. She hopes to contest the upcoming assembly elections, relying on her boss, whom she sees as her Godfather, to secure her a ticket. However, he is focused on managing current MLAs and is searching for a younger, wealthier, and more dynamic version of Malatitai to advance his political ambitions.

Like Malatitai, 47-year-old Kunal

(name changed), a former youth wing president, avoided marriage, hoping to wed the Dalit leader's daughter (now a Lok Sabha MP) to launch his political career. However, the Dalit leader has no interest in a son-in-law; he's focused on making his daughter the next chief minister, a far more secure plan than relying on followers like Kunal, who might switch sides as soon as they gain power.

A successful career in Indian politics requires a godfather. For a newcomer with no family connection, a godfather is a boon, but often the real task is the ability to find one or be found by one. Having a godfather helps to smooth out the difficult journey ahead, which is largely dominated by caste equations, money and muscle power, character assassinations, and backbiting.

Finding a godfather today remains a formidable task. Mere networking may not land you that perfect mentee. You must possess several qualities before you come under the focus of a godfather. A typical godfather in Indian politics has access to lots of money, power, connections, and the ability to 'get things done.'

Compared to the early seventies and eighties, almost all political


parties in India today are overflowing with leaders controlling their camps of all castes and sizes. These camps continue to be dominated by self-proclaimed godfathers who control their 'territory.'


Seeking out a godfather requires tact, skill, and the ability to gauge his capacity, resources, and commitment to delivering on promises. Some foot soldiers form relationships with godfathers to gain party positions and secure election tickets, while others, despite loyalty, switch allegiances based on the party's fortunes. In some cases, those seeking lasting ties with their godfathers choose marriage or business partnerships, marrying into political families to ensure lifelong loyalty, regardless of their political success. The lure of power and its perks are strong, leading many to practice social climbing, becoming stooges to access and bask in that power.

Another easy access to people already in positions of power and seeking out a godfather to groom their political ambitions is through the Indian Civil Service. There are many examples of government officials ending up in politics post-retirement.

Many godfathers are now wary of mentoring. With defections on the rise, veteran leaders are mindful of the shifting dynamics with their loyalists. Many admit they are proceeding cautiously, adopting an 'open-door policy.



## **US Open**

Djokovic was shocked at the U.S. Open one night after Carlos Alcaraz was, bowing out in the third round with a 6-4, 6-4, 2-6, 6-4 loss to 28th-seeded Alexei Popyrin of Australia on Friday

night. The No. 2-seeded Djokovic was trying to become the first player in tennis history with 25 Grand Slam singles titles. Instead, he finishes a year without claiming at least one major championship for the first time since 2017. Before that, it hadn't happened since 2010.

Also of note: 2024 now becomes the first season since 2002 in which none of the Big Three of men's tennis — Djokovic, Rafael Nadal and Roger Federer earned a Slam trophy.

The third-round exit equals Djokovic's worst showing at Flushing Meadows; the only other occasions he was beaten that early at the U.S. Open came in 2005 and 2006. The man who defeated Djokovic 18 years ago, International Tennis Hall of Fame member Lleyton Hewitt, is now Australia's Davis Cup captain and was sitting in Popyrin's guest box in Arthur Ashe Stadium.

Djokovic, who is 37, has reached the

### Krishan hopes to match 'Sree Bhai's' standards

New Delhi: Krishan Bahadur Pathak knows that being the Indian hockey team's new first-choice goalkeeper won't be easy thanks to the high standards set by PR Sreejesh but he believes "dedication and discipline" will help him fill the big boots of his retired predecessor, who played a key role in shaping him.

The 27-year-old custodian of Nepalese descent, who was born in Punjab's Kapurthala, is no greenhorn and has made 125 appearances for India since making his debut in 2018.

But becoming the firstchoice keeper has placed the spotlight firmly on him after Sreejesh decided to call time at the end of India's bronze-winning Olym-

"It's a nice feeling that I am the main goalkeeper now. But it comes with added responsibility. What I have learnt from Sree bhai is to go along with the team...I was with him for the last six years, so it's a nice feeling to take his place," Pathak told PTI in

an exclusive interview.

Pathak's first major test is going to be the Asian Champions Trophy starting September 8 in Hulunbuir, China. He acknowledged that it would be challenging to guard the post the way Sreejesh did, sometimes becoming the only difference between a victory and defeat.

"It will be difficult to fill in his shoes because he endured a 20-22 years journey to reach this level. But I will definitely try to match the benchmark which he has set for us, which is difficult but not impossible," he said.

The Arjuna awardee's biggest moment so far has been to be a part of the Asian Games gold-winning team last year. He was a reserve in the squads for both the Tokyo and Paris Olympic Games.

Pathak said he has had the good fortune of learning from Sreejesh and the affable Kerala-man remains ever-ready to help even now.

"He just told me play normal hockey the way you used to play with me. Keep playing with confidence in

tournaments. He said 'if you need any help or advice, I am always there for you'." Pathak recalled. Not just advice, Sreejesh

has also given him targets to achieve. Pathak wants to realise his mentor's dream of winning an Olympic gold in 2028 Los Angeles Olympics.
