# **Modi equates Rahul** with 'urban naxal'

### SAYS THOSE WHO ENTERTAIN THEMSELVES BY GETTING PHOTO SESSIONS DONE IN HUTS OF THE POOR WILL FIND THE TALK ABOUT THE POOR IN PARLIAMENT BORING.

New Delhi: In a scathing attack on Leader of Opposition Rahul Gandhi, Prime Minister Narendra Modi on Tuesday said some people are openly speaking the language of urban naxals and asserted that those who "declare a war" against the Indian State can neither understand the Constitution nor about the country's unity.

He also took a dig at Arvind Kejriwal and AAP a day before the Delhi assembly polls, saying "some parties are like 'AAP-da' for the future of the youth".

Modi asserted that while his government's schemes saved lot of money, it was not used to build 'Sheesh Mahal'.

Replying to the debate on the Motion of Thanks to the President's Address in Lok Sabha, he made several veiled attacks at former Congress chief Rahul Gandhi, saying those who entertain themselves by getting photo sessions done in huts of the poor will find the talk about the poor in Parliament boring.



### **Centre lists measures for LGBTQ+ couples** Same household for ration cards, joint bank account

New Delhi: The Centre on Tuesday outlined a series of measures aimed at ensuring the welfare and rights of the LGBTQ+ community, including allowing queer partners to open joint bank accounts, be treated as a single household for ration cards, besides strengthening their access to healthcare.

Minister of State for Social Justice and Empowerment BL Verma outlined these steps in a written response to a question in the

Lok Sabha on Tuesday. Among the initiatives, Verma said the department of food and public distribution has issued an advisory to the states and Union Territories, stating that "partners in a queer relationship

are to be treated as part of the same household for the purposes of ration cards". Additionally, states have been asked to ensure that

such couples do not face discrimination while obtaining these documents, said Verma, who's also the MoS for consumer affairs, food, public distribution. The government also clarified that there are no restrictions on the mem-

bers of the queer community opening joint bank accounts or nominating their partners as beneficiaries. "The department of fi-

nancial services has issued an advisory stating that persons in a queer relationship can be nominated to receive the balance in an account in case of the account holder's death." -PTI

### Property tax on commercial establishments in slums

BMC has decided to impose property tax on commercial establishments operating in slum areas, and is also considering the levy of a Solid Waste Management (SWM) user charge in the future. Addressing a press conference after the civic body's budget was presented on Tuesday, BMC commissioner and administrator Bhushan Gagrani said an additional revenue of Rs 350 crore was expected in FY 2025-26 from property tax on shops and other commercial units in slums. The civic body is expecting to collect a total of Rs 5,200

crore in property tax during the next financial year. Overall, it is expecting to earn more than Rs 43,000 crore in revenue from various sources.

# New rules likely for 'Award Wapsi'

New Delhi: A parliamentary committee has suggested "consent of the recipient" was a must in case a National Akademi decided to confer an award to prevent the honour's return by the individual for political reasons as it was "disgraceful" to the country.

The panel also recommended that an undertaking would have to be signed before an award is given and suggested adding a non-disclosure clause to protect against the potential breach of confidentiality of the selection process.

In its report, presented in Parliament on Monday, the panel has observed that "such inappropriate incidents involving the return of awards undermine the achievements of the other awardees and also impact the overall prestige and reputation of the awards".

The report is titled, "Action taken by the government on the recommendations/observations of the committee contained in its three hundred fifty-first report on the subject, 'Func-

tioning of National Akademis and other Cultural

Institutions". "The committee notes the instances of recipients of awards, given by Akademis (such as Sahitya Akademi Awards), returning their awards in protest of certain political issues which are outside the ambit of the cultural realms and the autonomous function-

ing of the concerned Akademi," it said. The panel also observed that awards given by each Akademi continue to be top honours for an artist in India. The committee emphasised that Sahitya Akademi or other Akademis are "apolitical organisations".

"There is no place for politics. The committee, therefore, suggests that whenever an award is given, the consent of the recipient must be taken, so that he/she does not return it because of political reasons; as it is disgraceful to the country," the panel said in its report.

The committee has also recommended "prior concurrence of short-listed candidates" for awards be-

fore finalisation.

"A system may be put in place where an undertaking is taken from the proposed awardee citing acceptance of the award and that the awardees cannot dishonour the award at any point of time in future. Awards may not be given without such an undertaking," it said.

In the event that the awards are returned, the awardee shall not be considered for such an award in the future, the report said.

### ACTIVIST ALLEGES SCAM IN AGRICULTURE DEPT UNDER MUNDE; HE DISMISSES CHARGES

Mumbai: Activist Anjali Damania on Tuesday alleged that there was a Rs 88 crore scam in the agriculture department when NCP leader Dhananjay Munde held the portfolio in the previous Mahayuti coalition government.

Munde, currently the minister for Food and Civil Supplies, termed her allegations as "baseless". There were no irregularities in the tender process questioned by Damania, and his department provided nano fertiliser to farmers at rates lower than market rates, he claimed. Holding a press conference here,

Damania, a former Aam Aadmi Party leader, claimed that despite the Union government's 2016 directive to transfer money directly to farmers' bank accounts under Direct Benefit Transfer (DBT), the agriculture department purchased equipment and fertilisers for distribution to farmers at inflated rates.

Dhananjay Munde is already under fire over the arrest of his aide Walmik Karad in an extortion case related to the murder of sarpanch Santosh Deshmukh in Beed district.

Damania also presented documents related to the alleged scam. "These documents are proof of

how the minister siphoned off farmers' money and violated laws. As per the government resolution (GR) on DBT, all scheme-related funds were to be transferred directly to farmers' bank accounts, except for certain government entities such as Mahabeej, KVK, and MAIDC, which produce their own goods. However, this rule was disregarded," she claimed.

She referred to a GR dated September 12, 2018, which listed 62 components under DBT.

While the chief minister has the power to add new components to the DBT list, the existing compo-



nents could not be removed without approval of a committee of the chief secretary, finance secretary and planning secretary, Damania said.

Just before the Model Code of Conduct for the Lok Sabha elections came into effect, the state government issued a new GR on March 12, 2024, appointing agriculture commissioner as controlling officer for purchasing agricultural inputs, she said.

Then agriculture commissioner Pravin Gedam raised concerns on March 15, 2024, stating that implementation of a purchase-based scheme was wrong, the activist claimed

Gedam pointed out that as the items being procured were not produced by Mahabeej or MAIDC, the funds should have been disbursed through DBT to farmers instead of purchasing these items, she said.

Gedam told Munde about these irregularities, but the minister advised the Director and Deputy Secretary of the Agriculture Department to proceed with the purchases, Damania alleged

Gedam's comment was not available immediately.

The NCP leader claimed that the March 2024 tender process was conducted as per government regulations.

He had been facing a "media trial" for the last 58 days (apparently referring to the aftermath of the December 9 murder of Massajog sarpanch Santosh Deshmukh), Munde claimed.

'Why is this happening? Who is behind it? I do not know. As far as the DBT system is concerned, any exclusion from it requires the approval of both the agriculture minister and chief minister. When I was agriculture minister, all procedures were duly followed," he asserted.

On the nano fertiliser controversy, Munde said, "Prime Minister Narendra Modi himself has strongly endorsed nano fertiliser. After his encouragement, Maharashtra provided it to 4,00,000 farmers. It was procured from a central government-affiliated company, and its price remains the same across the country.

"We provided it at an even lower rate. Nano fertiliser has significantly increased farmers' income, and there has been no wrongdoing," he said.

### Construction of submerged weirs sanctioned **By Correspondent**

Mumbai: The Maharashtra State Cabinet on Tuesday approved a special provision of Rs 170 crore for construction of 25 submerged weirs in the Koyna Reservoir area, covering Mahabaleshwar and Jaoli talukas in Satara District.

These 25 weirs fall within the submerged zone of the Koyna Reservoir, where water levels significantly drop between February and May, creating acute drinking water and irrigation challenges for local residents. To address this issue, new weirs will be constructed to ensure water availability during low reservoir levels.

The cabinet also approved an administrative sanction of Rs 315.05 crore for strengthening and leakage prevention work on the Temghar Dam in Mulshi Taluka, Pune District.

The Temphar Dam supplies 3.409 TMC of drinking water to Pune city annually and also supports irrigation for 1,000 hectares in Mulshi Taluka. However, leakage from the dam has resulted in significant water wastage, posing a serious risk to both the dam's stability and Pune city's water security. Multiple expert committees have reported on the urgent need for remedial measures. The approved project will help stop leakage, enhance dam safety, and ensure sufficient water availability for irrigation.

The cabinet approved one-year extension for the amnesty scheme that allows Class-2 government landholders to convert their land into Class-1 ownership at concession.

### Woman kept chained in parents' house

Jalna: The police have rescued a woman held captive by her parents, who kept her chained inside their house for two months in a remote village in Jalna district, an official said on Tuesday.

The police acted on Monday following directions of the Aurangabad bench of the Bombay High Court on a complaint by the woman's husband, the official said.

He said the woman, Shahnaz alias Sonal, was rescued from her parents' house in Alapur village in Bhokardan tehsil, where they had allegedly kept her chained for two months.

According to the police, the woman, who is in her 20s, had an interfaith mar-

#### riage, and the couple had a three-year-old son.

Police said she went to visit her parents with the child two months ago. Upset about the interfaith marriage, the parents refused to allow her to return to her husband and kept her chained in the house, where they lived in isolation.

The official said despite repeated attempts, the husband was unable to bring her back and was denied entry into the house, following which he moved the court. He said a police team raided the house, rescued Shahnaz and her son, and handed them over to the husband through a government lawyer.

Besides the 'Mumbai Eye' that would enhance the Mumbai skyline, the BMC has a slew of other big and small projects that are expected to improve the



The actor, arrested last week, was remanded in 14day judicial custody by a court here on Monday after his police custody ended. The police did not seek an extension of his custody but said they would apply for fresh remand if the need arose.

During the investigation, Ataine claimed that he was an Indian national and produced a birth certificate, Aadhaar card, driving license and other documents, the remand note submitted by the police said.

"Upon inspection of the documents, suspicion arose regarding the birth certifi-

cate, as it was mentioned that it was issued by the F Ward of the Brihanmumbai Municipal Corporation. Therefore, the said birth certificate was verified with the F Ward, and it was found to be forged," it said.

Platinum Hern Pvt Ltd. owner of Torres jewellery brand, is accused of cheating investors of crores of rupees through a combination of Ponzi and multilevel marketing (MLM) schemes.

New Delhi: Delhi Police registered an FIR on Tuesday against Chief Minister Atishi, the AAP candidate from Kalkaji, for allegedly violating the Model Code of Conduct (MCC) and obstructing public servants on duty, an official said.

"We have registered an FIR against Kalkaji AAP candidate at the Govindpuri Police Station under various sections and further investigation is under process," said the police officer.

He further said that action was taken as the AAP candidate was found at Fateh Singh Marg along with 50-70 supporters and 10 vehicles. Police instructed them to vacate the area as per MCC guidelines. But they obstructed an officer from doing his duties, he said.

In a post on X. Atishi hit out at the Election Commission, alleging BJP candidate Ramesh Bidhuri and members of his family were openly resorting to "hooliganism" but no action was taken, while a case was registered against her.

# **THE TARIFF WAR China counters with** tariffs on US products

Beijing: China countered President Donald Trump's tariffs on Chinese products with tariffs of its own on multiple US imports Tuesday as well as announcing an antitrust investigation into Google and other trade measures. US tariffs on products from Canada and Mexico also were to go into effect Tuesday, though Trump agreed to a 30-day pause on his threats against Mexico and Canada as they acted to appease his concerns about border security and drug trafficking.

Trump planned to talk with Chinese President Xi Jinping in the next few days. This isn't the first round of tit-for-tat actions between the two countries China and the US had engaged in a trade war in 2018 when Trump raised tariffs on Chinese goods and China responded in kind. This time, analysts said, China is much better prepared to counter. "They have a much more developed export control regime. We depend on them for a lot of critical minerals: gallium, germanium, graphite, a host of others. So ... they could put some significant harm on our economy," said Philip Luck, a former State Department official and director at the Center for Strategic and International Studies on Monday at a forum. The slew of measures announced Tuesday cut across different sectors of the economy, from energy to individual US companies.



### **Russia renews attacks**

Kviv: Moscow's renewed attacks on Ukraine's electricity infrastructure this winter have heightened scrutiny over the Ukrainian Energy Ministry's failure to protect the country's most critical energy facilities near nuclear power country.

Despite more than a year of warnings that the sites were vulnerable to potential Russian attacks, the Energy Ministry failed to act swiftly, current and former Ukrainian officials in Kyiv told The AP.

Two years of punishing Russian strikes on its power grid have left Ukraine reliant on nuclear power

sites.

for more than half of its electricity generation. Especially vulnerable are the unprotected nuclear switchvards located outside the perimeters of its three functioning nuclear plants, which are crucial to transmitting power from the reactors to the rest of the "The switchyards that

handle electrical routing from nuclear power plants are a vital component of Ukraine's nuclear energy infrastructure — powering homes, schools, hospitals, and other critical civilian infrastructure. Given Ukraine's heavy reliance on nuclear energy, military at-

tacks on these switchvards would be devastating, severely impacting civilian life and undermining the resilience of the energy grid," said Marcy R. Fowler, head of the office for research and analysis at Open Nuclear Network, a programme of the USbased NGO PAX sapiens that focuses on reducing nuclear risk.

Only in the fall, after Ukrainian intelligence agencies warned of potential Russian strikes targeting the nuclear switchyards, was action taken to begin building protection — far too late in the event of an attack, analysts said.

Goma: The Rwandabacked rebels who seized eastern Congo's key city of Goma announced Monday a unilateral ceasefire in the region for humanitarian reasons, following calls for a safe corridor for aid and hundreds of thousands of displaced people.

The M23 rebels said the ceasefire would start Tuesday. The announcement came shortly after the UN health agency said at least 900 people were killed in last week's fighting in Goma between the rebels and Congolese forces. Government officials previously cited a toll of 776.

The city of two million people is at the heart of a region home to trillions of dollars in mineral wealth, and after consolidating control of Goma last week. the rebels were reported to be gaining the upper hand in other areas of eastern Congo and advancing on another provincial capital, Bukavu.

But the rebels said Monday they would halt fight-



ing to allow humanitarian activities and that they did not intend to seize Bukavu, though they earlier have expressed ambition to march on the capital a thousand miles away.

"It must be made clear that we have no intention of capturing Bukavu or other areas. However, we reiterate our commitment to protecting and defending the civilian population and our

positions," M23 rebel spokesman Lawrence Kanyuka said in a statement.

There was no immediate comment from Congo's government

The announcement came ahead of a joint summit this week by the regional blocs of southern and eastern Africa, which have called for a ceasefire. Kenva's President William Ruto said Monday the presidents of Congo and Rwanda would attend.



# India is a sleeping giant in golf: Greg Norman

Gurugram: Australian legend Greg Norman believes India is a sleeping giant in golf and it would require more competitions in the country to help its players realise their true potential as he pitched for making the recently-concluded International Series here an annual affair.

The 69-year-old former world number one, who has 88 professional titles under his belt, was hopeful of India's growth in the sport.

"One of my initial focus points was to invest into the sleeping giant, which was the Asian tour. India is a sleeping giant when it comes to Golf. I mean you just look what's happening in India with the game of golf, it has only just started, right?" Norman told select media on the sidelines of

the Asian Tour event here on Sunday.

"For the next 25 years, which is a generation, India is right in the middle of them." he said.

Norman was the CEO of LIV, a breakaway league founded in 2022 and financed by Saudi Arabia.

It has introduced some fresh rules like three-day 54-hole tournaments, instead of the traditional 72-hole four-day events. The LIV tournaments have also done away with the concept of weekend cut and all those who start get to play the entire tournament besides being entitled to prize money.

The International Series is a partnership between the Asian Tour and LIV but it adheres to the traditional 72-hole concept with a cut at the end of two rounds to ensure that players

are entitled to points under the world golf ranking system, which has refused to

recognise the 54hole LIV events.

The LIV events have also faced significant resistance from the existing PGA Tour (USA)and the European Tour. which claim that the parallel tour "disrupts" the sport by offering players higher prize money and a seemingly more relaxed rules

#### structure.

Norman believes LIV can have a great role in helping Indian golf, which was on a high when the likes of Jeev Milkha Singh, Shiv Kapur, SSP Chawrasia, Jyoti Randhawa and Arjun Atwal regularly won tournaments on all three tours till about a decade back.

However, the momentum has been somewhat lost in the past five years.

"I love LIV to come to India because to me, it's significant, right? Everything takes baby

steps. And obviously, the international place to enter the league is important to do that," he pointed out.

"LIV created a new dynamic for the game of golf because it gave an opportunity in the competitive golfing world for a new business model...Different formats have come out and enticed millions and millions of people to come into the game of golf," he asserted.

"I truly believe LIV will be the true global golf platform for golf. We want to be in all the continents of the world...We bring a product that's a plug and play that's never been done before. We bring franchise models. We're bringing the youth side of it," he explained.

### Norman lauds Anirban Lahiri

Lahiri has joined ranks with LIV

along with some other prominent names like Bryson DeChambeau, two-time Major winner Dustin Johnson and Lee Westwood, a former world number one.

"He's not just a great golfer, but he's a great person. He's a great spokesperson. He's a great representative of your country. So, all those ingredients allowed me to go, let's go do it." Norman said of the Indian. who has seven Asian and two European titles to his credit.

The Australian great was also full of praise for 15-year-old rising Indian golfer Kartik Singh, who made the cut at the International Series here.

"He's captured it. He made the cut. I think it's pretty impressive. I haven't seen his swing at golf club...I look forward to seeing his swing at golf club." -PTI

# **Anderon stands** by Hindenburg report on Adani

### SAYS CLOSURE NOT DUE TO ANY THREAT

New Delhi: Activist shortseller Nathan Anderson. known for his high-profile campaigns against the likes of Adani Group, said the decision to shut his firm, Hindenburg Research was not because of any legal or any other threat, but due to workload. And that he stands by all its reports including the one against Adani Group.

Anderson told PTI that Hindenburg's January 2023 report accusing Adani Group of "the largest con in corporate history" was a result of following "red flags" raised against the conglomerate in reports.

Adani Group had repeatedly denied all allegations in the report.

He termed as "goofy conspiracy" the attempts by some to link Hindenburg with alleged anti-India groups like OCCRP and George Soros, saying his outlet never commented on them as it followed the policy of not feeding into "silly conspiracy theories".

Anderson, who came to be known for meticulously detailed reports against companies he alleged were committing fraud, last

month announced shutting down his forensic research firm nearly eight years after he founded it.

Asked why he chose to shut down Hindenburg when he could have stepped back and passed on the reins of the company to someone else, he said there is "no way to separate me from the brand.

"Hindenburg is basically synonymous with me," he said. "If it was a software application or a bicycle factory you can sell the application or the factory. But when it's research driven by me, you can't really just hand that off, and so I would not actually be 'done'. But I am happy to support the team if they want to launch a new brand, which I expect they will.

The interview with Anderson, who is based in New York, was done over phone calls and text messages.

Anderson, who first shot to fame with a report against electric truck company Nikola and had gone after the companies of major financial figures, including Carl Icahn's Icahn Enterprises LP, had last month blamed the "inten-

sity and focus" of the job for the decision to wind up.

He had spent much of the last eight years either in fights or preparing for the next fight. Many times during this period, he was often trailed and attempts were made to infiltrate his system. "As to why I retired - it is

all in the letter (released on January 16 that announced shutting down of Hindenburg) - it is not based on any threat, health issue, personal issue or otherwise," he said.

Conspiracy theories like being on the verge of an investigation by the US Department of Justice and/or US SEC to "concoct a counter-narrative about my retirement is a great example of why I am happy to instead be enjoying more time with family, friends and good music," he said.

Hindenburg has said it is not under investigation by

the US SEC over anonymous reports linking its founder to a hedge fund for preparing reports targeting companies.

Asked if he stood by Hindenburg's reports, particularly against the Adani group, Anderson said, "We 100 per cent stand by all of our research findings.'

Hindenburg had alleged that Adani Group had used a web of companies in tax havens to inflate its revenue and manipulate stock prices, even as debt piled up. The conglomerate vehemently denied all claims but the damning report at one point sheared over USD 150 billion off its value, losses it eventually recouped in over a year's time. This, as it slashed debt, pared share pledges and won new investors.

The issue was agitated before the Supreme Court which did not find any need for a probe other than the

one markets regulator Sebi had initiated into certain issues prior to the Hindenburg report.

On some seeing the Hindenburg report as against India and India's growth story, Anderson said, "We have always believed in India's potential and view market transparency and strong corporate governance as key factors that can fuel India's growth story.'

He did not elaborate. "We initially saw media articles outlining red flags, took a closer look, and just kept following the evidence," he said on why the Adani group was chosen.

On allegations of being in cohorts with OCCRP and George Soros, he said, "Of course not, but we have a policy of not feeding into silly conspiracy theories. When the main response to 100+ pages of evidence (presented in the report against Adani Group) is a goofy conspiracy, we view it as a sign that we were right on the mark.'

Asked about the response of regulatory bodies in India to Hindenburg reports, he said, "We view our role as researching and writing about issues in need of transparency."

### Dissanayake bids to achieve economic freedom

## Sensex, Nifty settle at one-month high

Mumbai: Benchmark stock indices Sensex and Nifty rebounded nearly 2 per cent on Tuesday in line with a recovery in Asian peers after US President Donald Trump delayed tariffs on Mexico and Canada for a month.

The 30-share BSE Sensex jumped 1,397.07 points or 1.81 per cent to settle at a month's high of 78,583.81. During the day, it surged 1,471.85 points or 1.90 per cent to 78,658.59.

The NSE Nifty soared 378.20 points or 1.62 per

cent to 23,739.25, a level not seen since January 3.

From the 30-share bluechip pack, Larsen & Toubro rallied nearly 5 per cent. Adani Ports, IndusInd Bank, Tata Motors. Reliance Industries, UltraTech Cement and Asian Paints were also among the major gainers.

ITC Hotels, Zomato, Nestle and Maruti were among the laggards. "Yesterday, the Indian

market struggled to absorb the optimism generated by the good Union Budget due

### EDITORIAL Marathi Mandate

he Maharashtra government has taken a commendable step to promote its native language. The Mahayuti administration's recent directive making Marathi compulsory for all government, semi-government and local self-government offices, as well as state-run corporations and aided institutions is an ambitious effort to elevate Marathi's role in public administration and governance. Officials will be required to use Marathi with visitors, excepting foreigners and non-Marathi speakers. Keyboards must include Marathi Devanagari script, with penalties for non-compliance.

The directive transcends the confines of the mere symbolism and extends to advertisements, official correspondence, tenders and notices - all of which must now be issued exclusively in Marathi. Even central government offices operating in Maharashtra are expected to comply, with signboards, application forms, and websites to be trilingual under the Centre's policy, but with Marathi taking precedence.

In theory, this move should bolster the language's prestige and ensure greater accessibility for the state's citizens. In practice, however, its effectiveness will depend on its implementation and the clarity of communication. If executed well, this could be a model for linguistic policies in multilingual societies. If done poorly, it risks becoming yet another bureaucratic edict that is ignored.

Official correspondence between departments has historically been conducted in English, and key policy decisions have been documented in it. The result has been a linguistic disconnect between the government and large sections of the population. While English remains indispensable in global commerce and higher education, making governance more accessible in Marathi in Maharashtra should be the goal every government strives for.

Mere compulsion is not enough. If Marathi is to be the primary language of administration, it must be used in a manner that is clear and simple. A heavy reliance on bureaucratic jargon will only alienate citizens rather than empower them. In the past, the use of highly Sanskritised Marathi in legal and administrative documents has made comprehension difficult even for native speakers. To be truly effective, the government must ensure that official communication is in a language that people can understand, rather than one that is so formal that it feels foreign.

The government has framed this as part of a broader Marathi Language Policy, aiming to establish Marathi as the language of knowledge and employment over the next 25 years. But the challenge remains for a linguistic mandate to translate into meaningful change.

By mandating Marathi in governance, Maharashtra has taken a decisive step in reinforcing its linguistic heritage. The key now is to implement this directive pragmatically, ensuring that the language of administration is one that truly serves the people and not one that turns into yet another bureaucratic obstacle.

# GLOBAL AFFAIRS Trump, the Panama Canal and the Cost of Climate Denial

I n 1989, as American troops descended on Panama to oust Manuel Noriega, Washington justified its intervention by citing the need to protect the Panama Canal. The 51-mile waterway, a lifeline of global trade and a pillar of U.S. strategic influence, was too important to be left in the hands of an unpredictable strongman. Three decades later, the canal faces an even graver threat - not from a dictator, but from a force that Donald Trump has spent years dismissing: climate change.

Even as Trump continues to fume on 'taking over' the Panama Canal, the 51mile waterway, which handles 6 percent of global maritime trade, faces the real danger of drying up. Deforestation and erratic rainfall have left its freshwater reservoirs, especially Gatun Lake, at historic lows. In 2023, the Panama Canal Authority (ACP) was forced to cut daily vessel transits from 36 to 24, impose weight restrictions, and raise transit fees. The consequences for global trade are severe: higher shipping costs, supply chain disruptions and longer transit times.

For the United States, the stakes are

particularly high as roughly 70 percent of all goods passing through the canal are bound for or originate from American ports. The shortcut the canal provides is invaluable: a container ship carrving goods from China to New York can save two weeks of travel time by bypassing the treacherous route around Cape Horn. A drying canal means longer transit times, higher costs, and disruptions to industries that rely on just-in-time supply chains. Electronics, raw materials, and foodstuffs will become more expensive, triggering inflationary pressures at a time when the global economy is still recovering from pandemic shocks.

The canal has always been central to U.S. economic and geopolitical power. Since its completion in 1914, it has underpinned American global trade dominance, allowing goods and energy to flow efficiently between the Atlantic and Pacific. The United States controlled the canal until 1999 when it handed over operations to Panama under the Torrijos-Carter Treaties. That transition was seen as a landmark moment for Latin America-an assertion of sovereignty after nearly a century of American control. But even under Panamanian management, Washington has remained deeply invested in the canal's operations, seeing it as critical to both commerce and security.

The crisis in Panama is not happening in a vacuum. The immediate cause of the canal's crisis is climate change. Scientists have long warned that deforestation in the Amazon - the planet's 'air conditioning system' - is disrupting rainfall patterns across Latin America, including Panama. The Amazon rainforest generates massive amounts of moisture, regulating climate systems that extend far beyond its borders. But rampant deforestation, driven by agriculture and logging, has transformed the rainforest from a carbon sink into a carbon emitter. In 2023, the Amazon experienced its worst drought in recorded history, intensifying El Niño weather patterns and



worsening the dry conditions in Panama. Less rain means less water for the canal, forcing difficult trade-offs between vessel capacity and economic efficiency.

Some have proposed engineering solutions like pumping seawater into Gatun Lake or diverting rivers, but these measures carry steep environmental and social costs. They risk contaminating freshwater supplies and displacing local communities. The only sustainable answer lies in reducing emissions and curbing deforestation. Yet Trump's approach to climate policy remains unchanged. During his presidency, he rolled back environmental protections, withdrew from the Paris Agreement, and championed fossil fuel expansion. His 2024 campaign rhetoric has continued in the same vein, attacking climate policies as job-killers while dismissing global warming as a hoax.

Trump's insistence on prioritizing short-term economic gains over longterm sustainability could prove costly. The drying canal is not just an environmental concern but a national security risk. If its decline accelerates, alternative trade routes will emerge. China, already the second-largest user of the canal, has been expanding its Arctic shipping ambitions as melting ice opens new passageways. A weakened Panama Canal could push more trade toward China's Belt and Road Initiative, undermining American influence in Latin America.

The canal's plight underscores an inconvenient reality: climate change is no longer a distant threat but an immediate economic disruptor. Droughts, extreme weather, and shifting environmental conditions will continue to reshape global trade. Sensible policymaking would recognize the need for climate adaptation and international cooperation. Trump's brand of populist denialism, however, offers no solutions, only a dangerous illusion that America can insulate itself from the consequences of a warming planet. The drying Panama Canal should serve as a warning. If the world's largest economy cannot reconcile economic policy with environmental responsibility, the costs will be measured not just in rising shipping fees, but in economic instability and lost global influence.

As Trump rallies his base with promises of economic revival and America's resurgence, his vision remains dangerously shortsighted. The forces shaping the 21st-century economy - climate instability, shifting supply chains, and geopolitical competition - require leadership that sees beyond the next election cycle. Will America navigate these turbulent waters, or will it be left adrift is the question.

# **Counting Castes,**

Rew issues are as politically explosive in South Africa as land reform. More than three decades after apartheid ended, the vast majority of private farmland remains in white hands, a glaring legacy of colonial dispossession and racial segregation. President Cyril Ramaphosa's decision last month to sign into law a bill that allows land expropriation without compensation has reignited fierce debate which now extends far beyond South Africa's borders.

Donald Trump, never one to shy away from controversy, has waded into the fray with characteristic bluntness. The US president announced that he would cut all future funding to South Africa over what he called the country's policy of "confiscating land" and allegedly "treating certain classes of people very badly." He has demanded a full investigation into what he perceives as state-sponsored land seizures.

The South African president has dismissed these allegations outright, declaring that his country remains a constitutional democracy. The law, his government insists, is neither arbitrary nor discriminatory, but rather an essential corrective to an unjust past. As Ramaphosa fends off Trump's broadsides, he is also contending with mounting resistance at home - not just from white landowners and opposition parties but even from within his own government.

To understand the current controversy, one must look back more than a century. In 1913, the British colonial authorities enacted the Natives

Trump's threat to cut funding over South Africa's land reform exposes a deeper, unresolved historical wound.



Land Act, which restricted black land ownership to just 7 percent of the country's total area. This was later expanded to 13 percent but remained grossly disproportionate in a country where black people formed the overwhelming majority. Apartheid-era forced removals deepened the injustice, relegating millions to impoverished townships and socalled "homelands."

When Nelson Mandela's African National Congress (ANC) took power in 1994, land reform was a priority. But successive governments struggled to implement it effectively. By 2017, a government report found that 72 percent of privately owned farmland remained in white hands, despite whites constituting just 7.3 percent of the population.

The new law, its proponents argue, is a belated but necessary step to address this imbalance. It allows for expropriation without compensation in cases where land is unproductive, abandoned, or poses a social risk. The government insists that it will not lead to mass land seizures.

Comparisons with Zimbabwe's disastrous land seizures loom large. At the turn of the millennium, Robert Mugabe's government forcibly removed white farmers, triggering economic collapse and hyperinflation. Investors fled, and agricultural productivity plummeted.

Ramaphosa's critics warn that South Africa could be heading down the same path. The pro-business Democratic Alliance (DA), the country's second-largest party, has vowed to challenge the law in court. Even some members of Ramaphosa's governing coalition are wary, arguing that the process of enacting the law lacked due diligence.

On the other side of the spectrum, the radical Economic Freedom Fighters (EFF) have lambasted the law for not going far enough. They advocate sweeping nationalisation of land, arguing that anything short of this is a betrayal of the landless black majority.

Into this volatile mix steps Trump. His threat to cut aid is unlikely to have a crippling financial impact as most US funding to South Africa comes through Pepfar, the health initiative that supports HIV/AIDS treatment. But it signals Trump's alignment with white South African farmers, a constituency that has long sought international support against land reform.

Trump's position also plays well to his base. Many on the American right view South Africa's land policies as an example of 'reverse racism.' Yet, Trump's posturing may prove counterproductive. His comments risk alienating South Africa, a major player in the BRICS bloc that has been moving closer to China and Russia.

They could also backfire domestically; even AfriForum, an organisation advocating for white Afrikaner rights, has distanced itself from Trump's blanket condemnation, suggesting that any punitive measures should target ANC leaders rather than the country as a whole.

C aste, the defining feature of Indian politics, has always been at the center of any political debate. The Telangana government's recently released caste survey, completed in record time, has provided a numerical basis for long-standing demands for greater representation, potentially upending political calculations in the state. With Backward Classes (BCs) forming the majority of the state's population, their leaders are demanding higher political quotas, putting pres-

Unlike its neighbour Karnataka, where Siddaramaiah's Congress-led government has been sitting pretty on a similar exercise, Reddy appears intent on stirring the caste cauldron in Telangana. However, what was meant to be a tool to consolidate support among BCs could soon become a political liability for the state government as well as Congress leader Rahul Gandhi's nationwide pitch for a caste census.

The preliminary findings of Telangana's Socio-Economic, Educational, Employment, Political, and Caste (SEEEPC) Survey hold few surprises. The survey, covering around 9 percent of all households, found that 56.33 percent of Telangana's population belongs to the Backward Classes (BCs), including 10.08 percent Muslim BCs. Scheduled Castes (SCs) make up 17.43 percent, Scheduled Tribes (STs) 10.45 percent, while the so-called 'Other Castes' (OCs) account for just 15.79 percent. These figures largely align with historical estimates but now serve as a rallying cry for BC lead-

Telangana's caste survey could prove a political landmine for Rahul Gandhi and the Congress. ers, who are demanding that their numerical strength translate into increased political and economic representation.

With local body elections due soon, the survey's findings are bound to shape party strategies. BCs, already seen as a crucial voting bloc, played a pivotal role in the Congress's victory over the Bharat Rashtra Samithi (BRS) in 2023. Now, BC leaders want tangible political gains. The Congress government, which has only two BC ministers in its Cabinet, now faces intense pressure to act.

The BJP, which is keen to expand its footprint in Telangana

after securing eight seats in 2023, is actively courting BCs, sensing an opportunity in Congress's predicament. The BRS, still reeling from its electoral defeat, is also demanding the immediate implementation of the survey's findings. If Congress fails to meet BC demands, it risks alienating a key constituency ahead of both local and future assembly elections.

Rahul Gandhi has been the loudest advocate for a nationwide caste census, making it a cornerstone of Congress's political strategy. Yet, the Telangana survey now forces Congress to walk the talk, raising uncomfortable questions about whether the party is willing to implement the very policies it champions at the national level.

The Karnataka caste survey, completed in 2018, has been a political hot potato for Congress. Despite commissioning the survey, the Karnataka government now led by the Congress has kept its findings under wraps for seven years.

By contrast, Bihar's caste census was completed relatively swift-

ly. The Nitish Kumar-led government took just

six months and spent Rs. 500 crore to publish its findings, which revealed that BCs and EBCs make up a staggering 63% of Bihar's population. The move allowed Kumar to claim the mantle of championing backward caste politics while Congress, despite being a coalition partner, played a secondary role. The Telangana survey's timing is particularly inconvenient for Rahul Gandhi, who has championed a national caste


gana survey's timing is particularly inconvenient for Rahul Gandhi, who has championed a national caste census but now faces internal resistance within his party. The Telangana government has already committed to increasing BC reservations in local body polls, yet BC leaders remain unsatisfied, fearing a repeat of

Karnataka's dithering. If Congress appears hesitant in Telangana, it risks losing credibility on its national caste census campaign. If it acts decisively, it could alienate upper-caste leaders within the party, triggering internal rifts similar to those in Karnataka. The BJP, which has historically been reluctant to embrace caste-based politics, could exploit Congress's divisions to consolidate its position among non-BC voters.

## 'The Great Silence' and the Subversive Genius of Spaghetti Westerns

ast year, I, along with some friends, visited Wai for two days. Wai is located in Satara district in the State of Maharashtra. During our free time while there, we decided to do some sightseeing. However, aside from well-known places like Menavali, we weren't aware of any other place to visit. A casual search for places to see around me on our faithful companion. Google. also did not reveal much more, other than what we already knew. So, we went ahead and visited the same places we had visited a few years back nothing new to see. I was disappointed when I later learnt that the Laxmi-Nrusinha Mandir, which has a unique Nandi-Mandapa on the back of a turtle sculpture, was located nearby.

All of us may have experienced this disappointment at least once in our lives when we visit an unfamiliar place and regret missing a beautiful temple or monument that was situated nearby. Our everyday life saviour, Google is very useful when providing us with a list of restaurants, hotels, etc. around us. But it is not particularly good when showing us heritage monuments, especially lesser-known ones. And you may be surprised when you learn of the heaps of beautiful monuments that lie hidden in plain sight.

idea—why shouldn't there be an app that provides common people access to hidden gems that, so far, have only been known to archaeologists and scholars? It should be user-friendly and convenient. Not everyone travels solely to visit temples and caves, but everyone travels for some reason—be it work, family pilgrimages, trekking, vacations at resorts, etc. During their travels, people often have at least an hour of free time. When in an unfamiliar town or city, they naturally wish to explore something remarkable nearby-especially since they may never visit that place again. For the hundreds of thousands who travel, a smart and convenient app would be the perfect companion.

Depending on the time available, users should be able to search for monuments within a 2-3 km radius or even up to 20-50 km. For those too busy to check their phones, imagine an app that does the work for you sending notifications when you're near a historical site. Even better, if you're travelling from point A to B, the app could alert you to interesting spots along the way. The best part is, such an app already exists! Currently available for Pune district, it has the potential to expand across the state or even the country, depending on user response.

The sites provided in the app have been personally searched by the creator, who happens to be an archaeologist. So as not to waste the user's time, each site has been rated by him out of 5. So, a user can predecide if the site is worth a visit. For those history enthusiasts and scholars who visit a place just to see its monuments, the app can help too. It will be easier to plan which site to visit more monuments are always preferable to a single one. The app can help you surf and search. It will have up to nine filters for nine categories of monuments: temples, forts, caves, Wadas, tombs (Samadhi, Chhatri, etc.), step-wells, mosques, bridges, and river Ghats. This filter will prove useful to many people, not just tourists. For example, NGOs that restore step wells and water resources can check out only what they need.

If I were to describe my app in some other way, I would call it a 'treasure map'! What's more, this treasure map fits in your pocket. Our heritage is like a treasure and providing easy access to it can bring new life into the dying and forgotten wonders.

In the winter of 1968, Sergio Corbucci's uncompromising Western, 'The Great Silence', arrived like a snowstorm in the desert. A bleak masterpiece set in the snowbound frontier of Utah towards the close of the 19th century, it upended the conventions of both American and Italian Westerns with its utterly merciless vision of justice – brutal even by the violent standards of Spaghetti Westerns.

The film has become notorious for having possibly the most downbeat ending in the history of Westerns. In so doing, it has cemented Corbucci's place as the true revolutionary of the Spaghetti Western, a genre often overshadowed by the towering presence of Sergio Leone.

When American critics first came to grips with Italian Westerns, they witnessed a radical subversion of a beloved, staple genre. For decades, Hollywood had enshrined the Western as America's mythic foundation, an elegy to 'Manifest Destiny' as evinced by the films of John Ford and Howard Hawks.

But by the 1950s, Cold War paranoia had unsettled the genre. 'High Noon' (1952) reflected McCarthyite anxiety, while Anthony Mann's and Budd Boetticher's collaborations with James Stewart and Randolph Scott introduced tormented anti-heroes, reshaping the Western into stark tales of isolation and vengeance.

Then, in the summer of 1962, Akira Kurosawa's 'Yojimbo' opened in Rome, and two Italian directors saw in it the seeds of a new cinematic language. Sergio Leone would win the race to reimagine the film as 'A Fistful of Dollars' (1964), giving Clint Eastwood his signature role. Corbucci, working in Leone's shadow, would instead craft the fever-dream, anti-clerical, apocalyptic 'Django' (1966), a twisted homage to 'Yojimbo.'

By 1968, the Spaghetti Western had become a movement, capped by Leone's masterpiece 'Once Upon a Time in the West'. Corbucci delivered his own masterwork in form of 'The Great Silence.' Shot in the frigid Italian Dolomites rather than sunbaked Almería of Leone's films, Corbucci replaces the dust and tumbleweeds with unforgiving snow. The setting serves as a metaphor for the film's pitiless moral climate.



Frenchman Jean-Louis Trintignant plays 'Silence,' a mute gunslinger wielding a Mauser whose vocal cords were mercilessly cut as a child. His adversary is 'Loco' - a maniacal bounty hunter played by German actor Klaus Kinski, at his most reptilian. Loco is a systematic executioner, a man who finds legal loopholes to justify his butchery. The film's secondary antagonist, the banker Pollygut (Luigi Pistilli), a ruthless land-grabber, forces farmers into the wilderness, where Loco can legally exterminate them for profit.

In Leone's world, survival depended on cunning, not virtue. In Corbucci's, even cunning was not enough. Instead of the moral certainty of a John Wayne film or the mythic grandeur of Leone's Dollars Trilogy, The Great Silence offers only nihilism. The silence of the title is both literal - its hero cannot speak- and metaphoric: it is the silence of history, the silence of the oppressed, the silence of those crushed beneath the boot of capital and power.

The film's shocking ending, where Silence is unceremoniously gunned down along with the innocents he tried to protect, remains one of the most haunting finales in cinema. There is no last-minute salvation, no act of divine justice. Loco wins. The bounty hunters collect their rewards. The frontier is not tamed but consumed by its own brutality. It is a world where the lone hero cannot hope to triumph, only to be obliterated.

This nihilistic vision of the West was a radical departure, even within the Spaghetti Western genre. Leone's films, for all their cynicism, still operated within a mythic framework; 'The Good, the Bad and the Ugly' ended with a triumphant duel while 'Once Upon a Time in the West' was an elegy to the Old West. Corbucci offers no such solace.

Despite its brilliance, 'The Great Silence' was largely ignored outside of Europe. Prominent American critics like Roger Ebert dismissed the genre outright, failing to see its influence on American filmmakers. Yet, the lineage of The Great Silence runs deep. Sam Peckinpah's 'The Wild Bunch' (1969) echoed its finale, while Quentin Tarantino paid homage in 'The Hateful Eight' (2015) with its snowy setting.

If the Spaghetti Western was a subversion of the American Western, then 'The Great Silence' was the genre's most radical act of sabotage. Corbucci didn't just make a great Western; he made the Western's most devastating eulogy.
