SEBI employees protest at HQ

Demand Buch's resignation

Mumbai: A large number of SEBI (Security and Exchange Board of India) employees protested outside the capital markets regulator's headquarters on Thursday, seeking chairperson Madhabi Puri Buch's resignation.

The staffers, numbering over 200 as per an estimate. held a silent protest outside the main building in the Bandra Kurla Complex, housing Buch and other officials' offices

None of the protesting employees spoke to the media, but a handout purported to have been drafted by the protesting officials sought the withdrawal of a press release issued by SEBI on Wednesday and also Buch's resignation.

The protesting employees assembled in front of the building and were seen standing there for about 90 minutes before dispersing.

For Puri, protests and internal issues have come at a time when she is probably facing the most challenging times in her stint. The career banker-turned-regula-



tor is battling speculations on whether a conflict of interest made her go slow on the probe against Adani Group and a raft of other allegations around it.

This is not the first instance of a protest at the SEBI, which witnessed a similar protest over a month ago by some employees. At that time, officials had said that the protests were by a few elements and do not have the backing of the recognised unions or associations.

In what is unprecedented for any financial regulator, around 500 employees are reported to have written to

the Finance Ministry on August 6 against the top management for what they called a "toxic" work environment, which includes instances of public humiliation and shouting down.

After the publishing of a media report about the letter, SEBI responded with a press release, which said such claims are "misplaced", which seems to have irked the employees.

The regulator said that some "external elements" had instigated its employees into believing that they shouldn't be held to high standards of performance and accountability, though, it did not provide specific details. "The claims of unprofessional work culture in the letter dated August 6, 2024, are misplaced," SEBI said in a statement.

The regulator suspects that junior officers have been receiving messages from outside parties encouraging them to "go to the media, the Ministry, or the Board," possibly for the outsiders' own agendas.

Attacks on Hindus 'exaggerated': Yunus

Dhaka: Chief Adviser to Bangladesh's interim government, Muhammad Yunus, has said the issue of attacks on minority Hindus in his country is "exaggerated" and questioned the manner

in which India projected it. In an interview with PTI at his official residence here, Yunus said the attacks on minorities in Bangladesh are more political than communal.

He suggested that the at-

tacks were not communal. but a fallout of a political upheaval as there is a perception that most Hindus supported the now-deposed Awami League regime.

"I have said this to (Prime Minister Narendra) Modi also that this is exaggerated. This issue has several dimensions. When the country went through an upheaval following the atrocities by (Sheikh) Hasina and the Awami League, those who

were with them also faced attacks," the Nobel laureate told PTI. The minority Hin-

"Now, while beating up Awami League cadres, they had beaten up Hindus as there is a perception that Hindus in Bangladesh mean Awami League supporters. I am not saying that what has happened is right, but some people are using it as an excuse to seize property. So, there is no clear distinction between Awami League supporters and Hindus," he

Unusual photograph keeps tongues wagging on Shinde's Hindutva credentials

Mumbai: Is Chief Minister Eknath Shinde keeping away Hindutva to woo Christians? This was the question asked in hushed voices in Mantralava corridors on Thursday on the sidelines of the meeting of the state Cabinet.

Shiv Sena's full-page advertisement appeared in a prominent Marathi daily on Thursday giving information of an "Interdenominational Christian Conference" to be held at CIDCO exhibition centre at Vashi in Navi Mumbai and appealing people register for the conference. The advertisement carries a prominent photograph of CM Shinde. Interestingly this is a unique photograph of CM Shinde where he is seen without vermilion on his forehead, his style statement proclaiming his Hindutva inclination.

Shinde always ensures he has vermilion on his

forehead before leaving home everyday. He also takes care that it is prominently seen on his forehead in a proper manner throughout his meetings and public rallies throughout the day. This backdrop led to the question in hushed voices in the coridors of Mantralava whether the CM's photograph was deliberately changed to woe the Christian community.

A former corporator from Navi Mumbai Municipal Corporation and Shiv Sena Navi Mumbai Jilha Sampark Pramukh Kishor Patkar's name appears at the bottom of the advertisement as 'welwisher'. When contacted, Patkar said that the party is just a sponsor and the program has nothing to do with the party. "It is being organised by the Christian organisations and everything is done by them," Patkar, who has very close connections with the local Church in Vashi, said.



Sanjay Nirupam condemned the photograph used in the advertisement and said that it must have been a work of someone who doesn't understand the Shiv Sena's ethos. Interestingly, Eknath Shinde had came down heavily on his predecessor Uddhav Thackeray after the latter's party had organised a competition for Muslim community in Parel last

Mumbai: A man fired a revolver at two persons at crowded Badlapur railway station in Thane district on Thursday evening, injuring one of them in what police said was a fallout of professional rivalry.

The incident took place at platform number 1 at around 6 pm when the suburban station on the Central Railway route was chock-a-block with commuters, said the Government Railway Police.

The entire incident was captured on cameras and a video of it went viral on social media within minutes. After opening fire, the assailant, identified as Vikas Nana Pagare (25), ran towards railway tracks in a bid to escape, but he was chased and pinned down by policemen on duty with the help of some commuters, and later placed under arrest, they said.

The injured person was



Shankar Sansare, while the second man targeted by Pagare escaped unhurt, but his identity was not revealed. Sansare was rushed to a local hospital, where he is being treated for gunshot wounds, said the GRP. The assailant and also

the duo he attacked have criminal records and the firing was linked to professional rivalry over TV cable business between them in the area, said the police, citing preliminary probe.

Initially, there was a fight between Pagare and the duo outside the railway station.

As Sansare ran inside the station, the gunman followed him and fired at him and the other person accompanying him from his revolver, they said. The GRP's Kalyan unit, under whose jurisdiction the incident took place, were in the process of registering an FIR against the accused and carrying out further

'Modi should apologise to every Maharashtrian'

Vishwajeet Kadam's Power Play in Sangli

Sangli (Maharashtra): Leader of Opposition in the Lok Sabha Rahul Gandhi on Thursday said Prime Minister Narendra Modi should apologise not only for the collapse of Chhatrapati Shivaji Maharaj's statue in Sindhudurg district, but also for demonetisation, anti-farmer bills and GST.

Modi should say sorry to each and every citizen of Maharashtra for the insult caused to the legendary 17th century warrior king when the statue at Rajkot fort collapsed on August 26, he added.

The Congress leader was speaking at a public meeting here after inaugurating a life-size statue of late party leader Patangrao Kadam.

With the BJP-Shiv Sena-NCP government in
Maharashtra coming under fire over the collapse
of the Shivaji Maharaj
statue, the prime minister
during his subsequent
visit to the state said he
apologised to the iconic
king, his "deity", and also

the people whose sen ments were hurt.

"I want to ask the prime minister what he is sorry for, is it because the contract to make the Shivaji statue was given to an RSS person who had no merit, or for the corruption in the process," Gandhi said.

Modi should answer why all contracts are given only to "Adani and Ambani" and why he was running the government only for "two people", the Congress leader added.

Modi did not visit Ma-

nipur which is facing a civil war-like situation as the BJP itself has set the northeastern state on fire, Gandhi alleged.

Small and medium businesses were being finished for the benefit of "two people", he said, adding that Adani and Ambani groups cannot generate employment.

Late Patangrao Kadam dedicated his life to the Congress party, Maharashtra and the country, and worked for development and spread of education, the Raebareli MP said.

The prime minister has not apologised for the "anti-farmer laws" which were later withdrawn due to protests, he further said, and demanded that Modi apologise for demonetisation and the "wrong" Goods and Services Tax.

When Indira Gandhi lost the Lok Sabha election, Kadam stood by her and organised a public meeting even at 2 am, Gandhi noted.

Reiterating his demand for a caste census, he said it would provide a snapshot of how many people are there in different social strata, and their share in the country's wealth and decision-making.

"But the BJP says no. Now the RSS has said that caste census is necessary. Congress and INDIA bloc will ensure that caste census is carried out at any cost. We need to understand the truth, who benefits from the country's wealth," he said.

Sangli: The death of former Maharashtra minister Dr. Patangrao Kadam in 2018 left a void not just in Sangli district's Palus-Kadegaon Assembly constituency but in the Congress leadership ranks as well. His son, Dr. Vishwajeet Kadam, is now rapidly

filling this gap. On Thursday, Kadam staged a grand display of Congress strength in the Sangli district with the unveiling of

his father's statue.

Congress leader Vishwajeet Kadam reportedly spent around `50 crore on the statue unveiling ceremony. For the event, approximately 20 acres of land was acquired, necessitating the removal of sugarcane crops and compensation of around Rs. 4 lakh per acre to affected farmers. A waterproof tent, costing about ₹8 crore and sourced from Jalandhar, Punjab, was erected. Around 1.5 lakh chairs were set up, each with snacks, juice, and water bottles. Approximately 150,000 people, including village and district council members, Congress leaders, and well-wishers, were invited. Additionally, a 20-acre memorial site featuring landscaped gardens, a museum, and a large hall has been established as a tourist attraction.

nounced wrestler Chandrahar Patil for the Sangli seat — a move that had irked the Congress leadership across the State given that Sangli had been a Congress bastion for half-a-century.

The Congress had been grooming Vishal Patil for the Sangli seat. Patil had been mentored by Kadam. Eventually, Patil rebelled, contested as an Independent candidate and pulled off a major victory by beating the Sena (UBT)'s Chandrahar Patil in the Sangli Lok Sabha seat. It is widely believed he had Kadam's strategic support. Vishal Patil's win had further aggravated tensions between the Sena (UBT) and the Congress, particularly with Kadam.

Thackeray's name was notably excluded from the program as well. In contrast, Sharad Pawar's presence signaled continued support from key Maha

Closely allied with Rahul Gandhi, has been a rising force in Congress. Gandhi's emphasis on promoting young leaders is evident in Kadam's role as the President of Maharashtra Youth Congress. This effort aligns with Gandhi's broader strategy to invigorate the party with fresh, dynamic leadership.

As veteran Congress figures such as Prithviraj Chavan, Balasaheb Thorat, and Sushilkumar Shinde approach retirement, the party is pivoting towards a new generation. Kadam's prominence in Sangli, supported by significant investment—reportedly around ₹50 crore—demonstrates his growing influence and potential.

The BJP's strategy of elevating younger leaders is being mirrored by Congress.

Suddenly in the series, the Ajit Pawar-led NCP has released two advertisements in which the party tried to project that it was Ajit Pawar who brought the scheme for women that costs the state exchequer ₹46,000 crore annually. In one advertisement, a man asks his daughter where she got a new dress and she replies saying Ajit Dada. "Dada", is a Marathi term meaning "elder brother". In another adver-

tisement, a wife requests her husband to sign a form which turns out to be a form for subscribing to a joint fixed deposit scheme. To his surprise, the man asks his wife where she got this amount. She replies with a big smile saying "Ajit Dada gave us." In the background of the advertisement, the voiceover artist also says, "Ajit Dadanchi Ladki Bahin Yojana." (Ajit Pawar's Ladki

Bahin Yojana).

The Shinde camp reverted back with displeasure. Shambhuraj Desai, Excise Minister, said "The various schemes are being run on the head of the Country and the state. There are Prime Minister gram sadak schemes in the country. Similarly, in Maharashtra Ladki Bahin is being run under the CM's name."

Man beats elder brother to death

Nagpur: A 25-year-old man allegedly beat his elder brother to death in Nagpur after he scolded the former's wife, police said. The incident occurred on Sunday in Hingna area of the city, they said. Govind Chowkhe attacked his 36-year-old brother Kisan following a heated argument. The brothers and their families lived in the same house with their mother.

"The argument between the siblings broke out after Kisan reportedly scolded Govind's wife over a family matter. Angry with him, Govind hit Kisan on his chest and head multiple times, in which the latter was seriously injured. He was rushed to a hospital, where doctors declared him dead," an official of Hingna police station said.

Teen allowed pregnancy

Mumbai: The Bombay High Court on Thursday allowed a 17-year-old sexual abuse survivor to continue her pregnancy, noting that it was conscious of her reproductive freedom and right to choice.

A division bench of Justices A.S. Gadkari and Neela Gokhale said that while the teen initially sought to terminate the pregnancy, she later chose to deliver her baby as she intended to marry the man who had allegedly

abused her.
"We are conscious of

the right of the petitioner (teenager) to reproductive freedom, her autonomy over the body and her right to choice," HC said.

The court said it permits the teenager to medically terminate her 26-week pregnancy if she so desires. "However, since she has also expressed her willingness and desire to continue with the pregnancy, she is fully entitled to do so," the bench said.

The girl and her mother learnt about the pregnancy when she was taken for a check-up for fever. A case was later registered against a 22-year-old man for sexually abusing her. The survivor then moved the HC seeking to terminate the pregnancy.

However, the teen later claimed that she was in a "consensual" relationship with the man and that they intended to get married and raise the baby.

The minor was examined by a medical board at the state-run JJ hospital which submitted a report to the HC, saying that there were no abnormalities with the foetus. -PTI



Dealing with heavy traffic has become a daily struggle for Ghodbunder Road residents. It's affecting not only the working class but also schoolchildren.

She said, "I think 100 times before leaving home, just because of traffic issues. Facing hardships due to traffic especially on Ghodbunder road has become evervone's destiny here.

Truck mishap led disruption

Notably, a truck mishap on the wee hours of Wednesday on Ghodbunder road caused massive traffic disruption lasting for nearly 11 hours and this was the second such incident in two days, which left thousands of commuters, including students, travelling to and from Thane and Mumbai, stranded along the highway. The driver of the truck, laden with 35 tonnes of chemical and headed towards Haryana on the Ahmedabad-bound lane. crashed into the divider. The truck then toppled on the slip road ahead of the Patlipada flyover. Meanwhile, irate motorists waiting on the Borivli-bound lanes in Thane ended up jumping lanes, compounding the problem and bringing traffic to a grinding halt.

New line between **Borivali and Virar**

HC allows cutting of mangroves

Mumbai: Construction of fifth and sixth lines between Borivali and Virar stations of the Western Railway (WR) would ease traffic congestion, reduce emissions and save fuel, the Bombay High Court has said while allowing cutting of mangroves for the project.

A division bench of Chief Justice Devendra Kumar Upadhyaya and Justice Amit Borkar permitted the WR to fell 2,612 mangroves on the land required for the new lines on the Mumbai suburban train route.

The order of August 30, which became available on Thursday, said the project was overwhelmingly in public interest and has significant ecological benefits.

As per an old judgement, the high court's permission is needed to remove mangroves in the Mumbai region.

The WR had filed a petition seeking permission to cut the mangroves. The construction of fifth and sixth lines would meet the demand for additional services, it said.

The HC noted that broader public interest, weighed against environmental consequences, is balanced by the fact that the construction would alleviate congestion on the existing lines.

"The railway system is an eco-friendly mode of mass transportation and one of the most efficient in the world. The construction of these lines would reduce emissions, alleviate traffic congestion, and con-



court said.

The project was absolutely necessary and had no viable alternative as its site is adjacent to the existing tracks, the judges observed, adding that the "alignment has been determined to be the most suitable from technical, economic and functional perspectives.

The bench directed the railway authorities to replant 7,823 mangroves to compensate for the ecological damage.

The fifth and sixth railway lines between Borivali and Virar are being constructed under Phase III-A of the Mumbai Urban Transport Project (MUTP) at a cost of Rs 2,184 crore.

The 26-km lines are expected to increase the frequency of trains beyond the western suburbs.

Currently there are five lines between Mumbai Central and Borivali, and a sixth one is under construction. From Borivali to Virar, there are only four

Sculptor had intention to surrender, says lawyer

Thane: Sculptor Jaydeep Apte, who has been arrested in connection with the collapse of Chhatrapati Shivaji Maharaj's statue, came to meet his family at Kalyan in Thane district as he wanted to surrender before the police, his counsel has claimed.

Apte, 24, was arrested from near his house in Kalyan on Wednesday night by a team of police.

The police in Sindhudurg district were looking for Apte since the statue made by him and installed at the Rajkot fort in Malvan collapsed on August 26, less than nine months after it was inaugurated. Police had formed seven teams to trace him.

Talking to the reporters late Wednesday night, his counsel advocate Ganesh Sovani said Apte decided to surrender before the police and face legal action instead of applying for a prearrest bail.

The decision was made on Wednesday and as per the plan, he came to Kalyan to surrender before the po-

The Sindhudurg police on Thursday told a court there that the materials recovered from the Chhatrapati Shiyaji Maharaj statue which collapsed last month at Rajkot fort in Malvan were rusted and it needs to be ascertained if items of subpar quality were used by the accused.

The police, while seeking custody of sculptor-contractor Jaydeep Apte and consultant Chetan Patil, said interrogation was required to find out what kind of materials they had used to design and construct the 35-foot

Sena leader booked for attacking

Thane: A Shiv Sena leader and several others were booked in Thane for allegedly attacking some people and preventing them from entering a temple, a police official said on Thursday.

The incident took place late Wednesday night after a meeting called at a temple by accused Vikas Repale, who is a former corporator, the Wagle Estate police station official said.

"As per the complainant, who is a 25-year-old Dalit student, he and some others of his caste were stopped from entering the temple for the meeting by Repale. He told them why they should come to a temple when he (complainant) belongs to a different religion (Buddhism). As per the complaint, Repale tried to hit them with a rod while others with him threw slippers," the official said.

"The group also threw stones when the complainant was going to the police station to get a case registered. We have booked Repale and some others under BNS and SC/ST (Prevention of Atrocities) Act.

Companies form JV to recycle PET bottles

Mumbai: Two Indian companies listed on the stock exchanges have proposed a joint venture to recycle PET bottles, as per the corporate filing with the stock exchange.

The joint-venture, which is yet to be finalized, will see Race Eco Chain and Ganesh Ecosphere holding 51 percent and 49 percent stake, respectively.

The joint venture aims to launch numerous washing lines across India to transform PET bottles into reusable flakes, thereby significantly reducing plastic waste and fostering a circular economy and address the escalating demand for recycled PET (rPET) in India, driven by Environmental, Social, and Governance (ESG) mandates and regulatory requirements.

Phishing link located

New Delhi: Indian cybersecurity agencies have detected a phishing fraud that "mimics" the official website of the Ministry of Defence to "harvest" the log-in credentials of officials to "steal" sensitive government documents.

The communication has been accessed by PTI and it says both the URLs seek NIC-provided log-in credentials of government officials through a fake e-mail that comes attached with a "fake' document titled "Hackers Targeted Defence Personnel in Mass Cyber Attack".

Once individual credentials like log-in IDs and passwords are punched, the links re-direct the users to a "login-error.html" page.

"Both the phishing URLs have mirrored the original MoD website (www.mod.gov. in) to lure end users into believing they are legitimate MoD websites," the communication says.

The two links are "mimicking" the Department of Defence under the Ministry of Defence and the phishing campaign is primarily aimed at harvesting the NIC credentials of government officials to steal sensitive documents pertaining to the Indian government, the communication says.

Quick commerce platforms in 60 cities

Mumbai: Indian quick com-Blinkit among others are transforming the retail landscape by offering household products that are 10-12 percent lower than MRP (maximum retail prices), according to a report by Equirus Research - a wealth management firm.

The report estimates target addressable market for quick commerce in top-60 Indian cities at USD 150 billion as a larger share of the grocery market will shift towards it.

These platforms are offering more SKUs (stock keeping units) or products, superior service along with discounts, disrupting the market by targeting affluent impatient customers in affluent areas

Unlike food delivery, which tends to be expensive, quick commerce is more affordable than offline retail. making it accessible across income groups and these sales are not confined to smaller SKUs, but even larger grocery packs are increasingly becoming popular, suggesting that



consumers are using them for monthly purchases.

Competition has intensified with players Flipkart and BigBasket, now transitioning to a full quick commerce model by entering this space and incumbents like Blinkit and Zepto are set to double their store count next year.

As players add stores in overlapping geographies, price competition and discounting may increase over the next 12 months.

These platforms are driven by execution rather than just strong balance sheets and demand a distinct operational DNA for positive unit economics.

India's market for quick commerce is large enough to support 4-5 players, though some may operate sub-optimally in specific regions.

Rebellion in BJP, min quits



Chandigarh: A day after the ruling BJP announced its first list of 67 candidates for the October 5 Haryana assembly polls, the party faced rebellion with minister Ranjit Singh Chautala and MLA Lakshman Dass Napa who were denied ticket quitting the party.

Energy and Jails Minister Ranjit Chautala (79), son of former deputy prime minister Devi Lal, said he took a decision after a meeting with his supporters and will now enter the fray as an Independent.

Napa quit the party after being denied ticket while former minister Karan Dev Kamboj also stepped down as state BJP's OBC Morcha chief after party ignored his candidature.

The rebel trouble for BJP started shortly after it came out with the first list of candidates as it left many sulking. After quitting the party, Napa met former chief minister Bhupinder Singh Hooda at his residence in the national capital and later said he will be joining the Con-

HC to constitute special bench for hearing

Kochi: The Kerala High Court on Thursday said it will constitute a five-judge special bench to hear cases related to the Justice Hema Committee report.

A bench of Acting Chief Justice A Muhamed Mustaque and Justice S Manu made this oral observation while hearing a plea challenging a single judge's decision allowing release of the committee's report.

The special bench would also comprise women judges, the High Court said in its oral observation, a lawyer associated with the petition said. The single judge on August 13 had allowed release of the report by dismissing a plea challenging the State Information Commission's order permitting the panel's findings and recommendations to be made public. The single judge order came while rejecting the plea by Sajimon Parayil, a film producer, who had challenged the Information Commission's July 5 order directing the State Public Information Officer (SPIO) to reasonably disseminate the information in the report while ensuring that it does not compromise the privacy of individuals.

Parayil filed an appeal against the single judge's order before a division bench headed by the Acting Chief Justice which on Thursday decided to constitute a special bench for hearing matters related to the panel's report. The committee was constituted by the Kerala government after the 2017 actress assault case and its report revealing instances of harassment and exploitation of women in the Malayalam cinema indus-

HC seeks CBI report on nasty social posts

The body of the on-duty trainee doctor was found in the seminar room of the state-run hospital on August 9, triggering nationwide outrage. The CBI is investigating the case from the second week of August on an order of the high

The petitioner prayed in the PIL that the CBI be directed to investigate the cyber offences in connection with the "unfortunate and brutal incident."

Kerala to host conclave of five opposition states

Thiruvananthapuram: Kerala will host a conclave of five opposition-ruled states--four from South India and Punjab from the North--to discuss how to ensure their fiscal needs are addressed in the upcoming 16th Finance Commission, state Finance Minister K N Balagopal said on

Thursday. Besides the Left-ruled Kerala and AAP-governed Puniab, the states that will take part in the conclave are Tamil Nadu (DMK) and the Congress-ruled states of Karnataka and Telangana. The move by the Left government is seen as an effort to bring together the opposition-ruled states to strengthen their bargaining position with the BJP-ruled Centre. Last year, the state had filed a suit in the Supreme Court against the Centre for imposing limits on its borrowing capacity.

Balagopal said that the conclave, which will be inaugurated by Kerala Chief

Minister Pinarayi Vijayan on September 12, aims to 'protect and strengthen' the cooperative and fiscal federalism of the country.

Besides himself, Telangana Deputy Chief Minister and Finance Minister Bhatti Vikramarka Mallu, Karnataka Revenue Minister Krishna Byre Gowda, Puniab Finance Minister Harpal Singh Cheema, Tamil Nadu Finance Minister Thangam Thennarasu and Leader of the Opposition in the Kerala Assembly V D Satheesan will also take part in the conclave, Balagopal said.

Additionally, officials including finance secretaries of all the five states and several subject matter-related experts like former Economic Advisor to the Central Government Arvind Subramanian, will also attend, the minister said.

He further said the conclave was being hosted by Kerala at a time fiscal federalism in the country was under challenge to a great extent. "The main objective of the conference is to conceptualise the developmental and financial issues being faced by the states and present them before the 16th Finance Commission.

"A healthy Centre-State relationship requires fiscal stability of the states," Balagopal said. In 2011-12, the share of cess and surcharge in Central government revenue was 9.4 per cent and by 2022-23, it had gone up to 22.8 per cent, he said. As a result, the states get only 29.6 per cent of the Centre's revenue as against the recommendation of 41 per cent by the 15th Finance Commission.

Six Maoists killed in Telangana

Hyderabad: Six cadres of the outlawed CPI (Maoist) including two women were killed after an exchange of fire between the ultras and police in Bhadradri Kothagudem district of Telangana on Thursday, police said.

Two commandos of the Greyhounds, the elite antinaxal force of Telangana Police, were also injured in the exchange of fire and were shifted to a hospital and their condition is out of danger, they said.

Railway Board wants contractual staff verified

New Delhi: Crime data suggests that contractual staff have been found to be involved in a large number of cases of molestation, theft of passengers' belongings and railway property, so their pre-employment police verification should be mandatory, the Railway Board said.

The board said that on checking the records, it has been found that police verification was not done in many of these cases.

In a circular addressed to the general managers of all 17 railway zones and the chairman and managing director of the Indian Railway

Catering and Tourism Corporation (IRCTC), the board said, "Security (Crime) data has highlighted that several incidents have been reported over IR (Indian Railway) wherein contractual staff have been found to be involved in a large number of cases of theft of passengers' belongings, molestation, theft of railway property

Funding For Climate Change

India ahead of many rich nations

New Delhi: India contributed USD 1.28 billion in climate finance through multilateral development banks (MDBs) in 2022, surpassing the contributions of many developed countries, according to a new

The analysis, conducted by the UK-based think tank ODI and the Zurich Climate Resilience Alliance. comes amid a renewed push by some developed countries to broaden the donor base for climate finance to include developing countries like China and Saudi Arabia.

Researchers noted that the significant gap in climate finance is largely due to the United States failing to contribute its fair share. Australia, Spain, Canada and the United Kingdom also performed relatively poorly in this regard.

The analysis has identified the top 30 non-Annex II countries that provided substantial climate finance to developing countries in 2022 through multilateral contributions to development banks and climate funds.

This group includes former economies in transition like Poland and Russia, countries that have achieved high-income status since 1992, such as Chile, Kuwait, Saudi Arabia and South Korea, and middle-income countries with large populations, including Brazil, China, In-

The report reveals that only 12 developed countries provided their fair share of international climate finance in 2022. These countries are -- Norway, France, Luxembourg, Germany, Sweden, Denmark, Switzerland, Japan, the Netherlands, Austria, Belgium and Finland. China - USD 2.52 billion New Zealand Brazil - USD 1.135 billion Ireland - USD Portugal – USD 0.23 billion Greece - USD/

According to the United Nations Framework Convention on Climate Change (UNFCCC), adopted in 1992, high-income, industrialised countries (referred to as Annex-II countries) are responsible for providing finance and technology to help developing countries combat and adapt to climate change. These countries, including the US, Canada, Japan, Australia, New Zealand and European Union (EU) member states, such as Germany, France and the UK, have historically benefitted from industrialisation and contributed the most to greenhouse gas emissions.

At COP15 in Copenhagen in 2009, these developed countries pledged to jointly provide USD 100 billion each year by 2020 to help developing countries mitigate and adapt to climate change. However, this target has not been fully met, leading to a significant finance gap. This shortfall has eroded trust and hindered climate action in developing countries.

In May, the Organisation for Economic Cooperation and Development (OECD) claimed that developed

countries had met the longstanding USD 100 billion-ayear promise by providing nearly USD 116 billion in climate finance to developing countries in 2022, with nearly 70 per cent of the money given in the form of

The ODI researchers pointed out that many developed countries, despite performing well in terms of climate-finance contributions, would make "markedly less progress towards meeting their fair share if the finance provided was accounted for on grant-equivalence terms" -- in other words, if it reflected their real fiscal

The report calls for the inclusion of a "burdensharing mechanism" in the New Collective Quantified Goal (NCQG) to provide clarity on each country's obligations and hold countries accountable.

The NCQG refers to the new, larger amount that developed nations must mobilise annually, starting 2025, to support climate action in developing countries. Countries are expected to finalise the NCQG at this year's UN climate conference -- COP29 -- in Baku, Azerbaijan in November.

The current USD 100 billion annual climate-finance goal is a collective commitment by developed countries. Its collective nature has meant that individual developed countries are not accountable for specific sums of money, potentially reducing the overall amount of climate finance provided due to the lack of individual scrutiny. The inclusion of a burden-sharing arrangement among developed countries could potentially strengthen the NCQG by fostering greater accountability and trust among parties, according

to the ODI researchers. Many developing countries, including India, have recently advocated for such an arrangement to enhance accountability among developed countries.

Karnataka HC emphasises need for swift conclusion

Bengaluru: The Karnataka High Court has emphasised the need for expeditious trials in cases under the Wildlife Protection Act, expressing concern over lengthy delays in bringing offenders to justice.

A single judge bench of Justice M Nagaprasanna made this observation while rejecting a petition by Abdul Rehman and others, who faced charges for killing a spotted deer in the Bandipur forest in 2008.

Despite 16 years having passed, the trial against the accused is still ongoing.

The court criticised the prolonged proceedings, stating: "Why such a long time? Why do you take 16 vears to conclude a forest offence? This is not correct if you book under the Forest Act for killing a deer in 2008 and it is still being tried in 2024. What is this?"

The bench attributed the delay to the accused evading court appearances, leading to repeated adjournments.

Rehman and his co-accused had sought quashing of the proceedings, arguing that they faced "double jeopardy", as a separate case related to the illegal possession of meat and unlicensed arms was filed against them in Kerala.

The court dismissed this argument, noting that the deer was killed in Karnataka, where the Wildlife Protection Act applies. The case in Kerala, involving the seizure of 35 kg of deer meat and weapons, falls under the Arms Act.

Impact of huge gale, cloud burst About 50,000 trees uprooted in Telangana



Hyderabad: In an ecological disaster, an estimated 50,000 trees spread over about 500 acres in the forests of Mulugu district in Telangana were uprooted following a huge gale and a sudden cloud burst.

This happened on the night of August 31 because of local climatic conditions that suddenly developed there due to cloud formation, a senior forest official said on Wednesday.

"We never saw such an incident in our lives," the official told PTI. With the massive wind and water gushing (in a particular width and length), it has destroyed the forest and big trees have been uprooted, he said.

The other reason why the trees got uprooted was that the plants do not develop a very deep root system as moisture and nutrition are easily available for them in the area, he said.

In some places, the root system is developed within one foot, he added.

Had it been a very deep root system, the damage would have been less, the official said. In some places, the top part was broken as one tree fell on another tree or the top might have got broken due to any "injury" to the tree.

The forest department

of the damage, which is expected to be completed in about a fortnight once the ongoing rainfall subsides.

The official said though cloud bursts have been reported from places like Himachal Pradesh, he has not come across damage to the forest on such a large extent of land.

The forest department would prepare a report and also urge experts or agencies like the Meteorological department to throw light on the reasons for the weather phenomenon that led to the massive damage to the forest, he said, and added that they would plan on how to rejuvenate the area to bring back the glory. Though the forest is home to bison and spotted deer, no wildlife casualty has been reported, he said.

Telangana Panchayat Raj Minister Danasari Anasuya expressed anguish over the loss of trees on about 500 acres. There would have been widespread destruction had the incident occurred in villages, she said in a release. She said Union Ministers from Telangana G Kishan Reddy and Bandi Sanjay Kumar should depute special teams from the Centre to ascertain the reasons for the incident.

In 2024 so far, 68 killed in wild animal attacks in Odisha

Bhubaneswar: At least 68 people were killed in attacks by elephants and other wild animals in Odisha during the current year, state Forest Minister Ganesh Ram Singkhuntia told the Assembly on Tuesday.

While replying to a written question of BJD legislator Arun Kumar Sahoo, the minister said besides human casualties, 1,087 houses and crops over 2315.79 acres were also damaged in incidents of the humanwildlife conflict in different forest divisions of the state during the current year.

To prevent human habitations located near forest areas from elephant and other wild animal attacks. the government has been taking steps for the roll-out of an artificial intelligence (AI) supported e-surveillance project at Bharatpur

area in Chandaka forest division, Hindol of Dhenkanal division and Bantala in Angul division on a pilot basis, he stated.

With the help of AI, the forest officials can monitor the movement of wild animals and accordingly, human habitations can be put on alert in advance, the minister said.

A maximum of 14 people were killed in such wild animal attacks in the Dhenkanal forest division, while eight such deaths were reported from the Keonjhar forest division, the minister

Similarly, wild animal attacks claimed six human lives in each of the Bonai and Rourkela forest divi-

sions, five people were killed in such attacks in the

> Angul forest division. The Athagarh and Baripada divisions reported four human deaths each.

> Ram Singkhuntia has informed that the government has so far received 9.168 complaints seeking compensation for the loss incurred due to elephants and other wild animals.

For commercial crops, the compensation amount is Rs 25,000 per acre, he said. According to official sources, the forest department is also providing an ex-gratia of Rs 6 lakh to the next of kin of the person, who died in the wild animal attack in the state.

Elephant kills man in CH

Korba: A 60-year-old man was trampled to death by a wild elephant in Chhattisgarh's Korba district, officials said on Thursday.

The incident occurred on Wednesday night at Thadpakhan village under Pali forest sub-range when Mewa Ram Dhanuhar was at his house, said Kumar Nishant, Divisional Forest Officer (DFO), Katghora forest division.

On sensing the presence of the tusker, the man went to his vegetable garden behind the house but came face to face with the pachyderm, he said. The elephant caught hold of Dhanuhar with its trunk and trampled him to death, he said. Earlier on Wednesday, the same tusker had attacked and killed a bull in nearby Mudabhata village, he said.

India leads world in generating plastic waste

The country produces 10.2 million tonnes a year

New York: India leads the world in generating plastic waste, producing 10.2 million tonnes a year, far more than double the next big-polluting nations, according to a new study.

According to researchers at the University of Leeds in the UK, the world creates 57 million tonnes of plastic pollution every year and spreads it from the deepest oceans to the highest mountaintop to the inside of people's bodies. The study also said more than two-thirds of it comes from the Global South.

It's enough pollution each year to fill New York City's Central Park with plastic waste as high as the Empire State Building, according to researchers. They examined waste produced on the local level at more than 50,000 cities and towns across

the world for a study in Wednesday's journal Nature.

The study examined plastic that goes into the open environment, not plastic that goes into landfills or is properly burned. For 15 per cent of the world's population, government fails to collect and dispose of waste, the study's authors said — a big reason Southeast Asia and Sub-Saharan Africa produce the most plastic waste. That includes 255 million people in India, the study said. India leads the world in gen-

erating plastic waste, producing 10.2 million tons a year, far more than double the next bigpolluting nations, Nigeria and Indonesia. China, often villainised for pollution, ranks fourth but is making tremendous strides in reducing waste, Velis said. Other top plastic polluters

The United Nations projects that plastics production is likely to rise from about 440 million tonnes a year to more than 1,200 million tonnes, saying "our planet is choking in plastic."

are Pakistan, Bangladesh, Russia and Brazil. Those eight nations are responsible for more than half of the globe's plastic pollution, according to the study's data.

The United States ranks 90th in plastic pollution with more

In 2022, most of the world's nations agreed to make the first legally binding treaty on plastics pollution, including in the oceans. Final treaty negotiations take place in South Korea in November.

The study used artificial intelligence to concentrate on plastics that were improperly burned — about 57 per cent of the pollution — or just dumped.

In both cases incredibly tiny microplastics, or nanoplastics, are what turn the problem from a visual annoyance at beaches and a marine life problem to a human health threat, Velis said.

Several studies this year have looked at how prevalent microplastics are in our drinking water and in people's tissue, such as hearts, brains and testicles, with doctors and scientists still not quite sure what it means in terms of human health threats.

"The big time bomb of microplastics are these microplastics released in the Global South mainly," Velis said. "We already have a huge dispersal problem. They are in the most remote places ... the peaks of Everest, in the Mariana Trench in the ocean, in what we breathe and what we eat and what we

cance of the global trade in plastic waste that has rich countries sending it to poor ones. The study said plastic waste trade is decreasing, with China banning waste imports. But Karlsson said overall waste trade is actually increasing and likely plastics with it. She cited EU waste exports going from 110,000 tonnes in 2004 to 1.4 million tonnes in 2021.

Taslima Nasreen Says Situation Is Alarming

Islamic radicals want to make B'desh another Afghanistan

New Delhi: Expressing concern that Bangladesh might go the Afghanistan way, writer-activist Taslima Nasreen has said that Islamic radicals are brainwashing and indoctrinating youths to make them "anti-India, anti-Hindu and pro-Pakistan".

Nasreen said she and others had initially supported the students' movement in Bangladesh against "autocratic government".

However, the recent actions like violence against Hindus, targeting of journalists and the release of "terrorists" from jails showed it was not a students' movement but was "planned and funded by Islamic jihadis", she said.

"When students protested against the quota system in July, we supported them... people who believe in women's rights, human rights and freedom of expression.

She said they had hoped that a fair election would be conducted to democratically form a new government.

"We realised that after they started demolishing everything, all the statues, sculptures, museums. The way Hindus were attacked and killed; it was a nightmare.

"Now these people are filing cases against journalists and people who were close to Hasina. They are gradually showing their real faces and motives. All the terrorists, who were in

Hindus are leaving now and they are left with less than seven per cent. Islamic radicals attack Hindus during elections, puja or to grab their properties. Hasina allowed them to give religious sermons everywhere that were always anti-women and anti-Hindus. Muhammad Yunus Says India Is Captive Of Narrative

Hasina must stay silent till B'desh seeks extradition

Dhaka: Muhammad Yunus, the head of Bangladesh's interim government, has said that former prime minister Sheikh Hasina making political remarks from India is an "unfriendly gesture", asserting that she must remain silent to prevent the discomfort to both countries until Dhaka requests her extradition.

In an interview with PTI at his official residence in Dhaka, Yunus, who was appointed the country's Chief Advisor after Hasina's ouster, stressed that while Bangladesh values strong ties with India, New Delhi must move "beyond the narrative that portrays every other political party except Awami League as Islamist and that the country will turn into Afghanistan without Sheikh Hasina."

Yunus was apparently referring to Hasina's statement on August 13 in which she demanded "justice", saying those involved in recent "terror acts", killings and vandalism must be investigated, identified and punished.

"It is not good for us or for India. There is discomfort regarding it," he told

Following unprecedented anti-government protests that peaked on August 5, Hasina resigned as prime minister and fled to India. Her presence in India for nearly four weeks has fuelled speculation in Bangladesh.

When asked whether Bangladesh has communi-

Trump's crypto business could create conflicts

Washington: Donald Trump is promising to make America the "crypto capital of the planet" if he returns to the White House. Fulfilling that promise would likely pay off for him personally.

Amidst his run for president, Trump has launched a new venture to trade cryptocurrencies that he's promoting on the same social media accounts he uses for his campaign. His two eldest sons, Donald Jr. and Eric, are also posting about their new platform, called World Liberty Financial, as is his daughter-in-law, Lara Trump, who is married to Eric and also serves as cochair of the Republican National Committee.

Trump has long melded his political and business interests, promoting his hotels and golf courses in the White House while selling sneakers, Bibles and shares in his social media company during his current campaign. Now, Trump has launched a new moneymaking venture that could explode in value if he's elected and gets the power to push through legislative and regulatory changes long sought by crypto advocates.

"Taking a pro-crypto stance is not necessarily



troubling; the troubling aspect is doing it while starting a way to personally benefit from it," said Jordan Libowitz, a spokesperson for the government watchdog group Citizens for Responsibility and Ethics in Washington. "The success of this could be very tied to American economic policy," Lihowitz said

Cryptocurrencies are forms of digital money that can be traded over the internet without relying on the global banking system. They are commonly traded on exchanges, which are marketplaces that can be used to buy, sell and trade cryptocurrencies. Exchanges often charge fees for withdrawals of Bitcoin and other currencies. World Liberty Financial is expected to be a borrowing and lending service similar to recently hacked Dough Finance, an app built by four people listed as World Liberty Financial team members.

Peace Gambit

The Modi government's recent signing of a peace accord with the insurgent group, the National Liberation Front of Tripura (NLFT), marks another step in its broader strategy to quell decadeslong insurgencies in Northeast India. This move, following similar agreements in Nagaland, Assam, and Mizoram, is part of Prime Minister Narendra Modi's ambitious plan to stabilize the restive region that has been marred by ethnic strife, insurgency, and underdevelopment for decades. The accords, while celebrated as milestones of reconciliation, are also calculated political manoeuvres aimed at consolidating the ruling Bharatiya Janata Party's (BJP) influence in a region where its presence was once minimal.

The accord with the NLFT, which once terrorized Tripura with a campaign of violence and extortion, promises a new era of peace and development. In exchange for the cessation of hostilities, the government has pledged to provide the group's cadres with rehabilitation packages, including financial assistance and skill development programs, as well as greater autonomy for tribal communities. The accords have been touted as symbols of Modi's resolve to bring "lasting peace" to the Northeast, a region that has historically been sidelined in the national consciousness.

However, the flurry of agreements raises critical questions about the political objectives and long-term ramifications of such deals. These accords are not merely about peace but also about political capital. The Northeast, home to over 45 million people and a mosaic of ethnic identities, represents an untapped electoral reservoir. The BJP's rapid rise in the region, driven by developmental promises and strategic alliances, uses these accords to diminish armed opposition and bolster its political foothold.

The Tripura agreement is emblematic of this strategy. By bringing the NLFT into the mainstream, the Modi government not only diffuses a source of armed resistance but also co-opts a segment of the tribal vote bank that has long been alienated from state politics. This approach aligns with Modi's broader narrative of 'Sabka Saath, Sabka Vikas, Sabka Vishwas' which aims to project the BJP as a party of inclusivity, even in regions with complex ethnic and political landscapes.

The Northeast is a region of fractious identities, where multiple groups with competing claims have often found themselves at odds, not just with the central government but also with each other. The peace accords, while promising an end to violence, also risk stoking new tensions by emboldening certain groups over others. In Assam, for instance, the signing of the Bodo Accord in 2020 led to discontent among other ethnic communities who felt sidelined. For Modi, these agreements are political capital, useful in projecting his government as a peacemaker ahead of national elections. Yet, the true test will be in delivering tangible changes on the ground as the success of this peace gambit hinges on more than just signing on the dotted line.

Battleground of the Deep: Geopolitical Storm in South China Sea

In his splendidly evocative 2014 book Asia's Cauldron, master geo-strategist Robert D. Kaplan begins his geopolitical study of the South China Sea with a dazzling prologue on the ancient kingdom of Champa, its Hindu legacy.

In his trademark lapidary prose which has come to define his many works, Kaplan observes that Vietnam's nearly one-thousand-mile-long coast lay astride two great civilizations: those of India and China with the South China Sea being "the maritime heart" of the Indo-Pacific region.

Long before the Cold War fault lines of North and South Vietnam, Kaplan notes there was a similar one in ancient times with the Sinicized Dai Viet, which established itself in Hanoi in North Vietnam clashing with Hindu Champa in the South. Dai Viet ultimately gobbled up

As tensions flare up again between China and its Southeast Asian neighbours in the maritime heart of the Indo-Pacific, India's Act East policy bolstering ASEAN defence cooperation will be key in ensuring regional stability

Hindu Champa.

Fittingly, Prime Minister Narendra Modi's historic visit to Brunei this week resurrects the legacy of Champa and the Indian influence to counter a truculent China in the Indo-Pacific and the flashpoint that is the South China Sea.

His meeting coincides with heightened tensions between China and its neighbours in the Indo-Pacific region, particularly the Philippines and Malaysia.

Last week, a Chinese coast guard vessel's ramming of the Philippine flagship BRP Teresa Magbanua brought the confrontational environment in the South China Sea region into sharp relief. The Philippines has intensified its maritime patrols, only to face increasing provocations from China. The aerial domain is also becoming contentious, with the Philippines' increased air patrols prompting warnings from Chinese think tanks about potential clashes.

Meanwhile, China recently demanded that Malaysia halt its oil exploration activities near the Luconia Shoals citing encroachments on its areas marked by the so-called 'Ten-Dash Line'. This, despite Malaysia's efforts to placate China, including remarks by Prime Minister Anwar Ibrahim emphasizing mutual benefit.

In this charged diplomatic atmosphere, India's role comes as a deus ex machina in defusing tensions and rallying the Southeast Asian nations to counter China. During his meeting in Brunei, PM Modi reiterated India's support for The Association of Southeast Asian Nations (ASEAN) centrality and peaceful resolution of disputes. The trip, marked by discussions on strengthening defence ties, exploring cooperation in liquefied natural gas (LNG) and renewable energies, and enhancing long-standing space partnerships, is indicative of India's intent to deepen its engagement with Southeast Asia to counterbalance China's domineering influence in the region.

The South China Sea, covering approximately 3.5 million square kilometres, is one of the world's busiest mari-



time trade routes which accounts for a third of global shipping traffic.

Its resource-rich waters, with vast reserves of oil and natural gas buried beneath its seabed, make it a prime geopolitical prize – a veritable waterborne 'Constantinople' to which China, along with Malaysia, Brunei, Taiwan, Indonesia, the Philippines, and Vietnam are among the seven claimants to parts of the South China Sea.

For nearly two decades, China's aggressive assertion over the South China Sea has been marked by a campaign of artificial island-building, military fortification, and assertive maritime patrols. Beijing justifies its expansive claims with the so-called 'Nine-Dash Line' - a vaguely defined demarcation that cuts into the exclusive economic zones of several Southeast Asian nations, including Vietnam, the Philippines, Malaysia, and Brunei. These nations, along with the selfgoverning territory of Taiwan, find themselves in a precarious position as they confront a rising China intent on rewriting the rules of maritime

India, under its 2014 Act East Policy, has increased its engagement in the region, highlighting the importance of freedom of navigation and the rule of law, including

adherence to the United Nations Convention on the Law of the Sea (UNCLOS). By aligning with ASEAN nations like Brunei, India reinforces the call for a Code of Conduct in the South China Sea, advocating for a rules-based order and peaceful resolution of disputes — a veiled critique of China's expansionism.

The policy's ten-year milestone was marked by increased diplomatic engagements, including visits from the prime ministers of Vietnam and Malaysia to India, and President Droupadi Murmu's trips to Fiji, New Zealand, and Timor-Leste.

In the midst of the China-U.S. rivalry, as Southeast Asian nations struggle to navigate tensions. But ASEAN's long-sought Code of Conduct for the South China Sea continues to be stalled by diverging member priorities and chiefly by China's reluctance to compromise.

Political scientist John Mearsheimer, in his classic work, The Tragedy of Great Power Politics claims that global hegemony is made difficult by the "stopping power of water." As tensions in the South China Sea persist, it will need more than water to halt China's hegemony. That counter could be in the form of India's Act East strategy with its emphasis on a rules-based order.

With the two already in a business partnership with each other, it makes sense for them to politically align as well.

Not hard work, not talent, but dynasties and connections will once again play a role in the appointment of the next Chief Minister of one of the richest states of the country. The cabinet minister, with strong connections to Nagpur (the base of the RSS), is interestingly also said to be the nephew of one of the key leaders of the RSS and is expected to take over the new position once the assembly state elections are over.

Maharashtra has been and will always remain an important state for the BJP, as it brings in well over 40% of the revenue of the entire country. The status of a Chief Minister of Maharashtra, says Shyamsunder, is almost equal to that of being a Deputy Prime Minister of India, and with the list of contenders rising within the BJP and its coalition partners, it was time to devise a new plan to stop this 'race' by bringing in a veteran face that would not only be accepted across all parties (even new coalition partners) but would also put in place any ambitious leaders within the BJP.

If this happens, one can expect to see changes in the political fortunes of many prominent leaders not only within the BJP and RSS but also with other political parties and their factions as well.

With the delay in seat-sharing formulas between political parties of both Maharashtra Vikas Aghadi and Mahayuti taking longer than expected, more leaders within the BJP are expected to defect over the next few days. The exit of BJP leader Samarjitsingh Ghatge to Sharad Pawar's Nationalist Congress Party is only the beginning.

The RSS has always been known to be one step ahead in planning and executing political strategies both for the organisation and the state. The BJP has been largely supported by the RSS, its parent body. Although RSS office bearers may deny the relation between the two, a large number of BJP party workers over the years have been promoted and elevated to various political positions with the support of the RSS. A book by the organisation titled 'About RSS-Rashtriva Swayamsewak Sangh' mentions that the RSS was established in 1925 and conducts social work across all states and districts of the country through its 40,000 shakhas.

Interestingly, an excerpt from the book reads, 'The RSS has its own vision and concept about our national development. And our Swayamsevaks naturally are inclined to political parties who share this Sangh view and will be supportive of them.' As the BJP shares this vision of the RSS, naturally, it receives the cooperation and the backing of Swayamsewaks. And judging from the plans currently in motion, it looks like the whole nation is Maharashtra for now!

Unchecked Menace in the Sahel

he latest attack in Yobe, Nigeria, on August 4 which left at least 100 people dead, serves as a grim reminder of Boko Haram's enduring threat. More than a decade after the group first rose to prominence, the militant Islamist organization continues to destabilize the Sahel region, underscoring the failure of international efforts to curb its violent campaigns. Despite numerous military offensives, regional alliances, and international aid interventions, Boko Haram's presence looms large over northern Nigeria and its neighbouring countries laying bare the frailties of both local governance and global counterterrorism strategies.

Boko Haram (which loosely translates to "Western education is forbidden") emerged in 2002 in northeastern Nigeria under the leadership of Mohammed Yusuf. Initially a small sect preaching a return to puritanical Islam, it mutated into a violent insurgency following Yusuf's death in police custody in 2009. Under the ruthless command of Abubakar Shekau, the group escalated its attacks, targeting schools, markets, and villages, sowing fear through mass abductions, including

the infamous kidnapping of 276 Chibok schoolgirls in 2014. Boko Haram's brutality and its pledge of allegiance to the Islamic State in 2015 positioned it as one of the deadliest terrorist organizations in the world.

The Sahel region (the semi-arid belt stretching from Senegal to Sudan) has long been plagued by underdevelopment and weak state institutions which have provided a fertile ground for Boko Haram's insurgency, allowing the group to exploit local grievances and evade capture.

Complicating this grim situation are the military responses from Nigeria and its neighbours - Niger, Chad, and Cameroon – which have often been heavy-handed and plagued by corruption, thus failing to win the hearts and minds of afflicted communities.


Instead, these efforts have sometimes spurred recruitment into Boko Haram as abuses by security forces pushed marginalized youth into the arms of militants.


Besides Boko Haram, the rise of other militant groups like Jama'at Nusrat al-Islam wal Muslimeen (JNIM), Islamic State in the Greater Sahara (ISGS), and Islamic State in the West African Province (ISWAP), reflects a broader collapse of counterterrorism support and a weakening of leadership within regional efforts. This vacuum has not only allowed these groups to thrive but has also exacerbated the ongoing humanitarian crisis, posing significant security and financial risks to the


United States, Europe, and beyond, International organizations and foreign governments have poured billions of dollars into counterterrorism initiatives across the Sahel, yet the results have been underwhelming. The United Nations, the African Union, and the European Union have all backed various military and humanitarian interventions, including the establishment of the Multinational Joint Task Force (MNJTF) in 2015, comprising troops from Nigeria, Chad, Cameroon, Niger, and Benin. Yet, coordination issues, funding shortfalls, and divergent national interests have hampered these efforts.

Moreover, while the MNJTF has claimed tactical victories, such as the recapture of key territories, Boko Haram's insurgency has morphed and splintered, with factions such as the Islamic State West Africa Province (ISWAP) gaining prominence.

The failure of international interventions can be attributed to a myopic focus on military solutions at the expense of addressing the root causes of extremism. Boko Haram's appeal lies not only in ideology but also in the absence of alternative opportunities and governance in a region marked by poverty, unemployment, and neglect. Counterterrorism strategies have often neglected the socio-economic dimensions of the conflict, failing to provide the muchneeded investments in education, healthcare, and infrastructure that could undercut Boko Haram's

The Narrative Building Around Religion

ntertainment and sports are meant to be free from religious bias, as we've always believed in India. But it's painful to see that certain narratives in films and sports still play into religious stereotypes. For example, a badge with the number 786 is portrayed as a protective symbol, while Hindu characters like a crooked Munimji or a temple priest are shown in a negative light. If sports truly have no religion, then why did the former Prime Minister of Pakistan, Imran Khan, show more love to India, or why did players from other countries express support for the Indian community in tough times? Filmmakers often try to appease minorities, assuming the majority won't object. This has been the trend for years, but when movies like the Kashmir Files or The Tashkent Files show a different side of the story, liberals quickly raise objections.

Let me be clear: I'm against both kinds of narratives. Why bring religion into any story at all? If it's fiction, don't use it to push an agenda; if it's based on real events, just tell the real story nothing more, nothing less.

Take Netflix's IC 814 series, which is



an adaptation of the book Flight into Fear: The Captain's Story by Captain Devi Sharan and Srinjoy Chowdhury. It's based on the December 24, 1999, hijacking of an Indian aircraft by five terrorists, just 40 minutes after the plane took off from Kathmandu. The series, however, presents a half-truth. By the time this article is published, Netflix might have added a disclaimer with the real names of the hijackers to pacify the outrage. But why did this happen in the first place? Was it a PR stunt to gain attention? Why did the creators play the religion card, instead of following the principle that entertainment should be free of religion?

The series doesn't discuss Pakistan's role-why? If they briefly show Pakistan in a negative light, it seems like there could be a hidden agenda. The story focuses on Afghanistan and Kandahar while conveniently ignoring Pakistan's involvement and the role of its intelligence agency, the ISI. Why?

The captured terrorist in the show talks about the brutality of Indian forces in Kashmir, but there's no mention of what these people were doing in the valley. Why?

Respected actors like Naseeruddin Shah, Pankaj Kapur, and Kawaljeet Singh portray politicians and bureaucrats behaving childishly. Why? They were supposed to be on a mission, in a war-like situation, yet they're shown gossiping about other departments. This portrayal could give the younger generation a wrong impression of how officials work—do you want to create such a reflection?

The pilot, who was unfairly criticized for things he didn't do, doesn't get a positive portrayal. Why? His wife reas-



sures their children that the world will know the truth, but the series doesn't clarify his side. Why?

The terrorists are shown as decent, not just in appearance but in behavior

Why? They're seen playing Antakshari—really? But there's no mention of how one of the terrorists asked passengers to convert to Islam (an incident documented in the public domain).

The terrorists use fake names, with two of them called Bhola and Shankar, which could have easily been Engineer or Professor. Is this a PR strategy to demean Hindu names and get away with

The worst part of the Netflix series is how it tries to humanize the terrorists involved in the hijacking. They repeatedly say they don't want to harm any passengers, but they killed innocent Rupin Katyal and slashed another passenger's neck. Despite this, they're shown as considerate enough to allow an air hostess to call home to check on her father.

The negotiations with the terrorists. which should have been serious and emotionally disturbing, are depicted comically, portraying the negotiator as incompetent.

Overall, the series has many loopholes, and the actors weren't used effectively-any actor could have played these roles. However, the most problematic part

comes at the end, where the released terrorists are shown celebrating with Osama

Bin Laden. It's suggested that Osama kept ISI away from the celebrations, implying

that ISI wasn't involved in the hijacking and that it was all Osama's idea.

This could have been a great story if it had been told from an Indian perspective, rather than from another viewpoint.

Sexual Harassment of Women In Films

The main functions of cinema are – entertainment, education, information and social change. How does sexual harassment enter into this medium that has been bringing colour and sound and music and romance intoour lives for ages? But this is true and has made its invisible but strong presence felt not only by those who are involved in the industry, men, women and children but also by the audience in the country which produces the largest number of films in the world.

Broadly stated, sexual harassment is defined as any attention of a sexual nature in the context of the work situation which has the effect of making a woman uncomfortable on the job. It can manifest itself in looks, jokes, gestures, bawdy

In this three part series, I am going to explain how women are subjected to sexual harassment in the film industry and what could be done to stop this harassment.

remarks or plain propositions. A large section of women employees faces sexual harassment in varied degrees. Some are presented with the unpleasant alternative of putting up with it, possibly giving in to it, or looking for another job or a less attractive posting without any guarantee that the same thing would not happen at the

new place. The biggest drawback is that its threat keeps many women out of certain occupations and places where such behaviour is implicit in the very nature of the job itself. For young girls and women of all ages, cinema is the most potent field for sexual exploitation protected from any kind of legal penalisation because the victims are unified by an unspoken wall of

"Degi Kya?" asks a filmmaker of an assistant who approaches him to espouse the cause of a young girl aspiring for stardom. He brushes away her talent and beauty with two simple words.

This scene from Madhur Bhandarkar's Page 3 exposes the ugly face of stardom, especially for the female of the species. The starlet, who refuses to compromise, is seen cavorting with the same filmmaker later in the film.

Interestingly, Bhandarkar himself happened to be in the eye of a storm when an aspiring starlet Preeti Jain accused him of 'using' her under false promises of marriage. Why did the furore gainst Bhandarkar fade away with the girl being made to look as if she was making false accusations? Because Bhandarkar was famous and powerful while Jain no one had heard of till she came out with this accusation. Bhandarkar gave up his plans to go ahead with his film Casting Couch, a logical extension of Page 3. But this came out in a later film Fashion.

On the eve of Women's Day. it would be interesting to unfold contradictions that sustain within the woman question to find out whether women are still more sinned against than sinning.

Many years ago, Parveen Babi, when asked whether she was a virgin, retorted – 'there are no virgins in filmdom. If you believe there are, you would still find men doing female roles.' Veteran actress Nadira said that the word 'industry' linked to film gave it a dignity it does not deserve. "It is a racket, not an industry,"she said.

Among the quitters, one recalls Savita Dhanrajgir, a beautiful model from a royal family who wanted to make it in films. She recorded her bitter experience about the casting couch where one had to go bed hopping, from financier to producer to director to hero. The small ones do it for any role. The big names do it for plum ones.

In Clap-Trap, a documentary on junior artistes, Jill Misquitta shows how female 'extras' are sexually exploited by the middle-men who give them their daily contract. This is sexual harassment where sex is not consensual at all but forced.

In the film Luck By Chance, we find a young runaway girl who came down to Mumbai to become an actress, persuaded to sleep with a director under the false promise that she will be the main female lead in his next film. This never happens and we find her doing cameos in television soaps and serials and accepting her fate.

Harvinder's mantra is to always aim for a '10' with his final arrow, something he says, helped him achieve his goal in Paris.

"If you have confidence, you can learn the arrow. Sometimes it can slip to nine, but you always have to finish with a 10, because it's your last arrow. In my matches and many situations, I landed my last arrow in a 10. I focused on my last arrow," he said.

The champion archer dedicated the gold medal to his country and his late mother, who died just before the 2018 Asian Para Games were due to begin in Jakarta. As a tribute to his mother, he went on to win gold at the continental games six years back.

Accidental chess player Vidit Gujrathi

New Delhi: A self-proclaimed accidental chess player, Indian Grandmaster Vidit Gujrathi says he thought of sports as a more "stable" career option after watching his doctor parents being called to work at odd hours, an "error of judgement" that has ultimately "worked out well" for him.

The 29-year-old from Nashik will be turning up for Mumba Masters in the second season of the Global Chess League, a joint venture between Tech Mahindra and FIDE, from October 3 to 12 in London.

Guirathi was around six when he was advised to put his ambition of playing cricket on hold till he was older by a local club. He decided to pursue chess inmiliar with the sport after spending considerable time playing with his father.

"I saw it as a good opportunity to learn and beat him. It was a complete accident, but a happy one, Gujrathi recalled in a press release issued by the event organisers

Having seen his doctor parents work at odd hours due to late-night emergencies, Gujrathi said he wanted a relatively easy-going life and thought of sports as the right option.

"I did not realise then that sports can be more volatile. I made a judgment error, but it worked out well." he guipped, referring to long hours he has to devote to training.

Karunakaran, Subramanian in QF

Taipei: India's Sathish Kumar Karunakaran and Sankar Subramanian reached the men's singles quarterfinals of the Taipei Open badminton tournament but women's singles players had to deal with disappointment here on Wednesday.

In men's singles, Karunakaran was made to work hard for a win but he eventually prevailed over Kantaphon Wangcharoen from Thailand 24-22, 23-21 to make the quarterfinals.

Subramanian also had to toil but the Indian shuttler got the better of his Finnish opponent Joakim Oldorff, winning his round of 16 match 21-12, 19-21, 21-11.

In another round of 16 men's singles contest, Kiran George was in the lead when he won the first set.

Dharambir dedicates gold to Amit

Paris: Paralympics gold medallist in men's club throw F51 event Dharambir has dedicated his medal to teammate and coach Amit Kumar Saroha, hoping that his feat inspires the next generation of para athletes to take the legacy forward.

The 35-year-old Dharambir on Wednesday broke the Asian record with a throw of 34.92m en route to the gold medal at the Paralympics with Pranav Soorma clinching the silver with a throw of 34.59m

Saroha, however, failed to make it to the podium finishing last in the event.

"I am feeling very proud. For any athlete, winning a medal at the Olympics (Paralympics) is a dream and my dream has come true with this. My guide Amit Kumar Saroha has played a

big role in it," Dharambir

"We came into the sport after getting to know about him (Amit Saroha), I hope the next generation (of athletes) will see us and get into this sport," he added.

Dharambir, who has taken guidance from the 39-year-old Amit, dedicated the award to the veteran sportsperson.

"I dedicate this award to my guru Amit Saroha. His blessings are with me since the start and that is why I was able to win this medal," he said.

Dharambir suffered a serious injury when he misjudged a dive into a canal and was left paralysed from waist down after he hit the rocks. In 2014, he found his way into para games and trained in club

"Pressure is also a major factor and when you commit fouls, the mind stops working. I made eye contact with my coach and the fifth throw came out well.

"I am feeling very proud that the Asian record has also come with this medal. Pranav Soorma had beaten the record previously and now I hold it. He is a very good athlete and our fight will continue like this," Dharambhir added.

Yashasvi can learn from Rohit

Bengaluru: Yashasvi Jaiswal hinges his hopes of touching new heights in his fledgling Test career on batting alongside skipper Rohit Sharma, an experience he termed as incredibly educational.

Jaiswal, who made his debut last year against the West Indies, has played nine Tests with Rohit and has already forged a successful combination at the top with his captain, erecting multiple century stands. "It is an incredible experi-

ence whenever I go out and bat with him. He has shared his experiences with me. I think the way he controls the game and understands the wicket, it is spot on and there are a lot of things (to learn from him)," said Jaiswal here on the eve of the Duleep Trophy.

"You can learn from him things like adjusting your batting to seaming or turning tracks or change your batting when a wicket or two fall," he added.



Jaiswal, who has completed a year in top-flight cricket, said he has become a lot more aware about his own game in the last 12 months or so.

"Now, I can see a lot of scenarios and shift my game (accordingly) for the team and read the situations. I think these are very important for me in the last one year. When I was playing domestic cricket, I was not aware of many things.

But since I started playing international cricket. the communication and the reading of the game have improved a lot. I just want to keep learning."

The 22-year-old said new head coach Gautam Gambhir backs players to the hilt, something he said helps the players produce their natural game.

'Yes, I have spoken with him during the Sri Lanka series. He really backed us saying just go out and play

freely and enjoy the game and we will be with you. It gives us a lot of confidence and helps us to play fearlessly," he noted.

The left-handed batter said he wanted to use Duleep Trophy as a training platform to hone his skills ahead of the upcoming twomatch series against Bangladesh.

"I am working hard at nets ahead, first for the Duleep Trophy and then for the Bangladesh series. It's not about setting personal goals, as you know in cricket you have to be consistent and keep working on your

"Domestic tournaments like Duleep Trophy and Irani Trophy are very important games and it gives me a lot of confidence and helps me prepare for those (international) games," he

"I try to remain in my zone and contribute to the team's winning cause.

Arshad, Jyoti finish cycling

Paris: India's Arshad Shaik and Jyoti Gaderiya finished 11th and 16th in their respective cycling events at the Paralympics here on Wednesday.

Gaderiya finished the 5.8km women's C1 individual time trial in 16th and last position with a time of 30 minutes and 0.16 seconds.

Germany's Maike Hausberger won the gold, clocking 21:30.45 ahead of Britain's Frances Brown and Sweden's Anna Beck, who came up with 21:46.18 and 21:54.71 respectively.

In the men's C2 time trial, Arshad finished 11th and last with a time of 25:20.11. The gold was won by France's Alexandre Leaute with an effort of 19:24.25 ahead of Belgium's Ewoud Vromant and Australia's Darren Hicks, who ended with 19:26.45 and 19:26.61 respectively.

New Delhi: Indian table tennis great Sharath Kamal was expected to chalk out his retirement plans post his fifth appearance at the Olympics but the 42-year-

old on Wednesday committed to another season on the professional tour. Sharath was on Wednesday named captain of the Indian men's team for the Asian Championships in

Astana next month. Speaking to PTI, India's flag-bearer at the Paris Olympics said he would also be competing in the China Smash later this month before travelling to Kazakhstan for the Asian Championships beginning October 7.

The highest ranked Indian at 37 is also aiming to play in the 2025 World Championships in Doha.

"For the next nine months to one year I would still be an active player. But



at the same time, I will be exploring options in IOC and ITTF. At home with TTFI, I would try to help create a structure and bridge the gap between SAI and TTFI and bring in more corporate sponsorships into the game," said the veteran.

Sharath is the first Indian to be elected into the International Table Tennis Federation (ITTF) athletes' commission. He is also part of the athletes' body in the Indian Olympic Association and in future, he is aiming for a seat on the athletes' commission of the International Olympic Committee.

He ruled out competing in the 2028 Olympics but the 2026 Asian Games remains a possibility.

"I would like to take a call on the Asian Games next year. The body is holding up fine post the Olympics. I got some time off and UTT is in Chennai. I am able to balance personal life as well," said Sharath, who is currently busy with Ultimate Table Tennis League.

Sharath and the Indian team did not have the best of times in the Paris Olympics.

Sharath exited the individual events early before India, playing the team championship for the first time, could not do much against the mighty China in the pre-quarterfinals.
