Modi reaches USA for **Quad summit**

The PM will hold bilateral meeting with President Biden


New Delhi/Washington: Prime Minister Narendra Modi on Saturday arrived in the US on a three-day visit to "further strengthen India-US Comprehensive Global Strategic Partnership," attend the Quad summit and address a key conclave at the United Nations.

Modi will also hold separate bilateral meetings with US President Joe Biden and other world leaders on the margins of the Quad summit in Wilmington. Delaware, and the 'Summit of the Future' at the UN General Assembly in New York. Modi landed at Philadel-

phia for his onward journey to Wilmington.

At the Philadelphia International Airport in Pennsylvania state, he was greeted by a large gathering of the Indian diaspora. Modi greeted the group of people dressed in their traditional wear with many of them holding the Indian tri-colour. He walked along the fenced area, signed autographs for some of them and shook

hands with some others. The annual Quad summit at Wilmington, which is President Joe Biden's

hometown, is expected to roll out a series of new initiatives to boost cooperation in the Indo-Pacific and explore ways to find peaceful solutions to the conflicts in Ukraine and Gaza

The PM's other engagements include joining an Indian diaspora event at Long Island and participating in a round table with CEOs of American firms

working on cutting-edge technologies such as AI, quantum computing and semiconductors.

In his departure statement at New Delhi, Modi said he looked forward to joining his colleagues President Joe Biden, Prime Minister Anthony Albanese and Prime Minister Fumio Kishida for the Quad

"The forum has emerged as a key group of like-minded countries to work for peace, progress and prosperity in the Indo-Pacific region," he added.

The four-member Quad, or the Quadrilateral Security Dialogue, advocates upholding a free, open, and inclusive Indo-Pacific. Beijing sees it as an ant-China grouping.

Amar Preet Singh to be new CoAS

New Delhi: Air Marshal Amar Preet Singh, a fighter pilot with more than 5,000 hours of flying experience, will take charge as the chief of the Indian Air Force after incumbent Air Chief Marshal V.R. Chaudhari retires on September

Air Marshal Singh is currently serving as the Vice Chief of the Air Staff.

"The government has appointed Air Marshal Amar Preet Singh, PVSM, AVSM, presently serving as Vice Chief of the Air Staff, as the next Chief of the Air Staff, in the rank of Air Chief Marshal, with effect from the afternoon of September 30," the defence ministry said.

As Chief of the Air Staff, Air Marshal Singh's priorities are expected to be the procurement of new fighter fleets and advancing the modernisation agenda of the force in view of the fastevolving regional security landscape, including challenges along the Line of Actual Control (LAC) with China.

The number of the IAF's fighter squadrons has come down to around 30 as against the authorised strength of at least 42.

The military has continually accused Hamas of operating from within civilian infrastructure in Gaza, including schools, UN facilities and hospitals.

Earlier this month, an Israeli strike hit a school in the Nuseirat refugee camp, killing 14, according to Palestinian medical officials. The Israeli military said it was targeting Hamas militants planning attacks from inside the school.

In July, Israeli airstrikes hit a girls' school in Deir al-Balah, killing at least 30 people sheltering inside. Israel's military said it targeted a Hamas command centre used to direct attacks against its troops and store "large quantities of weapons".

Also Saturday, the Gaza Health Ministry said five of its workers were killed and five others injured by Israeli fire that struck the ministry's warehouses in the southern Musbah area.

Tensions soared in the region on Friday after an Israeli airstrike on a Beirut suburb in Lebanon killed 31 people, including civilians and Ibrahim Akil, who was in charge of Hezbollah's elite Radwan Force. Also killed was Ahmed Wahbi, another senior commander in the group's military wing.

The strike came hours after Hezbollah launched one of its most intense bombardments of northern Israel in nearly a year of fighting. Israel's Iron Dome missile defence system intercepted most of the rockets.

CM Atishi vows to bring back Kejriwal

New Delhi: Delhi Chief Minister Atishi, along with five cabinet ministers, took the oath of office on Saturday and requested people to ensure that her predecessor, Arvind Kejriwal, returns to the top post again.

Atishi also hit out at the Bharatiya Janata Party (BJP) for hatching a "conspiracy" against Kejriwal.

Addressing a press conference here soon after taking oath, Atishi said it is an "emotional day" for her as her "guru" and Delhi's son Kejriwal will not continue

to be the chief minister.

"It is an emotional moment for me as he will not be the chief minister. He understood the pain of every person. He ensured free treatment for people, worked to improve the lives of the students of government schools, brought the provision of free bus rides for women," she said.

The people of Delhi need to make Kejriwal the chief minister again to ensure that the free services, including free electricity and water, continue, Atishi

said, accusing the BJP of implicating the AAP national convenor in a false case and alleging that the saffron party tried everything to break him.

Lieuteant Governor V.K. Saxena administered the oath of office and secrecy to

After taking oath Atishi took Kejriwal's blessings by touching his feet at the Raj Niwas. Former deputy CM Manish Sisodia, Delhi Assembly Speaker Ram Niwas Goel, Leader of Opposition in the Assembly Vijender Gupta and Police Commissioner Sanjay were among the guests at the event.

Atishi is the 17th woman to hold the CM's post in independent India.

Among Atishi's Council of Ministers, Saurabh Bharadwaj was the first to take oath, followed by Gopal Rai, Kailash Gahlot, Imran Hussain and Mukesh Ahlawat, a new entrant in the cabinet.

Atishi has retained the 13 portfolios she held in the Kejriwal government, including education, revenue, finance, power and PWD.

Hold MU senate elections on Sept 24, says HC

Mumbai: The Bombay High Court on Saturday directed the holding of the University of Mumbai's senate elections on September 24 after staving a state government circular postponing the polls which it noted was a last minute intervention.

In a special hearing, a division bench of Justices A.S. Chandurkar and Rajesh Patil initially directed that the senate elections be held on September 22 as scheduled. The bench amended its order after the varsity flagged practical difficulties in holding elections on short notice.

"The order issued to postpone the elections sine die is stayed until further orders. The elections shall proceed as per schedule,' the high court stated in its operative order and posted the matter for further hearing on September 26.

The petition was filed by election aspirants- Milind Satam, Shashikant Zore and Pradeep Sawant who challenged the state government's circular temporarily staying the graduates senate elections under Rule 8 (7) of the Maharashtra Public Universities Act.



After the HC passed the order to hold elections on schedule on September 22, counsels for the varsity requested the high court to allow conducting the elections on September 24 as necessary arrangements would have to be made. The bench allowed the varsity's



The University of Mumbai was represented by senior counsel Anil Sakhare and advocate Manish Kelkar. The elections would be

held on September 24. The senate elections for ten seats representing the university's registered graduates have been pending for two years.

PMLA restrictions cannot override fundamental right, says HC

Mumbai: Stringent conditions under the Prevention of Money Laundering Act can not override the fundamental right to liberty under Article 21 the Bombay High Court has said while granting bail to a 72-yearold man.

The trial in the case of alleged bank fraud, for which applicant Suryaji Jadhav was arrested, was not likely to conclude any time soon and he was suffering from cancer, Justice Madhav Jamdar noted in his order of September 19.

The copy of the judgement became available on Saturday.

Restrictions imposed by laws such as the PMLA "melt down" where an ac-



carceration and the trial is inordinately delayed, the judge said.

"Despite the restrictive statutory provisions like section 45 of the PMLA, the right of an accused under Article 21 of the Indian Constitution cannot be allowed to be infringed," Justice Jamdar held.

Under section 45 of the PMLA, a court, while granting bail to an accused in a money laundering case, must be satisfied that there are reasonable grounds to believe that he is not guilty, and/or is above 60 years of age, or a woman or is sick or

Article 21 protects the fundamental right to life and personal liberty.

Jadhay was arrested by the Enforcement Directorate (ED) for alleged fraud at the Pune-based Shivajirao Bhosale Sahakari Bank in March 2021. He and others were accused of misappropriating funds and fraudulent disbursal of

Jadhav had sought bail on the grounds of long incarceration and delayed trial. The court noted that more than 250 witnesses were proposed to be examined by the prosecution, and the trial was yet to

Jadhav had completed more than half of the maximum punishment he could get in the case, the HC said.

"In such a situation, statutory restrictions will not come in the way of the court to grant bail to protect the fundamental right of the accused under Article 21," the court said. -PTI

Couple commits suicide in Thane district

Thane: A couple in their 20s allegedly committed suicide by hanging themselves at their house in Thane district, police said on Saturday.

Bodies of Haresh Ugade (28) and his wife Neelam (25) were found hanging in their apartment in the Nadgaon area of Shahapur on Thursday, an officer said.

Neighbours alerted the police, following which the bodies were sent post-mortem at a government hospital,

As per preliminary information, the couple had entered a suicide pact as they were frustrated that they could not have a child, the officer said.

Thane: Two hearing and speech-impaired children have been reported missing from a government-run children's home in Maharashtra's Thane district, police said on Saturday.

Man beats stray dog to death

Thane: Police have registered a case against a man for allegedly killing a stray dog in Thane, an officer said on Saturday.

The incident occurred on Thursday at Mogarpada in Ghodbunder locality, and a social activist lodged a complaint in this connection, the police said.

"As per the complaint, the accused Gokul Thore mercilessly thrashed the dog with a bat in which it suffered severe wounds. The dog was taken to different veterinary hospitals, but died during treatment on Friday afternoon," the complaint said.

Mumbai: After being ignored by the third front leaders, Vanchit Bahujan Aghadi (VBA) leader Prakash Ambedkar put up a brave face and on Saturday declared the first list of 11 candidates of VBA. VBA president, who an-

nounced the candidates at a press conference on Saturday, said, "Shamibha Patil, a transgender from the Leva Patil community, will contest from Raver assembly seat in Jalgaon district of north Maharashtra. Staying true to our sacred ideology, we have given representation to the deprived, 'bahujan' groups with the aim of gaining true representation and political power, and breaking the hegemony of families of certain castes".

"The party has named candidates from different social communities, which have been socially and politically excluded by the mainstream parties and their successive governments," he said. Ambedkar, also announced two candidates of the VBA's alliance partners Bharat Adivasi Party (BAP) and Gondwana Gantantra Party (GGP). It may be recalled that

before the Lok Sabha election, Ambedkar tried to show that he was with the MVA. He continuously spoke about saving the Constitution. He also kept MVA hanging and finally chose to follow a different path. Against this backdrop the third front leaders Former Rajya Sabha member Sambhajiraje Chhatrapati, MLA Bachchu Kadu, Raju Shetti of Shetkari Sanghatana have bolted the doors on VBA leader. At the very initial stage the leaders gave calls for unity, Ambedkar showed little interest in

joining forces. After this



MVA leaders turned their back towards him.

According to sources, three leaders Bachchu Kadu, Sambhajiraje Chatrapati and Raju Shetti have been active in the state's electoral politics in recent years. Three leaders met in Pune to shape what could potentially emerge as a new 'Third Front' in Maharashtra's upcoming assembly elections. This meeting has sparked widespread speculation in political circles about how such an alliance could alter the dynamics of the election.

While forging this front they ensure that Prakash Ambedkar and MIM will not be included in this new outfit. The leaders strongly felt that Ambedkar might back out anytime after making exorbitant demands in the form of seats, the sources added further. These leaders are also in talks with Maratha reservation activist Manoj Jarange.

Bachchu Kadu said, "announcing the candidates name is a comparatively easy task. What is more important is choosing the proper candidates. We have now undertaken this task. We think people are fed up with politicians switching sides, being disloyal, not delivering results. We think Maharashtra needs cultured politics. So, we have started the effort of a third alliance which will have fresh candidates and these new faces will be honest".

Dharavi locals stop BMC from razing illegal portion of mosque

The civic body grants time as trustees willing to remove illegal portion





Tension prevailed in Dharavi slum colony on Saturday morning after hundreds of residents blocked a road to oppose the Mumbai civic body's plan to demolish an alleged illegal portion of a mosque, an official said.

Some residents stopped civic officials from entering the lane where the mosque is located and soon hundreds of people assembled outside the Dharavi police station and squatted on the road.

As the situation became tense, trustees of the mosque held talks with officials of the Brihanmumbai Municipal Corporation (BMC). They sought four to five days to remove the encroached portion, which was agreed upon by authorities.

Thane: Despite multiple extensions, Thane Municipal Corporation (TMC) is struggling to find contractors for its affordable housing project under the Pradhan Mantri Awas Yojana (PMAY), The ambitious project, set to be constructed on two government-allotted plots in Betawade, Diva, aims to build 1,441 affordable housing units through a Public-Private Partnership (PPP) model. However, the lack of interested developers has posed a significant challenge, with the project's tender deadline being extended

three times. The TMC had initially set a profit margin of 16 per cent for developers, but this was recently increased to 20 per cent to attract more contractors. In addition, the corporation has relaxed some conditions, allowing construction companies from sectors beyond housing, including those with experience in road and bridge construction, to participate in the bidding

about the project's location Betawade. underdeveloped area with limited infrastructure, and the stringent requirement for developers to have experience working on five lakh square meters of construction, are deterring potential bidders. A TMC official highlighted that Betawade's location, beyond Diva, offers less favorable rates compared to the more developed city center, making it less appealing for developers

seeking higher returns. **Project Details**

The project, which includes constructing 1,441 flats of 30 square meters each, is targeted at the economically weaker section (EWS) and project-affected beneficiaries. Of the total beneficiaries, 1,253 will receive affordable housing at subsidized rates, while 188 others will receive flats by contributing 2 lakh each. The project, estimated to cost Rs 36.85 crore in development fees, also allows developers to commercially exploit the remaining plot area by

The Municipal Corporation now allows firms from various construction sectors to bid, offering the possibility of higher profits and greater flexibility.



Institute of Social Sciences (TISS) have alleged police action when they staged a protest during a convocation ceremony on its campus here against the suspension of PhD scholar Ramadas Prini Sivanandan.

The students staged the protest on Friday also in solidarity with 119 teachers and staff "who may lose their jobs by December 31 or have already lost," said a statement signed by Sara Bardhan, silver medallist, MA in Urban Policy and Governance, Sreyas Valsan, MA in Urban Policy and Governance,

They alleged that even though the protest was carried out peacefully without disrupting any other proceedings, the administration repeatedly discouraged students from exercising their right to free speech and many police personnel were called to the venue of the convocation ceremony.

"We chose to raise banners in solidarity with Ramadas Prini Sivanandan, a Dalit PhD scholar and a student activist who is denied access to education for the last 156 days due to the



arbitrary suspension, and 119 teachers and staff who may lose their jobs by December 31 or have already lost," the students

When Arghya Das, graduating student of MA in Women's Studies, was registering his protest by raising a placard seeking revocation of Sivanandan's suspension and job security for teachers and staff, he was forcibly taken off the stage by guards and police, they claimed.

The police kept Das in custody away from the Convocation Hall till the ceremony ended and all degree certificates were taken away, the students alleged.

In April, the TISS suspended Sivanandan for two years for allegedly indulging in activities

which are "not in the interest of the nation" and referred to instances like him participating in a protest in Delhi under the PSF-TISS banner. A Mumbai police official said

NCLAT rejects tax claim against RCom

New Delhi: The NCLAT has set aside a petition filed by the state tax department claiming dues from Reliance Communications (RCom) observing that it was based on the assessment made after the initiation of insolvency resolution process against the debt-ridden firm.

A two-member NCLAT bench upheld the earlier order passed by the Mumbai bench of the National Company Law Tribunal (NCLT), which had rejected the state tax department's second claim of Rs 6.10 crore.

Corporate Insolvency Resolution Process (CIRP) against RCom was initiated on June 22, 2019. The state tax department had filed two claims.

The first claim was filed on July 24, 2019 for Rs 94.97 lakh and a second claim was filed on November 15. 2021 for Rs 6.10 crore, which arose out of an assessment order dated August 30, 2021.



The NCLT had admitted the first claim, which was passed before the initiation of CIRP. However, it did not accept the claim which was based on an assessment order passed in 2021.

The Committee of Creditors (CoC) of RCom also approved the plan on March 2, 2020, and the subsequent claim was filed by the state tax department on November 15, 2021.

The said order was challenged by the state tax department before the National Company Law Appellate Tribunal (NCLAT), contending that NCLT ought to have accepted the entire claim.

However, it was also rejected by NCLAT observing that the subsequent claim was filed after the approval of the plan of CoC. It upheld the view taken by NCLT that delay in filing the second claim cannot be condoned.

"Apart from the reasons given by the Adjudicating Authority (NCLT), we are of the view that the claim which was on the basis of the assessment made subsequent to the initiation of CIRP could not have been admitted," said the NCLAT bench comprising Chairperson Justice Ashok Bhushan and Arun Baroka.

Congress slams SEBI over RTI rebuff

has slammed SEBI's refusal to disclose instances when its chairperson Madhabi Buch recused herself due to conflict of interest and said that this makes a "mockery" of public accountability and transparency.

The cases where Buch recused herself due to potential conflict of interest is not "readily" available and collating them would "disproportionately divert' its resources, the securities market regulator said in an RTI response on Friday.

In the response furnished to transparency activist Commodore Lokesh Batra (retd), the regulator also refused to provide copies of Buch's declarations to the government and SEBI Board on the financial assets and equities held by her and her family members on the grounds of these being "personal information" and that their disclosure may "endanger' personal safety.

Reacting to the development, Congress general secretary in-charge communications Jairam Ramesh said, "The multiple conflicts of interest of the SEBI Chairperson that have been revealed so far are shocking in themselves Now in a move that adds more fuel to the raging fire, SEBI has simply refused to divulge information to a RTI activist on instances of the SEBI Chairperson recusing herself on issues where there have been potential conflicts of

"This makes a mockery of public accountability and transparency as far as SEBI is concerned," he said in a post on X late last night.

The SEBI has also denied to disclose the dates on which the disclosures were made. The SEBI Central **Public Information Officer** (CPIO) used the grounds of "personal information" and "safety" to deny a copy of those declarations.

"Since the information sought do not pertain to vou and the same relates to personal information, the disclosure of which has no relationship to any public activity or interest and may cause unwarranted invasion into the privacy of the individual and may also endanger the life or physical safety of the person(s). The same is, therefore, exempt in terms of Section 8(1)(g) and 8(1)(j)of the RTI Act, 2005," the RTI response said.

Fuel price cut before Maha elections?

New Delhi: International oil prices continue to be extremely volatile, falling on one day and rising thereafter, a top oil ministry official said explaining the reason behind no reduction in petrol and diesel prices despite softening in input cost, but could not say if the rates will be cut before Maharashtra elections

Global oil benchmark Brent crude futures fell below USD 70 per barrel last week -- the first time since December 2021 -- but gained thereafter. Brent was trading at USD 74.58 per barrel on Thursday while West Texas Intermediate advanced to trade at USD 71.71.

A decline in price of crude oil -- which is converted into fuels like petrol and diesel at refineries -- had rekindled hopes for a reduction in petrol and diesel rates that have been on a freeze for over two years now barring a pre-election reduction earlier this year.

"Oil prices continue to be volatile. They fell one day last week to below USD 70 but rose the day after," the official, speaking on condition of anonymity, told reporters here.

Bangladesh reverses hilsa export ban ahead of Durga Puja

Dhaka: Bangladesh's interim government on Saturday said it would export 3,000 tonnes of hilsa fish to India, coinciding with the upcoming Durga Puja, revising its earlier decision.

Durga puja will be celebrated from October 9 to 13. The development comes days after the interim government, led by Professor Muhammad Yunus, earlier this month imposed a ban on hilsa

export to India to meet domestic demand, discontinuing a longstanding tradition of Bangladesh as a "goodwill gesture" to its neighbour.

"Against the backdrop of appeals by the exporters, approval has been given to export 3.000 tonnes of hilsa fish (to India), fulfilling the specific conditions on the occasion of the upcoming Durga Puja," the commerce

ministry

The ministry asked applicants to contact its relevant wing to obtain export permission.

The previous Awami League government led by deposed prime minister Sheikh Hasina had allowed hilsa exports to India between September and October every year as a goodwill gesture, a tradition

that had been nurtured for years. Bangladesh is the world's largest hilsa producer but it restricts the export of the fish due to high local demand. However, during the Durga Puia festival, it usually relaxes the ban on the export of the fish, which is a much sought-after delicacy of Bengalis.

India's Fish Importers Association earlier this month urged Bangladesh Foreign Affairs Adviser Touhid Hossain to allow the export of hilsa to India.

Horticulture production falls slightly

New Delhi: The country's horticulture production is estimated to fall marginally by 0.65 per cent to 353.19 million tonne in 2023-24 as compared to the previous

Fruit production is expected to increase by 2.29 per cent to 112.73 million tonne in 2023-24 (July-June), driven by higher outputs of mango, banana, lime/lemon, grapes, and custard apple. However, production of apple, citrus fruits, guava, litchi, pomegranate, and pineapple is likely to fall.

Rs 3 lakh cr needed to achieve green anergy target

New Delhi: An investment of over Rs 3 lakh crore is needed every year in the renewable energy sector to take India's installed green capacity to 440 gigawatt, Icra experts said on Friday.

"We expect India to have 440 gigawatt installed capacity of renewable energy by 2030," Vikram V, Vice President & Co-Group Head - Corporate Ratings, ICRA Ltd said at a media

The estimated capacity would require incremental investment of at least Rs 3 lakh crore every year over the next five to six years, Girish Kumar Kadam, Group Head Corporate Sector Ratings at ICRA Ltd.

He further said to meet the renewable purchase obligation (RPO) target of 43 per cent by 2030, the renewable energy capacity should more than double to 440 GW from the current level of

The government's target is to have 500 gigawatt of installed renewable energy capacity by 2030.

Sharing his outlook for the RE sector, Kadam said India has made significant progress in renewable energy capacity addition with a strong policy focus, but factors such as energy storage, grid integration, and fully-integrated renewable energy equipment manufacturing pose challenges, given the increasing share of renewables in the energy

The evolving landscape presents both risks and significant investment opportunities, especially as the demand for cleaner energy sources intensifies. The sector's growth potential is immense, provided the government addresses these pressing issues expeditiously, he said. In a presentation, ICRA

experts said that by FY2030, electric two-wheelers will

account for 25 per cent of new vehicle sales while electric three-wheelers and buses will constitute 40 per cent and 30 per cent,

respectively. The EV sector is expected to attract substantial investments, with nearly Rs 25,000 crore anticipated to be poured into charging infrastructure and localisation of EV components over the next three to four years, they said.

Stanford dropout to billionaire in three years

Mumbai: Kaivalya Vohra, who left Stanford University's prestigious computer science program at 18 to pursue entrepreneurship, is now a co-founder and Chief Technology Officer at Zepto, an Indian startup that has achieved unicorn status. Together with his friend Aadit Palicha, Kaivalya founded Kiranakart, an online grocery delivery service that promised to deliver

goods within 45 minutes. This venture set the stage for Zepto, which boomed during the pandemic as online shopping and delivery services became increasingly popular. Zepto was recognized as India's first unicorn of 2023, catapulting Kaivalya to the status of India's youngest billionaire.

Born in Bangalore, India on March 15, 2003, Kaivalya completed his early education in India before moving to Dubai. He attended Dubai College,



where he excelled in subjects like mathematics, physics, and computer science, demonstrating leadership skills through roles such as deputy head boy, captain of the under-19 basketball team, and

founder of the school's Computer Society.

Inspired by the rise of technology and the success of apps like Uber and Ola, Kaivalya considered working for a multinational company to gain experience before starting his own venture. However, he quickly realized that the concept of offering quick, door-to-door grocery delivery was perfectly suited to the current situation during the

The agitating doctors said that they would wait for another seven days for the administration to fulfill their demands for justice for the deceased doctor and the removal of state health secretary or else they would start another round of 'cease work'.

The doctors have been

protesting since August 9 when the body of a woman medic was found at RG Kar Medical College and Hospital, demanding justice for the deceased doctor as well as removing key officials from their posts alleging their involvement in the case.

CBI questions close aide of Sandip Ghosh

Kolkata: CBI sleuths on Saturday started questioning another doctor, allegedly close to arrested former principal of RG Kar Medical College and Hospital Sandip Ghosh, in connection with their probe into the rape and murder of a woman doctor at the medical establishment, an officer said.

Birupaksha Biswas, who was recently transferred by the West Bengal Health Department from Burdwan Medical College and Hospital to remote Kakdwip hospital in South 24 Parganas district, appeared before officers of the Central Bureau of Investigation (CBI) at its CGO Complex office in Salt Lake area.

Biswas, allegedly part of a 'North Bengal lobby' operational in medical colleges, was seen at RG Kar Hospital on August 9, when the body of the woman medic was found, the CBI officer

"He is being questioned about his presence at RG Kar Hospital on August 9 despite having no official engagement, apart from other queries," the officer told PTI.

An FIR has been lodged against Biswas and two other doctors -- Avik De and Ranjit Saha -- with Bowbazar police station for allegedly threatening students at different medical colleges and hospitals across West Bengal.

Chandigarh: JJP leader Dushyant Chautala, whose party is contesting the October 5 Haryana assembly polls jointly with Azad Samaj Party, predicts a hung assembly but exudes confidence that their alliance will win enough seats to emerge as a key player after the results.

The JJP had won 10 of the 90 assembly seats in the 2019 Haryana assembly polls, the BJP 40 and the Congress 31. Chautala, 36, the great grandson of former deputy prime minister Devi Lal, predicts that no single party will be able to cross the 40seat mark in the assembly elections.

No single party can form government on its own. There are chances that nobody crosses the 40-seat mark. So, there will be parties with numbers and some Independents too who will win, former deputy chief minister Chautala told PTI.

"Our alliance will win enough number of seats and emerge as a strong player in



the scenario," he said.

Asked whether they will support any other outfit in case of a hung assembly, Chautala quipped, "Why to go behind somebody. Why can't somebody come behind us. Anybody can form a good alliance in which we lead... rest of the things we can comment when results are out." he said.

"We have seen that in Delhi, Jharkhand and in Bihar, (Chief Minister) Nitish Kumar (JDU) has only 44 MLAs," he said.

Former MP Ajay Singh Chautala-led JJP and Chandra Shekhar Azad-led Azad Samaj Party (Kanshi Ram) had recently announced their alliance for the Haryana polls. While the JJP is fighting on 69 seats, the ASP has fielded 16 candidates.

From Dabwali segment, the JJP has fielded Dushyant's brother Digvijay Singh Chautala.

The JJP-ASP alliance has extended support to three Independents on Rania, Meham and Pundri seats while not fielding any candidates in two constituencies.

In the 2019 assembly polls, the JJP had won 10 of the 90 assembly seats, the BJP 40 and the Congress 31. Emerging as a 'kingmaker', it entered into a post-poll tie-up with BJP, which had fallen short of majority.

As it will take seven years to develop the Next Generation Launch Vehicle (NGLV), the launch vehicle being built by ISRO to replace currently operational systems, since the Venus mission is expected to be launched in March 2028, it will be launched from the existing vehicles, said Somanath.

According to him, although Venus is our nearest planet, it is more Russia, China and Japan are also sending missions to Venus by 2030. So, by 2028, we have decided to launch our Venus mission.

"When I saw some of the stalls today, I was really impressed by the work done by the industries. The transition has already happened. Today, we can see many startups building their own satellites. This is the change we are seeing,' he said.


Astronomers just detected biggest black hole jets ever seen

Sydney: The largest known black hole jets, 23 million light years across, have been discovered in the distant universe. This pair of particle beams launched by a supermassive black hole is over a hundred times larger than our galaxy, the Milky Way.

In 2022, we announced the discovery of one of the largest black hole jets in the night sky, launched from a (relatively) nearby galaxy called NGC2663. Using CSIRO's Australian Square Kilometre Array Pathfinder (ASKAP) in Western Australia, we confirmed that NGC2663's jet is one of the largest in the sky. In other words, it appears to be the largest when viewed from Earth.

The new jet, announced



been dubbed "Porphyrion" (a giant in Greek mythology) by its discoverers at the California Institute of Technology in the United States, It dwarfs NGC2663's jet in actual size and is over 20 times larger – a true colossus.

Porphyrion can tell us more about the great ecosystem of matter flowing inside and outside of galaxies. But this jet also has us scratching our

heads: how can something 23 million light years across be almost perfectly straight? Seeing invisible light

Porphyrion was discovered by astronomers using the International LOFAR Telescope, a network of radio sensors centred in the Netherlands, and stretching from Sweden to Bulgaria, and from Ireland to Latvia. Radio telescopes like ASKAP and LOFAR can see light that is invisible to our

What launches the jet in the first place? At the centre of the jet, researchers see a galaxy, and at the centre of the galaxy, they find evidence of a supermassive black hole.

As matter is pulled towards the black hole, various fates await. Some matter is eaten entirely. Some orbits around the black hole, forming a disk. And some of it becomes twisted and tangled in intense magnetic fields, until it is released into two opposing jets, blasting at almost the speed of light.

We've seen black hole iets before, even ones that stretch many millions of light years. What's striking about Porphyrion is that it looks almost perfectly

Early breeding shows Project Cheetah doing well

New Delhi: Early and successful breeding of cheetahs brought from Africa shows that the reintroduction project is progressing well and habitat conditions in India are conducive for supporting a stable and thriving cheetah population, according to a government report.

The report, released by the National Tiger Conservation Authority (NTCA) on the completion of two years of Project Cheetah on September 17, also revealed that the Indian authorities had prepared a standard operating procedure (SOP) to ensure successful reproduction by the cheetahs.

The SOP includes meticulously managing mating instances within enclosures.

Breeding usually signifies that the animals have adapted well to the new environment, are healthy, and are able to meet their basic ecological needs, said the report prepared by the NTCA, the Wildlife Institute of India and the Madhya Pradesh forest department.

Deadliest Israeli airstrike kills 31 in Lebanon

11 Hezbollah operatives including in-charge of elite force killed

Beirut: The death toll from an Israeli airstrike on a Beirut suburb has risen to 31, including seven women and three children, Lebanon's health minister said on Saturday.

Firass Abiad told reporters 68 people were also wounded of whom 15 remain in hospital, adding that search and rescue operations were still ongoing, with the number of casualties likely to rise.

The rare strike — the deadliest targeting the Lebanese capital since the 2006 Israel-Hezbollah war — hit a densely populated southern neighbourhood on Friday afternoon during rush hour as people returned home. Israel said it killed 11 Hezbollah operatives, including Ibrahim Akil who was in charge of the group's elite Radwan Force. The militant group members were in a meeting in the basement of the building that was destroyed.

Weaponising ordinary devices violates international law Weaponising ordinary communication devices

Volker Türk told an emergency meeting of the U.N. Security Council there must be an independent and transparent investigation of the two attacks in Lebanon on Tuesday and Wednesday where these devices exploded, reportedly killing 37 people and injuring more than 3,400 others. "Those who ordered and carried out these attacks must be held to account," he said.

In a nearby building, shops were badly damaged including one that sold clothes and had a sign in English that read: "DRESS LIKE YOU'RE ALREADY

Friday's deadly strike came hours after Hezbollah launched one of its most intense bombardments of northern Israel in nearly a year of fighting, largely targeting Israeli military sites. Israel's Iron Dome missile defence system intercepted most of the Katyusha rockets.

The militant group said its latest wave of rocket salvos was a response to past Israeli strikes on southern Lebanon. However, it came days after mass explosions of Hezbollah pagers and walkietalkies killed at least 37 people — including two children. Some 2,900 others were wounded in the assault which has been widely attributed to Israel.

Humanitarian chief calls for investigation into device explosions

The UN humanitarian chief told an emergency meeting of the U.N. Security Council that weaponising communications devices represents a new development in warfare and said targeting thousands of Lebanese people using them without their knowledge is a violation of international human rights law.

Volker Turk called for an independent investigation of this week's mass explosions of Hezbollah pagers and walkie-talkies that killed at least 37 people and wounding about 3,000 others. The attacks have widely been attributed to Israel.

Earlier this week, Israel's security cabinet said stopping Hezbollah's attacks in the country's north to allow residents to return to their homes is now an official war goal, as it considers a wider military operation in Lebanon that could spark an all-out conflict. Israel has since sent a powerful fighting force to the northern border. The tit-for-tat strikes have forced tens of thousands of people to evacuate their homes in both southern Lebanon and northern Israel.

Five health workers killed in Gaza

The Gaza Health Ministry said Saturday that five of its workers were killed, and five others injured, by Israeli fire that struck the ministry's warehouses in the southern Musbah area.

Israel's bombardment of Gaza has already killed at least 41,000 Palestinians, according to the Gazabased Health Ministry. which doesn't differentiate between fighters and civilians.

Lebanon's foreign minister urges UN Security **Council to condemn explosions**

Lebanon's foreign minister is warning the UN Security Council that if it doesn't condemn this week's deadly explosions and name Israel as the perpetrator a "Pandora's Box" will be opened, and governments and extremists will target and kill civilians with similar communications devices. Abdallah Bouhabib accused Israel on Friday of terrorizing the entire Lebanese population on streets, in markets and their homes where exploding pagers, two-way radios and other electronic devices reportedly killed 37 people and injured more than 3,400 others.

Ukraine bans Telegram because of Russian threat

tary personnel and other defence and critical infrastructure workers from installing the popular Telegram messaging app on state-issued devices, describing the move as necessary for national security during the war with Russia.

Ukraine's National Cybersecurity Coordination Centre said it issued the ban for the official devices of government employees, military personnel, security and defence workers, and critical infrastructure employees. The ban was announced Friday by Ukraine's Security and Defence Council in a statement on Facebook.

During a meeting on Thursday, the Security Service of Ukraine and the General Staff of the Armed Forces of Ukraine said Telegram is actively used by Russia for cyberattacks, phishing, spreading malware, establishing user locations and calibrating missile strikes.

An exception to the ban will be allowed for people

Kyiv: Ukraine has banned who use the app in their ofgovernment officials, mili- ficial duties. Ukrainians are free to use the app in their personal devices.

The app is widely used in Ukraine not only for texting but also for reading news, including updates on Russian air attacks. It is also the primary way Ukrainian officials, including President Volodymyr Zelenskyy, engage with the public and relay war developments. Zelenskyy is likely to continue using Telegram in his public communications since it is in his official capacity.

Ukraine's intelligence chief Kyrylo Budanov said Russian intelligence services are able to access the personal messages of app users, including deleted messages, as well as their personal data, according to the statement.

"I have always advocated and continue to advocate for freedom of speech, but the issue of Telegram is not a matter of freedom of speech; it is a matter of national security," Budanov said, according to the statement.

Pak police arrest four ISIS terrorists

Lahore: Four alleged ISIS terrorists have been arrested in Pakistan's Punjab province, police said on

A spokesperson of Punjab Police's Counter Terrorism Department said that acting on a tip-off, the CTD raided the hideouts of terrorists in four cities of Puniab -- Lahore, Toba Tek Singh Bahawalpur and Mianwali -- and arrested as many terrorists belonging to Daesh (ISIS)

The terrorists were iden-

tified as Amiadur Rehman Sher Ali, Zahabullah and Tayyab Raees. Police recovered 2,570 grams of explosives, three detonators, 18.7 feet of safety fuse wire, a Kalashnikov rifle with 40 rounds of ammunition, a 30bore pistol with 20 bullets, four hand grenades, and banned literature of ISIS from their possession.

The CTD spokesperson said the arrested terrorists had planned to target important installations and personalities.

Voting in Sri Lankan polls peaceful government employees nomic crisis, economic

Colombo: Polling concluded in Sri Lanka on Saturday with no violence or security breaches reported anywhere from all 22 electoral districts in the crucial presidential elections, the island nation's first since its worst economic meltdown in 2022.

Officials are yet to release the final voting percentage. By 2 pm, more than 60 per cent of the 17 million eligible people had voted, they said.

Observers said voting in the northern district of Jaffna was on a slow trickle by mid day. A Tamil minority hardline group had discouraged people from voting in the run up to the election.

The counting of postal votes commenced immediately after the voting closed at 4 pm, officials said.

Postal votes were cast by

mostly election officials, military and police. The postal voting was conducted four days earlier.

The election saw the deployment of nearly 8,000 polls observers local and foreign. This included 116 international observers from the EU, Commonwealth, Asian network of elections and seven from the south Asian countries.

The People's Action for Free and Fair Elections (PAFFREL), the leading local group, deployed 4,000 local observers.

The election will be a test for incumbent President Ranil Wickremesinghe who has claimed credit for putting the country on the road to economic recovery.

More women voters but no female candidates Women make up more than half of the voters in Sri Lanka, but not a single one will be on the ballot in

Saturday's presidential election. The island nation of more than 22 million people is voting for a president to take its economy forward after it went through an unprecedented financial crisis two years ago that led to the ouster of its head of government. The election will allow more than 17 million eligible voters to choose from a record 38 candidates. But women — who account for nearly 9 million voters — will have no gender representation.

tion is the most keenly contested of all presidential elections since 1982 with 38 candidates in the fray.

Some 17 million people were eligible to vote at over 13,400 polling stations. Over 2,00,000 officials were deployed to conduct the election. Buddhist temple halls, schools and community centres were converted into polling stations.

The three-cornered electoral battle saw Wickremesinghe facing stiff competition from Anura Kumara Dissanayake, 56, of the National People's Power (NPP), and Sajith Premadasa, 57, of the Samagi Jana Balawegaya (SJB) and the main Opposition leader. Wickremesinghe, 75, is

seeking re-election for a fiveyear term as an independent candidate, riding on the success of his efforts to pull the country out of the economic crisis, which many experts hailed as one of the quickest recoveries in the world.

Sri Lanka had plunged into an economic crisis when the island nation declared sovereign default in mid-April of 2022, its first since gaining independence from Britain in 1948. Almost civil-war-like conditions and months of public protests led to the fleeing of the then president Gotabaya Rajapaksa.

Wickremesinghe was appointed as president by Parliament a week after.

Under Wickremesinghe, the rupee has stabilised, inflation has slowed to near zero from over 70 per cent during the peak of the eco-

tive from contraction, and government revenue has iumped sharply after new taxes and an increase in value added tax (VAT). Though Wickremesing-

he's recovery plan to tie rigid reforms linked to the International Monetary Fund (IMF) bailout was hardly popular, it helped Sri Lanka recover from successive quarters of negative growth. Dissanayake and Premadasa want to tinker with the IMF programme to give more economic relief to the public. This time, the minority Tamil issue was not on the agenda of any of the three main contenders, instead, the nation's battered economy and its recovery had taken centre stage with all three front runners vowing to stick with the IMF bail-out reforms.

Sri Lanka's crisis proved to be an opportunity for Dissanavake, who had seen a surge of support due to his pledge to change the island's "corrupt" political culture.

After the counting, if no candidate receives more than 50 per cent of the votes, a second preferential vote count will be conducted.



Maharashtra's Scholarship Quagmire

In Maharashtra, a range of scholarships exists to support students from marginalized communities, primarily scheduled castes, scheduled tribes, other backward classes and economically weaker sections. Both the central and state governments offer these scholarships, supplemented by autonomous institutions such as the Dr. Babasaheb Ambedkar Training and Research Institute (BARTI), Tribal Training and Research Institute (TRTI) and others. These institutions provide crucial financial support, including post-matriculation scholarships and stipends for higher education, yet their operations are mired

in inefficiencies and growing public

disillusionment. The purpose of these scholarships is to uplift disadvantaged students through educational and economic empowerment. Institutions such as BARTI, Mahajyoti, SARATHI and TRTI are tasked with implementing these schemes, each tailored to a specific demographic. Each institution offers opportunities to 75 underprivileged students for higher education abroad and bears their entire expenses. Also, for PhD and research students, SARATHI, BARTI and Mahajyoti institutes offer stipends to 200 students, while TRTI offers stipends to 100 students. Free coaching, books and tuition are provided to meritorious students to aid preparation for the JEE and NEET exams.

In theory, this should create a framework for promoting social mobility. In practice, however, the system is riddled with contradictions, inefficiencies, and a lack of coordination

Over the years, the state government has expanded this network with the creation of new entities like the Annabhau Sathe Training and Research Institute (ARTI) and the Minority Training and Research Institute (MARTI). However,

these initiatives remain largely inactive, further complicating an already burdened system.

A significant issue lies in the lack of transparency and uniformity among these institutions. Despite their ostensibly autonomous status, decisions are made at the government level, leaving little room for flexibility at the directorate level. Furthermore, a new policy establishing a single committee to govern all institutions, irrespective of the distinct needs and socio-economic conditions of the constituencies they serve, has been met with widespread criticism. It raises the question of whether a onesize-fits-all approach can work in such a diverse state.

Budgetary discrepancies compound the problem. The institutions' operational rules are often confusing, with varying stipends, tuition fees, and eligibility conditions. Even the most basic provisions -like free coaching for competitive exams such as JEE and NEET require clearing preliminary examinations, creating additional hurdles for students already grappling with financial instability.

More worryingly, despite the shift to an online scholarship disbursement system in 2017, many students report significant delays. In some cases, scholarships have been withheld for over two years. These delays erode trust in the system, with many students opting out of the application process altogether as the frustration of waiting undermines the very purpose of financial aid.

For students from rural areas and backward communities, these scholarships are often the only means to break the cycle of poverty. The failure of the government to provide timely assistance pushes many students into deeper financial stress, leading them to abandon their studies entirely. Worse, delays in scholarship payments create a ripple effect of social and psychological distress, reducing future opportunities and depriving the state of much-needed talent rom its underserved regions.

The government's intention to assist these students is clear, but its execution is severely flawed.

FORGOTTEN HISTORY

From Lahore to the Stars: The Genius of Subrahmanyan Chandrasekhar

n the autumn of 1983, browsing through a university bookshop, stumbled upon 'An Introduction to the Study of Stellar Structure' by S. Chandrasekhar. The name rolled off my tongue with intrigue. Little did I know that just months later, the man behind the name, Subrahmanyan Chandrasekhar, would win the Nobel Prize for the insightful mathematics he done in 1930 — at the tender age of 19, while sailing from India to England to take up a scholarship at the University of Cambridge. His revolutionary discovery would forever change our understanding of the cosmos, even if it took the world many years to catch up with his brilliance.

Born on October 19, 1910 in Lahore to a family of Shaivite Brahmans, Chandra was a precocious if mischievous child. Tutored at home


The great theoretical physicist's brilliance illuminated the complexities of the cosmos, revealing truths that others blinded by their own stardom failed to see.

as his father distrusted the quality of the local schools - his mother taught him Tamil, his father English and mathematics - he did not enter formal schooling until he was eleven. By the time he was 15, at the Presidency College in Chennai, he was considered a maths prodigy. He was so devoted to his studies that his father used to admonish him, telling him to stop reading so much and get some fresh air. Then, at the age of 17, he spent the summer working in Kolkata, at his uncle's laboratory, where he broke some of the apparatus, confirming for him that he was not destined to be an experimentalist. That uncle of his was C.V. Raman, famous for his work in the physics of light scattering, winner of the Nobel Prize in 1930, the first non-White person to do so in any branch of the sciences.

It was in his uncle's laboratory that Chandra was introduced to the mathematics of the new quantum mechanics that was then transforming the world of physics, actually meeting such eminences as Arnold Sommerfeld and Werner Heisenberg. In 1929, with the help of Ralph Howard Fowler, Chandra published his first paper in the Proceedings of the Royal Society.

Fowler was to transform Chandra's life. Fowler had been thinking about white dwarfs - small, hot, and very dense remnants of stars that have burned through all their nuclear fuel. Such stellar remnants did not make sense. Such stars should undergo total gravitational collapse. But, by applying the new quantum mechanics to white dwarfs, Fowler solved the problem of their existence.

On his voyage to England to become Fowler's doctoral pupil at Cambridge, Chandra turned his mind to Fowler's work on white dwarfs. Chandra's insight was to



realise that special relativistic effects must be taken into account within a white dwarf. Working out the mathematics, he demonstrated that Fowler's explanation of the physics that stabilized white dwarfs would be true only up to a point, that there was an upper limit - now known as the Chandrasekhar Limit - to the mass of a star that could

evolve into a white dwarf, about 1.4 times the mass of our sun. Any greater and the star would collapse into what we now know as a neutron star or even a black hole. Chandra's insight has to be one of the greatest scientific discoveries of the 20th century.

However, at Cambridge, Chandra's work on white dwarfs was to be ignored. As he completed his doctorate, he refined his calculations, and was pleasantly surprised when the great astronomer Sir Arthur Stanley Eddington, arranged for him to speak in 1935 at the Royal Astronomical Society in London. Expecting Eddington to support him, Chandra was shocked when Eddington spoke after him, ridiculing his conclusions, stating that something as large as a star could not simply disappear. Such was Eddington's formidable prestige it would take many years for the Chandrasekhar Limit to be accepted. And it was not until 1972, when

the first black hole, Cygnus X-1, was identified, that Chandra and his

work would be fully vindicated. Deciding that any future career path in England was now blighted by Eddington, Chandra returned briefly to India in 1936, where he married Lalitha, a physics scholar herself. It was a rare love match in those days. They would share a passion for literature and classical music. Unhappy with the political situation in India, Chandra and Lalitha left for the United States where he took up a position at the University of Chicago. There, he would stay for the rest of his working life, conducting much more ground-breaking research, and achieving fame as both an inspiring and intimidating teacher.

Although his Nobel Prize in 1983 was awarded solely for his youthful discovery, Chandra's contributions to astrophysics spanned decades of groundbreaking work. Perhaps feeling the sting of the long-delayed recognition, he ended his Nobel lecture with a poignant reflection:

"The simple is the seal of the true. And beauty is the splendour of

The throne of thorns in Delhi

The most striking image, in recent times, of Delhi's new Chief Minister Atishi Singh, was of her being wheeled away in a stretcher after her health took a turn for the worse as she embarked on an indefinite hunger strike. Her demand was to get more water for Delhi from Haryana. Atishi was using this timetested powerful tool of protest-a hunger strike—that also played a role during the inception of her party, the Aam Aadmi Party. For those who recall the endless television coverage, in an anti-corruption movement in 2011. Anna Hazare had gone on a fast and Arvind Kejriwal, Atishi's party boss, had made headlines as he sat in protest. The feisty young politician who represents her party in television studios and at press conferences, is now the national capital's new chief minister.

A prominent face in television debates and press conferences of the AAP, Atishi, a first-time Member of the Legislative Assembly was inducted into the council of minister in March 2023 after the then deputy Chief Minister and Kejriwal's trusted lieutenant, Manish Sisodia, was arrested by the Central Bureau of Investigation in the excise policy case. Atishi, along with Saurabh Bharadwai. joined the Delhi government following the resignation of Sisodia and Satvendar Jain and has since has been entrusted with key portfolios such as finance, education and public works. Her work profile increased to 14 departments as senior leaders of the party were implicated in irregularities in the Delhi Excise Policy. Her responsibilities, the highest among all cabinet ministers in the outgoing AAP government, included education, finance, planning, PWD, water, power ites. While she unsuccessfully conand public relations, exhibiting the tested the 2019 Lok Sabha elections taith Kejriwai nas in ner.

Atishi's academic credentials are impressive; an alumnus of Delhi's St Stephen's College, she's been a Chevening and Rhodes scholar, where she completed a Masters' degree in Education at Oxford University. She used her academic background to implement reforms in Delhi's education system which won her recognition as the architect of Delhi's education policy. Delhiites say that she's raised standards of teaching, managed to keep fees in check and is the driving force behind the 'entrepreneurship mindset curriculum' and the 'happiness curriculum' in Delhi schools. With impeccable educational pedigree, she's got her attention in the right places with environmentfriendly policies such as pollution control, renewable energy and sustainability being key areas of focus



At 43 years, Atishi is the third woman Chief Minister of the national capital of India joining the ranks of Sushma Swaraj and Sheila Dixit. Her journey to the top has been rapid and steady since 2013 when she was played a role in drafting AAP's election manifesto and the government's early policies. In the initial years, she was advisor to Manish Sisodia, the former deputy chief minister of Delhi where she took a keen interest in educational reforms that are believed to have brought big relief to Delhi-

and lost to BJP's Gautam Gambhir, she won the 2020 Assembly elections from Kalkaji

However, her accession to the top job comes at a crucial time where party bosses have faced jail on corruption charges and elections are only a few months away. The Delhi Assembly elections are scheduled for February 2025, leaving Atishi with little time to make a sizable impact from the state's seat of power. With Kejriwal's resignation, his entire cabinet has resigned and Atishi may rejig the ministries as the new cabi-

She faces a belligerent BJP that will make corruption charges against Kejriwal a top issue in the upcoming elections. The AAP's flagship scheme of doorstep delivery of services needs to energised with implementation having slacked in recent years. In this year's state budget, Atishi had announced a financial assistance scheme to women, the Mahila Samman Nidhi Yojana, which promises a monthly amount of Rs 1000 to women above the age of 18 years. The scheme needs implementation especially in

an election year. Then there are schemes that await cabinet approval such as the Industrial and Economic Development Policy, the Electric Vehicle Policy 2.0 and Water Bill Settlement Scheme. The AAP government has promised policies to encourage employment like the Dilli Bazaar Portal and policies for start-ups and food trucks, all of which need approval with time running short.

Boards and commissions are nesting places to balance equations with political heavyweights who cannot be accommodated in the cabinet and Atishi will have to appoint senior politicians to these commissions with vacant posts.

The highest seat in government is a charming place to be in but Atishi's elevation comes at a crucial juncture in the journey of AAP. Will she be able to bring the party back to power with people-friendly schemes? The answer lies only a few months away.

Growing Risks Of Cyber Warfare

n a shocking series of events, multiple coordinated explosions have rocked Lebanon and parts of Syria, killing dozens of people and injuring thousands. The blasts occurred after explosive devices, hidden inside pagers and other radio communication devices, were detonated. The targeted individuals were primarily members of Hezbollah, with the explosions taking place in densely populated areas, resulting in widespread injuries to civilians, including children.

The devices, mainly pagers, walkietalkies, and radios, had been in the possession of Hezbollah operatives. who had acquired them months prior, under the assumption they were secure. However, Hezbollah has accused Israel's intelligence agency, Shin Bet, of tampering with the devices during transit.

According to security experts, Israel's elite secret cyber warfare unit was behind the attack. This unit. known for its global cyber operations, is also linked to the creation of the STUXnet malware, which was responsible for the failure of Iran's nuclear power plant. The pagers were rigged with explosive materials in place of a battery, and a relay switch was installed, allowing the explosions to be triggered remotely in a synchronized manner. The result was devastating injuries to the eyes, face, hands, and legs of those carrying the devices.

The incident occurred in Hezbollahstronghold areas, including the Dahieh suburb of Beirut, southern Lebanon. and parts of the Beqaa Valley, with some explosions also reported across the border in Syria. The blasts overwhelmed hospitals, as hundreds of victims sought medical help for injuries ranging from severe burns to shat-

attery malfunctions, indicates a highly sophisticated sabotage operation.

These explosions have not only deepened the crisis in Lebanon but have also raised critical questions about supply chain security, intelligence tactics, and the legality of using booby-trapped electronics in conflict zones.

What Are Pagers, and Why Are They Still Preferred?

Despite being old-school tele communication technology, pagers or beepers are still used in many countries, particularly in critical sectors and organizations. Pagers primarily facilitate one-way communication, pager uses higher frequencies than car radios i.e. 400 MHz band frequency. It also used a very basic type of VHF spectrum. These devices operate in restricted areas to transfer messages, alerts, and information. These devices are considered more secure and harder to trace or track compared to mobile phones, as they only receive messages, similar to a car radio that receives signals without revealing the listener's identity or location. Additionally, pagers lack features like Bluetooth or GPS, making them more difficult to hack or compromise.

Among their many advantages, pagers are known for their long battery life and durability, making them ideal for continuous use in specific industries. There are an estimated two million active pager users worldwide. Hezbollah began using pagers after Israel successfully assassinated a high-ranking Hezbollah target by hacking his cellphone and precisely targeting him with a missile. Since then, many Hezbollah members have switched to more primitive communication devices, like pagers, to avoid being tracked via the internet.

Are Mobile Phones and Smartphones Similarly Vulnerable?

American and European security agencies suggest that, theoretically, it is possible to alter mobile phones and other smart devices to turn them into explosive devices. However, practically, it is more difficult due to the ad-

tered limbs. The intensity of the explosions, far beyond that of ordinary smartphones. A hacked smartphone may exhibit various signs, such as ab normal temperature changes, slower system performance, unexpected reboots, odd sounds during calls, hung applications, or irrelevant messages and pop-ups, all of which could indicate tampering. These security systems make it more challenging to modify smartphones in the same manner as simpler devices like pagers.


New Security Challenges

The Hezbollah pager explosion serves as a wake-up call for sectors involving critical infrastructure and aviation. In an era where smartphones are network-connected and can be charged wirelessly, the possibility of tampering with batteries or embedding explosives, like HMX, PETN and other type of plastic explosives pose significant risks. During flights, even a minor explosion could result in catastrophic consequences. On the ground, the threat extends to damaging nearby aircraft, equipment, and infrastructure. Airport security may soon impose stricter regulations, potentially banning pagers, walkie-talkies, and radios, much like power banks, which are now restricted on flights. In the future, mobile phones may only be allowed in switched-off modes, placed in lithium-safe bags during flights. Suspicious devices could be handled separately in Faraday-sheet bags to block any network or signal connections.


This incident highlights the growing risks of cyber warfare and the dangers posed by everyday communication devices being exploited for sabotage. It is an alarming call for a nation's security as the treat of such critical infrastructure being handled by terrorist organisations can compromise the use of day-to-day electronics for malicious activities. As technology advances, so must the protocols for ensuring public safety, particularly in high-risk environments where even the smallest vulnerability could lead to devastating consequences.

LETTER FROM PAKISTAN

Pakistan-Russia Relations Enter New Phase

Pakistan and Russia are warming up bilateral ties. Credit goes to Indian authorities for beautifully maintaining the relationship between Washington and Moscow. India's excellent relationship with two archrivals Russia and the US, has provided much-needed courage to Pakistani authorities to follow suit.

Russian Deputy Prime Minister Alexei Overchuk met with Pakistani officials in Islamabad in a bid to deepen economic ties and expand cooperation "across multiple sectors" as Moscow grapples with U.S. and EU economic sanctions over its war against Ukraine.

Overchuk's visit comes after two days of meetings between John Bass, U.S. acting undersecretary of state for political affairs, and Pakistani army chief General Asim Munir and Deputy Prime Minister and Foreign Minister Ishaq Dar in Islamabad.

During a joint press conference with his Russian counterpart earlier this week in Islamabad, Dar revealed that discussions centred on expanding economic ties between the two countries. Islamabad is abuzz with the speculation that Russians are helping Pakistan to build a steel mill. If true, it is going to be an excellent step in the revival of Moscow-Islamabad ties.

Pakistan's bilateral trade with Russia reached an unprecedented \$1 billion last year. The countries are committed to expanding trade ties by addressing logistical and related issues. Officials familiar with the development in the Pakistan-Russia bilateral relationship are optimistic that the two sides can enhance the volume of bilateral trade from one billion US dollars to \$5 billion in a few years. In fact, India's bid to maintain an excel-



lent relationship with arch-rivals Russia and the US has given Pakistan much confidence to follow suit. However, it is not an easy task for Islamabad to follow the Indian path. Islamabad may lose its biggest economic partner like the US if it goes ahead to develop ties with Russia.

According to officials familiar with the development, Pakistan and Russia are expanding ties in many fields, including liquefied natural gas (LNG) purchases. However, sanctions against Russia restrict cooperation between the two countries. Can Pakistan still go forward to enhance bilateral ties with Russia? It's a million-dollar question.

Pakistan views Russia as an important player in West, South, and Central Asia. Authorities in Islamabad aim to work with Moscow toward peace and stability in Afghanistan. However, it will not be an easy task for Islamabad, as Washington can be a silent spectator. Pakistan may face the wrath of going ahead with Russian plans in Afghanistan.

Also, Pakistan's army media wing said in a statement on Wednesday that Russia's Overchuk spoke with General Syed Asim Munir, chief of the army staff (COAS), in Rawalpindi.

Analysts say the Russian deputy prime minister's visit and the expansion of cooperation show Moscow is expanding its influence in the region.

"In my view, a vacuum has emerged after the U.S. exit from Afghanistan, and Russia is positioning itself to fill that void. China is also making efforts in this direction. As a result, Pakistan is working under this policy framework to improve its relations with regional countries, including Russia," Professor Manzoor Afridi, a Pakistani academic on international relations, told VOA.

Analysts on Pakistan's foreign policy and geopolitics believe that the US may not react until warming ties in the Russia-Pakistan bilateral relationship focus primarily on enhancing trade, strengthening diplomatic relations, and developing infrastructure, particularly in the energy sector. However, the United States may react sharply if Pakistan-Russia ties go beyond that threshold. The US has restricted certain aspects of Pakistan's ballistic missile program, while tensions between Russia and Ukraine have escalated. In this context, Pakistan's relationship with

Russia holds significance.
Pakistan received its first shipment of Russian liquefied petroleum gas in 2023. Russian President Vladimir Putin and Pakistani Prime Minister Shehbaz Sharif discussed the possibility of liquefied natural gas supplies earlier in July on the sidelines of a Shanghai Cooperation Organisation summit at Astana,

Pakistan's bid to warm its ties with Washington is a welcome step. However, Islamabad has to pay a heavy price in case of cosying up with Russia. It may have to lose an economic partner like the US. Can Pakistan afford to lose a partner like the US? It's a million-dollar question.

Pager Blasts: A Global Threat?

Imagine ending your day, exhausted, but pausing before using your phone, laptop, or car radio. In Lebanon, such hesitation is now part of daily life. A new wave of terror – reportedly triggered by Israel in its relentless campaign to cripple Hezbollah - has shaken the country, with explosive devices embedded in pagers, walkie-talkies, and even solar cells. The devastation is staggering: over 30 dead and nearly 3,000 injured. This is a conflict not fought with drones or tanks, but with the very electronics

that power modern life.

The scale and sophistication of these attacks suggest a well-calculated strategy aimed at spreading fear and chaos. While the immediate target is Hezbollah, the potential for this digital warfare to spread beyond Lebanon is a terrifying prospect. As nations like Iran, Syria, and other anti-Israel forces watch with alarm, the world is left asking: is anyone safe from this new form of electronic sabotage?

What began as an isolated con-

flict between Israel and Hezbollah could have far-reaching consequences. The attacks on electronic devices, now a critical part of daily life, have sparked fears that the entire supply chain - spanning from manufacturers in Taiwan and Japan to retail outlets worldwide may become tainted. Consumers, already jittery from rising global tensions, could begin to shy away from the very products that keep the world connected.

The implications are clear - a decline in consumer trust, economic shockwaves, and a scramble to implement expensive screening technologies across global markets. Yet the fear of such attacks going mainstream is what truly haunts policymakers, Israel and Hezbollah are not the only adversaries with deepseated rivalries. With tensions simmering between Russia and Ukraine, China and its neighbours in Southeast Asia, and even India and Pakistan, it is not hard to imagine this new form of electronic sabotage becoming a favoured tactic in global conflicts.

India, with its large population and dependency on imported electronics, is particularly vulnerable. Consider the fact that a vast portion of the world's consumer electronics are made in China - a country with which India has an uneasy relationship. Moreover, Pakistan, which has long sought to destabilize India, could see this as an opportunity to stir chaos, possibly with support

from other regional players like China or Turkey.

The potential for widespread harm is clear. India has been no stranger to terrorist attacks, from the 2006 Mumbai train bombings to the 26/11 attacks. And while the country has developed a robust defence against conventional terror, the emerging threat of electronic sabotage demands new, preventive measures. If India is to avoid disaster, advanced detection systems will need to be implemented across the country - at ports, airports, and even consumer electronics stores. This will undoubtedly add costs, but in a world where electronic warfare could become the new norm, the investment is a small price to pay.

As nations worldwide grapple with the implications of Israel's latest campaign against Hezbollah, one thing is certain: the old rules of war no longer apply. With the ability to turn everyday electronics into weapons, this digital conflict is reshaping the global security landscape. Nations will need to rethink how they approach security, trade, and diplomacy in an era where any device could be a Trojan horse.

For Lebanon, the immediate aftermath is grim: a country on edge, citizens afraid of their own devices. But the rest of the world, too, must confront the unsettling reality that digital sabotage is no longer a faroff possibility. It is here to stay, and is a threat that no nation can afford to impore
