## Elections announced in J & K

Haryana too goes for poll, Maharashtra on wait



New Delhi: Assembly elections will be held in Jammu and Kashmir after a decade in three phases from September 18, setting the stage for the people of the union territory to elect a government after the scrapping of Article 370 in 2019. The Election Commission also announced that elections to the 90-member Haryana assembly will be held on October 1 and results for both the polls will be declared on October 4.

The two assembly elections will be the first popularity test for the BJP and the INDIA bloc following the Lok Sabha polls.

The three-phase elections to the 90-member Jammu and Kashmir assembly will be held on September 18, September 25 and October 1, Chief Election Commissioner Rajiv Kumar told a press conference in the presence of **Election Commissioners** Gyanesh Kumar and Sukhbir Singh Sandhu.

After suffering reverses in the Lok Sabha polls, including in Haryana, the BJP is keen to regain political momentum by retaining power in the state and putting up a strong show in Jammu and Kashmir, where its strongholds have

been traditionally confined to the Jammu division.

The Congress, however, is hoping to continue with its political revival by toppling the BJP from power in Haryana after 10 years and inflicting losses on its rival in the Jammu region where the two parties are the main contestants.

Two regional parties, the National Conference and PDP, have won most of the seats in the Kashmir valley between them in past elections. Both parties are part of the INDIA bloc along with the Congress but all three of them fought separately in the Lok Sabha elections, a scenario likely

to persist in the assembly

In the 2019 polls in Haryana, the BJP had 40 of its 90 seats and formed the government in alliance with the Jananayak Janta Party. In the last assembly in J and K in 2014, the BJP had won 25 of its 87 seats and had joined hands with the PDP to form government under the leadership of the regional party's leader Mufti Mohammad Sayeed.

Its assembly now has 90 seats following delimitation.

CEC Kumar said assembly elections in Maharashtra, which were held along with Haryana in 2019, will be announced later due to security requirements for Jammu and Kashmir.

He said four elections are due this year and by early next year and since Jammu and Kashmir was not in the picture last time (2019-20) the Commission decided to group two assembly elections together.

Besides Jammu and Kashmir and Haryana, elections are due in Maharashtra, Jharkhand and Delhi

Kumar said the next set of elections will be announced after the completion of the polls in Jammu and Kashmir and

### Metro in Thane, Pune gets approval

New Delhi: The Union Cabinet on Friday approved metro rail projects in Thane, Pune and Bengaluru. Information and Broadcasting Minister Ashwini Vaishnaw said the government has approved infrastructure projects worth nearly Rs 2 lakh crore since assuming office in June, making it clear that its priority was to generate jobs and boost connectivity to further economic growth.

The Union Cabinet, at a meeting chaired by Prime



Minister Narendra Modi on Friday, approved metro rail projects in Bengaluru in Karnataka, and Thane and Pune in Maharashtra, where assembly elections are due later this year.

The Phase-3 of the Bangalore Metro, comprising two corridors - JP Nagar to Kempapura and Hoshahalli to Kadabagere – will be completed at a cost of Rs

The Thane Integral Ring Metro, to be built at a cost of Rs 12,200 crore, will provide connectivity to the residential and industrial areas of the city with interchanges provided for the Mumbai Metro rail lines 4 and 5.

The Pune Metro, which will be extended from Swargate to Katraj at a cost of Rs 2,954.5 crore, will provide underground connectivity to Market Yard, commercial and residential areas at Padmavati and Katraj, which has residential areas, a university campus and a zoological park.

### Absolute failure of state machinery: HC

Kolkata: Observing that the mob violence in R G Kar Medical College and Hospital was an absolute failure of state machinery, the Calcutta High Court on Friday airectea the police and the hospital authority to file affidavits on the situation

A division bench presided by Chief Justice T S Sivagnanam said it was hard to believe that the police intelligence did not have information about the gathering of 7,000 people, when the state's lawyer told the court that a mob of such a number had assembled at the hospital in the early

hours of Thursday. After knowing that there was some renovation work on one floor of the hospital after the body of a woman doctor, who was allegedly raped and murdered, was found, the Chief Justice said the court can order closing down the medical establishment

The bench directed the police and the administrator of the hospital to file separate affidavits narrating the "true state of affairs" at the hospital and all connected matters on August 21 when the matter will be heard again

ing Justice Hiranmay Bhattacharyya, said that the po lice should place on record the entire sequence of events that led to the vandalism in the hospital.

A group of people, posing as protesters, entered the hospital and vandalised the emergency department, nursing station, and medicine store, while also damaging CCTV cameras.

The mob also ransacked a stage where junior doctors had been demonstrating since August 9. The body of a woman post-graduate trainee, who was allegedly raped and murdered, was found in the seminar hall of the RG Kar Hospital on that day.

The CBI was also directed by the court to file an interim report about the progress of its investigation into "rape and murder" of the medic, which led to a cease-work by junior doctors in different government hospitals in the state

demanding exemplary punishment to the culprits and security at the workplace.

Stating that the bench The court, also comprishad on August 13 urged the doctors to consider returning to work reminding them of their "pious obligation" towards the patients, the court said that the incident of vandalism and violence at the hospital on August 15 would definitely have an impact on the mindset of the

protesting doctors The court said that the doctors working in the hospital have to be given adequate protection, or else they will not be able to dis-

charge their duties. The Additional solicitor general, appearing for the CBI, stated that a special team set up to probe into the rape and murder case is proceeding with the matter.

He also submitted a copy of the FIR lodged by the CBI following the court's order transferring the investigation to it from the Kolkata Police. The bench wondered what would happen if a similar incident happened in any other facility in West

### Uddhav finds no takers for his demand

president Uddhav Thackeray's push for early CM candidate declaration found no takers on Friday as two major allies of MVA Congress and NCP (SP) preferred to discuss this position after the election. Uddhav Thackeray, while making a public appeal during an event in Sion, urged Congress and NCP to declare chief ministerial candidate before the poll, a demand that was parried away by the other party leaders in the meeting. Sharad Pawar remained silent on the issue. while Congress leader Nana Patole deferred the matter to the party's high command in Delhi. Notably, political parties in Maharashtra have begun gearing up for the upcoming Assembly elections, with all parties conducting outreach campaigns. Uddhav Thackeray openly expressed his disappointment over his recent visit to Delhi saying that congress did not prefer to declare Chief Ministerial candidate before election



Its me or someone else. make the decision today- Uddhav Speaking at the rally, Thackeray exuded, "Announce the candidate now, we all will support them. Whether it's my name or someone else's, make the decision today." Uddhav also recalled a 30-year-long alliance with Shiv Sena and BJP, noting that the party with the higher number of seats would get the Chief Minister's position. This formula however, according to him, led to candidates from both parties working against each other during elections. Thackeray emphasized that if such a scenario repeats, it defeats the purpose of an alliance. making it imperative to announce the Chief Ministerial candidate before the elections. He also clarified that he has no personal interest in the Chief Minister's position within the MVA, stating that he would support whoever is chosen by Sharad Pawar and Congress state president Nana Patole. Thackeray took the opportunity to launch a scathing attack on the state government as well.

Senior Pawar shrugs off Thackeray's demand received no response from either Congress or NCP

(SP). Throughout his speech, Sharad Pawar remained silent on the subject, not uttering a single word about the Chief Minister's position. Congress and NCP's stoic silence has fueled speculation about wnetner Pawar is unwill ing to back Uddhay Thack eray as the Chief Minister if the MVA returns to power. Sharad Pawar's reputation as the strategist of the MVA, his silence on this issue has raised questions and stirred discussions within political circles.

#### 'Take this decision after

Senior Congress leader Prithviraj Chavan had recently remarked that the decision on the Chief Minister's post within the MVA would be made collectively after the elections. NCP President Sharad Pawar agreed, suggesting that discussions on the Chief Ministerial candidate should not take place before the assembly elections. Sena (UBT) MP Sanjay Raut has been strongly advocating and pitching for a pre-poll declaration of the chief

### Pakistan reports three mpox cases; first in Asia

Islamabad: At least three patients with mpox virus have been found so far in Pakistan, it emerged on Friday as the government decided to strengthen the screening system at the

The mpox detection in Pakistan is the first in Asia and it might be more easily transmitted. The World Health Organisation has declared the spread of mpox a global health emergency.

All three patients belong to the Khyber-Pakhtunkhwa province in the northwest, the militancywhacked region bordering Afghanistan.

Salim Khan, the director



general of health services for Khyber Pakhtunkhwa said that two patients were detected on their arrival from the United Arab Emirates, while a third patient's samples had been sent to the National Health Institute in Islamabad for

confirmation. According to the spokesperson of the Federal Ministry of Health, the last patient in whom this virus was found belongs to the Mardan district of Khyber Pakhtunkhwa

It is not yet clear which strain of mpox the said patient contracted and whether it is the same variant that was first confirmed outside of Africa in Sweden.

"Contact tracing of the affected person has been started and samples of more people are being obtained," the spokesman

Officials said that all three patients were being quarantined and their contact tracing was going on.

Pakistan's Ministry of Health also issued an advisorv on the disease on Thursday, which states that "the screening system at airports and entry points is being further strengthened."

Prime Minister's Coordinator for Health Dr. Mukhtar Ahmed Bharath says that federal hospitals have been instructed to take precautionary measures

and the Ministry of Health and Border Health Services are "alert to deal with any kind of situation.

The WHO declared the outbreak of mpox in parts of Africa as a cause of international concern and a threat to public health.

The highly contagious disease, formerly known as 'monkeypox', killed at least 450 people in the Republic of Congo. It is caused by the monkeypox virus, which belongs to the same group of viruses as smallpox but is less harmful.

The virus was originally transmitted from animals to humans, but now it is also transmitted from humans to humans.

#### **Bodies of six** children found

Deoghar/Garhwa: The bodies of six children were recovered from water bodies in Jharkhand's Deoghar and Garhwa districts on Friday. They were identified as Suraj Oraon (11), Manish Minz (13) and Chan-

drakant Kumar (9). According to Deoghar Sub-Divisional Police Officer (SDPO) Ritvik Shrivastava, the bodies of the children were found in a pond in Dodia village. Their parents said the kids were missing since Thursday and after they failed to trace them, they lodged a complaint with police. Another three children drowned in a dam in Jharkhand's Garhwa district on Friday.

Pune: As the Eknath Shindeled Mahayuti coalition looks to solidify its position in the upcoming Maharashtra Assembly election, a question being hotly debated in political circles is the possible impact of the Maharashtra government's recently announced 'Ladki Bahin'

The scheme has sparked significant debate, not just for its potential impact on women's empowerment, but also as a canny political strategy on part of the Mahayuti comprising of CM the Bharativa Janata Party (BJP) and Ajit Pawar's Nationalist Congress Party (NCP). It has also led to tensions within the tripartite ruling coalition, say sources.

Predictably, the opposition Maha Vikas Aghadi (MVA) has been quick to criticize the initiative, branding it as 'an election gimmick'.

The scheme offers 1,500 per month to women earning below 2.5 lakh annually, thus covering lower-middleclass families which would include Muslim and Caste Scheduled communities.

This makes good political sense as in the recently concluded Lok Sabha election, it was clear that the minorities gravitated towards Uddhav Thackeray's Shiv Sena (UBT) over and above the Sharad Pawar-led NCP (SP) and the Congress, which anyway, have been their traditional 'go-to'

parties. To woo these critical constituents towards the Mahayuti, the Mahayuti parties, particularly CM Shinde's Shiv Sena and Ajit Pawar's NCP, who has stressed so often on pursuing 'secular and progressive'

politics notwithstanding its alliance with the BJP, have been extensively promoting this scheme.

<u>'Ladki Bahin' Scheme</u>
Political Game Changer for Mahayuti

The scheme has received enthusiastic support from women following its announcement, with over 1.62 crore registrations recorded as of August 14.

The first phase of the 'Mukhyamantri Majhi Ladki Bahin yojana' officially commenced today, with over 80 lakh eligible women receiving benefits so far, according to Women and Child Development Minister Aditi Tatkare.

She said that till date, Rs.



3.000 for two months' benefits have been deposited into the bank accounts of 80 lakh women across the state. The remaining eligible women are expected to receive their benefits by August 17.

Under this scheme, the government plans to provide financial assistance. healthcare benefits, and educational incentives to girls from economically

The scheme hopes to enhance the quality of life for women and ensure that girls receive the necessary support to pursue education opportunities by giving monthly stipends for girls attending school and college. Healthcare benefits in form of free health check-ups and subsidized medical treatment for women in rural and underprivileged areas and significant educational incentives in form of scholarships and grants for girls pursuing higher education, particularly in STEM fields

are envisioned as part of the project.

For the Mahayuti coalition, led by Chief Minister Eknath Shinde, the scheme represents a strategic move to consolidate its voter base among underprivileged women and rural voters. However, some BJP sources say the party is treading cautiously in promoting a scheme closely linked with CM Shinde and in wooing groups not traditionally aligned with the BJP.

The rollout saw some contretemps after Ravi Rana, an Independent MLA aligned

with the BJP, remarking that

the benefits of the scheme would be reclaimed if recipients did not vote for him in the Assembly elections. NCP (SP) leader Supriya

Sule today hit out at the government over the scheme, accusing it of committing the "sin of fixing a price for a sisters' love" while caustically adding Mahayuti leaders remembered their sisters only after the Lok Sabha elections.

Opposition MVA leaders have also raised concerns about the financial viability of the scheme.

### Tension during protest over anti-Hindu violence in Bangladesh

in Jalgaon and Nashik cities in north Maharashtra on Friday during a bandh called by a Hindu organisation to condemn the atrocities on Hindus in Bangladesh, officials said.

The glass facade of the showroom got damaged, he



"Hundreds of supporters of the Sakal Hindu Samaj took part in the march, and the protesters later went to the collector's office and handed over a memorandum of their demands," the police official said.

The incident triggered tension for some time, but

the situation came under control following the intervention of the local police, he said.

Police personnel were deployed in the city as a precautionary measure, he said.

Jalgaon city is located more than 400 km from Mumbai.

The police resorted to a

mild lathi charge after two groups clashed during a bike rally of the Hindu outfit in Nashik, an official said.

Stones were pelted, and some vehicles were damaged in the clash that erupted after some shops were found open in the Bhadrakali area.

The police resorted to a mild lathi charge to disperse the crowd. There is still tension in the Old Nashik area, but the situation is under control now.

"When the rally was on, some shops were open. It led to a verbal dispute. I appeal to everyone to maintain peace. I have spoken to the commissioner of police and district collector, and the situation is under control," state Minister Girish Mahajan said.

#### Three boys detained for morphing

Pune: The Pune police have detained three Class 10 students of a private school who allegedly morphed and circulated obscene photographs of their classmates on social media, an official said on Friday.

A case was registered under relevant provisions of the Indian Penal Code, Protection of Children from Sexual Offences Act (POCSO) and Information Technology Act with Hadapsar police station, and the boys, all aged 16, were detained on Thursday, the official said.

"One of the boys allegedly morphed photographs of girls from his class on an AI-enabled application and shared it with the others on Instagram," he said.

### Court refuses bail to ED official

Mumbai: A special court in Mumbai on Friday refused to grant bail to Sandeep Chand Yadav, an assistant director of the **Enforcement Directorate** held in a bribery case, after noting there was prima facie evidence to show his involvement.

Yadav, who was arrested by the Central Bureau of Investigation on August 8 for allegedly taking a bribe of Rs 20 lakh from a Mumbai-based jeweller, sought bail after he was sent to judicial custody.

In his plea, Yadav claimed there was no evidence against him and contended he need not languish in jail any further since the investigation into the case was complete. Refusing to accept these

contentions, the court rejected Yadav's bail plea by observing there was prima facie evidence to show his involvement in As per the CBI, the

**Enforcement Directorate** (ED) had earlier this month conducted searches in the premises of jeweller Vipul Harish Thakkar. As per the CBI, Yadav

allegedly threatened to arrest Thakkar's son if he did not pay him Rs 25 lakh. This amount was later reduced to Rs 20 lakh.

Thakkar approached the CBI, which laid a trap and held Yadav when he allegedly accepted the bribe.

#### Man on run held from Haridwar

Palghar: Police in Maharashtra's Palghar district have arrested a man, who had been on the run for allegedly raping his foster daughter in 2021, from Haridwar in Uttarakhand, an official said on Friday.

The accused, identified as Anil Bidlan, had allegedly raped the 19-year-old victim in September 2021 at her house in Nalasopara in the district. After the sexual assault, he also threatened to kill her, he said.

Based on the complaint by the victim, the police had registered an case under sections 376 (rape) and 506 (criminal intimidation) of the Indian Penal Code (IPC).

### "Mahayutiseat-sharingtalksmovingpositively"

Pune: Maharashtra Deputy Chief Minister Ajit Pawar, who heads the Nationalist Congress Party, has said that helming the NCP away from the shadows of his uncle and founder Sharad Pawar after the split is a huge responsibility.

In an interview with PTI during his Jan Sanman Yatra, Pawar said on Thursday that the seat-sharing talks among the ruling Mahayuti partners – NCP, Shiv Sena and BJP – for the assembly polls are proceeding positively.

Ajit Pawar and his loyalist MLAs broke away from NCP in July last year to align with the ruling alliance. He later got the party name and its clock symbol. Party founder Sharad Pawar, who now heads NCP (SP), is a part of the opposition bloc Maha Vikas Aghadi (MVA), also comprising Shiv Sena (UBT) and Congress

'This is the biggest responsibility that I have ever received. Till now, (Sharad) Pawar saheb was our leader and our chief. When I joined politics in 1991, there was no

"When I was in Congress, there were several leaders. Therefore, there was no question about it (extra responsibility). When NCP was formed in 1999... I was given responsibilities only after 2004. Now the final responsibility lies with me because I am the NCP chief."

Speaking about seat sharing for the upcoming state polls, Pawar said he had spoken to Chief Minister Eknath Sninge, who leads the Shiv Sena, and Deputy CM and senior BJP leader Devendra Fadnavis two to three times and the talks were positive.

Everyone wants to contest from maximum seats and a solution will be found, "However, we need to

hold talks with our other alliance partners as well... Let's wait for a few days," said the deputy CM. On being asked if the

polls could be held in November, he said there was such a buzz but added the schedule was the prerogative of the Election Commission and "not in our hands". Aiit Pawar also batted for

an all-party meeting to discuss the demand of the Maratha community for reservation in education and government jobs, saying the opposition parties cannot be neglected since they also represent the people.

"Maratha quota activist



Manoi Jarange wants reservation under the OBC segment. Chief Minister Eknath Shinde had called an all-party meeting to discuss the quota issue but the opposition stayed away. I don't know if the boycott was deliberate. It has been decided to seek their (opposition) time again," he said.

Hailing the Mukhyamnatri Ladki Bahin Yojana, under which women get a monthly aid of Rs 1,500 if their annual family income is less than Rs 2.5 lakh, Pawar said it would be launched on August 17 at an event in Balewadi here with beneficiaries getting money for July and August. CM Shinde and Deputy CM Fad-

It is a transparent scheme in which money is transferred to accounts linked to the beneficiary's Aadhaar.

navis will attend the event.

leaving no room for any illegality, Pawar added.

Slamming the opposition for calling it an election gimmick that would burden the exchequer. Pawar said he had presented 10 budgets and knew about finances.

On the issue of raising resources, Pawar said Manarasntra accounts for 16 per cent of the country's GST collections, with 50 per cent coming back to the

Moreover, the state also has revenue coming in from excise and other taxes. Pawar pointed out.

He refused to speak on the split in the Pawar household

(due to the NCP's break up) and asserted such matters need not be discussed in an open forum just because he was a public figure. "I am a public figure but I would not like to speak about my family. I will speak about my family within the family," he said.

On a question about chances of reuniting with Sharad Pawar, the deputy CM said, "I will only speak about my work and vision for Maharashtra. We will tell people to give us a chance again so that we can bring more funds for the state. The opposition is always negative."

Asked to compare bitter rivals CM Shinde and Shiv Sena (UBT) leader and former CM Uddhav Thackeray, Pawar said, "Everyone is different in behaviour and temperament. But everyone works for Maharashtra's interests and development. Shinde has worked with Thackeray for several years. What happened between them only Shinde can say."

# Resident doctors' strike intensifies

Mumbai: The resident doctor's indefinite strike intensified in Maharashtra on its fourth day on Friday, with their seniors joining the protest, disrupting services at government and civic hospitals and inconveniencing thousands of patients in the state.

Dr Pratik Debaje, president of Maharashtra State Association of Residential Doctors (Central-MARD) told PTI that 6000-7000 senior resident doctors affiliated to the Maharashtra Association of Bonded Resident Doctors (MA-BRD) and the Association of State Medical Interns (ASMI) joined the strike

"17,000-18,000 (resident) doctors in Maharashtra are on strike at present," Debaje said.

Resident doctors in the state launched an indefinite strike on Tuesday morning to express solidarity with the nationwide agitation against the rape-murder of a postgraduate trainee in Kolkata's RG Kar Medical College and Hospital last week

On the fourth day of the resident doctor's strike, elective services, including OPDs, OTs, and lab procedures, remain affected due to the strike, causing inconvenience to thousands of patients in Mumbai and other parts of the state.

Emergency services, however, continue uninterrupted, said officials. The Central-MARD has demanded an impartial and transparent investigation into the Kolkata

incident, speedy formation of an expert committee for implementation of the Central Healthcare Protection Act, improved security measures, including fully functional CCTVs and well-equipped guards, quality hostels, and proper on-call rooms

Debaje said that the resident doctors at JJ Hospital in Mumbai and other major hospital campuses are peacefully protesting over their demands, but they have planned a sit-in at Azad Maidan in the Fort area later in the day. A large number of resi-

### HC issues summons to Narayan Rane on UBT leader's plea

Mumbai: The Bombay High Court on Friday issued a summons to BJP MP Narayan Rane on Shiv Sena (UBT) leader Vinayak Raut's plea seeking cancellation of the former's election from the Ratnagiri-Sindhudurg constituency.

Rane defeated Raut, a two-term MP, by a margin of 47,858 votes in his debut election for Lok Sabha. He polled 4,48,514 votes, while Raut secured 4,00,656 votes.

Raut had last month filed an election petition in the high court, claiming that Rane had won the polls by "fraudulent means", and demanded the cancellation of the BJP leader's election from the Ratnagiri-Sindhudurg seat and that he be banned from contesting elections and voting for five

Despite having a female Chief Minister, women in Bengal are not safe and their rights are being violated. Whether it's

in Sandeshkhali, Chopra,

or Kolkata, these recurring incidents make it clear that women are far from being safe in the state."

In the case of rape and

brutal murder of a female PG Doctor in a government hospital in Kolkata, Mamata Banerjee delayed the transfer of the case to the CBI by several days and failed to ensure a proper investigation of the crime scene. This delay also resulted in the tampering and destruction of crucial evidence. A swift investigation and immediate action against the culprit were necessary. However, due to the failure of Mamata Banerjee's administration, the perpetrator remains free despite committing a heinous crime, Shukla added. He

also accused Ms Banerjee of shielding culprits like she did with Sheikh Shahjahan.

Congress and INDI Alliance leaders become the firsts to politicize issues in BJP-ruled states, but remain silent on Bengal. Will the response to atrocities against women depend and vary according to the state and coalition involved?, Shukla asked.

### **A Calculated Bid**

ddhav Thackeray's ambition to be the Chief Ministerial face of the opposition Maharashtra Vikas Aghadi (MVA) in the forthcoming Maharashtra Assembly election reflects a complex interplay of personal, political, and strategic considerations. It is a calculated gamble that seeks to address both personal and political imperatives. However, the success of this ambition will depend on his ability to navigate the complexities of alliance politics where the MVA's cohesion will be rigorously tested.

Thackeray's desire to lead the opposition bloc stems from a need to reassert his relevance in Maharashtra's political landscape. After the dramatic fall of his government in June 2022, following a rebellion within his party led by CM Eknath Shinde, Thackeray has been on a quest to rebuild his stature. His projection of himself as the face of the MVA is not merely a bid for power but an existential necessity, a strategic move to consolidate his leadership within his party and the broader opposition, offering him a platform to challenge the BJP and Shinde's faction.

For Uddhav Thackeray, vying for the Chief Ministerial candidacy is also a deeply personal mission to restore the Thackeray legacy. The Sena, founded by his father Bal Thackeray in 1966, has long been synonymous with Mumbai's and Maharashtra's politics. The intraparty split and the subsequent loss of the Chief Ministership have been perceived as a significant blow to this legacy. By leading the MVA, Uddhav seeks to reclaim the political narrative and restore his family's dominance in State politics.

This quest is also fuelled by the need to avenge the perceived betrayal by Shinde and BJP leader Devendra Fadnavis and to re-establish the Shiv Sena (UBT) as the rightful heir to the Thackeray brand.

However, Thackeray's ambition places the MVA in a delicate situation. The alliance, comprising the Shiv Sena (UBT), the Nationalist Congress Party (NCP), and the Indian National Congress (INC), was originally forged out of a shared antipathy towards the BJP after the 2019 Assembly election result.

While Thackeray may be a unifying figure against a common adversary, his leadership within the MVA is not without controversy. The NCP, under Sharad Pawar, and the Congress, buoyed by their resounding success in the recently concluded Lok Sabha election, will be disinclined to cede ground unconditionally to Thackeray whose strike rate was the lowest among the three MVA allies

The case of the Sangli Lok Sabha seat before the Lok Sabha, which saw the Congress and the Sena (UBT) nearly coming to blows, is microcosmic of the inherent schism within the MVA. The challenge for the MVA is to balance competing ambitions of all three parties while presenting a united front. Thackeray's insistence on being the Chief Ministerial candidate could strain this fragile alliance, risking the very unity that is its strength

## Death of Bangabandhu's Dream

Bangabandhu bestowed his land with a secular Bengali identity. His dream of independent secular Bangladesh was reduced to ashes merely within 50 years!

With freedom comes responsibility. To retain sovereignty, we must have wisdom, power, and a strong sense of emotion that leads us towards independence! For secularism, the country needs a common legal framework to ensure a conducive sociopolitical environment!

The electricity grids reached farflung areas; Sheikh Hasina's leadership, Bangladesh transformed from a struggling nation into a new 'Asian Tiger'. The electricity grids reached farflung areas; Sheikh Hasina built infrastructure previously unseen in Bangladesh. In 2020 Bangladesh's ranking on the Global Youth Development Index was 126 of 181 countries, in the middle among Bharat's rank 122 and Myanmar 130. Yet compliance with labour rights, accessibility to health insurance, minimum wage rate, unemployment benefits were few of the areas where Sheikh Hasina's government was limping along.

During her tenure, Bangladesh emerged as the second largest readymade garment (RMG) exporter in the world. The RMG sector alone contributes a whopping 85% of its export revenue. Heavy reliance on garment industry, ignoring the potential of other competitive merchandise, absence of diversification weakened the import-export dynamics of Bangladesh and made the country vulnerable to external pressure. The imposition of excessive trade and exchange controls also reduced capital flow, dropped forex reserves and hampered its manufacturing growth. Declined GDP, rising trade deficits and unemployment rate brought "the miracle development" under scrutiny.

With 80% of its key exports directed only towards Western markets, Bangladesh's vulnerability to external pressures becomes very much evident. For instance, the World Bank declined the Padma bridge loan to Sheikh Hasina on the pretext of corruption that later judicially proved to be non-existent! In response to the western political bullying, Sheikh Hasina completed the project with internal finance. By the end of 2021 the United States banned Bangladesh's Rapid Action Battalion, a premier counterterrorism force, unilaterally!

The strained relations with the West made Sheikh Hasina's government attract Russia for the imports of food grains and arms. Russia also financed Bangladesh's 1st nuclear power plant. Bypassing US sanctions on Russia, Hasina's government agreed to repay Russia in Yuan. In Nov 2023, Russian warships entered Bangladesh's Chittagong port for joint exercises. Sheikh Hasina's efforts to strengthen defence trade with China and Russia alarmed the West, The Great-Power Competition in Bay of Bengal and Sheikh Hasina's refusal to sign a Military Infor-



mation Agreement with the US reportedly irked Washington.

With the heavy media criticism, restrictive policies and pressure tactics US had pushed itself backward in its competition with China and Russia for influencing Hasina-led Bangladesh!

Hasina's government faced various massive protests throughout her tenure. The June 2024 episode came as a final nail in the coffin for Hasina's Awami League government. The student protest was infiltrated by radical Islamists and other anti-government elements. Sheikh Hasina's supporters were murdered, and her government was overthrown for "the democratic future" of Bangladesh!?

Sheikh Hasina's 15 years long governance had failed to protect minority interests. She could only prevent extremists from making things worse. In this muslim majority land, Hindu population decreased since 1952 from 22% to 7.95% in 2022; the other minorities in Bangladesh share the same fate. The Awami League that once dropped the word 'Muslim' from its name to form a 'secular' Bangladesh could not counter anti-secular elements as it imposed threat to their political power and survival.

It is not just the radicals or anti-government elements that caused the fall of Sheikh Hasina's Awami League. Nepotism and corruption are equally to blame. Sheikh Hasina's 8 family members were entrusted with key responsibilities in Bangladesh's government regardless of their qualification. Four of them who were elected MPs had amassed a huge

wealth. Her son, ICT adviser to the Bangladesh government, was accused of corruption too. Sheikh Hasina's peon who was nicknamed "Pani Jahangir" as he used to carry drinking water for her, pocketed a fortune worth Tk400 crore! The complete control over national apparatus invariably breeds autocracy, discounts the leader's integrity and then the stench of corruption grows stronger.

On 5th Aug 2024 Protesters set fire to 'Bangabandhu Memorial Museum'. Father of the Nation 'Bangabandhu' Sheikh Mujibur Rahman and his family members were assassinated in this same house, on 15th August 1975. The place that witnessed the new dawn of Independent democratic Bangladesh was looted by own countrymen. Bangabandhu gave their land a secular Bengali identity. Within 50 years, his dream of independent secular Bangladesh was reduced to ashes. The bullet trounced the ballot, once again! The literary legacy of the Bengal Renaissance could not shape the country's future the way it did in the past. The idea of nationalism, rights and social justice could not flourish in Bangabandhu's land.

With freedom comes responsibility. To retain sovereignty, we must have wisdom, power and a strong sense of emotion that led us towards independence! For the reinforcement of democracy, trust and cooperation are essential. For the positive secularism, the country needs a common legal framework to ensure a conducive socio-political environment!

he word 'reservation' acts like an alert or an alarm, impacting not just specific castes and categories but the entire population. The Supreme Court of India said it was considering implementing sub-caste reservations within pre-decided caste categories. Reservation issues remain a national concern, not only for a single state but for the whole nation.

Maharashtra, Gujarat, Rajasthan, Uttar Pradesh, Bihar, Chhattisgarh, Karnataka, and Punjab have all experienced significant reservation-based violence. Mayawati criticised the Supreme Court's decision to sub-classify Scheduled Castes (SC) and Scheduled Tribes (ST) communities, calling it "unfair" on Twitter. She argued that the reality contradicts the official statements, with various caste groups having their own grievances. Her remarks signal a strong rejection of the SC's decision and reflect political motives, with the BSP chief also accusing Congress of supporting sub-classification. The current situation remains disconnected from the real issues at

It's important to understand that the reservation system is not designed solely to alleviate poverty for specific castes or classes. Rather, it aims to create equitable opportunities for marginalized groups, including migrants and those at the lower end of the social spectrum. SC and ST classifications address specific groups, but some privileged classes perceive this as merely a quota system. Every few years, a designated team selects a prominent leader from the depressed


classes to represent them. However, the leader's effectiveness often reflects their caste's influence, and policies tend to impact the entire caste rather than benefiting individuals broadly. Ideally, a leader should address the needs of the entire category, but often, the results are confined to specific castes.

The National Congress President, Mallikarjun Kharge, announced that before finalising the party's stance on the sub-classification of SCs and STs, they will consult NGOs, lawyers, and other stakeholders. This suggests that Congress may support sub-classification. BSP leader Mayawati's tweet critiques not only Congress but also resonates with the common people who face persistent challenges. From railway tickets to highway tolls and recruitment forms, many feel stuck in a system where certain classes always seem to benefit more, highlighting a disparity between official policies and everyday realities

Lok Janshakti Party Chief, Ram Vilas, and Union Minister, Chirag Paswan criticised the Supreme Court's SC classification, stating it ignored the principles of untouchability, which were central to the original classification. This marks the first time during the Modi government that a leader has publicly countered a position taken by the senior leadership.

The Supreme Court's comments have had a big impact on Indians. We await the next hearing for further developments.

### The Supreme Court on juvenile

he Supreme Court has said bail cannot be denied to a juvenile in a criminal case unless the court records that the minor is likely to be associated with a known criminal, be exposed to moral, physical or psychological danger, or his release would defeat the ends of justice.

A bench of Justices Abhay S Oka and Augustine George Masih set aside the orders of the Rajasthan High Court and juvenile justice board denying bail to a juvenile, who was booked for sexually assaulting a minor.

"....the impugned orders are set aside. The appeal is accordingly allowed," the bench said while noting that the juvenile in conflict with law has been in custody for over one year, and directed that he shall be released on bail without surety.

"However, the jurisdictional Juvenile Justice Board shall issue appropriate directions to the jurisdictional Probation Officer to keep the juvenile under supervision and to submit periodical reports to the Board about the conduct of the Juvenile," the bench said in its order of August 14.

Referring to the provisions of the

Juvenile Justice (Care and Protection of Children) Act, 2015 (JJ Act), the bench said that from the phraseology used in sub-section 1 of Section 12, a juvenile in conflict with law has to be "necessarily released on bail", with or without surety, or placed under supervision of a probation officer or under the care of any fit person unless proviso is

The bench referred to the proviso to sub-section 1 of section 12 which said, "Provided that such person shall not be so released if there appears reasonable grounds for believing that the release is likely to bring that person into association with any known criminal or expose the said person to moral, physical or psychological danger or the per-

son's release would defeat the ends of justice, and the Board shall record the reasons for denying the bail and circumstances that led to such a decision".

It said the court has perused all the orders passed earlier by the JJ Board, the special court and high court, and especially the order dated December 11, 2023 passed by the JJ Board.

"There is no finding recorded that the proviso to sub-Section 1 of Section 12 is applicable to the facts of the case. Without recording the said finding, bail could not have been denied to a juvenile in conflict with law," it said.

The top court said its attention is invited to the psychological assessment report of the juvenile which records that he does not belong to high risk category, and against the column "worry list of child" it is mentioned that there was "no worry". The report is signed by a qualified clinical psychologist, it noted.

## The Lumumba Plot: A Cold War Tragedy in the Congo

Stuart Reid's stunning debut book unravels the gruesome assassination of Patrice Lumumba in 1961, the first democratically elected Prime Minister of Congo, and the CIA's involvement in it

s neighbouring Bangladesh burned, suggestions that America's Central Intelligence Agency (CIA) had undermined Sheikh Hasina's regime emanated from certain quarters. Other geopolitical experts have rubbished these 'conspiracy theorists' for resurrecting the CIA

Whatever the truth, the shadowy hand of the CIA in a Cold War assassination of a democratically elected leader 60 years ago in Africa's resource-rich Congo now shines in full light in form of Stuart Reid's enthralling 'The Lumumba

An executive editor at the prestigious Foreign Affairs magazine, Reid has meticulously crafted the rise and downfall of the charismatic Patrice Lumumba, the Congo's first democratically elected prime minister who was assassinated by Congolese adversaries in September 1961 after remaining in office a mere 67 days.

More than just a tale of Congolese politics, Reid's book is haunting meditation on the global forces that conspired to seal fate of an emerging African nation


Hailed by his countrymen, Lumumba, a pan-Africanist by disposition, was regarded by the outside world - including then U.N. Secretary-General Dag Hammarskjold – with suspicion and considered unpredictable and unsuited for leadership.

Worse, a paranoid U.S. thought Lumumba an alleged 'pawn' of Soviet interests in a newly decolonized Africa in the grip of the Cold

1960 was a turning point for Africa, as 17 countries including Congo - a Belgian fief since the 19th century - threw off the yoke of European colonialism and gained independence from European colonial powers.

Even as Belgium reluctantly prepared to relinquish control over the resource-rich region, independence was celebrated on June 30, 1960 with Lumumba, the leading advocate for a unified Congo free from external influence, being appointed prime minister. However, the hardwon independence quickly unravelled owing to internal conflicts within the Congolese leaders, triggering secessionist movements in South Kasai and Katanga which was aggravated by continued Belgian meddling.

Lumumba request for U.N. assistance received a lukewarm response, as Hammarskjold's peacekeepers were instructed to maintain neutrality. Reid's books shines in its analysis of U.S. culpability, with the role of an aging and uninterested President Dwight D. Eisenhower in Lumumba's ousting par-



It highlights the extent of CIA skullduggery (hitherto unknown) in persuading Lumumba's one-time aide, Col. Joseph Mobutu to stage a coup and assassinate Lumumba. The CIA's clumsy attempts, which included an aborted plan to poison Lumumba's toothpaste, ultimately failed. Instead, Lumumba was killed by his Congolese adversaries, with Belgian complicity, just days before John F. Kennedy's inauguration in January 1961.

Reid's prose is deliciously cinematic, whether describing riots in Leopoldville or power struggles in the Congo, Brussels and Washington and his pace matches the best thrillers by Eric Ambler or John le

He is extremely good on the relationship between Lumumba and Mobutu, which was simultaneously marked by camaraderie and deep-

seated mistrust. Lumumba, the idealist and orator, holding Svengalilike sway over the masses, envisioned a Congo free from the shackles of colonial influence - a dream that Mobutu, the Machiavellian military tactician, ruthlessly shattered during his 32-year rule as a US-backed strongman

Reid is equally superb in etching the character of Larry Devlin, the CIA station chief in Leopoldville, whose covert operations were instrumental in orchestrating Lumumba's downfall.

Devlin's cold pragmatism, combined with Washington's paranoid fear of communist influence in Africa, led to a colossal misjudgement that would not only seal Lumumba's fate but also plunge Congo into decades of turmoil.

Reid's work culminates with a thoughtful counterfactual: What might Congo have become if the U.S. had supported, rather than undermined, Patrice Lumumba?

His book is arguably the finest and most thrilling narrative work on the Congo since Adam Hochschild's modern classic 'King Leopold's Ghost' (1998) which detailed the rapine of this bedevilled African state.

In 1939, cinematic wunderkind Orson Welles set out to film Joseph Conrad's classic novella 'Heart of Darkness' (a standard marker for race and colonialism) set along a treacherous river voyage on the Congo as an anti-fascist allegory. The film never got made.

But Reid has written a literary equivalent of Welles' cinematic

Decoding Food Labels: Protecting Your Health from **Hidden Contaminants**

n our routine lives, we consume a wide variety of food products, both fresh and processed. But how often are we really concerned about food safety and quality? Even while the government monitors and regulates these aspects, it is essential for each of us to be vigilant as well. Simply observing hygiene during preparation and delivery is not sufficient. We must also consider other factors

- Physical contaminants: Foreign materials like metal etc., which can be easily detected and removed.
- Chemical contaminants: Adulterants like detergents, pesticide residues, permissible and non-permissible additives, veterinary residues etc
- Foodborne Microorganisms: Food pathogens like bacteria, viruses, moulds, etc. Understanding and reading food labels is key to safeguarding against these risks.

#### Food Labels - What to check.

The food or nutritional label visible on the backside of packaged food is a mandatory regulation enforced by the Indian Government (FSSAI - Food Standard and Safety Authority of India) and other international bodies. In addition to the standard content like carbohydrates, proteins, fats, and calorific value, the label also includes other important information like sugar, types of fats, such as cholesterol, and, most importantly, preservatives and additives

Rather than getting swayed by the claims on the front, consumers should check and verify labels printed on the backside of the packaging. You might have come across various words in advertisements and on labels like organic, low sugar, low fats, keto, whole food, added sugar or minerals, no preservaWhile consuming food products, both fresh and processed, how much attention do we pay to the risks they may harbour? **Government regulations** help, but personal vigilance is equally essential.

tives, additives, and many more. One more important factor on the label is the allergen claim. It is mostly found on export materials or in foreign countries. Do you fully understand what the claim from the manufacturer's side is or what exactly it means? As responsible and health-conscious individuals, we must understand this.

In addition to nutritional content, other important information to be checked on labels are - FSSAI Licence number, Veg-Non-Veg-Fortified logos, manufacturing and expiry dates, serving size, net weight, and other relevant information as per the claims. Here are some logos for your reference:

## Opposition continues to rattle sabres with ruling coalition

haravi sits in stark contrast to the adjacent Bandra-Kurla Complex (BKC), the showpiece of the new global Mumbai since Liberalisation and Globalization gathered steam in the country after 1991.

Last month, former Maharashtra Chief Minister and Shiv Sena (UBT) chief Uddhav Thackeray went on the offensive by advocating the ouster of Adani Realty from the project.

"We will scrap the Dharavi slum redevelopment project contract after coming to power and float a fresh one. We will not allow Mumbai to be turned into Adani city," said Thackeray, warning that his party workers would hit the streets against the project.

In December 2023, Thackeray led a protest rally against the Mumbai office of the Adani Group (sited at BKC) to protest against the concessions provided to the conglomerate in the Dharavi redevelopment project work.

Thackeray demanded that the citizens of Dharavi ought to be relocated there itself because of their livelihood, which mostly depends on man-

ufacturing products. "The Dharavi residents must get a space of 400 to 500 sq feet each. Around 80,000 to 90,000 slum dwellers are still shown as ineligible to be qualified for the space after redevelopment. I want to ask Adani what he is going to do about it. The government is helping the industrialist," he said, trading barbs at the industrial while hinting at the close ties between Adani and PM Modi.

Thackeray, who has often said that he would not permit the transformation of Mumbai city into an 'Adani city', has lashed out against the 'concessions' given by the Eknath Shindeled Mahayuti government, dubbing it the world's biggest "Transfer of Development Rights (TDR) scam.

He further alleged that one of the reasons for the BJP to pull down the erstwhile Maharashtra Vikas Aghadi (MVA) government led by him was to award the revamp project contract to the Adani group.

Thackeray was alluding to the alleged tweaking of the TDR rule through a notification issued by the Urban Development Department (UDD) headed by Chief Minister Eknath Shinde last year.

The notification makes it mandatory for the builders in Mumbai to buy first 40% of their required TDR for their projects from the Dharavi Project before utilising other TDR.

As per the Opposition, this provision reportedly gives the Adani group a large readymade market for the TDR which will be generated from the Dharavi redevelopment project. It allows the Adani group to



charge up to 90 % of the ready reckoner value of the receiving plot as the TDR rate.

Thackeray has alleged a potential TDR scam exceeding Rs 100 crore based on this easing of rules

On his part, Shinde has defended his move to provide incentives. "The real estate sector is not in very good shape and needs a boost. This incentive will ensure that Dharavi residents get their rightful homes," said the CM, accusing his opponents of an 'anti-developmental' disposition.

The Opposition Congress jumped into the fray with Congress leader Varsha Gaikwad, former four-term MLA of the Dharavi Assembly constituency and newly-minted MP, alleging that Adani had roped in former police officers and encounter specialists to threaten the residents to vacate their homes

The allegations were refuted by former MP and Eknath Shinde-led Shiv Sena leader Rahul Shewale, who in turn accused Thackeray of trying to derail the revamp project. The Dharavi revamp project, brain-

During the first round of tenders in 2007, there were 101 bidders. This



dropped to a mere two in 2019. This last tender elicited much hope as a company backed by the United Arab Emirates (UAE) royals became the highest bidder and were all set to undertake the project.

However, the whole tender process was scrapped on technical grounds.

In February 2019, Seclink Technology Corporation (STC) won the bid to transform India's largest slum pocket by outbidding Adani Infrastructure and Developers Private Limited. STC bagged this project as it had quoted Rs 7,200 crore, outbidding its competitor who bid at Rs 4,539 crore.

However, trouble brewed after the then BJP government led by Devendra Fadnavis acquired the railway land and Rs 800 crore was paid to the Railways. As this was not mentioned in the tenders, the attorney general's views were sought on the matter with the AG. Ashutosh Kumbhakoni, stating that fresh tenders needed to be called for as the costs of the railway land and rehabilitation had not been incorporated in the original tender

This was accepted by the Uddhav Thackeray-led MVA government (which had replaced the Fadnavis regime after the 2019 Assembly election) which in October 2020 cancelled this tender.

In November 2022, the Adani group finally won the bid to revamp Dharavi. Adani has appointed well known architect Hafeez Contractor, design firm Sasaki, and consultancy firm Buro Happold as city and infrastructure planners for the project. It plans to invest Rs 21,000 crore in the first phase of the project.

Eligibility is another major issue dogging the project. The contentious issue is that there are more than 0.2 million hutments whereas the official figure is that only 69,160 are legal entities eligible for new houses.

In fact, in the preliminary survey conducted by the Brihanmumbai Municipal Corporation (BMC) in 2009 in Sector 4, it was found that only 37% residents were eligible for new homes. This survey had sparked widespread fear that the majority of Dharavi's residents would be deprived of new houses in the revamp project.

#### **Electric shares** deliver 75% returns in 1 week

On Friday, the stock of Ola Electric reached a record high of Rs. 133. The shares opened at Rs. 76 the last Friday, marking a 75% increase for investors in just one week. Currently, Ola Electric is valued at Rs. 58,664 crore (\$6.99 billion).

The international investment bank HSBC has initiated coverage on the stock with a 'buy' rating and a target price of Rs 140 per share. HSBC believes that Ola Electric is a good investment due to ongoing regulatory support. "Ola Electric has the ability to cut costs, with positive risk-reward in its battery venture," the brokerage firm reportedly said.

Meanwhile, the Indian two-wheeler sector is expected to expand at a compound annual growth rate (CAGR) of 11%, reaching a market value between Rs 2.8 trillion and Rs 3.6 trillion by the fiscal year (FY) 2028.

The company has also announced plans to manufacture its own batteries for electric vehicles starting in the first quarter of fiscal year (Q1) 2026, which will provide it with a competitive advantage through more efficient cost structures. The battery is currently undergoing testing at Ola's Gigafactory

In the first quarter of fiscal year (Q1) 2024, Ola Electric achieved its highest quarterly earnings of Rs 1,718 crore, capturing 48.63% of the market share. This figure represents a 34.2% increase from the previous year's quarter (Q1FY23) earnings of Rs 1,279 crore. Buy rating from HSBC, stellar quarterly results and announcement of integration of its own cells in 2-wheelers fuelled the rally in this

### India's FTA with Bangladesh may be put on backburner: Rating agency

agreement with Bangladesh is seen on the back foot, due to the ongoing political crisis in the South Asian nation, according to a report by rating agency.

"The current scenario may lead to deferment or slowdown of fresh investments by Indian companies in the neighbouring country pending the establishment of a stable government. The proposed FTA with Bangladesh will also be put on the backburner under the current circumstances," said Suman Chowdhury, Chief Economist and Head-Research, Acuité Ratings & Research.

Bangladesh may experience a severe shortage of foreign exchange, which hampers its ability to pay for imports while Indian exporters may face payment delays and challenges in receiving payments for their goods. This financial strain can further disrupt trade relationships and lead to a decline in exports,



the report said.

Though Bangladesh accounts for only 1.2 percent of India's aggregate trade volumes, the latter has a healthy trade surplus with Bangladesh (USD 9.3 bn in FY24) with significant exports of cotton yarn, agricultural items, engineering goods and chemicals.

In the short term, exports to Bangladesh are likely to be adversely impacted as much as imports which might have a moderate impact on India's merchandise, said the report by Acuité Ratings & Research.

Indian manufacturing and infrastructure companies having business or project operations or supply linkages therein are likely to witness some disruption and uncertainty in the near term, Chowdhury said.

The crisis in Bangladesh may lead to rising inflation and reduced domestic demand, which may lower the overall consumption of both local and imported products. This economic downturn can further strain bilateral trade as demand for Indian exports declines, the report said.

#### **ED** attaches assets of **Pearlyine**

New Delhi: The Enforcement Directorate on Friday said assets worth more than Rs 29 crore have been attached under the anti-money laundering law as part of an investigation against a fraud investment website that ran a Ponzi scheme across the country.

The action has been taken against the portal --www. pearlyine.com -- that runs under the banner of Pearlvine International, the central agency said in a statement.

The money laundering case stems from an FIR filed by the CID of Meghalaya Police on a complaint made by the RBI.

Pearlvine International was an "unrecognised" entity, which claimed itself to be US-based and provided several lucrative investment options. It collected a minimum amount of Rs 2,250 as membership fees and ran a Ponzi scheme in India between 2018 till March, 2023, the **Enforcement Directorate** (ED) said

### Adani Power will continue to supply power to Bangladesh

New Delhi: Adani Power on Friday said it will continue to supply power to Bangladesh from its 1,600MW Jharkhand plant, set up to supply 100 per cent electricity generated from the facility to the neighbouring nation.

Earlier this month, the power ministry amended power import/export guidelines to enable electricity supply from plants set up as an export-oriented unit to sell power within India. The amendment provides

that the government may permit connection of such generating station to the Indian grid (inter-state or intra-state grid) to facilitate the sale of power within India 'in case of sustained non-scheduling of full or part capacity or default notice issued by the generator for any default, including delayed payment under the PPA (power purchase agreement)'.

Adani Power's 1,600 MW Godda plant is probably the only plant in the country which has been set up with a commitment of 100 per



cent electricity supply to Bangladesh.

In a statement, Adani Power explained the amendment to India's Power Export Guidelines is an industry-enabling universal provision aimed at streamlining power export processes without altering existing arrangements.

"We have been providing uninterrupted power to Bangladesh from our Godda plant. We understand the importance of reliable power supply to Bangladesh and are committed to fulfilling contractual obligations as per BPDB's demand schedule and provisions of PPA," the company stated.

The government's decision to allow the power plant with export commitment to supply electricity within India follows the recent political crisis in Bangladesh.

### New South Wales eyes India

Mumbai: With more direct air connectivity between Sydney and India and seamless visa approval through e-visa application process, New South Wales (NSW) is eyeing double digit growth in tourist arrivals from India this calendar year.

"We are witnessing a steady growth in international tourist arrivals. In the calendar year 2023, we welcomed 1.81.600 tourists from India. Looking at the current trend coupled with

more direct flights connecting India with Sydney, rise in disposable income, and easy e-visa application process, we are expecting to boost our tourism and the footfalls are likely to grow in double digit," Destination NSW Country Manager Samar Chokshi told PTI.

NSW welcomed 3.4 million international visitors, a 104 per cent increase compared to 2019, which is pre-Covid time, he noted. Quoting data from International Visitor Survey, Tourism Research Australia, Chokshi

said, in 2023 Indian visitors stayed a total of 7 million nights in NSW, contributing AUD 482.2 million to the state's economy, marking a 109 per cent increase in expenditure compared to 2019.

"On average, Indian visitors spent AUD 69 per night and AUD 2,655 per visitor, with an average length of stay of 38.3 nights. India ranked sixth in terms of the number of visitors and expenditure, and third in terms of nights stayed among all international visitors to NSW.

### RBI imposes penalties on banks

bank's reply to the notice,

oral submissions made during the personal hearing and exami nation of additional submissions made by it, RBI found that the charges against the bank were sustained, warranting imposition of monetary penalty.

### FDI in food processing sector down 30 pc

New Delhi: Foreign direct investment (FDI) in India's food processing sector declined 30 per cent in the last fiscal to Rs 5,037.06 crore, according to official data.

The FDI in the food processing sector stood at Rs 7,194.13 crore in 2022-23.

According to the data presented by the Food Processing Industries Ministry in Lok Sabha, the FDI in food processing sector stood at Rs 5,290.27 crore in 2021-22 and Rs 2934.12 crore in 2020-21

FDI was Rs 6,414.67 crore in 2019-20; Rs 4430.44 crore in 2018-19; Rs 5,835.62 crore in 2017-18; Rs 4,865.85 crore in 2016-17; and Rs 3.312 crore in 2015-16 in the food processing sector.

In order to enhance foreign investment in the food processing sector, the ministry has taken various measures, including 100 per cent FDI permitted through automatic route for the food processing sec-



regulations. It has allowed 100 per

cent FDI, under the government-approval route, for trading including through e-commerce, in respect of food products manufactured or produced in India.

The government has exempted all processed food items from the purview of licensing under the Industries (Development and Regulation) Act, 1951.

There is a lower GST for raw and processed products. More than 71.7 per cent of food products under various chapter heads/subheads are covered in lower tax slabs of 0 per cent and 5 per cent.

The export of processed foods declined 17 per cent to USD 10,881.81 million in 2023-24 from USD 13,078.3 million in the preceding

For the development of

this sector, the ministry is implementing the Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) and Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Prime Minister Formalization of Micro Food Processing Enterprises (PMFME) schemes.

All these three schemes are demand-driven and implemented across the country.

### FSSAI scales up training for vendors

A meeting was held in Mumbai under the chairmanship of Bhushan Varsha Ashok Gagrani, Commissioner of Municipal Corporation of Greater Mumbai (MCGM), to make a strategy

for ensuring safer street food. The meeting, attended by the Food Safety and Standards Authority of India (FS-SAI) CEO and other senior officials, focused on elevating Mumbai's street food to global safety and hygiene standards by exploring the development of Healthy and Hygienic Food Streets (HHFS) in the city, according to a statement issued by the regulator on Friday.

Representatives from Thane, Nagpur, Nasik, and Pune Municipal Corporations, also attended the meeting.

In the meeting, the issue of ensuring safe, healthy and sustainable food was discussed for the food being sold by street food vendors.

"Just as the theme of Har

Ghar Tiranga, orange colour shall ensure safety, white shall ensure healthy and green shall ensure sustaina-

ble food," the statement said.

According to the statement. Gagrani said that Mumbai is renowned for its vibrant and diverse street food culture, which attracts both locals and tourists.

He said that stringent training of street food vendors would ensure widescale availability of safe street food in the city, making it even more popular.

Rao said FSSAI's Food Safety Training and Certification (FoSTaC) programme equips food handlers with the knowledge of the latest food safety and hygiene

He said the "FSSAI is significantly scaling up training programmes across the country, which would also see a large increase in the number of trained street food vendors in Mumbai".

KH Govindraj, Principal Secretary, Urban Development Department and Pritee Chaudhary, Regional Director, FSSAI West Region also attended the crucial meeting held on August 13, 2024, to discuss strategies to strengthen food safety measures in the city.

### **India** initiates anti-dumping probe

New Delhi: India has initiated an anti-dumping probe into the import of hot rolled steel products from Vietnam following a complaint by a domestic

The commerce ministry's investigation arm Directorate General of Trade Remedies (DGTR) is probing the alleged dumping of 'hot rolled flat products of alloy or non-alloy steel'.

According to the DGTR notification, Indian Steel Association has filed an application on behalf of domestic producers - JSW Steel Ltd and ArcelorMittal Nippon Steel India Ltd - seeking initiation of an anti-dumping investigation on imports from Vietnam.

The applicants have alleged that the product is being imported at dumped prices which is causing material injury to the domestic industry.

They have also alleged that there is a further threat of injury to the domestic industry due to dumped imports and have requested for imposition of anti-dumping duty.

## TikTok fights forced sale or ban


Thursday pushed back against US government arguments that the popular social media platform is not shielded by the First Amendment, comparing its platform to prominent American media organizations owned by foreign

Last month, the Justice Department argued in a legal brief filed in a Washington federal appeals court that neither TikTok's China-based parent company, ByteDance, nor the platform's global and U.S. arms – TikTok Ltd. and TikTok Inc. — were entitled to First Amendment protections because they are "foreign organizations operating abroad" or owned by one.

TikTok attorneys have made the First Amendment a key part of their legal challenge to the federal law requiring ByteDance to sell TikTok to an approved buy-

On Thursday, they argued in a court document that TikTok's U.S. arm doesn't forfeit its constitutional rights because it is owned by a foreign entity. They drew a parallel between TikTok and wellknown news outlets such as Politico and Business Insider, both of which are owned by German publisher Axel Springer SE. They also cited Fortune, a business magazine owned by Thai businessman Chatch-

aval Jiaravanon. 'Surely the American companies that publish Politico, Fortune, and Business Insider do not lose First Amendment protection because they have foreign ownership," the Tik-Tok attorneys wrote,



arguing that "no precedent" supports what they called "the government's dramatic rewriting of what counts as protected speech.'

In a redacted court filing made last month, the Justice Department argued ByteDance and TikTok haven't raised valid free speech claims in their challenge against the law, saying the measure addresses national security concerns about TikTok's ownership without targeting protected speech.

The Biden administration and TikTok had held talks in recent years aimed at resolving the government's concerns. But the two sides failed to reach a

TikTok said the government essentially walked away from the negotiating table after it proposed a 90page agreement that detailed how the company planned to address concerns about the app while still maintaining ties with

However, the Justice Department has said TikTok's proposal "failed to create sufficient separation be-

tween the company's U.S. operations and China" and did not adequately address some of the government's concerns.

The government has pointed to some data transfers between TikTok employees and ByteDance engineers in China as why it believed the proposal, called Project Texas, was not sufficient to guard against national security concerns. Federal officials have also argued that the size and scope of TikTok would have made it impossible to meaningfully enforce compliance with the proposal.

TikTok attorneys said Thursday that some of what the government views as inadequacies of the agreement were never raised during the negotiations.

Separately the DOJ on Thursday evening asked the court to submit evidence under seal, saying in a filing that the case contained information classified at "Top Secret" levels. TikTok has been opposing those requests.

Oral arguments in the case are scheduled to begin

### **State govts** may follow Jharkhand

Mumbai: Several state governments including Karnataka, Chhattisgarh, Maharashtra may follow Jharkhand in levying new cess on mining activities following the Supreme Court order, according to a

The Jharkhand government was first to move and levied additional cess of Rs 100 per ton on coal and iron ore, Rs 70 per ton on the bauxite Rs 50 per ton on manganese ore after the Supreme Court order allowed the state governments to levy loyalty on mining activity.

Supreme Court in its order earlier this week had allowed states to not only levy additional cess/royalty on the mining assets but it can collect the dues retrospectively as well

Investors and mining companies feared the retrospective effect more than prospective. Though the fear came true but couple of provisions by the SC have diluted the negative effect to a large extent which is a welcome relief, said the report by investment and wealth management firm -- Phillip Capital.

While the judgement without doubt is negative for the metal and mining sector as future cost of production is seen rising by 1-3 percent for these companies, the fear of retrospective impact being

devastating on the financial of the companies was watered down to a large extent by Supreme Court order by extending the payment period to 12 years and forbidding State Governments to impose any additional interest or penalty, the report said.



A stroll to the beach became the turning point in Jay Shringarpure's life and promoted him to take to cleaning up Maharashtra's beaches

What's your Sunday plan? Most people will say it's all about breakfast-inbed, long lunches with family and movie outings with friends. But for Jay Shringarpure, the weekly holiday from work means early mornings spent cleaning Mumbai's beaches.

The next day, he went to the same place with his little daughter and collected nearly one ton of garbage, with help from municipal employees. There on, he set up the Jay Foundation.

Jay Foundation is dedicated to creating awareness and bringing about a change in society for environmental conservation and sustainable development. This is being carried out through various initiatives and campaigns for the betterment of our environment while engaging com-

Friday's successful mission enables NewSpace India Ltd to commence the dedicated commercial launch of satellites to industry players who are keen to launch satellites weighing up to 500 kg into Low Earth Orbits (LEO) or up to 500 km above Earth.

ALV rocket is shorter at 34 metres (compared to PSLV rockets which are 44 metres tall) and are used to place satellites (mini, micro or nano satellites) that weigh up to 500 kg below  $500 \mathrm{\ km}$  of LEO.

The satellites carried in the mission weigh 175.5 kg and the launch vehicle comprises three solid propulsion stages and a liquid module as a terminal stage.

The key features of LV vehicles are -- it provides low-cost access to Space, offers low turn-around time and flexibility in accommodating multiple satellites, launch on demand feasibility and demands minimal launch infrastructure.

A former ISRO scientist in a brief interaction with PTI had said the cost of LV would be around 20-30 per cent lesser than that of a PSLV mission, which uses bigger rockets capable of deep space missions.

"Another point is that if someone plans to launch a satellite in a Low Earth Orbit, it will be possible to launch an LV rocket within two days of planning," he said, indicating the flexibility of the small satellite launch vehicle missions.

cludes a structural panel embedded with PCB, an embedded battery, a Micro-DGA (Dual Gimbal Antenna), a Micro-Phased Array Antenna and a flexible solar panel, each serving as a key component for onboard technology demonstration.

In June, NSIL said the LV would have its first dedicated commercial launch when it puts into orbit the Optimus- a satellite built by Australia-based Space Machines Company, in 2026.

Mobro 4000 was a barge that used to carry garbage collected from New York City in the USA to a nearby Islip island in the Atlantic Ocean that was the official dumping site for city garbage in the latter half of the twentieth century. The city used to generate so much garbage that, at one point, this island was no longer willing to hold any more garbage. It was at full capacity.

One day, in 1987, this barge carrying 3186 metric tonnes of garbage started its journey through the Atlantic Ocean, hoping to dump this garbage on Islip Island as usual. But the island officials rejected it, as there was no space to accommodate this load. So this barge set out on a journey to find a suitable place for dumping the cargo it was carrying. It was systematically rejected by the authorities and people along the coastal states of North Carolina, Florida,

including Mexico, the Ba

Finally, after travelling for about six thousand miles, and six months through the Atlantic, the barge returned to New York. Its cargo, the garbage, was incinerated and reduced to 400 tonnes and then dumped at the initial site that had earlier rejected it! The plight of the Mobro snapped the world's attention. Its message was clear: we must handle our garbage, trash, or waste. We are running out of places to put our garbage. The

4000, carrying **3,186** metric tonnes of New York's garbage, was rejected by Islip Island and various other locations before returning six months later to New York for incineration.

## China weaponising lucrative tourism to break Taiwan ties

Palau's president says his country is paying price

Wellington: Beijing weaponised tourism to the Pacific archipelago of Palau over its allegiance to Taiwan and its accusations that China was behind a major cyberattack there, President Surangel Whipps Jr said.

Palau, along with Tuvalu and the Marshall Islands, is one three Pacific nations to recognise Taiwan as an independent democracy viewed as a snub by Beijing, which asserts it is part of China. Taipei's allies in the Pacific have dwindled from six countries in 2019; Nauru abandoned its ties in January

Whipps told the AP in an interview late Thursday that, in 2020 while he was running for his current post, the Chinese ambassador to a neighboring country pledged to flood his tourism-dependent nation of 20,000 people with a million visitors if he capitulated on the country's stance.

"That continues to be the overture," he said by phone Thursday. "They say, why are you torturing yourselves? Just join us and the sky's the limit."

Whipps refused. "We don't need a million tourists," he added. "It's not always about how much money we get.

His stance is vanishingly rare amid Pacific island nations — some struggling to sustain themselves and feeling overlooked by Western powers while their backyards are increasingly the settings for some of the world's most potent contests for influence. Amid intensifying conflict over ocean territory, resources and political sway, Beijing's pres-

Islamabad: For the first time, the Pakistan government has confirmed that it was upgrading its "web management system" to cope with cyber security threats amid speculation about the installation of a so-called 'firewall' that could be leading to internet disruptions in the country, according to a media report on Friday.

Millions of people across Pakistan have been facing trouble accessing internet services for some time now due to limited connectivity, particularly while using mobile data in some regions.

So far, official stakeholders in Pakistan have either been feigning ignorance in response to public outcry and media queries, or claiming that the problems were because of telecom and internet service providers, or

In fact, more than a third of the 110 hostages still held are said to have died in captivity or on Oct. 7, their bodies taken to Gaza. Three hostages were mistakenly killed by the Israeli military. Seven hostages were freed in rescue missions, as were several bodies.

The hostage families have watched as their weekly protest in central Tel Aviv has gradually dwindled in size, with Israelis growing weary of the seemingly endless struggle.

"We owe something to our country. We owe something to our future. The best way to invest in it is to ensure the next generation actually exists," he said. "I think we have to go to war against the anti-child ideology that exists in our country.'

Vance has suggested people without children should pay higher taxes than people who have children. That's the spirit of the existing child tax credit at \$2,000 per qualifying child, which Vance has said he'd love to see raised to \$5,000. He has also mentioned in interviews he wants to ban pornography for minors. citing it as one of the causes for why people are marrying less and having fewer

children

His anti-abortion views, he has said, are separate from his concerns on birth rates, arguing the procedure is not really driving the decline in fertility.

In several interviews, he's argued policymakers should make it easier for two-parent households to be able to live on a single wage so that one of the parents can stay home with their children.

"The ruling class is obsessed with their jobs. Even though they hate a lot of their jobs, they are obsessed with their credentials and they want strangers to raise their kids," he told then-Fox News host Tucker Carlson in 2021. "But middle-class Americans, whatever their station in life, they want more time with their children.'

### BJP leaders fan out to slam Opposition

New Delhi: The BJP leaders fanned out across the country on Friday to target the opposition parties over the issue of safety of women following the rape and murder of a doctor in Kolkata, and alleged that core values of the Constitution were being undermined in West Bengal under Chief Minister Mamata Banerjee-led government

Addressing a press conference in Kolkata, BJP spokesperson Sudhanshu Trivedi claimed that opposition parties have exhibited a "dangerous mindset of hatred and disregard" for women, and protection of criminals from Kannauj to Kolkata.

"Sonia Gandhi and Rahul Gandhi should answer whether their 'Mohabbat Ki Dukan' is run only by criminals, corrupt individuals and rapists," he said.

Congress leader Adhir Ranjan Chowdhury has claimed that democracy does not exist in West Bengal and that Mamata Banerjee is a dictator, protecting criminals, asking how can his party still be in an alliance with her.

Union Minister Giriraj Singh said in the national capital that Banerjee is so consumed by power that she would not hesitate before abusing Lord Ram, an apparent reference to her aim at the BJP and the Left by blaming "Ram and Vaam" for the last night vandalism in the hospital where the spine-chilling incident had occurred.

Singh alleged that the Trinamool Congress (TMC) president has abandoned the principles of 'Maa, Maati, Maanush' and said that Lord Ram embodies peace, harmony and love, and also eradicates evils. BJP spokesperson She-

hzad Poonawala said in Karnataka that the Calcutta High Court does not trust the West Bengal government and police, and handed over the investigation into the crime to the CBI. When will Banerjee take

responsibility for the incident and resign, he said, claiming that she no longer has any moral, legal or constitutional right to remain as the chief minister. Another BJP spokesper-



### Survey reveals poor mental health conditions of medical students

New Delhi: Nearly 28 per cent of UG and 15.3 per cent of PG medical students reported having been diagnosed with mental health conditions, according to an online survey conducted by a National Medical Commission (NMC) task force.

The survey, which included 25,590 undergraduate students, 5,337 postgraduate students, and 7,035 faculty members recommended that resident doctors work no more than 74 hours per week, get a weekly one-day off and seveneight hours of daily sleep.

Thoughts of self-harm or suicide in the last 12 months were reported by 16.2 per cent MBBS students while the number was recorded at 31 per cent in MD/MS students, according to the report by the National Task Force on Mental Health and Well-being of Medical Students.

According to the task force survey report that was finalised in June this year. feelings of loneliness or social isolation are common, with 8,962 (35 per cent) experiencing them always or often and 9,995 (39.1 per cent) sometimes. Social connectivity is an issue for many, as 8,265 (32.3 per cent) find it difficult to make or maintain social connections and 6,089 (23.8 per cent) find it 'somewhat difficult'.

Regarding adequate knowledge and skills for managing stress, 36.4 per cent reported that they feel lack of knowledge and

skills to manage stress. Faculty or mentors are seen as extremely unsupportive by 18.2 per cent. According to the survey,

the majority of students (56.6 per cent), find their academic workload manageable but heavy, while 20.7 per cent consider it too heavy, and only 1.5 per cent find it light or too light, the survey showed.

"The fear of failure is a significant issue in UG students with 51.6 per cent agreeing or strongly agreeing that it negatively impacts their performance. Furthermore, 10,383 (40.6 per cent) students feel constant pressure to achieve top grades," it showed.

Balancing academic work with personal life is a struggle for 56.3 per cent of UG students.

cent, the survey found. Accessibility to mental health services is rated as very or somewhat inaccessible by 18.6 per cent students and the quality of these services is perceived as very poor or poor by 18.8

The analysis of ragging and stress-related parameters for 25,590 undergraduate medical students provides significant insights into their experiences and stress levels.

A majority (76.8 per cent), reported not experiencing or witnessing any form of ragging or harassment, while 9.7 per cent reported such experiences.

Regarding institutional measures, 17,932 (70.1 per cent) students believe their college has adequate measragging, while 3,618 (14.1 per cent) disagree, and 4,040 (15.8 per cent) are unsure, the survey showed. As for PG students, re-

garding academic stress, 20 per cent students admitted that they find the current academic workload frequently challenging, 9.5 per cent too intense, while 32 per cent reported manageable academic stress levels.

Close to half the PG students (45 per cent) revealed working for more than 60 hours a week with more than 56 per cent not getting their weekly offs.

### ED arrests four in Chinese betting app fraud

New Delhi: Four persons have been arrested in connection with a Rs 400 crore "fraud" online betting and gaming app allegedly linked to some Chinese nationals, the Enforcement Directorate (ED) said on

Arun Sahu, Alok Sahu, Chetan Prakash and Joseph Stalin were taken into custody under the provisions of Prevention of Money Laundering Act (PMLA) in the case related to the app named 'Fiewin',

Friday.

the federal probe agency said in a statement.

The money laundering case stems from an FIR filed at the Cossipore police station in Kolkata against some unknown persons for "cheating" and "conspiracy" with a number of online gamers through the app.

"An amount of Rs 400 crore was generated from the Fiewin app fraud and thereafter was credited into eight Binance (global crypto exchange) wallets

in the name of Chinese nationals. These wallets were operated from the Chinese mainland as revealed by the access IP logs.

"The Chinese nationals communicated with and instructed the four accused persons through digital communication especially groups on Telegram (social communication app)," the ED said.

Since these four persons played an "active role" in the Fiewin app-based scam and they are found to be

involved in the offence of money laundering, they were arrested, the agency said.

The ED did not say when these persons were arrested but added that a special PMLA court in Kolkata sent them to 14 days of ED custody.

Probe found, the ED said, that Chinese nationals were operating the app with the help and support from Indian nationals, sources said.

Dubai: Former Australian captain Ricky Ponting reckoned that Joe Root could surpass batting legend Sachin Tendulkar's tally of runs in Test cricket, provided the England batting mainstay stays 'hungry' and keeps scoring at a consistent rate for the next four years.

Root became only the seventh batter in the history of the conventional format to cross the 12,000run mark — a feat he achieved recently during the Edgbaston Test against the West Indies.

With 12,027 runs in 143

Tests at 50.11 with 32 centuries and 63 fifties so far, Root is also overall the seventh highest run-scorer in Tests and could overtake Sri Lanka's Kumar Sangakkara (12.400 runs) and his former teammate Alastair Cook (12,472) soon.

Tendulkar leads the table with 15921 runs from 200 Tests.

Ponting, who sits second behind Tendulkar in the list with 13.378 runs from 168 Tests, told The ICC Review, "He (Root) could potentially do that. He is 33 years of age...

(more than) 3000 runs behind.'

"It depends how many Test matches they play, but if they're playing 10 to 14 Test matches a year and if vou're scoring 800 to 1,000 runs a year, then that sort of says he's only three or four years off getting there. So that'll take him to 37 (years of age)," said the legendary Australian. Ponting said Root will need to remain hungry for runs and the England batter has got the age on his side to aim for the Test record.

New Delhi: "Forget the past and think about the future," this was Indian women's hockey team chief coach Harendra Singh's advice to his wards as he chalks out his side's roadmap for 2028 Los Angeles Olympics.

After reaching a new high in Tokyo, where they finished a creditable fourth, the Indian women failed to qualify for Paris Games, where the men's team won a second consecutive bronze medal.

"When I took up this team, we had discussed this topic in length. I always look into the positive side and feel that something better is there in store for them. "Obviously girls were disheartened, the whole country was sad but I told them that there is something bigger waiting for them," Harendra, who was appointed to the role in April this year, told PTI

"I told them to forget

for LA 2028," said the Dronacharva awardee.

When asked about what prompted him to leave his lucrative job as head coach of USA men's team and return to the country, Harendra said: "I am happy to be back home and serving for the vision of women empowerment in India.

"Somewhere I wanted to contribute and not a better place to serve Indian hockey, especially women

"Professionally I have learnt many things in my stint as a coach of the US men's team. I think after Rio Olympics we have realised we are a sleeping giant and must wake up now. The kind of talent we have and the infrastructure now, that inspired me a lot," he said.

"We have a lot of potential in women's hockey and it's not impossible to climb the ladder and win medals. It's about passion and coming back to your roots," added the 55-year-old, who coached India to the men's Junior World Cup title in 2016.

Harendra said fitness is

one area which is a primary concern for

him. lacking in the fit-

ness standard which is needed for modern-day hockey. It includes speed, endurance, agility and decision making ability. They have technical skills and if they fulfil the fitness parameters that will give them an edge in big tournaments," he said.

"My prime job is to improve the strength, power and speed of this team."

He also insisted that his long-term plan revolves around a self-confined tern 'SST', which is science, skills and technology.

"We have to incorporate science, skill and technology, which I call SST. We are now playing European style which was the biggest lacking earlier. We have made a blueprint. There should be one model, one coaching philosophy from the grassroots to national camp," he said.

He also defended the deci-

sion to have a new captain in Salima Tete, as it allow acegoalkeeper Savita to play more freely.

"Savita is wall of Indian women's hockey. She has served our country for many years now and is an integral part of our scheme of things but there is one technical glitch.

"If the captain is shown the green card during the match what will happen because she is the goalkeeper? So it's better to have a captain who is not a goalkeeper, Harendra said.

## Delhi HC restores mandate of IOA ad hoc panel

New Delhi: The Delhi High Court on Friday restored the mandate of Indian Olympic



Association's (IOA) ad hoc committee constituted for running the affairs of the Wrestling Federation of India (WFI) on a plea by celebrated wrestlers Bajrang Punia, Vinesh Phogat, Saksni malik and her husband Satyawart Kadian. following the elections held in the federation in December.

The court, in an interim order, said the IOA's decision to dissolve the ad hoc committee was incompatible with Union Sports Ministry's order suspending the WFI shortly after the December elections, while adding that until the suspension order is not recalled, it is necessary for the ad hoc committee to manage the federation's affairs. Justice Sachin Datta turned down the petitioners' prayer to appoint a retired high court or Supreme Court judge as the administrator of WFI, and said it shall be open to the IOA to re-constitute the ad hoc committee

"Since this court has concluded that the dissolution of the ad-hoc committee was unwarranted, it restores the mandate of the ad-hoc committee appointed by the IOA vide order dated 27.12.2023.

"However, it shall be open to IOA to reconstitute the adhoc committee so as to ensure that the same is a multimember body comprising of eminent sportsperson/s and/or experts who are wellversed in dealing with the International Federations, so as to allay any concerns that the UWW (United World Wrestling-the world body for the sport) might have as regards the steps taken qua the WFI," the court held. The wrestlers, who were

at the forefront of last year's protest at Jantar Mantar demanding the arrest of outgoing WFI chief Brij Bhushan Sharan Singh for alleged sexual harassment of seven women grapplers, had moved the high court earlier this year for setting aside and declaring as illegal the elections held to elect the office bearers of the federation held in December. Sanjay Singh, a Brij Bhushan loyalist, was elected the new WFI chief in the polls held on December 21, 2023

The Centre had, however. suspended the WFI on De-

cember 24, 2023, three days after it elected the new office bearers, for allegedly not following the provisions of its own constitution while taking decisions, and requested the IOA to constitute an ad noc committee to manage and control its affairs.

In February, UWW lifted the suspension, leading to the IOA also dissolving its ad hoc committee on March 18.

In their application for interim relief in the matter, the petitioners had sought a stay on the functioning of the WFI in its present form and to prevent it from undertaking any activity as a national federation for the sport of wrestling.

In the 31-page order, Justice Datta said the lifting of the ban by the UWW was

"unconnected" with the circumstances set out in the Centre's suspension order and the consequent formation of the ad hoc committee by the IOA, and "disapproval" by the UWW was also not a valid justification for not  $implementing \, the \, Centre's \,$ directives.

The IOA had submitted in court that UWW had issued a warning that if there was any interference with the autonomy of WFI, it would impose a temporary suspension on wrestling federation.

There is no reason, the court said, for the Sports Ministry to "adopt a passive approach which undermines its own orders" and that the "remote possibility of the UWW taking

umbrage" should not  $have \, prevented \, it \, from \,$ doing what it must to with the Sports Code and the law of the land.

Paris Olympics launchpad for Indian sports' rise Modi believes the justconcluded Paris Olympics is going to be a turning point for India. The 117-member Indian contingent returned with six medals, including one silver and five bronze. The count was one less than Tokyo and there was no gold in the tally this time.

But Modi appreciated the efforts of all athletes who represented the country and said their inputs will help in successfully getting the hosting rights of the 2036 Games.

"Those who have returned after losing, please get this out of your mind. You made the country proud and came back after learning something. Sports is one area where no one loses, everybody learns," Modi said.

"I believe Paris Olympics will be a launch-pad for the rise of Indian sports. This is going to be our turning point. After that there will only be wins. We are not going to stop," the Prime Minister added.

The Prime Minister termed the athletes as "India's soldiers of 2036 Olympics".

"India is preparing to host the 2036 Olympics. In this case many athletes who played in the Olympics, their inputs are very important. You might have observed many things there, from Olympics planning to all facilities, from sports management to event management," Modi said.

'Your experiences, your observations, we need to write them down, so in 2036 Olympics all the little things and experiences of yours will help us in preparing for the Games. In one way you are soldiers of 2036 Olympics," he added.
