"Social justice top priority for government"

New Delhi: President Droupadi Murmu on Wednesday emphasised the need to strengthen affirmative action as a tool for inclusion while urging the rejection of divisive tendencies rooted in perceived social hierarchies.

In her address to the nation on the eve of 78th Independence Day, Murmu highlighted the steady progress of political democracv in India, asserting that it reflects advancements towards social democracy.

She noted that the nation thrives on its diversity and plurality, moving forward as a cohesive entity.

"Social justice is a top priority for the Narendra Modi government, which has initiated unprecedented measures for the welfare of Scheduled Castes, Scheduled Tribes, and other marginalised communities,' the president stated.

She quoted B R Ambedkar, the architect of the Indian Constitution, emphasising that "political democracy cannot last unless there lies at the base of it social democracy" and said steady progress of political democracy testifies to the progress made towards the consolidation of social democracy.

The spirit of inclusion pervades every aspect of our social life. We move to-



gether as a cohesive nation with our diversity and plurality. Affirmative action must be strengthened as an instrument of inclusion. I firmly believe that in a vast country like ours, tendencies that stoke discord based upon perceived social hierarchies have to be rejected," she said.

Lauding the president's speech, Prime Minister Narendra Modi said, "An inspiring address by Rashtrapati Ji on the eve of our Independence Day. It motivates us to keep working to build a prosperous and developed India."

Murmu also detailed several government initiatives aimed at uplifting marginalised groups, including the Pradhan Mantri Samajik Utthan evam Rozgar Adharit Jankalyan (PM-SURAJ), which provides direct financial assistance, and the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JAN-MAN), focused on improving the socio-economic conditions of Particularly Vulnerable Tribal Groups (PVTGs).

She also mentioned the NAMASTE scheme, designed to eliminate manual scavenging by ensuring sanitation workers do not engage in hazardous tasks.

The president stressed the importance of justice in its broadest sense, particularly in terms of gender and climate justice.

She acknowledged that while women in Indian society are seen as equals. traditional prejudices

Murmu noted that government efforts have tripled budget allocations for women's welfare over the past decade, leading to increased female labor participation and an improved sex ratio at birth.

"But I am glad to note that the government has given equal importance to women's welfare and women's empowerment. The budget allocation for this purpose has more than tripled in the last decade," she said. She cited the Nari Shakti Vandan Adhiniyam (Women Reservation Act) as a significant step towards women's empowerment.

Speaking about the 2024 Lok Sabha elections, Murmu highlighted the record number of nearly 97 crore eligible voters, describing it as the largest electoral ex-

Vinesh Phogat's appeal rejected



Paris: Indian wrestler Vinesh Phogat's appeal against her disqualification from Olympic Games final has been rejected by the adhoc division of the Court of Arbitration for Sport (CAS), the Indian Olympic Association said on Wednesday.

Vinesh was disqualified for being 100gm overweight at the time of the weigh-in on the morning of the women's 50kg freestyle final last

In a statement, IOA President PT Usha expressed "shock and disappointment at the decision of the Sole Arbitrator at the CAS to dismiss wrestler Vinesh Phogat's application against the United World Wrestling (UWW) and the International Olympic Committee (IOC)."

"The operative part of the August 14 decision, which dismisses Vinesh's application to be awarded a shared silver medal in women's 50 kg category at the Paris Olympic Games has significant implications for her in particular and the sporting community at large," the IOA stated.

The rejection of Vinesh's appeal means India's tally from the Paris Olympics will be of six medals which includes one silver and five

Army captain martyred; one terrorist killed

Jammu: An Army captain and a terrorist were killed in an ongoing operation in the higher reaches of Jammu region's Doda district on Wednesday.

A civilian was also injured in the encounter that broke out on the eve of Independence Day and is the latest in a series of incidents in the Jammu region that has witnessed a spike in violence of late.

This is the fourth encounter in recent days in the Udhampuri-Doda-Kishtwar region of Jammu and Kashmir.

Bullets rang out on Wednesday morning in a thickly-forested area during a cordon-and-search operation (CASO) launched by a joint team of security personnel to track down a group of foreign terrorists hiding in the Shivgarh-Assar belt, the officials said.

Captain Deepak Singh was critically injured during the operations and shifted to a military hospital where he succumbed to his injuries, they added.

"One terrorist has been neutralised in the ongoing operation. One AK 47 has been recovered. Intermittent exchange of firing continues as the operations are ongoing," the Army said in a post on X.

Four blood-soaked rucksacks were seized from the site of the encounter, leading officials to initially believe that a total of four terrorists were killed. M-4 carbines were also found, the officials said. However, the death of only one terrorist has been confirmed.

The terrorists crossed into Doda from a forest area near Patnitop in adjacent Udhampur district after a brief exchange of fire between security forces and the ultras there on Tuesday evening, officials said.

They said the security forces established contact with the terrorists in Udhampur around 6 pm on Tuesday. An encounter broke out about half an hour later and continued intermittently until both sides paused. A cordon was established overnight.

At about 7:30 am on Wednesday, there was a renewed exchange of fire in Doda where the terrorists had fled to, the officials said.

"Supari allegation defamation"

Mumbai: Former Mumbai Police Commissioner Sanjay Pandey has refuted Home Minister Devendra Fadnavis' allegations over an alleged contract to frame him in false cases. Pandey said accusing a police officer of taking a supari (contact) is defamation of the entire police force.

"As far as I know, till now I have only heard that goons and gangsters were given 'supari'. This is the first such instance of giving 'supari' to the policemen,' Pandey said in an exclusive interview to The Perfect Voice. He was reacting to

Fadnavis' allegation that the then Maharashtra Vikas Aghadi (MVA) government had given a contact to Pandey to implicate him and his colleague in the BJP Girish Mahajan in "I have no need to give

clarification about these baseless allegations. Accusing a police officer of taking 'supari' is a defamation of the entire police force and government servants not only in Maharashtra but entire India. What else can I say about this?" Pandey said.

He refuted the allegation that the police force was working under political

pressure. When asked about his successor Param Bir Singh's allegations against then Home Minister Anil Deshmukh over alleged monthly extortion of Rs 100 crore Pandey shrugged his shoulders. "Only he (Singh) knows about this and he can tell. What can I say about this?"

We had blood streaming down our faces

The hero of Tiger Hill recounts the story of valour and courage

Mumbai, August 14, 2024: When he fearlessly charged towards the Pakistani army, despite taking 17 bullets, Subedar Major Captain Yogendra Singh Yadav, made history as the youngest Indian ever to be awarded the Param Vir Chakra, the highest gallantry award. He was only 19 years old during the Kargil War when he played a key role in capturing Tiger Hill which led to India's victory over Pakistan Army. This year, on July 26, India marked 25 years of the victory which came at a price of lives of 545 brave officers and jawans.

When Yadav opened his eyes after what seemed like eternal deep sleep, all he saw was the ceiling fan rotating. He looked around; every muscle and sinew in his body hurting. He realised that he was in the army hospital at Srinagar. His last memory was of



camp and ploughing down the treacherous mountain while bleeding profusely. He had awakened after three days. And the horrifying events of the past three days started flashing in front of his eyes. "God kept me alive so that I could tell the tale of the unparalleled valour of our battalion and our brave men who were martyred while protecting our motherland," Yadav tells The Perfect

Voice. Soon after he completed his military training, Yaday, the son of an army

man living in Bulandshahar, joined the 18 Grenadiers battalion and was part of the Ghatak Force Commando platoon. Within two years, he was thrust into the heart of the bloody war with Pakistan—at Tiger Hill. Yadav was on leave for his wedding on May 5, 1999 and was to resume duty on May 20. By then, Pakistani soldiers had infiltrated into Indian territory and taken position across 160 km of Indian land in Kashmir. Yadav joined duty and was posted in Manasbal in the Ganderbal

district of Kashmir when

his platoon received orders to move to the Drass sector.

The Pakistanis had captured Tololing peak which gave them a sweeping view and access to the Kashmir Leh highway. Control over a key stretch of this highway meant that movement of the Indian troops would be halted preventing them from reaching forward posts. Tololing had to be cleared but the initial attempts had not been successful. On May 22, the infantry launched a well-planned attack which continued for several days and claimed numerous lives. "We climbed for 22 days and our battalion lost two officers, two junior commissioned officers and 21 jawans," says Yaday who was part of the brave 18 Grenadiers who played a kev role, along with 2 Rajputana Rifles, in winning back Tololing.

Pune: With its back to the wall after its rout in the Lok Sabha election, Maharashtra Deputy Chief Minister Ajit Pawar and his Nationalist Congress Party (NCP) has now girded up for the upcoming Assembly election by launching a 'Jansanman Yatra' on August 8 from Nashik.

To counter his nephew, uncle Sharad Pawar's rival Nationalist Congress Party (SP) announced its own rally titled 'Shiv Swarajya Yatra' that began from August 9.

The last time they faced each other was the bitterly contested Lok Sabha election in their home town Baramati. Ajit Pawar suffered a humiliating defeat when his wife Sunetra Pawar lost to Sharad Pawar's daughter Supriya Sule. Ajit Pawar's party could win only one (Raigad) of the five seats it contested. In stark contrast, the 83-yearold Sharad Pawar proved his political mettle to his estranged nephew by winning eight of the 10 Lok Sabha seats it had contest-

Panel set up in Maharashtra's Palghar to address land right issues of tribals

Palghar: A committee has been set up in Palghar district of Maharashtra to address the issues relating to joint forest rights of tribal people and expedite resolution of their pending claims, the district administration has said.

Antar Singh Arya, chairman of the National Commission for Scheduled Tribes (NCST) made the announcement about the panel to be chaired by district collector Govind Bodke, after an inspection tour of the district on Monday and Tuesday, an official release here said.

The chairman held a meeting of all the stakeholders on Tuesday and reviewed the projects meant for tribals in the district, it said.

During the two-day tour, Arya and other commission members visited several villages and ashram schools to assess their present condition and expressed concern over the quality of facilities and amenities provided to students in these schools.

Following this, the district administration has been given a one-month deadline to enhance conditions at the ashram schools, and to ensure that each student has access to a bed and other essential amenities. A follow-up inspection is scheduled for next month to evaluate the improvements, the release

Jarange's demand for Muslim OBC quota likely to affect Maratha stir adversely

Mumbai: Yet another demand and controversy by Manoj Jarange Patil. In his new demand of granting reservation to Muslim community from the OBC (Other Backward Castes) quota, Maratha activist Manoj Jarange has sported yet another controversy which may even erode his support base, leaders supporting Ja-

Jarange had raised the new demand after BJP leader Pasha Patel's record showed that he was a Kunbi. "If there are such records. then all Muslims should get a reservation from the OBC quota. I will see how they don't get their rights," Jarange stated.

While mentioning the apprehension that granting a blanket Kunbi (OBC) status would adversely affect prospects of the members of OBC community in general and Muslim OBC communities, during his public meeting on July 24, Jarange said, "In the old govt records Muslims also have been mentioned as Kunbi. Members of whichever community, be it Muslim or Lingayat or even a Brahmin or a Marwadi – if they have a record of mention as Kunbi, they should be granted the status and get quota as OBCs." "in fact all Muslims in the state should get quota under this status," he further added

Senior minister in Maharashtra cabinet Chhagan Bhujbal reacted sharply to Jarange's new demand and said, "Jarange should study the existing provisions before raising new demands. Some of the Muslim com-

enjoying quota under OBC status. Jarange makes such baseless statements in a bid to please different community groups and hence keeps on making statements in favour of community groups like Vanjaris and Dhangars.'

BJP leader Pasha Patel, while extending his support to the demand of Maratha quota, questioned Jarange Patil's intentions behind the demand of Muslim quota. "Why Jarange is interested in issuing reservations for the Muslim community, which in fact is a separate religion and not a Hindu caste like that of Marathas? This a ploy to annoy OBCs," he said.

"Hinduism is divided into social hierarchies, but the Muslim community is seen as a religion," OBC activist Laxman Hake said while objecting to Jarange's demand.

While the leaders from OBC communities and political parties like the BJP, who are facing the heat of the Maratha quota stir, criticizing Jarange is understandable, other leaders within the Maratha agitation fold too have now started voicing their reservations about Jarange's ever-rising demands.

"Our Constitution does not allow giving reservations on religious grounds. Our leaders should know that the reservation can be granted only on the backwardness of a caste," said Adv Swati Nakhate of the Maratha Morcha, while Mahesh Rane of Maratha Kranti Morcha feared that such deviation would weaken the successful agitation.

The thesis submitted by ASI Bhange had earlier prompted the Maharashtra police to direct district-level officials to study trial court judgements

One of his suggestions was that a special cadre of "scenes of crime officers" should be created for collection of evidence.

Activist complains to PMO

MUMBAI: A Mumbaibased activist on Wednesday claimed there was a discrepancy in the country's map on the Government of India's 'MyGov' website, and he has written about the same to the Prime Minister's Office.

In his complaint to the PMO, activist B N Kumar said that parts of the Union Territory of Jammu and Kashmir were missing from the map provided on 'my-

The PMO has registered the complaint, and as per the latest status, referred it to the concerned official as well as the CEO of MyGov, he said. Still, he felt sad that such a mistake should creep in, Kumar told PTI

"I feel sad, ahead of Independence Day," he said, adding that he also attached the correct map of Jammu and Kashmir with his complaint. Some international websites including the World Health Organisation (WHO) consistently show PoK (Pakistan-occupied-Kashmir) separately on the map," Kumar claimed.

Fraudsters extort money by creating fake email accounts of Nagpur cyber police

Nagpur: In an "unprecedented" kind of a fraud, a gang extorted money from several persons by creating email addresses similar to those of the Nagpur Cyber Police and getting their accounts freezed by contacting the banks, police said.

Two men have been arrested in the case, said Deputy Commissioner of Police (detection) Nimit Goyal here Wednesday.

The fraudsters, who somehow obtained details of at least 176 bank accounts, sent emails to the banks in the name of Nagpur Cyber Police and demanded that these accounts be freezed be-



cause of suspicious transactions, he said.

The fraudsters then

contacted the account holders, told them that their accounts had been

freezed because of `antinational activities', and demanded money to un-

freeze them, the DCP

This modus operandi was "unprecedented", Goyal added.

He, however, did not specify the total amount extorted by the fraudsters.

The scam came to light when Sweta Kumar Trilochan Panigrahi, an assistant manager with IC-ICI Bank, received an email from `cyberpolicenagpur@maharashtrapolice.in. asking to freeze certain accounts.

Panigrahi suspected that it was a fake email address and alerted authorities, following which the Nagpur Cyber Police started a probe and arrested Pradum Anil Singh (26) and Shubham Pitambar Sahu (32) from Mumbai earlier this

Investigation revealed that the fraudsters targeted 176 accounts across seven banks: SBI, HDFC, Bank of Baroda, AU Small Finance Bank, Federal Bank, Punjab National Bank and IndusInd Bank

Police are probing how the fraudsters obtained the victims' banking information and the role of insiders is suspected, Goval said.

A court here has remanded the arrested duo in police custody till August 14.



How is Raj playing in the hands of BJP

Mumbai: After declaring 'unconditional support' for the ruling Mahavuti in the Lok Sabha elections, the MNS has now decided to go solo in the forthcoming state Assembly elections. Just months ago, Thackeray had extended unconditional support to Prime Minister Narendra Modi and the NDA in the Lok Sabha elections has now taken the U turn and started preparing for nearly 225 to 250 seats out of a total of 288 assembly seats.

In a strategic political move, the BJP is considering the MNS as a reliable party to check UBT Sena, the sources added

further. When contacted initially MNS leaders were tight lipped. On insistence MNS spokesperson Sandip Deshpande said our party cannot wait for a proposal from the Mahayuti alliance. "There is no consensus between the BJP, Shiv Sena Shinde camp, and

NCP Ajit Pawar camp on seat sharing. So we choose our path," Deshpande pointed out.

Mumbai-London Air India flight returns

Mumbai: A Londonbound Air India flight, which departed from here on Wednesday morning with 354 people on board returned to the city after the pilot-in-command reported pressurisation issue in the cabin, a source

The aircraft landed safely, the source said.

"Air India flight AI-129 that had departed from here Wednesday morning returned to the city after the pilot reported pressurisation issue in the Boeing 777 aircraft cabin," the source told PTI.

The flight departed from Mumbai at 8.36 am and returned to the city at around 11.30 am.

Meanwhile, an Air India statement said: "The flight operating from Mumbai to London made an air-return to Mumbai due to a technical issue. The aircraft landed safely at Mumbai for precautionary checks.'

The airline also said it has already made alternative arrangements to fly the passengers to their destination.

Air India said it has offered full refunds on cancellation and complimentary rescheduling to another date, if so desired by passengers.

Consumer panel junks woman's complaint against Uber for drivers refusing rides with pet dog

Mumbai: A consumer commision here has dismissed a woman's complaint against cab aggregator Uber for its drivers refusing her rides when she was accompanied by her pet dog.

There is no law or legal provision in India regarding the transportation of pets in public vehicles, said the District Consumer Disputes Redressal Commission, Central Mumbai, in an order passed on Tuesday.

In her complaint filed in June 2022, the woman, a Wadala resident, stated that despite the company's petfriendly policies, she was denied a ride by Uber drivers on two occasions after she informed them that her pet dog would be traveling

The woman demanded Rs 10 lakh in compensation for "deficiency in service, unfair trade practices, mental agony, and litigation

She also requested the commission to direct the



to allow commuters to travel with pets and stray animals in the cabs.

Uber India pointed out that the complainant did not make the drivers -against whom the woman had the grievance -- parties

There was no evidence to back her allegations except that she informed the drivers about traveling with a pet dog, it said.

to the case.

There was no policy in India regarding allowing pet animals to travel in public transport, the company said, demanding that the complaint be dismissed.

The commission, after reviewing the company's business model, noted that the drivers canceled the ride at their discretion, and

"Additionally, there is no evidence showing that the complainant informed the driver that a pet would be accompanying them, nor is there any established law or provision in India regarding pet transportation in public vehicles," it observed.

Nor did the woman provide any evidence to show that the policies related to pets, which may be applicable in other countries where Uber operates, are binding on the company in India too, said the commission.

But it noted that her "concerns regarding the need for a pet-friendly environment are acknowledged and appear to be made in good faith and essential."

"The absence of any binding agreements, specific legal provisions, or established rules on this matter prevents us from granting the relief as requested," the commission said, while dismissing her plea.





RSS Role in Freedom Struggle

he Indian independence struggle, often narrated through the lives of a few prominent leaders, is only a partial story. But emerging documents now reveal a more complete picture. Kalyan Kumar De's book 'Netaji' reveals British archive information linking public outrage over INA trials and the naval rebellion to the British's decision to leave.

Few are aware that the first revolt for independence was led by the Maruthu Pandiyar brothers at Tamil Nadi in 1801. Similarly, the contributions of figures like Subramanya Bharathi, VO Chidambaram Pillai, Kumarswamy Mudaliar, Birsa Munda, and U Tirot Sing Syiemlieh are rarely mentioned in favour of more widely recognised leaders like Gandhi and Nehru.

The Rashtriya Swayamsevak Sangh (RSS) has received little recognition. Founded in 1925, the RSS focused on spiritual patriotism rooted in India's Hindu culture, inspired by Bankimchandra, Lokmanya Tilak, and Savarkar. Dr. Hedgewar advocated for nationalism based on Bharat's cultural and geographical identity.

He initially revolted against the British during his school days. While studying medicine in Kolkata, he joined the Anusheelan Samiti and led against the British-imposed restrictions on Indian doctors. As a Congress joint secretary, his advocacy for 'complete freedom' was rejected in favour of limited self-rule. His support for the non-cooperation movement led to a nine-month prison term.

Realising that India's divisions-caste, orthodoxy, parochial conflicts, and language, hindered the unity required to overthrow the British. After conferring with leaders of Hindu Mahasabha and Congress, he established a new organisation apart from politics, the RSS.

The original RSS pledged to work with complete commitment for the freedom of the Hindu Rashtra, that is, Bharat. Dr. Hedgewar envisioned an all-India organisation prepared to fight for freedom after WWII. Before his passing, he regretted not completing this task by 1940 to seize this historic moment. His vision became clearer when we see that the Quit India movement was launched in 1942 and the INA was formed.

The second RSS sarsanghchaalak, Shri Guruji, worked to make the RSS a strong all-India organisation. At this time, the Quit India came to the fore, and RSS swayamsevaks participated in the movement.

Since RSS's biggest and most powerful participation was in Vidarbha, two towns, Chimur and Ashti, saw a takeover of government with 'Patri Sarkar.' Multiple Swayamsevak were either shot, hanged, or imprisoned.

The swayamsevaks not only actively contributed to the freedom movement but also played a heroic role in post-independence colonial liberation within India."

The RSS further supported the Quit India movement by providing shelter and legal assistance in fighting cases of satyagrahis and these leaders.

When independence was declared, RSS volunteers protected the people of Punjab and Sindh and assisted many of them in escaping from the newly formed Pakistan. Hundreds of swayamsevaks sacrificed their lives, families, and businesses.

Even before the Indian army marched into Jammu and Kashmir after the signing of the treaty of accession, it was the RSS that stood with the Dogra army and later the Indian army to provide support.

They aided in the construction of roads, bridges, and runways; and picked up ammunition dropped by air force planes.

As unbelievable as it may sound, there were small colonies in India even after independence. Pondicherry was liberated with a treaty with the French in 1954. Dadra Nagar Haveli was liberated by RSS swayamsevaks led by Vinyakrao Apte, Sanghchaalak of Pune, in 1954. Thousands of swayamsevaks liberated Goa under the leadership of Jagannathrao Joshi. Rajbhau Mahkal from Indore was shot through the eye and lost his life, holding the Tricolour aloft.

In my book "Sangh & Swaraj", I have included the names of 33 swayamsevaks who lost their lives defending Hindus in the Amritsar riots. Other books like "Now it Can be Told", "Jammu Kashmir ki Ankahi Kahani", and "Jyoti Jala Nij Pran ki" must be read to understand the contribution of the RSS, before and after Independence.

Post World War II, the British Raj decided to give up on Bharat as they realised the rising anger against INA trials and the Naval rebellion. I do not negate the sacrifices of Indians under the non-violent path of freedom struggle, but request historians and others to take a balanced view and give credit where it is due. We all pay our respects to all the freedom fighters, whether sants, patriotic sadhus, janajaati leaders, revolutionaries, Congress, or others like the RSS. To truly understand our struggle for independence, we must revisit it with the depth and nuance it deserves, as the venerable historian R.C. Majumdar began, and finally give voice to the silenced narratives that shaped our nation.

On December 16, 1971, Bangladeshis overthrew the brutal authoritarian West Pakistani regime that seemed unstoppable and had the support of the United States. I believe they could because they were pushed to the limit with no means of self-expression. When you're treated like vou do not matter and vour way of life is under attack, leading you to lose all hope, you will be driven to fight. However, that victory came at a tremendous cost: millions were killed, around 400,000 women were raped, and in desperation, the regime murdered intellectuals and

US leaders Nixon and Kissinger ignores the genocide despite US Consul General in Dhaka, Arthur Blood's "Blood telegrams," urging action. Instead, they supported the regime with arms and sent a naval fleet. While India provided political and military assistance, the victory was unequivocally that of the Bangladeshi people.



In 1971, the people overthrew the brutal West Pakistani regime through armed struggle, driven by a lack of self-expression and extreme desperation. Despite significant economic progress under Sheikh Hasina, many are feeling now feel hopeless, leading to renewed calls for action.

J. Krishnamurthy, the philosopher, said all conflict comes from ownership. Thus, when a few individuals attempt to hoard resources while alienating the majority, conflict becomes inevitable. During the making of Pippa and on previous trips to Bangladesh, I was fortunate to meet with diverse people-intellectuals, artists, musicians, businesspeople, and students. I noticed one common characteristic: their incredible cultural capital: a deep value for their tradition, music, and way of life. To me, it seems like this unity is what empowers them to rise in revolt whenever necessary. With Sheikh Hasina at the helm

for 15 years, Bangladesh prospered economically, and social indicators improved. I wonder, why did we witness these recent events? How are the two rebellions similar? what lessons can we learn from these situations? I am neither a political scientist nor well-versed in Bangladesh's politics. However, as a filmmaker I observed that in historical and recent conflicts, people in power seemed disconnected from ordinary people, believing they could be subdued by force. The events of 1971 demonstrated that no force can stand against the human need for self-determination and expression. There is no comparison to the brutality or issues that drove 1971. However, when people are pushed into despair, it triggers a need to express themselves. They will stand up for their rights.

Propaganda and curated truth do not change reality. Suppressing dissent does not eliminate it. Without room for debate, conversation, or credibility for opposing points of view, the festering angst, even over minor issues can spiral into something much deeper. The need to be released from subjugation gives rise to rebellion, with a new beginning being the only acceptable solution.

Instability only benefits bad actors who use it for their political gain. I hope that through the next few months, all political parties will find solutions to ensure Bangladesh's stability. I hope, that the future is not taken for granted.

Rising Drone Threats and India's Response

ince 2019, Punjab and several other states have reported a sharp increase in drone sightings and incidents, particularly related to smuggling operations involving arms and drugs. The possibility of terrorist attacks or incidents targeting critical infrastructure using drones cannot be dismissed. India has already experienced attacks on military installations involving drones.

India has also faced drone attacks from the Houthis at sea, with 22 Indians onboard a British oil tanker being affected. While this may be considered a case of mistaken identity, where Indians were not the direct target, the incident underscores the growing threat posed by the proliferation of drones.

The increased involvement of China and Pakistan in drone-related activities is a serious concern for the Indian security community. In just a few months, over 100 drones flying from Pakistan were intercepted, a number consistent with previous years. Chinese-made drones, readily available at prices ranging from 1 lakh and 5 lakhs, are easily accessible to terrorists and criminals.

Pakistan-based groups like Lashkar-e-Taiba and Jaish-e-Mohammad have been identified as being behind the smuggling of arms, IEDs, and narcotics into India via drones. Pakistan's Inter-Services Intelligence (ISI) has reportedly established six drone centers across the border, facilitating these smuggling operations with the assistance of the Pakistan

Meanwhile, the India-Bangladesh border, once relatively stable due to Bangladesh's economic growth and



India confronts growing drone threats, fueled by increased smuggling and terrorism, with significant concerns over Chinese and Pakistani involvement. In response, the country is boosting border security, advancing domestic drone technology, and implementing stringent regulations to address this rising challenge.

Sheikh Hasina's cooperation, now faces uncertainty following her ouster and subsequent unrest.

There are concerns that the ISI may seek to exploit other frontiers as well. While unrest continued even after her departure, the formation of an interim government has slightly calmed the atmosphere, lingering fears persist, causing people to flee toward the Indian borders.

To counter these evolving threats, India's smart border management now requires smart policing. The use of drones, initially intended for other zones, could also prove effective in managing the Eastern border.

The frequent use of drones

against India has compelled the country to adopt a multi-pronged approach to address this menace. Indian diplomacy has engaged with like-minded nations in various bilateral and multilateral forums, aligning with global efforts to counter the threat posed by drones. For surveillance purposes, India has purchased drones from several countries and is also collaborating with others to produce drones demostically.

India is aware of the dangers posed by 'off-the-shelf' drones operated by terrorists or violent extremists worldwide. As a precaution, warnings and restrictions against drone use have been prominently displayed near sensitive installations. Additionally, an Interpol alert highlights the potential for drones to deliver chemical, biological, radiological, nuclear, and explosive materials in conflict zones.

The global threat landscape also raises concerns about possible terrorist attacks against soft targets, such as crowded public places.

Moreover, India has taken significant steps to develop indigenous drone technology. Under the IDEX (Innovation for Defence Excellence) initiative, start-ups have demonstrated their capabilities in counter-drone measures, and some indigenous anti-drone systems have already been inducted. Currently, 72 certified companies either manufacture or import drones in India, and they are being encouraged to develop both drone and counter-drone capabilities locally.

In addition, India has established a legal framework through the Drone Rules, 2021, and created institutions like the Drone Emergency Response System and the BSF Drone and Cyber Forensic Lab in New Delhi to tackle the security challenges posed by drones.

Anti-drone systems have been deployed along the border, with all security agencies coordinating their efforts. The focus must now shift to bolstering security along the Bangladesh border.

VADHVAN PORT PROJECT

A watershed moment in India's maritime saga

'n June this year, the Narendra Modiled Union cabinet cleared the decks Lefor developing a state-of-the-art, "allweather greenfield deep-draft major port" in Vadhvan near Dahanu in Maharashtra which is to be built at a whopping cost of Rs. 76,200 crores.

Since then, epithets like 'game-changer' and 'revolutionary' have been frequently bandied about in news reports while mentioning this ambitious project, a veritable engineering marvel which is planned to be operational by 2030.

Vadhvan , sited near Dahanu in the state's Palghar district around 150 km from Mumbai, is all of this and much

It is believed that the expansion of the port could revolutionize India's maritime sector and Indian business, besides acting as the hinge of which Maharashtra development would pivot for the next two decades.

Vadhvan is to be three times bigger than India's mega-ports - the government-run Jawaharlal Nehru Port Authority (JNPA) in Mumbai and the Adani-owned Mundra, the largest private port in the country while having the capacity to accommodate the world's biggest cargo ships that can sail in with

Such is the depth of ambition behind its conception that this major port, India's thirteenth and Maharashtra's third, is to be transformed into taking its place among the top ten container ports

As a touchstone of the Central government's Sagarmala Program, Vadhvan 's strategic importance is hard to overstate: it is positioned as a hub port in the Arabian Sea, strategically catering to container traffic bound for the Gulf, Europe and even African nations, essaying a crucial part in the India-Middle East-Europe Economic Corridor (IMEEEC) with Minister for Ports, Shipping and



Waterways Sarbananda Sonowal stating that Vadhvan would act as the main feeder port of the IMEEEC and propel cargo movement to Chabahar Port in

The employment potential is enormous with the infrastructure expected to create around 12 lakh employment opportunities.

Today, the country does not have a single port to accommodate the largest container ships in the world.

Once Vadhvan sees the light of day, it will have a cargo handling capacity of 298 million metric tonnes per annum including approximately 23.2 million Twenty-Foot Equivalent Units (TEUs) of containers, which exceeds the capacity

of any Indian port and positions it among Asia's largest ports. (TEU is the general unit for cargo capacity, germane to container ships and container ports)

The project, a joint venture between the JNPA and the Maharashtra Maritime Board (MMB), with a shareholding of 74% and 26% respectively, will also reduce the burden on the Jawaharlal Nehru Port which has been constrained in terms of cargo evacuation for the past several decades owing to the ever-burgeoning Mumbai city as well as due to limited depth of the harbour (barely 15 meters) which allows the mooring of only small ships. Because of this geographical constraint, cargo ships coming to India are compelled to first unload

the goods at Colombo or Singapore and bring them back to India with the help of small ships.

That problem will disappear with the expansion of the port at Vadhvan as its projected capacity to handle container ships ranging from 16,000 to 24,000 TEUs is expected to make trade highly

Geographically, the Arabian coast at Vadhvan is ideally suited for a new port as there is a natural depth of 20 meters near the shore.

So, what will propel Vadhvan into the ranks of a world-class mega port?

Automation in port container terminals (fully automatic and semi-automat ic) will help avoid port congestion and avoid delays which in turn will reduce port storage charges. Vadhvan will be integrated with state-of-the-art systems for monitoring and evaluation of various port equipment.

Keeping in mind environmental concerns, Vadhvan is to be constructed as a green port with the optimal utilization of efficient systems to reduce fuel consumption and air pollution.

A raft of sustainable solutions has been conceptualized during the construction phase itself; for instance, the use of green additives in concrete

As part of the employment generation process, skill development will form a vital component with various training programs to be organized for youth in the construction phase. There are proposed open sea cage culture training programmes that are to be facilitated by NGOs to aid fishermen. Several other training programmes have already been conducted which includes computer software, tailoring, heavy vehicle driving and mechanics, custom servies, and more. Over 156 candidates have already been employed locally after pursuing these training programs.

"Vadhvan Port will bring prosperity"

Dr. Hemant Savra, the Member of Parliament from Palghar, says the Vadhvan Port will bring prosperity in the region. He addresses the concerns of the locals over the infrastructure project. He, however, is hopeful that the concerns would be resolved in a peaceful manner.

How do you look at the proposed Vadhvan Port project? This is a very important project. The Prime Minister has given his approval to this project. Vadhvan will be the largest port, deepest port in India having capacity of around nine ports. Also, it will be the ninth largest port all over the world. It will drastically change not only Palghar but overall India's



What is so special about Vadhvan Port?

The most important thing is it is designed in the sea. On the land, around 5,000 acre area which is close to 1,500 hectares is being created. That will be dedicated for the railway and highway. Only that part of land acquisition will take place. The first phase will open in 2029. The total cost is around Rs 76,000 crore. The Union government has allotted Rs 45,000 crore recently. So it is a very important project for Palghar district. It will change the overall scenario of Palghar.

What about employment generation?

This project will generate around 11.50 lakh jobs. The locals are going to get a lot of employment opportunities. Apart from jobs, all other sectors will bloom here. That includes the hotel industry, service industry and tourism. There will be prosperity with the economic

There is a bullet train project as well. What are your plans to project Palghar as a logistics hub? There is no need to project Palghar as a logistics hub. It has already acquired that identity. It will automatically come on the logistic map. It only bullet train but also a dedicated freight corridor is coming up in this region. There is a dedicated highway too. Palghar's geographical position near Mumbai gives us an advantage.



All eyes on Ather's \$450 mn IPO

Mumbai: Ather Energy, a Bengaluru-based electric two-wheeler manufacturer, is poised to launch its Initial Public Offering (IPO). It is anticipated that the company will submit its preliminary red herring prospectus to the Securities Exchange Board of India (Sebi) in September 2024 for its IPO. This offering is expected to raise a substantial amount of over \$450 million.

The company has already garnered significant investment, raising \$71 million from the governmentbacked National Investment and Infrastructure Fund Limited (NIIF), valuing the company at \$1.3 billion. This valuation places Ather Energy among the unicorn club, having achieved a valuation of over \$1 billion be-

fifth company in India to surpass this valuation threshold this year, alongside Rapido, Perfios, Krutrim, and Porter.

In May of this year, Ather Energy secured an additional \$34 million in funding through a blend of debt and equity, predominantly from venture debt and its cofounders. Data platform Tracxn reports that the company has successfully raised \$502 million across 19 rounds of funding as of Au-

The journey of Ather Energy began in 2013, founded by Tarun Mehta and Swapnil Jain, both graduates of IIT Madras. Mehta's enthusiasm for electric vehicles prompted him to leave his position at Ashok Leyland in 2012 to dedicate himself to enhancing battery packs. Recognizing that battery packs were merely one component of the challenge, Mehta and his team embarked on the ambitious task of developing an entirely new electric vehicle. Jain joined Mehta in this endeavor, conceptualizing Ather Energy with him in 2012.

The company's investor base includes notable entities such as Tiger Globe Management, the co-founders of Flipkart, Sachin and Binny Bansal, Innoven Capital, among others. Presently, Ather Energy operates two manufacturing facilities in Hosur, Tamil Nadu, with one dedicated to battery production and the other to vehicle assembly. Plans are underway for the establishment of its fourth facility in Maharashtra, with an investment exceeding Rs 2,000 crore.

Zepto plans to raise \$310 M

Mumbai: Quick-commerce grocery delivery platform Zepto, currently headquartered in Singapore, is set to sniit its operations to India ahead of its initial public offering (IPO) filing. This strategic move is part of Zepto's ambitious plans to further its growth and valuation.

The company, which has been in operation for three years, is poised to raise an additional \$310 million, significantly increasing its valuation to \$5 billion. This represents a 40 percent increase from its valuation at the time of its most recent funding round, which occurred just over a month ago.

The new funding round is expected to attract a diverse group of investors, including Mars Growth Capital—a partnership managed by Mitsubishi UFJ Financial Group Inc and Liquidity Group from Israel. This collaboration is in addition to existing investors such as General Catalyst and other notable entities.

As deposits lag credit growth, Indian banking at crossroads

Mumbai: August 14, 2024: Indian banking system is undergoing a paradigm sniit with av erage depositors shifting their allegiance towards the capital market through systematic investment plan (SIP) making the lenders starved for deposits.



At an industry event earlier this month, Reserve Bank of India (RBI) Governor Shaktikanta Das said, "There will always be some gap between the two, but credit growth should not run ahead of deposit growth by miles.

While credit growth has been robust at over 17 percent, bank deposits have been lagging by growing just around 11 percent, as banking customers have been lured

to other investment avenues like mutual funds that can be threatened into a structural liquidity management issue.

RBI Governor at the industry event did point out that customers were increasingly allocating their savings to mutual funds, insurance funds and pension funds that has led to the decline in the share of bank deposits. As a result, interest rates on the deposits might firm up.

According to a report by brokerage house – KR Choksey on State Bank of India after the latter's Apr-Jun results - "The cost of deposits (for SBI) increased by 45 bps yearon-year and 19 bps quarter-on-quarter. The increase in the term deposit rates over the past two quarters resulted in the increase in overall cost of funds (for the bank).'

Last week, Finance Minister Nirmala Sitharaman commenting on the need to reverse the flagging deposit growth rate called upon banks to focus on mobilizing small deposits.

Banks need to take the old-fashioned route to bring back focus on mobilising "small deposits" and not just big deposits in order to reverse the flagging deposit growth rate, Finance Minister Nirmala Sitharaman said Saturday.

"It's right that credit is going through digital format and collection of deposits is not. Huge big deposits have always been a very lazy banker's job but the trickles which come are going to be the bread and butter money to lend regularly," the Finance Minister said adding that small deposits though a grinding monotony is where the bread and butter lies for the

Stating it as a positive caution to the banks, RBI Governor Das said that they have been witnessing a 300-400 basis points gap between deposits and credit growth, with deposits being lower. Though RBI doesn't see a crisis, if unattended can lead to a potential structural liquidity management issue.

Domestic exporters have expressed concerns over the political crisis in Bangladesh and said developments in the neighbouring country would have implications on bilateral trade.

Barthwal said that the situation in Bangladesh is improving fast and "we are monitoring the trade which is happening across the borders and what we feel that is whatever disruptions were there, they have been largely addressed".

"We also believe that between India and Bangladesh, there should be improvement in trade. So we feel that whatever best efforts, we can make for improving the trade, we should do that and we are doing that".

On August 8, Nobel laureate Muhammad Yunus returned to Bangladesh from Paris to take oath as the head of Bangladesh's interim government, three days after Sheikh Hasina resigned as Prime Minister and fled the country following widespread protests against her regime.

India's exports to Bangladesh in July rose by 11.13 per cent to USD 803.52 million. During April-July, exports increased by 10.76per cent to USD 3.58 billion.

Bangladesh is India's biggest trade partner in South Asia and India is the second biggest trade partner of the neighbouring country in Asia.

India's exports to Bangladesh dipped to USD 11 billion in 2023-24 from USD 12.21 billion in 2022-23. Imports too declined to USD 1.84 billion in the last fiscal from USD 2 billion in

India's main exports include vegetables, coffee, tea. spices, sugar, confectionary, refined petroleum oil, chemicals, cotton, iron, steel and vehicles. The main import items are fish, plastic, leather and apparel, among others. "We are monitoring

things. We want that trade relations to be restored...we are watching the situation. It will be premature to say how things will change and happen," he added.

Federation of Indian Export Organisations (FIEO) President Ashwani Kumar said that returning of normalcy of trade between India and Bangladesh will not only further give a boost to the overall order bookings but also to the labour-intensive sectors of exports.


Tata Steel acquires equity

India, Russia discussing rupee-rouble trade

New Delhi: India and Russia are discussing holding trade in local currencies and reducing non-tariff barriers by Moscow to boost the bilateral trade, Commerce Secretary Sunil Barthwal said on Wednesday.

The secretary raised these issues during his meetings with Russian Minister for Economic Development Maxim Reshetnikov; Russia's Deputy Minister of **Industry and Trade Alexey** Gruzdev; Head of FSVPS (Federal Service for Veterinary and Phytosanitary Supervision) Sergei Dankvert of the Russian Federation last month.

"We discussed a lot of issues to improve trade between India and Russia. We also discussed how to facilitate rupee-rouble trade, how non-tariff measures are impacting our trade and how they should be reduced," he told reporters

He added that Russia has started working to cut the barriers. Indian export sectors such as meat and pharma face issues in Russia. India, Barthwal said, also

discussed diversification of

trade beyond petroleum products.

"We are expecting that even in non-petroleum trade, there will be a good improvement in volumes,' he said.

Further, the secretary said that balancing bilateral trade is key at present as there is a trade imbalance.

"The rupee-rouble trade will also be affected only when there is more balance of trade," he said adding that over 53 vostro accounts have been opened.

The meetings with Russia hold significance as both countries look to increase the bilateral trade to USD 100 billion by 2030. India is focussing on vari-

ous sectors like electronics, besides taking up issues of non-trade barriers in areas like shrimp and pharma, to boost exports to sanctionhit Russia and move towards achieving this

At present, the bilateral trade stands at about USD 67 billion.

India's exports to Russia stood at USD 4.3 billion in 2023-24 while imports were USD 61.4 billion.

Mumbai: In May 2019, the Bharatiya Janata Party (BJP)-led coalition government helmed by then Maharashtra Chief Minister Devendra Fadnavis had allocated a bauxite mining project at Nanar (in Ratnagiri district) in the State's verdant Konkan coastal belt to a firm based in the neighbouring state of Goa. The project was given to Goa-based Sociedade De Fomento Industrial Pvt. Ltd. - a member company of Fomento Resources - following an auction even as the controversial Nanar refinerv project was facing strident protests by the local populace.

After a successful campaign, in which parties of the opposition Maha Vikas Aghadi (MVA) coalition jumped into the fray, stalled the proposed refinery project, villagers of Nanar and adjacent Humdara-Ghodepaiwadi (Sagave Village) now are embroiled in another campaign to prevent the bauxite mining project from taking off.

The proposed Nanar Bauxite mining site spans 358 acres whereas the Sagave site covers approximately 297 acres of land, following an auction in May 2019.

Fomento resources headed by Amber Timblo purchased the electoral bonds through subsidiaries such as Infrastructure Logistics Pvt. Ltd. and Hardesh Ores Pvt. Ltd. whereas Gamma Iron India Limited is deployed for the bauxite mining project located in Humdara- Ghodepaiwadi (Sagave Village). According to sources, the Timblo family, who run the Fomento



group, are said to be major donors to the ruling BJP. The bauxite project has been hanging fire for a number of reasons with the 2019 Maharashtra Assembly election followed by the COVID-19 pandemic coming in way of its implementation. The vociferous protests against the proposed oil refinery in Nanar, which allegedly threatened to destroy Konkan's rich biodiversity, helped create an atmosphere against the bauxite mining project

What is the project?

As per the pre-feasibility report to obtain environmental clearance, the proposed Bauxite mine is to be developed by the opencast mechanized mining method (a surface mining technique where heavy machinery is used to efficiently remove overburden and extract minerals from large open pits or quarries).

While assuring that all recommended environmental protective measures including "dust suppression, water treatment, water conservation, soil conservation and afforestation will be undertaken to mitigate with the impacts caused by mining activities," the replantation, deplete groundwater resources, and disrupt the livelihoods of fishermen as well. after the Nanar gram panchavat last month informed them of a public hearing on the bauxite mining proposals. The Maharashtra Pollution Control Board (MPCB) had announced the public hearing of the bauxite mining projects to be held on August 29 (Nanar) and September 5 (Sagave) respectively.

The MPCB's draft report on the environmental impact assessment of the project assures that the project proponent will take all precautionary measures "to reduce the impact of mining operations on air, water, noise and soil and ensure that all control measures shall comply with the prescribed standards." The report also added that the proposed production of ore will be carried out by fully mechanised open-cast mining, with no drilling and

However, villagers remain sceptical. Satyajit Chavan, a local activist, says, "People in the Konkan region are nature lovers. They are all too aware of the false promises made by companies in the past in the name of employment opportunities, environmental protection as per their previous experience. So, people here do not want such a red-category project."

There are concerns related to health hazards as well due to the particulate matter and pollution caused by the mining, Chavan observes.

Environmental degradation resulting in increasing incidents of landslides'

Sringeri: Environmentalist and author Dr. Kalkuli Vittal Hegde, who is spearheading the environmental movement in the Malnad areas in Karnataka, has said unscientific methods of development and scant respect for structural integrity of hills were among reasons for incidents of landslides in Shiroor and Wayanad recently.

He also expressed concern over the increase in landslides and erratic rainfall in the Western Ghats.

"Too much use of fossil fuels and irresponsible development models have resulted in a great degree of topsoil erosion on both sides of the Western Ghats, which is a barometer of the environmental health of the Southern Peninsular region," he said

Hegde is the first environmental expert on the Malnad regions (hilly terrain) of the southern peninsular region, to collect rain related statistics from 1895 to 2020 and beyond until the current monsoon.

'We were already warned by unexplained occurrences of cyclones even on the western seaboard of the Arabian Sea since 2020. But we chose to ignore the signals, and now we have enough and more rain than the typical monsoons every alternative year and the increase of volumes of rain in certain areas like Kodagu, Wayanad, the coastal region, and the slopes of Western Ghats on the western region is fearsome." Major landslides hit the Mundakkai and Chooralamala regions of Wayanad on July 30 almost decimating both the areas, leaving over 230 people dead.

Nar-Par-Girna river linking

Enhanced irrigation facilities on card

Mumbai: The Maharashtra government has approved the river linking project Nar-Par-Girna with an aim to irrigate the parched areas of Nashik and Jalgaon districts in North Maharashtra region. Once completed this project will drastically improve the irrigation facilities in this region.

What is the project?

The Nar river is in Peth taluka and Par river is in Surgana taluka of Nashik district. The Girna basin is on the east of the mountain in Jalgaon district. The

Nar and Par rivers flow through Gujarat into Arabian Sea. The river Girna flows through Nashik and Jalgaon before merging with river Tapi. The river link-

divert the surplus water from 20 small proposed dams of west-flowing rivers such as the Ambika, Auranga, and Nar-Par basins to the east side - Girna river of Tapi basin. Through this scheme, 10.64 thousand million cubic feet (TMC) of water is proposed to fetch from Nar-Par to Girna. It will benefit 49,516 hectares in Nashik and Jalgaon districts. The project's cost is estimated at Rs 7,015 crore.

The residents and farmers in Kalvan, Satana, Deola, Malegaon, Chalisgaon, Pachora, Bhadgaon, Erandol, Dharangaon, Amlaner could increase their area under irrigation. A part of Dhule district will also come under the irrigation under this project. The Tapi Irrigation Development Corporation (TIDC) had conceived a detailed plan consisting of 22 dams to transfer all the surplus water from the four west flowing basins into eastern Maharashtra.

Political dividend

The approval to the river linking project has come as a boost for the Mahayuti government ahead of the Assembly elections due in October. The Maharashtra government had locked horns with Gujarat over sharing the water of Girna river and Narmada. The Mahayuti government's success in maintaining Maharashtra's stand is expected to give the ruling dispensation some political dividends in the north Maharashtra region. There are 35 out of 288 Assembly seats in the north Maharashtra region that includes Jalgaon, Dhule, Nandurbar and Nashik.

Kerala announces Rs 6 lakh compensation to kin of deceased amount will be allowed as which has been tasked by

Thiruvananthapuram: Kerala Chief Minister

Pinarayi Vijayan on Wednesday announced a compensation of Rs six lakh to the next of kin of those who died in the massive landslides that hit Wayanad district recently and claimed over 200 lives.

vıjayan said that of the Rs six lakh, Rs four lakh would come from the State Disaster Relief Fund and the remaining from the Chief Minister's Disaster Relief Fund (CMDRF).

He also announced that Rs 75,000 would be allocated from the CMDRF to those who lost eves and limbs or suffered disability up to 60 per cent in the

landslides.

The CM also said that Rs 50,000 financial assistance would be given to those who suffered disability between 40 to 60 per cent or suffered very serious injuries in the disaster.

Besides that, the survivors opting for rented accommodation or living with their relatives will get Rs 6,000 per month towards rent as part of the rehabilitation of the victims, he said.

This amount, however, will not be available to those who get rent-free or fully sponsored accommodation, he added.

In cases of partial sponsorship, the remaining monthly rent up to a maximum of Rs 6,000, the CM said at a press conference Vijavan also said that so

far 231 bodies and 206 body parts have been found, following the massive landslides that hit parts of Wayanad on July 30.

A total of 401 samples of bodies and body parts underwent DNA testing and of them 349 were found to be of 248 persons -- 121 males and 127 females, he further said.

The CM also said that the five-member expert team led by senior scientist John Matthai of the National Centre for Geosciences,

the State Disaster Management Authority to inspect the landslide-hit areas in Wayanad's Meppadi panchayat, was carrying out its work. The team will assess the

possible dangers in different parts of the disasterstricken area and nearby sites as well as how the disaster happened and what phenomena occurred in the landslides, he said.

Vijayan further said that additionally a drone-based LIDAR survey will also be carried out to determine what is underneath the disaster-stricken areas and how the land there can be used in future.

Heat wave caused 47,000 deaths in Europe in 2023

Madrid: In an alarming sign, more than 47,000 people died in otherwise cold Europe due to heat wave in 2023. The countries in south Europe were the most hit. The year 2023 was officially the world's hottest year. This data has come to fore in a study report by the Barcelona Institute for Global Health (ISGlobal). The report was published on August 11. The study replicated the methodology used last year in another paper published in Nature Medicine, which estimated that heat caused more than 60,000 deaths during the summer of 2022, which represented the highest heat related mortality burden of the last decade. The researchers used temperature and mortality records from 823 regions in 35 European countries for the period 2015-2019 to fit epidemiological models to estimate heat related mortality in each European region over the entire year 2023. They estimated that 47,690

people died from causes related to high temperature. The highest heat related mortalities were recorded in Greece, Bulgaria, Italy and Spain. Two episodes of high temperatures in mid-July



and late August would have accounted for more than 57 per cent of the overall estimated mortality, with more than 27,000 deaths.

Using this method, it was estimated that if the temperatures recorded in 2023 had occurred in the period 2000-2004, the estimated heat related mortality would have exceeded the number of 85,000 deaths, that is, 80 per cent higher than the result arising from the vulnerability to heat in the period 2015-2019. "Our results show how there have been societal adaptation processes to high temperatures during the present century, which have dramatically reduced the heat-related vulnerability and mortality burden of recent summers, especially among the elderly", says Elisa Gallo, researcher at ISGlobal and first author of the study.

ISRO to launch new satellite today

Mumbai: The Indian Space Research Organisation (ISRO) is going to launch its latest earth observation satellite, EOS-08 on Thursday morning. The satellite will be launched aboard the third and final developmental flight of the Small Satellite Launch Vehicle (SSLV-D3). The launch will take place from the Satish Dhawan Space Centre in Sriharikota.

ISRO has said that the primary goals of the satellite is to develop a microsatellite, creating payload instruments compatible with the microsatellite bus, and incorporating new technologies for future satellites.

The spacecraft, with a mission life of one year, has a mass of approximately 175.5 kg and generates around 420 W of power. The EOIR payload is designed to capture images in the Mid-Wave IR (MIR) and Long-Wave IR (LWIR) bands during both day and night, useful for applications such as satellitebased surveillance, disasmonitoring, environmental monitoring, fire detection, and more.

This mission marks the completion of the SSLV Development Project.

This expansion aims to provide users with a more extensive and detailed flood condition overview. The new version in-

cludes data on the storage positions of 150 major reservoirs. This feature is designed to offer insights into potential flood risks in downstream areas, aiding in better preparedness and response. 'FloodWatch India' utilises advanced technologies such as satellite data analysis and mathematical modelling.

emories of horrific incidents like the Nirbhaya case in Delhi will always remain unforgettable. Unfortunately, similar tragedies continue to be reported in both urban and rural areas across all states, without exception. Incidents of gang rape involving young girls from scheduled castes or scheduled tribes occur. Some cases involve individuals who deceive girls under false identities and then rape them. Often, these perpetrators record these horrific acts, blackmail the victims, and even subject them to repeated assaults. There are instances of girls being coerced into marriage. Their refusal leads to their murder and their bodies disposed of in a remote place

Investigations reveal that many of these acts are committed by juveniles aged 16-18. In addition to gang rapes, rapes, dacoities, and murders, there are reports of juveniles involved in rash and drunk driving in luxury cars, often resulting in the deaths of innocent pedestrians and two-wheeler riders. These incidents invariably provoke public outrage, with a demand for an explanation from law enforcement and questioning the government's effectiveness in addressing these issues. Often, public anger escalates to demands for the immediate execution of the accused, even if the suspect is a juvenile. Data compiled by the National Crime Record Bureau (NCRB) from all states reveals an increasing number of incidents involving juveniles aged 16 to 18 as suspects. According to the Juvenile Justice Act (JJA) 2015, a person below the age of 18 is considered a juvenile. The JJA stipu-

Factors such as family issues. poverty, and exposure to inappropriate content fuel this dangerous trend. Effective measures like counseling, occupational training, and community involvement are urgently needed to prevent juvenile delinquency.

expose children to inappropriate and pornographic content. Advertisements, TV/OTT serials, and cinemas also have an adverse impact. In redlight areas, children are often forced out during business hours, leading them into bad company and the use of illegal substances. Additionally, adolescent boys may steal to impress their friends and meet their needs.

Analysis of undertrial juveniles reveals most come from deprived backgrounds, having dropped out of school or attended irregularly. Lacking education and vocational skills many work as casual labourers. Due to dysfunctional families, these children lacked mental or social support. Their family situations involved poverty, forced child labour, inadequate parenting, continuous stress, or crises like death, desertion, etc. Moreover, NCRB data shows that drug addiction is leading to an alarming rise in serious crimes among children from affluent families

Although these children might have broken the law, police officers must remain sensitive to their circumstances. As the Commissioner of Police in Nagpur, I ensured they received counselling and school enrolment, if eligible. Others received vocational training, helping them become responsible individuals contributing to their families' income. The police should seek action from the Juvenile Justice Board against the parents of such children and safeguard them from adult offenders who might coerce them into crime. Collaborating with voluntary organisations, child psychiatrists, child guidance clinics, social care workers, and probation officers is crucial to address the root cause of juvenile delinquency. Efforts should be made to identify at-risk, destitute, and neglected children before they become

How the IMEC will Boost India's Trade and Reduce Reliance on China

Trade routes and economic corridors have become essential arteries of global commerce, driving economic growth, fostering regional integration, and enhancing geopolitical stability. These networks facilitate the efficient movement of goods, services, and resources across international borders, making them indispensable for modern economies

The newest ambitious economic corridor project on the global stage is the India-Middle East-Europe Economic Corridor (IMEC). This ambitious project aims to enhance economic connectivity and cooperation across these regions, providing new trade routes, boosting economic development, and reducing dependency on any single global power. The IMEC promises to open new markets, improve supply chain resilience, and foster geopolitical stability by strengthening ties between India, the Middle East, and Europe.

The Memorandum of Understanding (MOU) for the India-Middle East-Europe Economic Corri-

dor (IMEC) was signed on September 9, 2023. The initiative was launched by India, the US, UAE, Saudi Arabia, Italy, France, Germany, and the European Union, representing around 50% of the global GDP.

Additionally, there are plans to construct an underwater pipeline from Israel to Italy to transport green hydrogen produced in Gulf countries to Europe.

Unfortunately, the proposed rail line passing through the UAE and Saudi Arabia to Israel has been disrupted due to the Israel-Gaza conflict, which began in October

IMEC provides India with efficient trade routes to Europe and the Middle East, boosting economic activity and attracting foreign investment. The project will involve substantial infrastructure development, including improved port facilities and rail connections, enhancing India's logistics and transport sectors. Additionally, India's role in the IMEC will strengthen its geopolitical influence and strategic partnerships in the region, create job opportunities across various sectors, and facilitate technological and knowledge exchange, benefiting its industrial and technological capabilities.

By diversifying supply chains, the IMEC will reduce dependence on any single trade route and enhance resilience against global disruptions. Recent incidents, such as the near-blockage of the Suez Canal due to Houthi attacks, underscore the vulnerability of existing routes and highlight the need for alternatives like the IMEC. As global trade continues to grow, the IMEC represents a crucial step toward a more secure and interconnected future.



f one has to assess our present state as a nation, it is necessary to acquaint oneself with what transpired here, in at least the last five centuries. That will give us the tools to place ourselves in a historical and cultural perspective as a people and as a nation. It was not at all unusual for people to migrate into the land mass called India. For millennia many came and left their mark on our society. The change was slow, subtle and largely assimilative. Those who came here under stress, also found sanctuary in India.

Then about eight centuries ago, probing attacks into India led to the formation of a full-fledged Sultanate in Delhi, founded by men who professed a different belief, lifestyle and iurisprudence. That would not have been unusual, however, the invaders proscribed and restricted the practices of those who had made India their home before them. That was the first point of conflict. Iconoclasm, lower status for the indigenous people who could not claim Turko-Persian ancestry, an alien faith and court language followed. The Sultanate of Delhi and of the Deccan largely followed this model. The conquered submitted and survived. Freedom was lost.

The Mughals followed the same model. The state religion, the law of the land, the court language, promotions based on ancestry - continued from Akbar to Aurangzeb. The taxes. the social status of the local populace – largely Hindu – were also based on their faith and their ancestry. The Swarajya of Raja Shivaji was a reaction to the oppression in the Deccan. Beginning in the mid-1740s, he introduced a string of economic and agricultural reforms to succour his oppressed people. Coronated as Chhatrapati in 1674, he expanded his kingdom to the Cauvery. His death was followed by a quarter century of war, devastating the Deccan and its



people, yet the Marathas emerged from this ordeal of fire stronger than

The freedom earned after four centuries of thraldom, was precious. From the mid-seventeenth to the early-nineteenth century, the Marathas under the Chhatrapatis and the Peshwas, regained their political freedom, rebuilt the lost cultural emblems of their ancient faith, and for a century and more were the paramount power in India. Their rule extended at different times from Attock to Cuttack, the plains of Kumaon to the Cauvery, from Gujarat to the Maratha Ditch of Kolkata. Indeed, the cultural renaissance of India and its indigenous people, was during this crucial period in our re-

cent History. The importance of this freedom has not been sufficiently realised; the Marathas were the first indigenous Empire after centuries of foreign rule. It was also the last before we once again succumbed to a foreign power.

Swarajya was lost, and after the battle of 1857 led by the four Maratha chiefs -Nanasaheb Peshwa, Raosaheb, Tantia Tope and Laxmi bai - the fight for freedom continued until it was achieved in 1947.

The cost of regaining Swarajya was high indeed. The heroes of the movement - unknown and unnamed – were in lakhs. That freedom, and what it means, is often lost sight of. The word 'Swarajya' is used only twice in our history; first by Chhatrapati Shivaji and then by Lokmanya Tilak. And at both times we were under foreign rule.

Since 1947, India has progressed across many fields and can no longer be ignored.

The next hundred years are, however, crucial. Free from divisions that are often fomented for narrow political ends, we need to take fresh guard and focus on being the greatest nation on earth. We owe this to those

The Evolution of Indo-US Ties from 1947 to Today

ndia, the world's largest democracy, shares a deep bond with the U.S., home to the largest Indian diaspora. Since India's independence in 1947, the Indo-US relationship has been evolving significantly. On this Independence Day, let us look at the history of this pivotal partnership from its origins to now.

The U.S. was one of the first countries to recognise India as an independent country. On August 15, 1947, President Harry S. Truman sent a congratulatory message to Lord Louis Mountbatten, the Governor-General of India. Interestingly, On November 1, 1946, the American Embassy in New Delhi upgraded from a mission to an embassy, indicating the anticipation of India's impending independence.

Prime Minister Jawaharlal Nehru visited the US in 1949. His meeting with President Harry S. Truman was intended to solidify Indo-US ties, but the relationship remained cautious due to India's non-aligned stance during the Cold War. The US also declined to provide any economic aid to struggling India.

The US supported Pakistan during the Bangladesh Liberation War and the Indo-Pak War of 1971. When India conducted its first-ever nuclear test under Prime Minister Indira Gandhi in 1974, it also resulted in another significant setback in bilateral relations, with nuclear non-proliferation becoming a contentious issue between the two countries.

The Janata Party coalition came to power in 1977. This government aimed to adopt a more non-aligned and independent foreign policy, seeking to distance itself from the strong Soviet alignment of the previous Congress government. Eftions with the US, as a commitment to non-alignment and its nuclear ambitions.

Prime Minister Morarji Desai sought to enhance economic cooperation between the two countries. US President Jimmy Carter's visit to India in January 1978 was overshadowed by tensions over nuclear issues. The US tried to pressurize India to sign the Nuclear Non-Proliferation Treaty (NPT), which India refused, insisting on its right to maintain a nuclear deterrent in a region with nuclear powers like China and, potentially,

Rajiv Gandhi came to power after the assassination of his mother, Indira Gandhi, in 1984. He represented a younger, more modern, and technologically focused leadership, which created some optimism in the West, including the United States. He was also keen on modernising India's economy and military, and he saw an opportunity to engage with the United States for technology, investment, and defence cooperation. In 1985, he met with President Reagan in the U.S. to discuss economic cooperation, technology transfers, and regional security.

Besides disagreements over the NPT, shifting regional dynamics also raised concerns for India. The two countries had differing views

The end of the Cold War and India's economic liberalisation in the 1990s marked a turning point in relations. The liberalisation policies opened Indian markets to American businesses, fostering economic ties. President Bill Clinton's visit to India in 2000 symbolised a thaw in relations and the beginning of a strategic partnership. The landmark US-India Civil Nuclear Agreement in 2005 allowed India access to civilian nuclear technology, underscoring growing

trust between the two nations. India and the US have their conflicts with China, and that is also a reason that despite the suspicions, disagreements, and various ups and downs, the relationship between the two countries has continued to grow as both are dealing with a common adversary.

In 2016, the US designated India as a "Major Defense Partner," reflecting deepening defence cooperation. Agreements like the Basic Exchange and Cooperation Agreement (BECA) and participation in multilateral groups such as The Quad (comprising the US, India, Japan, and Australia) highlight the strategic alignment of interests, particularly in the Indo-Pacific region.

Nuclear proliferation may not be a frequently mentioned anymore, but the US immigration policy is an issue that impacts millions of Indians who live and work in the US on temporary work visas. They are waiting for employment-based Green Cards, with wait times extending to multiple decades due to the per-country quota. This backlog has significant implications, causing uncertainty for individuals and families. Advocacy for reforms, such as the EA-GLE Act to eliminate per-country caps, is ongoing, but substantial progress remains to be seen.

The 2024 US presidential election will significantly impact Indo-US relations, but we will have to wait at least until early next year to see the full extent.

CBI begins probe into Kolkata doctor's rape, murder case

CBI officers, who reached Kolkata on Wednesday morning, began its investigation into the alleged rape and murder of a woman doctor at a state-run hospital in West Bengal, officials

The CBI team, which comprises medical and forensic experts, will visit the RG Kar Medical College and Hospital's seminar hall where the body of the trainee doctor was found on August 9, they said

Three groups of CBI officers have been formed to investigate the matter, a central agency official said.

"One group will visit the RG Kar Medical College and Hospital, and talk to the witnesses and the doctors who were on duty on that night. Another team will take the arrested civic volunteer to a local court after medical tests and plea for his custody, while another will coordinate with the Kolkata Police sleuths who were conducting the investigation," he told PTI.

The Calcutta High Court on Tuesday ordered the transfer of the probe from the Kolkata Police to the central agency.

A source in the Central Bureau of Investigation (CBI) said that the agency has filed an FIR under various sections of the Bharatiya Nyaya Sanhita (BNS) in New Delhi in connection with the alleged rape and murder of the doctor.

"Today, our officers will seek the call details of the deceased woman and those on duty on that day. They may submit the FIR in a local court," another central



agency source said

The Kolkata Police handed over Sanjoy Roy, who was arrested in connection with the case, to the CBI at the CGO Complex here after his medical tests were conducted at the state-run SSKM Hospital.

Two CBI officers on Tuesday evening went to the Tala Police Station here and took documents related to the Kolkata Police's investigation.

The court had on Tuesday directed the city police to hand over the case diary to the central probe agency by the evening, and all other documents by 10 am on Au-

Victim's parent misguided: BJP

"The attempt to save the accused instead of providing justice to the victim raises serious questions on the hospital and the local administration," Gandhi said in a post on X in Hindi.

"This incident has forced us to think that if doctors are not safe in a place like a medical college, then how can the parents send their daughters outside for studies? Why are even the strict laws made after the Nirbhaya case unsuccessful in preventing such crimes?"

SC denies interim bail to Arvind Kejriwal in excise case

Court on Wednesday refused to grant interim bail to Delhi Chief Minister Arvind Kejriwal in a corruption case filed by the Central Bureau of Investigation (CBI) in the alleged excise policy scam and sought a response from the probe agency on his plea challenging his arrest.

As the hearing commenced before a bench of Justices Surya Kant and Ujjal Bhuyan, senior advocate Abhishek Singhvi, appearing for Kejriwal, submitted that he had got interim bail on three occasions in the money laundering case, also linked to the alleged scam, despite the stringent conditions laid down for grant of bail in cases under the Prevention of Money Laundering Act (PMLA).

Singhvi cited the top court's interim bail orders passed on May 10 and July 12, as well as the regular bail granted by the trial court on June 20

He informed the bench that the June 20 order of the trial court was stayed by the Delhi High Court on an "oral mention".

Singhvi argued when Kejriwal could secure bail despite the stringent conditions laid down under the PMLA, he cannot be denied regular bail in the CBI case since the Prevention of Corruption Act (PCA) does not have similar rigorous provisions like the antimoney laundering law.

Cong nominates Singhvi from Telangana New Delhi: The Congress on Wednesday named Abhishek Manu Singhvi as its candidate for the ensuing Rajya Sabha bypoll in Telangana. The Election Commission had announced last week that elections to 12 Rajya Sabha seats in nine states will be held on September 3. Earlier this year, Singhvi had lost the Rajya Sabha election from Congressruled Himachal Pradesh. 

Odisha to bring tigers from Maharashtra, MP

Bhubaneswar: To bolster big cat population in Odisha, forest officials have begun the process of relocating five Royal Bengal Tigers from Maharashtra and Madhya Pradesh, with the transfer scheduled to be completed in September.

According to Principal Chief Conservator of Forests (PCCF)-Wildlife, Susanta Nanda, three of these tigers will be released into the Debrigarh Wildlife Sanctuary in Sambalpur, while the remaining two will be introduced into the Similipal Tiger Reserve in

Mayurbhanj. "On our request, both Maharashtra and Madhya Pradesh have given their consent for relocation of



their tigers to Odisha. They have also identified the tigers from core areas of their forests," Nanda told media persons on Wednesday.

Two teams of Odisha forest officials will visit the two states very soon, within a week, to see the tigers, he


In its latest tiger estimation conducted for the first time during 2023-24 in 47 forest divisions of Odisha, 30 tigers and eight cubs were found.Out of the 30 Royal Bengal Tigers, 27 were found in the Similipal

Tiger Reserve (STR), while Keonjhar territorial and Keonjhar wildlife, Paralakhemundi territorial, and Hirakud wildlife had one tiger each.

The PCCF also said that the Nandankanan Zoological Park is all set to welcome two giraffes by the end of this month.

"I have resigned as the coach of the Davis Cup team," Zeeshan Ali told

Zeeshan, 54, had replaced Nandan Bal as coach of the team in 2013 ahead of the tie against South Korea in New Delhi.

"I've been coach of the Davis Cup team for 11 years now. To top it all, I was also the captain of the Davis Cup, the historic tie that we played against Pakistan in Pakistan earlier on this year. I don't think there is any such person from any country who has had the privilege and honor of doing all these three things, he said.

"There have been players who were captains, but



I don't think there has been a situation where the player was a coach and then the coach was also the captain of the team.

"So having done all these three things, I felt that I have already achieved whatever there was to achieve as far as Davis Cup was concerned. And frankly speaking, I have been thinking about this for quite some time now.

India will take on Sweden on hard indoor court in Stockholm from September New Delhi: A proud owner of two consecutive Olympic medals, Indian hockey star P.R. Sreejesh says the bronze claimed in Tokyo three years ago is closer to his heart than the one fetched in Paris as the former was like a mythical tale coming true after decades of merely hearing about it.

"Was umpiring in world cup, unaware of daughter's death"

Aleem Dar came to know about the tragedy when a person consoled him after a match

Karachi: Pakistan's most capped umpire, Aleem Dar has shared the saddest moment of his life when the death of his seven-month old daughter was kept a secret from him by his wife and family members in the early stages of his International career in 2003.

The 56-year-old recounted on a Pakistani channel that his wife and his family didn't tell him about the death of his infant daughter while he was umpiring in the 2003 World Cup.

"It was the start of my career as a ICC panel umpire and it was a very important assignment for my career and they knew if I came to know about my daughter's demise, I would return home immediately,' Dar said on the show

The highly-regarded Pakistani umpire said eventually when he learnt about his daughter's demise it



was the most sad moment of his life and he was hurt badly.

"I was kept in the dark for nearly a month after her passing away and I only came to know about it by chance in Johannesburg where a Pakistani man who belonged to my hometown Sialkot came to offer his condolences to me.

"It was a big shock to me at that time and I immediately informed the ICC and returned home," Dar said.

The umpire said the moment he learnt about his daughter he called up his wife and she started crying over the phone.

"I came to know later that my father had strictly told the media friends to not print the story," he

Dar stood in 145 Tests, 231 ODIs and 72 T20 Internationals in a career spanning from 2000 to 2023.
